The Amerigo Vespucci

Captain Angelo Patruno, Ambassador of Italy to the United States Armando Varricchio, and Nicola De Santis, Consul General of Italy in Boston, aboard the Amerigo Vespucci surrounded by junior officers of the Italian Navy. The ship, currently docked at the World Trade Center Pier, has been for used training since being launched in 1931. Often referred to as the "most beautiful ship in the world," the full-rigged, three hundred-thirty foot ship is an official training ship of the Italian Navy. She was last in **Boston Harbor during Sail Boston** in 2000. Boston is the seventh port that the Amerigo Vespucci will be visiting as a part of her 6-month transatlantic journey that began in her homeport of La Spezia in April. From here, the Amerigo Vespucci will travel to New York and then four more ports before returning back home. The ship will be open for free public tours during her stay from now through July 21st.



NERO'S PERVERSION

Nero's acts of maliciousness, extravagance, lust, greed, and cruelty came to light gradually and were thought to have been committed because of his youth. As time passed, there was no doubt that his mind was twisted and that his mentality was perverted.

As soon as darkness fell, he left the palace garbed in various disguises and viciously attacked men who were homeward bound. Those who resisted were stabbed and thrown into the sewers. He even robbed shops, set up a secret black market in the palace, and then squandered the proceeds. During one of his nightly escapades, he mistreated a woman and was almost beaten to death by her husband; thereafter, he never went out on the prowl without having some of his palace guards following in the shadows.

His vices gradually grew stronger and could no longer be shielded in secrecy. He abused boys, seduced married women, and even violated a vestal virgin. He had a young boy named Sporus castrated and even ordered a transsexual operation for him. Nero then married the youth, complete with bridal veil, and they

lived together as man and person. One witty remark of those times stated that the world would have been a much better place if Nero's father had had the same kind of wife.

History tells us that one of his favorite games was to cover himself with an animal skin and then approach on hands and knees to commit perverted acts on men and women who were first bound to stakes. One

historian reports that there is strong evidence that Nero even had illicit relations with his own mother.

He gave presents and wasted money without limitation, and in a comparatively short time he squandered the vast wealth that Tiberius had left him. He never wore the same garment twice. He generally played dice for four hundred thousand sesterces a point (about \$20,000.00). When fishing, he often used a golden net, and he never made a journey with less than a thousand carriages. They say that his mules were shod with silver, and with a thousand carriages that makes for a lot of mule shoes!

There is no way that Nero was more extravagant than in building. He built a palace that extended all of the way from the Palatine Hill to the Esqualine Hill and he called it the House of Passage. It was destroyed by fire, but was soon rebuilt and called "Nero's Golden House." Obtaining the vast amount of land required for a house of this size might have been a most difficult and expensive task for most people, but not for this noble Caesar.

Foreign Intervention

Okay, I'll admit it. If it weren't for foreign intervention in America, **Donald Trump** would likely not be president.

Imean that if the French had not intervened in the **Revolutionary** War, we likely would not have had a president at all. We'd likely be one of the Commonwealth nations with a parliamentary system, a prime minister as head of the government, and Queen **Elizabeth II** as titular head of state.

The American Revolutionary War began April 19, 1775, here in Massachusetts. The war became a fight for independence with the July 1776 adoption by the Americans' Continental Congress of the Declaration of Independence. The war ended with the signing of the Treaty of Paris, September 3, 1783.

As a young schoolboy, I was taught how the Americans used unconventional fighting methods and had the advantage of fighting on their own land, for their own land. It helped, too, that their cause was just. Washington's aide, the French aristocrat General Lafayette, was praised and the contribution of the French mentioned, but just barely. In fact, it is not at all clear that the Americans could have defeated the British without the assistance of the Kingdom of France. We also had support from the Dutch Republic and the Kingdom of Spain.

This year we commemorate the centennial of the United States' entry into World War I, on April 6, 1917. The war in Europe had been grinding on since the late summer of 1914. Just as French arms and men sent to America in the Revolutionary War may been the final necessary element of the Patriot victory, so, too, the American Expeditionary Forces — over a million strong — under John Joseph "Black Jack" Pershing, broke the stalemate of the War to End All Wars.

The popular song, "Good-Bye Broadway, Hello France," (composed by Billy Baskette, with lyrics by C. Francis Reisner and Benny Davis) - a huge musical hit exactly one hundred years ago this year — made clear the connection between French assistance to the U.S. in our war of independence and America's assistance to France in The Great War.

"Vive Pershing" is the cry across the sea. We're united in this fight for liberty. France sent us a soldier, brave Lafayette Whose great deeds and fame we cannot forget. Now that we have the chance, We'll pay our debt to France.

L'Anno Bello: A Year in Italian Folklore

From Confetti to Birds: The Weird World of Italian Superstitions

Summer is here, and for many people that means wedding season. There are many wonderful aspects that I love about weddings: the reunion of family and friends, delicious and intricately decorated cakes, pulsating dance floors, peals of laughter resounding through the room. However, in the midst of this joyous festivity, I am often reminded that Italian weddings carry a sinister side, enveloped in the world of superstition. Because marriage involves such a monumental life change, Italian society ascribes a number of superstitions to weddings, born of natural anxieties and the universal desire to prescribe good luck to the new couple. Some of my family members still hand out confetti, or sugared almonds, as favors at showers and weddings. Supposedly, when wrapped in groups of five, they bestow fertility, health, longevity, happiness and wealth to the newlyweds. However, wedding confetti are merely a portion of the rich tapestry of Italian superstitions.

I love learning about superstitions because they are reminders of the values held dear by ancient societies. The superstitions that survive to this day tap deep into the fears and desires of the human subconscious: worries over our mortality, longing for a good harvest, a need for control in an unpredictable world. People scoured everyday occurrences for both good and bad omens, and often the signs were contradictory: a black cat, for example, could be the harbinger of fortune or disaster. (On a side note, I have a black cat, and I can attest that there is nothing bad about her!) Gathered below are some Italian superstitions repeated in my family, mostly by my grandmother. If you think that summer proves an odd time to talk about something as creepy as superstitions, keep in mind that Italian culture begs to differ. Ancient Romans celebrated many festivals honoring the dead during the spring and summer. Odd, perhaps, but in the harsh world of antiquity, death was an ever-present companion — along with primal emotions of joy and hope - no matter what the season. So get ready to dive into the spooky side of Italian folklore!

- The number 17 is bad luck: This is an often repeated nugget from my grandmother. In the United States, Friday the 13th serves as the quintessential bad-luck day. In Italy, it is the 17th of the month. I am not sure why this is so, but author Mirella Sichirollo Patzer theorizes that this is because the Roman numeral for 17, XVII, can be rearranged to spell VIXI, a Latin word meaning "he lived" that is found carved into many ancient tombstones.
- Malocchio: This translates to "evil eye" and is an extremely popular superstition, not only in Italy, but in the entire Mediterranean world. Supposedly, looking at a person with jealousy or anger is enough to trigger a mountain of bad luck

upon them. As such, Italians devised a plethora of charms to ward away malocchio. One of them is the corno, a hornshaped amulet found everywhere, from necklaces to home decorations, usually colored red (true story: when I was little, I thought these were supposed to represent chili peppers). There are many contrasting theories as to how this amulet came to be, so I would appreciate hearing readers' family stories!

- Birds: My grandmother acquires a very ominous voice when she talks about birds, as they are generally harbingers of bad luck in Italy. A bird flying into the house is a death omen, perhaps because ancients viewed birds as being closer to the world of the dead due to their ability to fly. My grandmother mostly fears owls, which Italians also consider a death omen because of their intense stare and eerie cry. Conversely, however, owls also represent wisdom and knowledge.
- Salt: Many readers will probably be familiar with the idea that spilling salt is bad luck since this is a superstition that has reached all corners of the globe. It is also quite popular in Italy, and my grandmother swears by it. This superstition originates from the fact that salt was a very precious commodity in ancient times, and thus spilling it could really result in financial bad luck. Also related to the "precious commodity" line of superstitions are the Italian beliefs that it is bad luck to spill olive oil or throw away bread.

Okay, L'Anno Bello readers, I now have a challenge for you. Since I am so interested in the fascinating world of Italian superstitions, I would really appreciate it if you could send me other omens and tidbits of lore passed down through your families. If I collect enough, I will publish them in a later edition of L'Anno Bello. Until then, watch your salt shakers and mind your eyes!

One recent morning, shortly after awakening, I turned my TV on to Channel 509 on Comcast for R&B Classics. The first song I heard was by David Ruffin from back in 1969, shortly after he left The Temptations. He was the original lead singer. This solo, called "My Whole World Ends," was about losing someone you love deeply. However, it could also have been about Ruffin, who died much too young, reportedly from a drug overdose.

The older we get, the more we realize how little time we really have. It goes by so fast. There's never enough time, or so it seems. The Rolling Stones once sang about time being on our side, but that really isn't

As a Reagan fan who voted Donald Trump last November, I am not a "Trumpocrat." What his son Donald Trump, Jr., did recently, meeting with Russians who held out the idea that they had good opposition research on Hillary, was pure stupidity. people. I just did my job, which included saving lives on several occasions. I have sympathy for victims and their plight, but I refuse to turn people into helpless victims. More education is needed and a bit of tough love, too. Society needs to be in the business of empowering people and not turning them into empty souls.

Markey attacking Conway for her words is in itself outrageous. Criticize her for not advocating for more funds for substance abuse treatment. However, advocating as she did that victims need to help themselves, too, is not being disrespectful to anyone.

Opioid addiction is in crisis mode here and nationwide. We must do all we can to curb it, alleviate it and help those suffering from it. It will take a commitment by all parts of society to meet the challenge.

I would rather see United States senators working to bring this opioid crisis to an end. Stop bashing each other and just do your job! That goes for Conway, too.

How many lives are being lost much too soon over substance abuse? How many out there need help, but either don't know where to get it or really could care less about freeing themselves from addiction? As a former police officer, I saw too often people who wasted their lives and fried their brains. They roam through society waiting to die. They don't know when, but it will probably come sooner than later.

Too many of our politicians are useless. Conway used a bad choice of words to say something that needed to be said. Her intent wasn't to demean those addicted or those helping folks with their substance abuse issues. Markey had to know that, but why let a good sound bite go to waste? Attack Conway and talk about how good you are on the issue.

I care about those addicted to drugs. Some of them can't even get out of their own way; but as a retired cop, I care also about public safety issues connected to drug use, too. We need less useless talk and more action because the opioid crisis is killing too many



Talking with Brandon G. Green

Award Winning Actor to Play Benvoio in Commonwealth's Shakespeare's

Romeo and Juliet

For its 22nd season, Commonwealth Shakespeare Company will be presenting Romeo and Juliet on the Boston Common. The production, which is free to the public, will run from July 19th through August 6th.

Brandon G. Green will be taking on the role of Benvolio, Romeo's cousin and friend. Brandon grew up in Selma, Alabama, and earned his Bachelor's Degree from Alabama State University. He moved to the Boston area to attend Brandeis University, where he received his MFA. He now teaches at Brandeis.

Most recently he was seen on a Boston stage in the part of Mr. Tambo in the critically acclaimed SpeakEasy Stage production of The Scottsboro Boys. He also won the 2016 Elliot Norton Best Actor Award for his role in the Company One/Arts Emerson production of An Octoroon.

I had a chance to speak with Green before rehearsal at the Sorenson Center for the Arts at Babson College in Wellesley. When we began our conversation, I was struck by Green's rich, deep voice. I could immediately imagine him in the role of the peacemaker Benvolio. His tone would convey both a calming effect and a command that would certainly enable his message to be heard and understood. Accepting that message will prove to be another thing.

When I asked Green if there was much opportunity in Selma for a student to pursue acting, he said, "I went to a school that was very much about the arts when I was in the 6th grade, the School of Discovery. I got the bug there. Well, I actually had the bug before then." When I asked about what he used as an outlet in his younger, pre-6th grade days, he responded, "Yes, I had the bug way before then. I would take part in school assemblies, Christmas plays, as well as at church." Was he a class clown? "No, actually, I was really quiet, very quiet. In high school I was in the marching band and choir. There wasn't a lot, but what they did have helped me out."

Green recalled his time at Alabama State University in Montgomery fondly. "It was a really amazing program. I would argue it is one of the best undergraduate programs in the country."

Our conversation turned to his latest project, playing Benvolio for CSC. "I kind of feel like I'm playing a bit of myself. The peacemaker almost reluctantly taking care of his cousin. Benvolio has his own things, but he is definitely there for Romeo, and definitely the peacemaker. I was very much that in my friend circles. I was also the one people would come to for counsel in a way. I found myself there a lot of times, and there were times I was in need of a Benvolio in my life."

When I ask about Benvolio being a voice of calm and reason in a play where so many characters are irrational, Brandon gives some insight. "Benvolio means good will, well wisher, and peacemaker. I feel like the straight man to a lot of the chaos that goes on. He is the cool head that is trying to prevail and survive in a way." Why is Benvolio no longer in the play after Act I? "The peacemaker in this world has decided [to] go away. He's

It scared me. That was the perfect storm. A role that called on all my facilities as a performer. It was fun. It was challenging to me and the audience. I got to let loose in a way I wanted to, or that I didn't know I wanted to. I will carry that with me forever.'

As our conversation wound down, I asked Brandon why people should see the CSC production of Romeo and Juliet on the Boston Common. "It is a magical experience. I truly believe that. Also, seeing a cast this diverse telling the story is incredible. There is nothing like this, it is transformative. You are out there with thousands of people. It's crazy and it's beautiful. A very unique experience." His enthusiasm is contagious.

In closing, I asked Brandon what he would like to say to the audience. I found his comments very thoughtful, sincere, and important. "Theatre is a collaborati[on] between the audience and the performers, so please, we need your energy as much as you need ours. It's reciprocal."

Shakespeare said "All the world's a stage." Well, you

lights a bit."

Brandon tells me he has always loved Shakespeare. While in the 10th grade at Selma High, he took a theatre arts class. He remembers, "LeBaron Mack taught us the Scottish play (Macbeth). It was my first way into it and I fell in love with it there. When I got to Alabama State, I saw Othello. It was amazing." Brandon would go on to the Shakespeare Theatre of New Jersey in 2010 and then to Brandeis, where he got more training in classical theatre. Two years ago he played Oswald in the CSC production of King Lear.

Does he have a dream role? "I kind of already played it and that was in An Octoroon. I could not have dreamt up that role.



Here's How to Make a Dog Love You

If your friend or girlfriend/boyfriend, a relative or a neighbor has a dog, but you've never really been a good "dog person," and haven't a clue how to get the dog to like you, you may benefit from some suggestions. Or, if your own family has a dog but you really don't "get" what the dog wants, these simple steps will help you to work towards gaining a dog's favor. Bring treats.

Getting to know the dog well: Observe the dog for a while. How does it act when it wants to play? When it's hungry? When it wants to cuddle? Understanding what the dog wants is a great first step in being more responsive to the dog's needs, and will make him or her like you more.

Learn more about the dog's behavior by finding out what obedience lessons it has had and what it responds to. All dogs should be taught obedience routines. Find out whether the dog knows how to respond to commands to sit, stay, come, heel, and other simple behaviors. If so, try the commands and use food rewards. This command and treat process helps to create bonding with people. You also get to know the dog better and its behavioral issues, quirks and preferences.

Don't stare the dog right in the eye: Some dogs consider it a threat. Look off to the side. Dogs bare their teeth when they are ready to lash out and may take your pearly whites the wrong way.

Pet the dog if the owner says its okay: This is a good way to start. However, observe signs that the dog is done with being petted. Many dogs won't let you pet them when they want to play, so play with them instead. When petting the dog, find their "sweet spot." For example, if your are scratching its ear and it leans its head towards you that shows that it likes it. If you rub its belly and its leg twitches, that's also a good thing. However, if it leans away from you when you scratch it somewhere, the dog obviously doesn't like it.

Offer treats: The fastest way to a dog's heart is through its stomach. Soft treats that give off a strong meat scent are usually a great way to get attention. If the dog is being trained, get him or her to sit, or lie down, or stay before giving the treat. Don't offer treats too often if you're using them in training. If they come too easily, the dog thinks every action is the correct one.

Remember, if the dog isn't yours, always ask permission from its owner before attempting to feed the dog.

Treats are fun for you and the dog; you get to see the dog do tricks and the dog gets a treat for doing it.

Respect the dog's space: Don't always be smothering the dog, or it may begin to avoid you. Every animal needs some time to not be bothered, so respect its space and it'll enjoy the time around you more.

Praise the dog when it does things correctly: 'Good Dog!"

Give the dog a pet on the back for every time it does something good or something cute, or just for fun. Every dog likes a pat on the back!

Give the dog belly rubs: However, you must ask its owner if it likes these first. While most dogs love belly rubs, some don't. If the dog loves it, you will love it, too, as you get to observe the way its little tongue sticks out, with its little eyes looking at you with happiness.

Offer to take the dog for a walk: If you can, offer to occasionally take it on a longer walk every weekend or any time where you have additional time to walk the dog. This provides exercise for you and the dog and gets you in the good books with the owner, as walking regularly or for long distances can be hard for an owner to fit in all the time. This will make the dog happy and provides more bonding time for you.

Ensure that the dog knows how to heel prop*erly*: This ensures that you can direct it without the dog pulling you over or tripping you. This skill also helps the dog to release energy.

Groom the dog: Take a few minutes out of your day to brush the dog. It'll benefit from the daily attention, and its coat will be healthier, too. Plus, if you keep complaining to your date that there is dog hair everywhere, you'll be helping to reduce it!

Give the dog lots of attention: This will help the dog to get to know you better and reassures the dog that you like it.

Let the dog dig in the dirt at your place: This will help it to make your place its own territory, too, which will help raise you in its esteem. Just make sure you do not use the digging area for plants or garden.

Play with the dog using a chew toy.

Offer to dog-sit the dog: If the owner goes away or is going through a busy period, you can care for the dog each day, including letting the dog outside for at least 30 minutes and playing with it outdoors.

Enjoy spending time together: The more time you interact with the dog, the greater chance it will grow to love you.

That's all for now ... Remember to pick up after your pet!

Saint Francis de Sales

Francis de Sales was born on August 21, 1567, to a noble family at Chateau de Sales in the Kingdom of Savoy near Geneva, Switzerland. Francis was both intelligent and gentle. From a very early age, he desired to serve God and knew he had a vocation for the priesthood, but kept it from his family. His father wanted him to enter a career in law and In 1584, de Sales attended

a theological discussion about predestination, convincing him of his damnation to hell. A personal crisis of despair resulted. This conviction lasted through December 1586. His great despair made him physically ill and even bedridden for a time. He visited the parish of Saint-Étienne-des-Grès in Paris, where he prayed the "Memorare" before a famed statue of Our Lady of Good Deliverance, a Black Madonna. He consecrated himself to the Blessed Virgin Mary, and decided to dedicate his life to God with a vow of chastity. He then became a tertiary of the Minim Order.



De Sales ultimately concluded that God had good things in store for him, because "God is love," as John's First Epistle attests. This faithful devotion to the God of love not only expelled his doubts but also influenced the rest of his life and his teachings. His way of teaching Catholic spirituality is often referred to as the Way of Divine Love, or the Devout Life, taken from a book he wrote.

In 1588, de Sales completed his studies at Collège de Clermont and enrolled at University of Padua in Italy, where he studied both law and theology. In 1592, de Sales received his doctorate in law and theology. He was ordained in 1593 and immediately received a promised appointment as provost of the cathedral chapter of Geneva.

In 1599, he was appointed coadjutor bishop of Geneva. In 1602, Bishop Granier died and de Sales was consecrated Bishop of Geneva, but he resided in Annecy (now part of modern-day France) because Geneva remained under Calvinist control and was therefore closed to him.

During his years as bishop, de Sales acquired a reputation as a spellbinding preacher and something of an ascetic. His motto was, "He who preaches with love, preaches effectively." His goodness, patience and mildness became proverbial. His diocese became famous



A Nostalgic Remembrance



In my entire life, I only spent one week at a summer camp. When I was a kid, Dad played with a couple of bands that catered to county fairs in the northeastern part of the country, and Mom and I traveled with him from fair to fair. He had done this type of work back in the '30s, before he got hooked up with the swing bands of the era. Now, in the '40s and '50s, he was back at it during the summer months.

The one episode at a summer camp for me came when I was in the Boy Scouts 67 years ago. I was a member at St. John's Church in East Boston, and the option of Boy Scout summer camp was presented to us scouts. It was two weeks at a place called Loon Pond where scouts from all over Boston and the suburbs could experience what scouting was really like. I jumped at the chance to go to summer camp, something I had only heard of. I knew lots of kids that had gone to camp through East Boston social service organizations, but I never went, as vacations with my folks, and sometimes my cousins, were more fun.

Before the war (WWII), Dad was hooked up with a band led by a man named Chet Nelson. When the war started it disbanded, as most of the men headed for either Europe or Asia to fight our enemies. Once the war was over, county fairs and the Chet Nelson Band came back to life. When I told Mom and Dad about Boy Scout summer camp, Dad told me that I had to compromise. I could go, but only for one week. After that one week, Dad would be playing in New York, New Jersey, Pennsylvania, and Ohio. He and Mom wouldn't be back in this direction until after Labor Day. So, it was one week or nothing.

At times, when Dad was on the road during the summer, he and Mom would take Nanna and Babbononno along, especially when there were going to be any entertainers playing the fairs that were Italian.

That one week was fun. We did everything included in scouting. Beyond this, it was a strange new experience for some of the kids who had never really been out of East Boston. As I mentioned, there were kids (scouts) from all over Boston and some of the suburbs surrounding the city. Some of my fellow scouts had never been in close contact with anyone not Italian or Irish. We met kids of color from the black neighborhoods of Boston, Asian kids from Chinatown, and Jewish

kids from Mattapan. After getting acquainted with some of these scouts from other parts of the city, the myths surrounding their ethnicity or race seemed to disappear and new friendships were formed. For me, it was a bit different. With Dad and my uncles being musicians, I was exposed to all types of people at a young age, and thought of myself as more sophisticated than most of my friends. But I never said anything about it.

At the end of that first week of camp, Dad and Mom came by to pick me up. I don't remember the man's name, but the director was expecting my folks and gave them the tour of Loon Pond Camp before they came to look for me. When I was located. Dad introduced me to the man, who asked me how I liked the camp. I raved about the activities and the new friends I had made. I did blurt out one negative, "But, the food stinks!" Mom looked shocked, and Dad was embarrassed. The camp director burst out laughing, put his hand on my head and said, "Son, you must be Italian." My folks laughed and all was forgiven, but I did get a dirty look from my mother for not being more diplomatic.

The next morning before sunup, we were in Dad's car heading for a place called Boonville, a village in Oneida County in upstate New York. Each summer, then and now, they have a county fair which lasts for about a week. The fairgrounds has buildings for displays of all types of events, a midway set up with rides and games of chance, several restaurants and a race track with a grandstand across from the starting point of the track. Across from the grandstand was a bandstand where the entertainers performed at night, accompanied by the music of the Chet Nelson Band with Dad on tuba. During the day, the band would play between races, where horses would pull sulkies with seated jockeys in brightly colored racing costumes. This environment was like Disney Land long before there was a Disney theme park in existence.

After we checked in at the fairgrounds, Nelson gave Dad the directions to the motel we would be staying at. Once we were unpacked, we headed back to the fairgrounds for a rehearsal. There were several entertainers who would perform each night on that stage opposite the grandstand and all had music that correspond-

ed to their acts; the rehearsal would solve any musical problems. Mom and I headed for a tent in the middle of the grassy area on the inside of the track. There were a couple of tents set up for the entertainers, one a gathering place and the other set up with dressing rooms.

Just as we headed into the tent where the families of the entertainers would socialize, a man, who was chomping on a cigar butt called to me, "Hey, vou, kid. You want a job? My name is Louie, I'm from Southie and am the scenery guy. You want a job helping me?" Mom nodded in the affirmative, and I became the assistant to the scenery director for the sum of \$35.00 for the week. I discovered later that Dad knew Louie, who was aware that I would be with my folks for the week.

Setting up scenery on an outside stage was hard work, but I loved it. It made me feel like I was in show business. This scenario would repeat itself at many of the other fairs Dad played that summer and for the next couple of summers. The only time I didn't work as a stagehand was when the fairs hired scenery people from New York City. They were all union and that eliminated me. When these instances would occur, the front office would hire me to work on the midway helping out a novelty salesman. If the locals didn't win any prizes pitching baseballs, shooting at targets, etc. ... they could buy something at the novelty stand and say that they won it. You would be surprised how many people did this. This was fun also, but I preferred to work as a stagehand and handle scenery whenever I could.

This experience had many sides to it, not just a work experience. Many, if not most of the entertainers, were from other parts of the world and had worked with circuses on just about every continent. Meeting these people was an education that couldn't be duplicated. When Nanna and Babbononno were along, most of the performers loved Nanna's down-home stories, and Babbononno's homemade wine.

Recipes from the Homeland

NONNA MARY'S FISH CAKES

1 lb. of cod or haddock fillet 3 large or 4 small potatoes

1 tablespoon grated Romano cheese

2 tablespoons chopped parsley 2 1/2 tablespoons butter or margarine 1 egg, beaten 1 four-quart pan Medium-size Teflon skillet 1/4 cup cooking oil 1/4 cup dried bread crumbs (optional)

Peel, cut and wash potatoes. Cover potatoes with water in the four-quart pan and bring to a boil. Boil for fifteen minutes. Meanwhile, remove all skin and bones from fish. Add cleaned fish to boiling potatoes. (If desired, fish may be boiled separately.) Boil fish and potatoes slowly for about ten to twelve minutes. When potatoes and fish are cooked, drain contents in colander for a few minutes. While still warm, place potatoes and fish in a bowl with butter and salt to taste. Add grated Romano cheese, parsley, and beaten egg. Stir and mix well. If mixture is too soft, add some bread crumbs to absorb any extra liquid. Store covered in refrigerator to cool. Mixture is easier to shape into flat fish cakes when cool.

SHAPING: Take a FULL tablespoon of mixture in hand and shape like a flattened meatball. Heat oil in skillet. Fry fish cakes until golden brown. Turn over with spatula to brown on other side. Then remove from skillet and place in paper plate to absorb excess oil.

OPTIONAL: For those who prefer baked food, place the fish cake mixture in a lightly oil-sprayed baking dish. After covering the baking dish with aluminum foil, place it in a preheated 350°F oven to bake for about twenty minutes. Remove cover to lightly brown top before serving. Serve with vegetable of choice or salad.

throughout Europe for its efficient organization, zealous clergy and well-instructed laity.

De Sales wrote many books, the most famous of which was Introduction to the Devout Life, which was written especially for laypeople. In it he counseled charity over penance as a means of progressing in the spiritual. De Sales also wrote mystical works, including the Treatise on the Love of God, and many highly valued letters of spiritual direction.

Along with St. Jane Frances de Chantal, de Sales founded the women's Order of the Visitation of Holy Mary (Visitandines) in Annecy on June 6, 1610.

While traveling as part of the entourage of Charles Emmanuel I, Duke of Savoy, for the Duke's Christmas tour of his domain, de Sales suffered a fatal stroke in Lyon, France. He died on December 28, 1622.

Saint Francis de Sales was Canonized on April 8, 1665; his Feast Day is celebrated on January 24th.



Emile Runs into a Hurricane

The Night Rubin Carter Stopped Griffith in the First Round



It was December 20, 1963, when reigning World Welterweight Champion Emile Griffith stepped into the ring at the Civic Center in Pittsburgh, PA, to face leading middleweight contender Rubin "Hurricane" Carter. Griffith had been campaigning for a shot at the middleweight title and the winner of this match would be in line for a chance at champion Joey Giardello.

Griffith, who had twice regained the welter-weight championship he lost and won to both Luis Rodriguez and Benny Kid Paret, was proving himself worthy as a contender in the heavier weight class. He had taken on and defeated middleweights Denny Moyer, Don Fuller, Jose Gonzalez, and Chris Christensen. Griffith's record going into this bout was 38 wins against 4 losses. He had never been stopped, and I believe he had never been knocked off his feet.

Going into the fight, Rubin Carter was ranked among the top five middleweights. His record at the time was 17 wins and 4 losses with 11 wins by knockout. He was stopped once on cuts by Jose Gonzalez. Carter had a reputation as a brutal puncher. He had a vicious left hook, but he tended to throw it a bit wide. This flaw was not a problem until he stepped in with more experienced fighters. In Carter's last fight before the Griffith match, he lost a decision to the light punching but very slick Joey Archer.

Griffith was a master boxer who also possessed a solid punch. This, combined with his experience, led the oddsmakers to rate him a slight favorite. While he was giving away 3 1/2 pounds (151 1/2 to Carter's 155), he was very strong with considerable upper body strength. The smart money was on Griffith to win by decision

People who follow the art of boxing are familiar with the dangers of the first round. It is no secret that a punch that will floor or deck a fighter in the opening round of a bout does not always have the same effect in a later round. This can be attributed to the fact that fighters



are not fully warmed up yet, or they are still a bit tense and have not yet found their rhythm.

As the bell rang for the opening round, Griffith came out loose and sharp. It did not appear he had not properly warmed up. He was jabbing beautifully and parrying Carter's punches. Griffith was also being effective with a short uppercut on the inside. Carter, on the other hand, did look a bit tense and tight. With only a minute gone in the fight, it appeared a pattern was already being established. Carter would throw solid lefts and rights, but his inability to keep them short enabled the more experienced Griffith to work inside of them.

Then it happened. The fighters had gone into a clinch. When referee Buck McTiernan broke them up, Griffith stepped back. Carter immediately leapt in with a solid left hook that dropped Emile for the first time in his career. Looking at the punch, it appears it may have landed more around Griffith's collar bone than on his chin, but nevertheless, he was stunned and a bit unsteady as he got to his feet.

Carter was on Griffith in an instant. He moved in and caught Griffith with a number of punches, including a solid left hook to the chin, flooring him again. Griffith landed on the seat of his trunks and reached out for the rope to steady himself. At this point, he looked back at the ropes and the camera caught a shot of him where his eyes looked clear. He got to his feet but was a bit wobbly. The referee then stopped the bout. Griffith insisted he could go on, but there was still close to a minute to go in the round. When a fighter is hurt, a minute can be an eternity. Could Griffith have survived the round? Very possibly, but it has to be remembered that it was just a little over a year earlier that Benny Paret lost his life in a bout against Emile Griffith. In that fight, referee Ruby Goldstein was heavily criticized for not stepping in earlier. Also, though it appeared Griffith's eyes were clear on film, the referee was the one person who was able to look directly at the fighter and make the determination whether or not he was fit to continue. McTeirnan clearly felt that allowing the fight to continue would be dangerous. Did he make the right decision? Yes, definitely yes.

Carter would go on to fight Joey Giardello for the title, losing a fifteen-round decision. After the Giardello fight, he would have another 15 bouts, losing 7 of them and never earning another shot at the title. He would eventually be found guilty of murder and sent to prison. The controversy surrounding his conviction would go on for years.

Emile Griffith would go on to win the Middleweight Title from Dick Tiger. He would lose it, regain it, and lose it again to Nino Benvenuti in 1968. In 1971, he would challenge Carlos Monzon for the championship. He fought a great fight but ran out of gas in the 14th round, being stopped for only the second time in his career. Amazingly, in 1973, at the age of 35, he would challenge Monzon again, this time losing a controversial decision to the great champion. It seems the old champ still had plenty left.

Griffith and Carter never fought again. While nothing is to be taken away from Carter on the night of his greatest victory, I firmly believe Griffith would have won a rematch. He was the superior boxer, but Carter went into the fight with a "puncher's chance" and he certainly took advantage of it.

HOOPS and HOCKEY in the HUB

ON THE MOVE AGAIN — Once more, he is on the move again. We refer to the recent announcement that former Celtics guard Rajon Rondo has once again continued on to another stop on his basketball journey around the NBA, this time to the New Orleans Pelicans.

Rondo, of course, was the playmaker on the Celtics squad that captured the 2008 NBA Championship and made it back to the 2010 NBA Finals. That team is remembered best for the performances of the Big Three — Paul Pierce, Ray Allen and Kevin Garnett. Rondo was the player who brought the ball up and dished off for the assists — something that he was very proficient at doing.

But there was another aspect of Rondo that did not come to light during his playing days on Causeway Street. Apparently, he wasn't always on the same page with a number of coaches over the years. That behavior didn't become a factor during his seasons with the Celtics. The unofficial story along press row was that Garnett kept Rondo in line while he was playing for the Green. And Rondo made a lot of green —his final Celtics contract was for \$55 million.

But as time went on and the Big Three — along with coach Doc Rivers — took their proper places in Celtics history, Rondo remained. After Rivers departed for the Los Angeles Clippers following the conclusion of the 2012-2013 season, Rondo's days became numbered.

That was especially true following the signing of current head coach Brad Stevens in July of 2013. Some 18 months late, Rondo was playing for a different team. In its preview of the 2014-2015 season, Sports Illustrated magazine said that Rondo would be gone by the NBA trade deadline in February. The magazine was not correct — he was traded to Dallas in December.

Danny Ainge had found a taker for Rondo — Dallas head coach Rick Carlisle, a former Celtics teammate of Ainge back in the 1980s. It was not a good deal for Dallas, at least from a personality perspective. Over the remaining months of the NBA season, Carlisle and Rondo had several differences of opinion, enough so that Carlisle vowed in public that Rondo would never play for the Mavericks again. And he didn't.

Rondo's next team was the Sacramento Kings, where he found a soul mate in DeMarcus Cousins. He also found a one-year, \$10-million contract — not bad for one season. Rondo would go on to blame a lack of team chemistry and distractions for the Kings' poor showing during the 2015-2016 season — a year that culminated with Rondo leading the NBA in assists and the firing of coach Karl.

Rondo became a free agent and immediately found a new team — the Chicago Bulls. It was a two-year, \$28-million contract this time. The thing is, this time featured some aspects that looked a lot like some of those other times. Rondo apparently had a difference of opinion with assistant coach Jim Boleyn, leading to his being benched by head coach Fred Hoiberg for a spell in January. Rondo also differed with some teammates in social media posts, which, of course, didn't help matters.

Things did get patched up enough that Rondo came on strong when the Bulls faced the Celtics at the Garden in the playoffs — taking the first two games in the series against the Cs. But Rondo injured his thumb in Game Two and was out for the rest of the series, which the Celtics closed out by winning the next four games.

Chicago chose to cut Rondo loose after one season. "Only" \$3 million of his \$14 million salary was due him if he was cut by June 30th — which he was. So, Rondo immediately made \$3 million by not playing for the Bulls in the upcoming 2017-2018 campaign.

A free agent once again, Rondo was picked up by the Pelicans, his fifth team in four years — all this by age 31. It's another one-year deal, but with a twist. Rather than being positioned as a starter, Rondo is expected to serve as a backup to guard Jrue Holiday, who recently signed a five-year, \$128-million contract.

But there's a super silver lining for Rondo in all of this. He will be reunited with his friend from Sacramento days, DeMarcus Cousins. He'll also have time to swap old college stories with Anthony Davis. Both played together at Kentucky.

Financial terms had not been announced as this was written, but remember Rondo comes to New Orleans already \$3 million ahead — not a bad way to hit the ground running.

There's evidence that Rondo and Cousins work well together on the court. During that one year in Sacramento, Rondo played in 72 games, averaging 11.9 points and 11.7 assists. Cousins averaged 26.9 points across a span of 65 games. But the Kings only won 33 games that season and finished 10th in the Western Conference — so individual performances did not translate into team victories.

Last season with the Bulls, despite his differences with the coaching staff, Rondo still played in 69 games, averaging 7.8 points, 6.7 assists and 5.1 rebounds per game.

We think the upcoming season has the distinct possibility of turning out to be especially challenging for Pelicans head coach Alvin Gentry given that Cousins and Rondo are together once again. That tandem has the potential to be a positive for a team that went 34-48 (.415) last year and finished 10th in the Western Conference. Recent history, however, tells a different tale.
