## **City of Boston COVID-19 News and Updates**

## STATEWIDE EVICTION MORATORIUM AND HOUSING SUPPORTS:

The Mayor began his press conference by acknowledging the Governor's announcement to **extend the moratorium on evictions and foreclosures to October 17**th. He said it was an important step, as the City and State works to protect residents from harm and manage the economic impacts of the COVID-19 pandemic.

He reminded everyone that the City of Boston offers services and resources for anyone struggling with housing.

- Struggling renters can contact the **Office of Housing Stability**. The City's **Rental Relief Fund** continues to be available for those who do not qualify for unemployment benefits.
- For help with mortgages, residents are encouraged to

reach out to their lenders. The City has agreements with major lenders to provide payment deferral plans.

## UPDATE ON TESTING AND RECOVERY METRICS:

The Mayor said that Boston continues to move forward cautiously in Phase 3 - Step 1 of the statewide reopening plan. The City is watching the data closely every day, and the recovery metrics are still positive.

• For the week ending July 13<sup>th</sup>, the City's positive test rate was **2.1**%, down from **2.5**% the week before. The cumulative positive rate since the pandemic began is now **14.2**%.

The Mayor noted that there is a clear cause-and-effect relationship between collective decisions, individual behaviors, and the spread of the virus, and that we see what happens in other cities and states when that science is ignored.

He reminded everyone what they must keep doing, to help the City prevent transmission and prevent another surge: wear a face covering whenever you are out; keep six feet of distance and avoid crowds; wash your hands frequently; and clean your surfaces.

• People should also follow all the public health guidelines for their place of work or business, as well as understand and manage the risks of infection before proceeding with any new activity.

#### UPDATE ON TESTING:

The Mayor urged everyone who has concerns about exposure to get tested. Boston has expanded testing to the point that it is widely available across the City at more than 20 locations. To see what testing sites are open near you, check the map at: boston.gov/coronavirus, call 311, or call your healthcare provider.

The City has also worked to support sites that offer free testing for everyone, regardless of whether or not they have symptoms. The City is launching a **new mobile testing team** that will be operating for the next three months across the City.

As of July 21st, at the BCYF **Jackson Mann Community Center in Allston**, will move to a different neighborhood every two weeks.

## ADDRESSING THE HEAT WAVE AND AN UPDATE ON SUMMER RESOURCES:

This past weekend through yesterday, the Mayor declared a **heat emergency** in the City of Boston. The City opened **20** BCYF community centers to the public as cooling centers, at 40% of building capacity for distancing needs.

The City is working to expand outdoor spaces, which are essential resources for fresh air, exercise, recreation, and mental health. Everyone must remember to follow public health guidelines.

As of July 22<sup>nd</sup>, the City of Boston's two outdoor swimming pools will be open to the public: the Clougherty Pool in Charlestown and the Mirabella Pool in the North End. These are both operated by Boston Centers for Youth and Families.

The Mayor noted that, right now, the 16 indoor pools at BCYF centers are only open for youth in summer programs.

- Pool capacity will be **40%** of normal, which means **75** people or fewer at a time. People must register for a time slot at *Boston. gov/BCYF-Summer*. There will be no walk-up admission.
- Registration will go live 24 hours before the following day's sessions.
- Sessions will be **90** minutes and residents should only sign up for **one** session per day. Three children under the age of 12 are allowed per adult.
- When registering for a session, people will be asked COVID-19 screening questions, and will be asked again when they arrive at the pool.
- People should arrive dressed to swim, because locker rooms/ changing areas will be closed. Restrooms will be accessible.
- People must wear a face covering at all times, except when in the water, and keep six feet of distance between household groups.
- Cleaning and disinfecting will be done at opening and closing time and between each swim session.
- All BCYF programming this year including outdoor pools is completely free of charge.

## UPDATE ON HEALTHY STREETS INITIATIVE:

The Mayor provided an update on the City's Healthy Streets Initiative, a package of changes to improve social-physical spacing in Boston's neighborhoods; help workers and small businesses recover.

The Mayor announced that temporary bike lanes in several downtown and Back Bay locations have been completed, connecting neighborhood routes to downtown.

In addition, a **temporary lane** reduction and bike lane will be installed today on Cummins Highway in Mattapan.

The City had a successful community meeting on the **planned** 

redesign of Columbus Avenue in Roxbury from Jackson Square through Egleston Square down to Walnut Ave. at Franklin Park.

All of this work builds on the City's progress so far this summer, which includes: 9 extended bus stops; 368 approved outdoor dining locations on sidewalks or streets; 125 temporary Food Pickup Zones; 23 temporary Food Truck locations alongside parks throughout the City, now operating in our neighborhoods; Bus/bike lanes on Essex St. and Washington St. in Chinatown, improving commutes from Roxbury, the South End, and Chinatown to downtown.

The City has distributed **25** mobility ramps to restaurants for outdoor dining, with **150** more on the way. The City is also redesigning City Hall to make it more accessible and inclusive for all.

#### 30<sup>TH</sup> ANNIVERSARY OF THE AMERICANS WITH DISABILITIES ACT:

The Mayor noted that this week marks the 30<sup>th</sup> anniversary of the Americans with Disabilities Act. In recognition of this milestone, on Wednesday, July 22<sup>nd</sup>, the City held a virtual rally.

The theme of the event was Equity, Diversity, Inclusion. It's focused on ending job discrimination, increasing access to public buildings, and permanent housing.

## ADDRESSING WEEKEND VIOLENCE:

The Mayor addressed the violence that occurred this past weekend. Among other incidents, a 16-year-old and a 17-year-old lost their lives to an act of gun violence. In addition, an 18-year-old is in critical condition after another incident. The Police Department is asking for the public's help in each of these investigations.

The Mayor made it clear that violence of any kind is unacceptable in our communities, and that when it involves young people as victims, it's especially devastating.

The City is focusing on the most highly impacted communities — on an ongoing basis, and in response to specific incidents.

The Mayor wants parents, grandparents, and guardians to know that there is help available if they are concerned

#### Pressley Remains Totally Radicalized

Ayanna Pressley introduced the People's Justice Guarantee back in 2019, because she believes that transforming our criminal injustice system is inextricably tied to "dismantling systems of oppression and white supremacy in this country."

She also is very concerned that in the U.S., we incarcerate people at a rate higher than any other developed nation — a disproportionate amount of whom are Black and Brown folks. The mass incarceration crisis has taken a severe toll on families — an estimated 1 in 2 U.S. adults, including 2.1 million American children, have had an immediate family member spend one or more nights in jail.

Pressley is working to dismantle these systems, build new ones that center, she says, in humane justice, and to create fairer legal systems for everyone.

The thing, she also says is, the system isn't "broken." It is working exactly as it was designed — the cruelty is the point. That is why it's essential that we dismantle and build new systems that center the well-being of our communities.

The People's Justice Guarantee lays out a new vision for criminal justice by centering the voices of the people most impacted by injustice in America.

#### Down to a Fine Art

To complement the artistic vibe of Downtown Oshkosh, Wisconsin, the city created its first outdoor gallery with murals displaying original works of art from 20 local artists in 20 locations. Joshua Marquardt, VP and partner of Art City Wraps (artcitywraps.com) and an internationally recognized competitive wrap installer, shared his idea of the Mini Mural Project with the Oshkosh Public Arts and Beautification Community in 2018.




# Stirpe Nostra A weekly col of the more i

#### **ARES**

Ares is next in our long list of primary and secondary mythological deities. He was worshipped by the Greeks as their god of violence, brute force and the slaughter of war. As the offspring of Zeus and the goddess Hera, it is supposed that he inherited his quarrelsome temper from his mother. We are told that he delighted in nothing but war and bloodshed, and that this is what made him so hateful to the other gods. His favorite haunt was the land of those savage, cruel, and rapacious early tribes of Thrace.

As the ideal of warlike heroes, Ares traveled around on foot or in a chariot drawn by beautiful horses, and was attended by his sister Eris, the goddess of strife. Eris was the greatest contributor to the discord that started the Trojan War. Eris is the one who threw a golden apple among the assembled goddesses. The apple was inscribed "For the fairest" and this is what started the quarrel between Hera, Athena, and Aphrodite for the prize. They referred the matter to a shepherd named Paris, for a decision and of course, he awarded the golden apple to Aphrodite after she promised to give him the fairest woman in the land for his wife. The abduction of Helen (Helen of Troy) and the ten-year Trojan War soon followed.

Ares had always been the friend and lover of Aphrodite. This union produced Eros, Anteros, Deimos, Phobos, and Harmonia, a brood or mixture that is hard to define. As Eros

was the god of love, Anteros was the god of requited love, Deimos was the god of fear, Phobos, the god of fright, and Harmonia, the goddess of friendly relations. How would you like to sit down to dinner with that group every night? I would certainly be frightened to carry on any kind of love or harmonious relationship for fear that it would not be requited.

Ares was especially worshipped in Sparta, where young dogs were sacrificed to him, and in Athens, where the site of the Areopagus (Hill of Ares) was consecrated to him. His symbols were the spear and the flaming torch, and we note that before trumpets were introduced, the signal for battle was given by hurling a flaming torch at the enemy.

This god was usually represented as young, strong, handsome and with curly hair. At times he was shown bearded while at other times, cleanshaven. One of his most famous statues is sometimes identified with Mars, his Roman counterpart. This sculpture was in the Ludovisi Museum (Italy). But in 1901 and 1902, that collection was added to the already rich Natural Museum of Rome, located in the old Baths of Diocletian. The sculptured piece shows the young god in a seated position, and it is called "Ares Resting" or "Mars Resting" depending upon whether the viewer is Greek or Italian.

## PUBLIC HEALTH REGULATIONS

## Due to public health regulations please note:

Walk-ins are not allowed. You must register to swim at **Boston.gov/BCYF-Summer.** 

Swim sessions are 90 minutes. Visitors are asked to register for and attend no more than one session per day.

You must be dressed to swim. Access to locker rooms or changing areas is not allowed. Face coverings (covering both the nose and mouth) must be worn at all times when not in the water. Distancing at least 6 feet from others is required for all individuals outside of a household group and applies to deck areas, bathrooms, wading areas, and the water.

Three children under 12 are allowed per adult. Children under 8 need an adult in the water with them at all time.

Pool capacity this summer is 75.

Preference will be given to Boston residents.

## **Protect Yourself from Mosquito Borne Diseaess**

West Nile Virus (WNV) and Eastern Equine Encephalitis (EEE) are two mosquito borne diseases found in Massachusetts. They are spread after being bitten by an infected mosquito. It is rare to find EEE in MA, but there are outbreaks every 10-20 years. The latest outbreak began in 2019. WNV has been found in MA every year since 2000.

## TO PROTECT YOURSELF FROM MOSQUITO BORNE DISEASES:

- Be sure to use insect repellent when outside. Be sure the repellent contains DEET, oil of lemon eucalyptus or Picaridin.
- Limit your time outdoors between dusk and dawn. This is the time that mosquito's are most active.
- When you are outdoors, wear protective clothing such as long sleeves and pants, and socks.
- Check that your window and door screens don't have holes in them.
- Items that collect water such as flower pots, birdbaths, and garbage cans should be emptied of water at least once a week.
- If you are bitten by a mosquito and develop any of the following symptoms, call your health care provider. Symptoms are high fever, confusion, severe headache, stiff neck, or eyes become sensitive to light.

#### The Dangers of Groupthink

"Groupthink is a phenomenon that occurs when a group of well-intentioned people make irrational or non-optimal decisions spurred by the urge to conform or the believe that dissent is impossible." – Psychology Today

Groupthink is deleterious to individuals and organizations. Groupthink results in bad decisions becoming institutionalized to the detriment of all involved, in addition to all who are impacted by the resulting group behavior.

With groupthink, there is pressure to conform to various outlooks, opinions, or ways of thinking. Pressure may come from the group, your family, friends, or segments of society. Pressure may involve threats of being ostracized if you don't conform. In unchecked situations, threats and actions become physical.

The fear of losing friends, or becoming an outcast, is a powerful motivator. No one wants to be rejected. However, when you compromise your beliefs out of fear, you set yourself up for long-term unhappiness.

Capitulating to groupthink erodes your self-esteem, while making you miserable. You won't be happy abandoning your core beliefs. Your psychological health will be impacted, leaving you frustrated and stressed.

You have your own set of beliefs, morals, and ethics which are based on your values. You instinctively know right from wrong. Your outlook emanates from your ethical grounding. Your beliefs are not dependent on what other's think.

Groupthink is a source of external pressure on your beliefs. Groupthink can exist at work, in your community, in your social network, and in your circle of friends and relatives. Groupthink feeds on an individual's fear of being shunned or attacked for holding their own views.

The imposition of groupthink has a chilling effect on individual thought and speech. Groupthink is the manifestation of intolerance which stifles the free flow of ideas. This discriminates against independent thinkers. Groupthink demands unquestioning obedience.

Capitulating to groupthink feeds the groupthink. Groupthink gains power by suppressing independent and contradictory thought. Conformity is essential for groupthink to persist. Groupthink seeks to immediately shutdown any and all dissent. Fear and intimidation are the tools of groupthink

Groupthink is defeated by independent thinking individuals who refuse to capitulate to the group's demands of compliance. You must say NO to demands of compliance. You should not change your thinking and behavior in response to threats. Groupthink cannot persist without blind obedience. It only takes a few people saying NO to groupthink to erode its viability.

When you are overwhelmed, fatigued, and worn out, you must stand firm instead of giving in to groupthink. Resist the temptation of succumbing to so-called conventional wisdom. Say NO to peer pressure. A groupthink viewpoint does not make it right. Furthermore, the purveyors of groupthink are often a very vocal minority masquerading as mainstream thinkers.

Asking questions and engaging in debate are powerful tools in vanquishing groupthink. Information and "facts" that you hear, read, or watch must be assessed as to their validity. Question everything you read and hear. News stories must be validated by checking the sources. Too much of what is reported today is either biased or has its own agenda.

Think for yourself. If something you see or hear doesn't make sense, you must remain skeptical until the truth is uncovered. Resist jumping on the groupthink bandwagon in the quest of acceptance.

## **Weir River Farm**

Hingham, MA

This family-friendly farm, one of the last farms in Hingham, will enthrall visitors with its own "family" of horses, pigs, cows, chickens, and sheep.

## What makes Weir River Farm a Special Place?

Originally part of a picturesque, early-20<sup>th</sup>-century country estate, Weir River Farm today is a 75-acre working farm comprised of fields and pastures surrounded by oak and red cedar woodlands. The farm supports diverse wildlife habitats, including upland grasslands, which are in rapid decline in the Commonwealth. Weir River passes through the farm at its northwest edge.

From the entrance at the top of Turkey Hill, a footpath meanders downhill through open fields and woods. At a fork in the trail, you can follow one path to the barnyard and visit with the horses, pigs, and chickens. The other path takes you across a grassy avenue before entering "The Grove," woods with an open understory reminiscent of a British woodland. A "Garden Path," bordered by flowering shrubs and flowers, within the Grove, creates a serene and pretty sanctuary for visitors.

From the trails on Weir River Farm, you can get to adjacent Whitney and Thayer Woods, whose trails are connected to those in Wompatuck State Park and the town's Triphammer

Conservation Area. This extensive trail network provides you with access to the largest contiguous tract of open space on the South Shore – nearly 5,000 acres in all.

The Weir River Farm Market is located at 140 Turkey Hill Lane. We offer our own beef, lamb, chicken, pork and eggs for sale during market hours. Market hours are Wednesdays 2:00-6:00 pm, and Saturdays 11:00 am-3:00 pm.

## L'Anno Bello: A Year in Italian Folklore

Almonds at Your Wedding and Amulets on Your Neck

Obviously, advice on gatherings and reunions contained within are not applicable to this current time when social distancing (and mask wearing!) is the best practice. Please read these articles as a testament to the joy and love that imbues Italian celebrations — and as suggestions for ways to spend time in the future once this pandemic is finally over.



Last year, I wore a brand-new dress to a close friend's wedding. As soon as I saw it, I was immediately struck by its beautiful pastel-flowered pattern, and I imagined how it would look like a garden in motion against a hot July sky. In addition, the dress, and the event to which it was worn, reminded me of another fact. Summer is here, and for many people that means wedding season. There are many wonderful aspects that I love about weddings: the reunion of family and friends, delicious and intricately decorated cakes, pulsating dance floors, peals of laughter resounding through the room. However, in the midst of this joyous festivity, I am often reminded that Italian weddings carry a sinister side, enveloped in the world of superstition. Because marriage involves such a monumental life change, Italian society ascribes a number of superstitions to weddings, born of natural anxieties and the universal desire to prescribe good luck to the new couple. My family members still hand out confetti, or sugared almonds, as favors at showers and weddings. Supposedly, when wrapped in groups of five, they bestow fertility, health, longevity, happiness and wealth to the newlyweds. However, wedding confetti are merely a portion of the rich tapestry of Italian superstitions.

I love learning about superstitions because they are reminders of the values held dear by ancient societies. The superstitions that survived to this day a need for control in an unpredictable world. People scoured everyday occurrences for both good and bad omens, and often the signs were contradictory: a black cat, for example, could be the harbinger of fortune or disaster (on a side note, I have a black cat, and I can attest that there is nothing bad about her!). Gathered below are some Italian superstitions repeated in my family, most from my grandmother. If you think that summer proves an odd time to talk about something as creepy as superstitions, keep in mind that Italian culture begs to differ. Ancient Romans celebrated many festivals honoring the dead during the spring and summer. Odd, perhaps, but in the harsh world of antiquity death was an ever-present  ${\rm companion} - {\rm along} \ {\rm with} \ {\rm primal}$ emotions of joy and hope - not matter what the season. So, in honor of wedding season, get ready to dive into the spooky side of Italian folklore:

• The number 17 is bad luck: This is an oft-repeated nugget from my grandmother. In the United States, Friday the 13th serves as the quintessential bad-luck day. In Italy, it is the 17<sup>th</sup> of the month. The roots of this superstition extend to ancient Rome. Author Mirella Sichirollo Patzer theorizes that this belief originated from the fact that the Roman numeral for 17, XVII, can be rearranged to spell VIXI, a Latin word meaning "he lived" that is found carved in many ancient tombstones.

• Malocchio: This transtap deep into the fears and lates to "evil eye" and is an desires of the human subcon- extremely popular superstition scious: worries over our mortal- not only in Italy, but in the ity, longing for a good harvest, entire Mediterranean world.

Supposedly, looking at a person with jealousy or anger is enough to trigger a mountain of bad luck upon them. As such, Italians devised a plethora of charms to ward away malocchio. One of them is the cornicello, a hornshaped amulet found everywhere ranging from necklaces to home decorations, usually colored bright red (when I was little, I thought these were supposed to represent chili peppers). The cornicello is modeled after the cornucopia, a symbol of abundance and fertility in ancient Greek and Roman mythology.

• Birds: My grandmother acquired a very ominous voice when she talked about birds, as they are generally heralds of bad luck in Italy. A bird flying into the house is a death omen, perhaps because ancients viewed birds as being closer to the world of the dead due to their ability to fly. My grandmother mostly feared owls, which Italians also consider a death omen as a result to their intense stare and eerie cry. Conversely, however, owls also represent wisdom and knowledge.

• Salt: Many readers will probably be familiar with the idea that spilling salt is bad luck, since this is a superstition that has reached all corners of the globe. It is also quite popular in Italy, and my grandmother swears by it. This superstition originates from the fact that salt was a very precious commodity in ancient times, and thus spilling it could really result in financial bad luck. Also related to the "precious commodity" line of superstitions are the Italian beliefs that it is bad luck to spill olive oil or throw away bread.

From birds and salt to numbers and amulets, Italian life is pepper with fascinating superstitions. Though most people do not take them as seriously as they did in the past, when uncertainty ruled the most basic interactions of daily existence, these superstitions are still followed out of appreciation of tradition or a sense of fun. Rite of passages and major life events, such as weddings, attract the bulk of these superstitions. As I enjoyed my friend's summer wedding, I also thought about the myriad superstitions that mark the Italian counterparts of these celebrations: the aforementioned confetti, the chiming of bells which originated as a way to ward off evil spirits, the belief that rain on a wedding day is paradoxically good luck, and the granting of the bomboniera, or wedding favor. No matter what occurrence life throws your way, you can be sure that Italian society has some sort of interesting lore attached to it! So as you enjoy the warm summer weather, make sure to watch your saltshakers and guard your eyes, whether or not you are attending a wedding!



## Venerable Carlo Acutis

Carlo Acutis was born in London on May 3, 1991, to Andrea Acutis and Antonia Salzano.

His parents worked in London though settled in Milan not long after their son's birth in September 1991.

From the day he received his First Communion at the age of 7, he never missed a daily Holy Mass. He always tried, either before or after the Mass to pause before the Tabernacle to adore the Lord, always truly present in the Blessed Sacrament. Our Lady was his confidant and he never failed to honor her by reciting the Holy Rosary every

To quote Carlo's own words: "Our goal must be the infinite and not the finite. The Infinity is our homeland. We are always expected in Heaven." Another phrase of his was: "All people are born as originals but many die as photocopies." To move towards this goal and not "die as photocopies" Carlo said that our compass must be the Word of God, that we have to measure up to constantly. But to reach such a lofty goal very special measures are necessary: the Sacraments and prayer. In particular, Carlo placed the Sacrament of the Eucharist at the centre of his



life and he called it "my highway to Heaven."

Carlo was very gifted with everything related to the world of computers so that both his friends and adults with computer engineering degrees considered him a genius. Everyone was amazed at his ability to understand the secrets of computers that are normally only accessible to those who have specialized university degrees. Carlo's interests involved computer programming, film editing, website creation, editing and laying out small publications, to help those most in need especially children and the elderly.

Carlo contracted a rare form of Leukemia. The doctor treating him asked him if he was suffering much pain and he responded that "there are people who suffer much more than me." He passed away on October 12, 2006.

To be always united with Jesus, this is my plan of life. "I am happy to die because I lived my life without wasting even a minute of it on anything unpleasing to God". Carlo asks of us the same thing: he asks us to spread the Gospel through our lives, so that each of us can be a beacon to light the journey of others. Carlo was buried in Assisi in accordance with his wishes.

Venerable Carlo Acutis is scheduled to be beatified on October 10, 2020 in Assisi, Italy.

The Worcester City Council has effectively killed a proposal to remove the city's Christopher Columbus statue. In an 8-2 vote Tuesday night, the City Council voted to "file" District 4 Councilor Sarai Rivera's motion seeking to remove the statue.

Following some discussion, City Manager Edward Auustus Jr. told the Council that the statue was given to the city as a gift. Under the agreement, the statue must be kept in a public place. If it were to be taken down, the city would be in violation of the agreement, and the statue would be given back to the heirs of the family who gifted it originally.

Councilor Candy Mero-Carlson and Councilor Donna Colorrio — both of whom claim Italian heritage – rightfully spoke in favor of keeping the statue. They told those pres-

ent that removing the status of Christopher Columbus would be hurtful to the Italian American community in Worcester.






#### WORDS TO LIVE BY

## Nanna & Babbononno

A Nostalgic Remembrance



People have asked me if I ever got into trouble when I was a kid, and the answer is, "Yes!" It was the beginning of 1950 and I was going on 12 years old. I had become friendly with a school chum who will remain nameless in case he's still alive ... but his nickname was Howdy Doody, because he looked like the TV puppet, with red hair, freckles, and a dumb smile. It was a Saturday and we were heading to the Central Theater for a Tarzan feature, ten cartoons and a free comic book for the price of twelve cent.

When we got to the Bennington Street location of the Central Theater, the line was neverending waiting to get in. We then decided not to go and head to Logan Airport. They had an observation deck in those days, above the main terminal and for ten cents, you could watch the planes take off and land. I told my friend that the Air National Guard was located at Logan and a friend of Dad's was the head of it, any maybe if he was there, we could look at their fighter planes, which in those days were P47s Thunderbolts left over from WWII.

Dad's friend, Jimmy Leary, was on duty that weekend and I introduced him to my pal. Jimmy got an OK to take us out to look at the fighters and I was thrilled. As a kid, I made model airplanes, fighters and bombers from WWII, and I had a couple of P47s in my collection. Jimmy asked a pilot to show us one of the fighters and he even let us sit in the cockpit. I was thrilled imagining myself shooting down enemy planes for the American cause.

As we were leaving the airport, we found a mailbag, a small canvas pouch with a leather strap and a padlock keeping it closed. It was beginning to snow, and we headed home, Howdy Doody taking the mailbag with him. Evidently, someone in his house cut the leather belt and opened the pouch. They saw documents inside that must have looked very important and panicked. They called Station 7 and the desk officer sent a patrol car to pick it up. When asked who cut the strap, my supposed friend blamed me, stating I carried a knife and did the cutting.

That Monday, just as I arrived home from school, an unmarked police car with two juvenile officers in plain clothes were waiting for me. They tried to usher me into the car, but neighbors stopped them, not knowing who they were. Just then, Dad pulled in and approached us,

not knowing what was going on. They showed him their credentials and explained what had happened. Dad assured them that on that past Saturday, I was at the Central Theater. At that point, I put my head down in shame. I had lied to my folks.

We headed to Station 7, and when I got there, I saw my friend, Howdy Doody with his father and an uncle. We were brought into an interrogation room, one at a time, and questioned about the events of the past Saturday. The two interrogating officers conferred with each other and sent my friend and his family home. I was accused of cutting the mail pouch open, and discovered at that point that there was federal correspondence in side. I tried to tell the juvenile officers that the bag was not open when I left my friend who took it home, but they were convinced that I cut it open. Not long after, we headed to juvenile court. Dad had had a couple of his friends question me about the events of that day at the airport before going to court. I didn't know them but they looked important, dressed in suits and ties with spit polished shoes.

In court, I saw a judge sitting high above the rest of us and a man near the judge read the charges leveled against me. They called me to the witness stand and began asking me questions about cutting the pouch open with my pocketknife. I explained my side of the story but the man standing (the prosecutor) yelled at me trying to get me to tell the story his way. I didn't relent. When they called my friend to the stand, one of Dad's friends (our attorney) began questioning him. He badgered and confused my friend to the extent that he became unglued and confessed that his uncle cut the strap on the pouch, not me. Then he began to cry. Just then, two men entered the court, and the judge stood up. The two men were Mayor James Michael Curley and Police Commissioner Sullivan. My crying friend's father and uncle looked shocked as the two men sat down next to Dad.

My attorney questioned my friend's father and uncle. They uncle became confused during the interrogation and admitted cutting the leather strap on the mail pouch. The judge dismissed the charges against me and my friend and told his uncle that he was going to be called by a federal judge, as the U.S.P.S. was part of the Federal Government.

What had helped me was exhibit B, the knife I was accused of using to cut the bag open. It was a switchblade, a foot long when opened and razor sharp. The closest I had to a cutting tool was an Exacto knife I used in model making.

When we were outside the courtroom, Dad introduced me to the mayor and police chief, whom he had become friends with as a result of his participation in the last mayoral election. Mayor Curley sat me down on a bench outside the courtroom and asked me how I felt. We talked for a few minutes, adult to child, and he then told me I owed my father an apology for lying to him about going to the movies and heading to the airport instead. With tears in my eyes, I apologized to Dad.

We were standing in front of Station 7 when Howdy Doody, his father, and his uncle came out. Dad left me with the mayor, excused himself and walked to the boy's uncle. He helped the man straighten his tie until he turned purple, and then grabbed the lapels of his coat. I don't know what Dad said, but the uncle nodded in the affirmative and scooted off as if he was in a hurry. Just as we left the mayor, he made me promise that I would never lie to my father again. (I don't think I ever did)

Well, the next day in school I had an absence note for my teacher that explained the happenings of the day before. At lunch, I avoided contact with Howdy Doody. When he eventually approached me, I told him we were no longer friends and he went on his merry way. Thank God, that was the closest I ever got to being in trouble. Then I had to deal with Babbononno who called me every name in the book, but that was the way my grandfather expressed himself, and I knew that he didn't mean half of what he said

Acini di Pepe (translates to peppercorns) are tiny pearls of pasta made from semolina flour. They are no bigger than a grain of couscous and known to be a member of the pasta family made to be cooked in a broth. Most often, you'll find them in Italian Chicken Soup or what some refer to as "Wedding Soup." When added to broth, these little spheres swell up and absorb their surrounding flavors beautifully. At the same time, if added to dishes that don't include a broth, Acini di Pepe tend to mimic the chewy and creamy texture of tapioca. Which could possibly explain why my Nonna made these little balls of pasta a main ingredient in her delicious "Italian Fruit Salad!"

In the summertime, Nonna often made fruit salad with fresh seasonal fruits such as peaches, plums, melons and berries. She never added sweeteners because she claimed the juices from the ripe fruits were "more than enough sweetness." On occasion, I remember her making a different type of fruit salad from a recipe that had been given to her by one of her girlfriends. She described this fruit salad as "almost an ambrosia; sweet and very good." Some of the ingredients in this recipe included canned fruits and frozen whipped topping. Nonna wouldn't use either, she preferred fresh fruits and homemade whipped cream. As a result, she created her own version that I am going to share with you today (the original is alongside in parenthesis). "Nonna's Italian Fruit Salad" is a perfect dessert to serve at any type of summertime gathering, and it's sure to be one that will be loved by all!

#### NONNA'S ITALIAN FRUIT SALAD Nonna's Macedonia di Frutta Italiana



- 1 cup Acini di Pepe, uncooked ¾ cup sugar
- 2 eggs, beaten
- 2 cups unsweetened pineapple juice
- 2 tablespoons flour
- 1 tablespoon potato (or corn) starch
- ½ tbsp butter
- 1 tablespoon lemon juice
- Homemade whipped topping (recipe below) (or 12 ounces of frozen whipped topping, thawed)
- 2 ½ 3 cups fresh pineapple, cut into tidbits (or 1 20-ounce can pineapple tidbits, drained and 1 cup crushed pineapple, drained)
- 2 cups fresh mandarin oranges (or 2 11-ounce cans mandarin oranges, drained)
- 1 ½ cups shredded coconut (optional)
- 1 ½ cups mini marshmallows (optional)
- (optional)

  1 small jar maraschino cherries
  (optional)

## STEP 1 Pasta/Custard Mixture

Cook Acini di Pepe according to directions, strain, rinse, and set aside to cool.

In a saucepan over medium heat, combine sugar, eggs, pineapple juice, flour, starch and butter, mix well. Cook, stirring constantly, until thickened. Remove from heat and add lemon juice. Place custard mixture in a large bowl, add pasta and fold together. Cover and refrigerate overnight.

## STEP 2 Homemade Whipped Topping

8-ounces cream cheese, room temperature 2/3 cup confectioners' sugar

2 teaspoons vanilla extract 1-pint heavy whipping cream

In a small bowl, beat cream cheese, confectioners' sugar, and vanilla until smooth, set side. In a medium bowl, beat heavy whipping cream until soft peaks form. Add cream cheese mixture, a small amount at a time, to whipped cream, and beat until stiff peaks are formed. Place in the refrigerator.

#### STEP 3

Remove pasta custard mixture from refrigerator and gently fold in whipped topping, until completely blended. Mix in fruits, and coconut, marshmallows and/or cherries, if desired (I always add coconut and sometimes marshmallows). Place in the refrigerator for 6 - 8 hours or overnight, so all of the flavors meld together and the cream/custard mixture sets. When ready, serve in pineapple boats or dessert dishes. Refrigerate leftovers.




## **EXTRA** Innings

Back Before The Birth of Red Sox Nation, We had Some Legendary Players Like Dick Stuart



I remember the 1962 Red Sox season! After the usual loss at Fenway on Opening Day, we all started chanting "Wait 'til next year." We waited and waited and next season brought us more of the same.

I was upset to learn back in the 9<sup>th</sup> grade at the Michelangelo that the Red Sox had gone and traded Pete Runnells. He had just won the batting crown and now he had been shipped off to the Houston 45s for some unknown outfielder named Roman Mejias, who stunk to the high heavens by the way, in 1963.

Then I remember during Mr. Regan's E101 class that we just got Dick Stuart from the Pirates. I knew who he was and liked him as a Pittsburgh Pirates first baseman who could hit the ball for distance. However, I didn't like giving up catcher Jim Pagliaroni and 1961 Rookie of the Year pitcher Don Schwal

We started 1963 off in great fashion with Johnny Pesky as manager. If that season had ended on the Fourth of July, we would have won the pennant but the rest of the season was not so good. We stunk again. It could have been the "Impossible Dream" but that was delayed until 1967. The 1963 Red Sox had a "Possible Delusion." We all thought we were so much better than we actually were.

However, I digress here and have gone off the road. Back to Dick Stuart, a.k.a., "Dr. Strangeglove," and "Stonefingers." He had an interesting career with the Pirates playing on some great teams with some fantastic players starting with Roberto Clemente, Dick Groat, Bob Skinner, Bob Veale and Elroy Face, a great relief pitcher who went 18-0 in 1958. Stuart was known as a slugger who could hit baseballs for miles, but on the field, he stunk to high heaven. He could be one of the all-time worst fielding first baseman in MLB history.

In 1958, when he came up with the Pirates, he played 64 games and committed 16 errors. In 1963 his first year with the Sox, he led the league with 29 errors. He didn't get better with time, did he?

He did get two great nicknames "Dr. Strangeglove" and "Stonefingers." Alexandre Dumas christened Stuart as "The Man with the Iron Glove."

As a young player in Pittsburgh, he had been so bad in the field one game, the manager called him into his office to yell at him. His manager exploded on him over a game losing misplay and told Stuart that he was the manager and that Stuart was nothing. Waiting for this to sink in with Stuart, he then bellowed asking Stuart "Who am I"? Stuart waited a few seconds and answered, "You are the manager of nothing" and left the office.

Stuart got a way with a lot because he was a great power hitter up there with Aaron. Mays, Colavito, McCovery, (Frank) Robinson and Mantle. Back in 1956 in the minors, he did whack 66 home runs in Single A Lincoln in the Western League. Oh, along with 158 RBI batting .298 but also struck out 171 times.

In Boston for his two seasons, he hit 42 homers in 1963 and then 33 in 1964. Fans came to see him either hit homers or make errors. Once during a pre-game practice in the field, Stuart, snatched a hot dog wrapper in mid-air and received a standing ovation for that skilled feat.

He also got his own Sunday night sports show on right after the late news ended. Sitting behind his desk and speaking into the camera, he imparted his baseball wisdom with his usual flair.

One Sunday night right after a loss to the Yankees at Fenway Park, Ralph Houlk, the opposing manager made some terrible comments about just how bad he thought Stuart was.

Stuart opened his desk drawer, pulled out an 8 by 10 glossy of the Yankees skipper, grabbed his cigarette lighter





AN OLD IDEA GAINS NEW TRACTION — It is a concept from another era in college athletics — before smartphones, before e-mails — indeed, before devices called personal computers became a reality in daily life.

It is the idea of having college basketball confined to one term — the second semester — with the fall being utilized for practice and intra-squad scrimmages.

Older fans may recall that the college basketball season of decades ago had a much later start date than it does today. Back then, it was December  $1^{\rm st}$ , making basketball close to a one-semester sport. Plus, there was a universal start date for the first practice of the season. It was October  $15^{\rm th}$ .

This brought the opposite of March Madness to some schools with big-time basketball programs. As the clock struck midnight and October 14<sup>th</sup> became October 15<sup>th</sup>, a school's team would enter the arena for its first practice of the season — complete with a capacity crowd, cheerleaders, the band, plus speeches by the head coach and various players. It was all very festive and came to be known as Midnight Madness.

But then something happened. Encouraged by television and, of course, by the dollars that selling broadcasting rights fees can generate, schools and conferences began to schedule regular season games earlier in the fall. It didn't happen overnight, of course, but gradually the start of the season crept into the earlier weeks of November. The 2019-2020 season actually began on November 5<sup>th</sup>.

Just as there had always been postseason tournaments, such as the March Madness event, a new concept — pre-season tournaments — were introduced with the Pre-Season NIT being a prime example. In addition, some institutions scheduled an "exhibition" game or two — usually at home against weak opponents at regular ticket prices, of course. Sometimes this practice backfired as it did when Syracuse lost to cross-town opponent Le Moyne College. But most of the time these were just easy wins that added dollars to the coffers of the athletic department at these larger schools.

Now, with a number of colleges having cancelled all fall sports outright and with the remainder having their seasons resting on shaky grounds, thoughts have begun to turn to so-called "winter" sports — which in reality begin practice a few weeks after Labor Day and play their first games as early as three weeks before Thanksgiving.

Now, with the COVID-19 virus making things murky for those who arrange college athletic schedules, an idea that was brought forth in earlier times is now being considered again — having men's and women's college basketball become, in essence, exclusively second semester sports.

The idea is actually one with a bit of history behind it. Again, older fans may recall an era when freshman players were not eligible for varsity basketball. No matter how talented, all first year players were assigned to freshman-only teams.

This meant that players who would go on to become some of basketball greatest stars — Oscar Robertson, Jerry West, and Lew Alcindor (now Kareem Abdul Jabbar), for example — never played four years of varsity college basketball. They only played three years on the varsity after seeing action on the freshman team — which didn't begin playing games until December. Plus, those freshman teams played a much more local schedule than the varsity and thus featured restricted travel.

The idea behind this was an academic one. Going from high school to college is a big jump academically. As any fan knows, basketball is not confined to the weekends. There are games on weeknights as well, taking players away from classes as they travel to games.

The thinking went that in addition to the higher academic standards, freshman players should not be traveling during the week but be on campus doing their homework and preparing for classes. Only after having completed a full academic year should they be permitted to play and travel with the varsity.

The topic of a second semester start has been thrown around in college basketball circles for quite some time; although only a few came to strongly state it in public. Among those in favor of the one-semester concept was the late C.M. Newton, formerly the Director of Athletics at the University of Kentucky who was inducted into the Basketball Hall of Fame in Springfield in 2006.

Another advocate has been Jamie Zaninovich, the former Commissioner of the West Coast Conference and the current PAC-12 Deputy Commissioner and Chief Operating Officer. He authored an article in the March 2, 2015 edition of *Sports Illustrated* magazine giving a bit more outline.

Under these proposals, the regular season in college basketball could start the day after the last day of fall final exams — probably a week or so before Christmas. Since there would not be classes during the Christmas — New Year's Break, athletes would be free to concentrate solely on basketball before the academic activity of the second semester actually started in mid-January. The bulk of March Madness would become an April tournament with the Final Four tipping off in early May.

Over the years, these proposals did not make it past the discussion phase — in essence going nowhere. But the coming of COVID-19 has changed that, moving consideration of them closer to center stage with every passing day.

It makes sense in other ways as well. There would be less competition from regular season college and pro football for television time and the first conference games could be slated for early February — shortly after the conclusion of the Super Bowl.

In addition, fans of college sports could concentrate on football in the fall, with only a few early-season non-league basketball games overlapping with the college football post-season bowls.

Will college basketball become a one-semester sport? The possibility has never been greater than now.
