## 123 Years of Continuous Publication

One hundred and twenty-three years ago, an Italian immigrant who arrived in Boston when he was only 16 years old saw the realization of his fondest dreams, the establishment of an Italian language newspaper that would be the genuine voice of the increasing flow of Italians to the United States. The boy was James V. Donnaruma, and the newspaper was *LA GAZZETTA DEL MASSACHUSETTS* which is now published in English as the *POST-GAZETTE*.

He remained at the helm of this well-known publication until his demise in 1953, at which time his son, Caesar, took over the reins of running the now famous national weekly newspaper located in the North End of Boston. Caesar was loyally assisted by his ingenious wife, Phyllis, who assumed the role of publisher in 1971, becoming one the nation's first Italian-American women publishers. Upon Phyllis' death in October 1990, their daughter, Pamela, continued the tradition as the third generation publisher of the *POST-GAZETTE*.

*LA GAZZETTA*, as it was properly called, was very short on financial means but had a large vision, to give its readers a better and wider understanding between two countries.

The so-called Italian Colony, or "La Colonia," had to face a variety of complex problems and *LA GAZZETTA* had to understand the slow and difficult transition of men who, in most cases, had been engaged in agriculture in their home country. Here, they had to work in construction, factories and restaurants, eventually becoming small business owners, and finally professionals, heads of business enterprises, industrial leaders, even heads of state — people to be respected by others.

If America was to some a bitter disappointment, to more it remained a great adventure filled with excitement. There were new ways to be learned as well as new institutions. There were speculators and exploiters to be fought, and a "padrone" system that needed to be destroyed. There were churches to be built and, above all, education to be had. Immigrants took great advantage of America's free education while learning the process of citizenship. We devoted pages and pages to that very important mission!

*LA GAZZETTA* became a guide, so to speak, the go-between that brought American political life to the Italian immigrant. Many times, our people were sent unknowingly to work in places

subject to a strike and were therefore exposed to physical violence on the part of strikers ... in time, the situation changed as they learned more about the new land of opportunity.

The Italian immigrant was a hard worker, a thrifty man, a family man. He had pride. As a family, their goal was to build a future in America. *LA GAZZETTA* stressed these virtues. We began to publish an all-English section which became a real forum for discussing many problems, and criticizing discriminating laws while advocating Americanization and responding to community needs such as the Red Cross appeals.

A typical Horatio Alger story could be repeated by thousands of immigrants and their American-born children who became an integral part of this great country, fighting in its wars and facing every national crisis. It would be impossible to enumerate here the many initiatives taken by our publication, from its inception as "*LA GAZZETTA*" to its present-day format as the "*POST-GAZETTE*," in its 123 years of uninterrupted publication. We have never missed an issue, even when the going was very hard.

The moral reward, over the

# Stirpe Nostra

CHOW DOWN IN OLD ROME, Part IV

Between courses of the cena (dinner) described in the previous issues, the ministratorii (waiters) kept the cups filled with a variety of fine wines. There were French and Falernian wines and also those, which were blended with resin and pine pitch. After dinner, wines were always mixed with warm or cooled water and never taken full strength. A ceremonial drinking match or “Roman chug-a-lug” usually followed the meal in which the cups were emptied in one draught. It was considered to be the exclusive right of the host to prescribe the amount of wine to be poured into the cups and the number of rounds for all to drink. Guests soon began to propose toasts, which soon turned the affair into a “comissatio” (wild drinking party). There were toasts to someone’s mistress (as many toasts as there were letters in her name). Toasts were also drunk to the emperor, government officials, army officers, the head of the house, the birds, the bees, you name it and they would drink to it. Entertainment was also provided between courses. These amusements were called “acroamata” and would consist of readings, poetry, music, riddles, lottery, clowns, and lascivious dances by Spanish maidens.

Considering all of the *Stirpe Nostra* columns to date, with their humorous inferences or summations, nothing seems to compare with the ancient




Roman attitude towards flatulence (stomach gas). With most eastern cultures as well as with the Romans, the good old after dinner belch was considered a politeness and a compliment to the host. Even the most learned felt that the greatest wisdom was to follow the dictates of nature.

The great Emperor Claudius, at one time, had seriously considered enacting a law permitting other emissions of wind in public places (probably through an emission control center). This was an act from which even those liberal easterners refrained. Doctors suggested to their patients that they take full advantage of the attitudes and liberties favored by this well-meaning but effervescent emperor. Old Roman music of this kind was not absent from the triclinium of even the famous “Trimalchio” who, at one time was reported to have said, “I have such rumblings inside of me that I fear the presence of a wild bull” and advised his guests not to risk injury to their health through self-restraint. He also announced that as far as he

was concerned, anyone could relieve himself in the dining room any time he was so inclined. However, even this ill-bred Trimalchio had the decency to leave the room when liquid emissions were necessary. More than one vulgar host simply snapped his fingers for a slave to bring in an empty wine jug which had just been relieved of its precious contents and then replaced, with uncanny measure, all of the wine which had recently been drunk from it while the unfortunate slave on bended knee attempted to guide the jug or the person to prevent priceless marble floor mosaics from being defiled (what a spot for a candid camera).

Finally, as I sit here before my trusty Underwood upright I can’t help but wonder ... when a dinner guest took advantage of his host’s liberal attitude toward the emission of wind ... if all of the other guests took time from their feasting to turn and say ... “figlio maschile.”

### A CHANGE IN COMMAND AT ONE POLICE PLAZA

This past Monday, we all learned that Police Commissioner Bill Evans would be stepping down from his post as Police Commissioner, a job he has held since 2014. Then, Boston Mayor Martin J. Walsh introduced his choice as new police commissioner, announcing that Supt.-in-Chief William Gross will take over the Department after serving as a police officer in Boston since 1985, and raising up in the ranks. He was named the highest ranking BPD police officer by Walsh in 2014.

After a 28-year career working as a special state police officer for the Massachusetts Department of Mental Health, I worked with a number of police departments including Boston as a supervising sergeant in Metro Boston DMH. I know what it is like to be a police officer and work with a population often at-risk. I know how important effective communications must be.

I have observed in his nearly four years as the highest ranking uniform police officer at the Boston Police and have seen him do an incredible job in some very difficult moments in the life of the city.

I have always been a strong advocate of good relations with the communities the police serve. The motto of most police departments is "To Serve and Protect" but it must never just be a motto on the side of a cruiser. It must be put into practice every day on every shift. Gross at the press conference said "improving relations between the police and the community is his number 1 priority."

Gross will become the city's first black police commissioner and all eyes will be upon him. He may have grown up on his grandma's farm in Maryland but he ended up in Dorchester as a 12-year-old when his mother and sisters moved to his adopted home. He has worn a badge since he was 22 years old. It is a part of who he is and he did it for a reason, to serve and protect his neighbors across the city!

He said something so simple and yet so profound at the press conference announcing his promotion. He said, "If you want change, be the change that is why I became a police officer."

Congratulations to Boston's newest Boston Police Commissioner William G. Gross. A cop's cop!

# L'Anno Bello: A Year in Italian Folklore

## Honoring Earth and Harvest on Lammas

I can feel the month of August approaching like a golden ray of sun, a month perfectly poised between the warm, blithe nature of summer and the rhythmic pulses of the autumn. Back-to-school ads beckon from television commercials and posters plastered on shop windows, recalling the scent of freshly sharpened pencils and smooth notebooks. The honey-colored sunset occurs earlier and earlier each evening, prompting me to spend cozy nights indoors with a homemade meal. This is the time for the high produce of summer, for the delectable tomatoes and corn and zucchini that line the stalls of farmers' markets, and also for the crisp first fruits of the autumn, such as succulent red and green apples. However, whenever August looms near, my mind always drifts to the summer I spent in Italy ten years ago. Throughout the quiet month of August, it was common to see round, tightly bundled bales of hay baking under the sun in the fields that dotted the Italian countryside. After all, late summer in Italy means *la mietitura*, or haying, in preparation for the autumn months. It was in Italy that I truly felt the power of Lammas, a wonderful seasonal holiday that carries with it the poignant symbolism of harvest and the arrival of autumn.

Lammas, which occurs on August 1<sup>st</sup>, was a widely celebrated feast in Europe until the Industrial Age pushed it into obscurity. Fortunately, interest in this rustic festival has been rekindled recently across Europe and the United States. Lammas stems from the ancient Celts, who viewed the holiday as the first day of autumn. Modern audiences may find it hard to associate the first days of August with the fall, as the temperatures still soar to ninety-degree heat and the leaves remain full and vibrantly green. However, Lammas honors the start of the agricultural autumn, when farmers harvest grain along with the first fruits of the year. Indeed, the very name Lammas harkens back to this harvest, as it derives from loaf-mass, the ritual in which bread made from the first harvested grain of the year was brought



to the local church for a blessing. Preceding Lammas was the pre-Christian festival known as Lughnasadh (pronounced loo-na-sah), a harvest feast held in honor of a god of light known as Lugh. Lughnasadh celebrations involved igniting bonfires, trekking to mountaintops in order to be closer to the sun, gathering the first fruits of the harvest, and dancing. Evidence of Lughnasadh celebrations has even been found in Northern Italy, a region with Celtic influence! Lammas is still a holiday in Ireland today, full of reunions between families and friends, and ritual blessings of fields by parish priests. Lammas remains one of my favorite holidays because it combines the communal pleasures of summer — reuniting with loved ones and enjoying the outdoors — with the honoring of the Earth's bounty, which will become more evident as the autumn progresses.

Every Lammas, when I can sense the changing of the seasons pulsing beneath my feet, I also honor grain by making a focaccia. The recipe I use is a traditional one, made with rosemary, sea salt, onions, and the indispensable Italian staple, olive oil. I admire the way the water mixes with the flour to create dough as if by magic, and I feel a special kinship with my ancestors who scraped a living out of Italian farmland by using the most basic ingredients. Indeed, my Italian forbearers viewed holidays like Lammas or harvest like *la mietitura* with a special significance precisely because bread played such an essential role in the diet. Bread, known as pane in Italian, is more than a food, but also a cultural touchstone, a staple that brought life to peasants and formed the basis of the society's major dishes. Bread

serves a deeply religious function in Italian life as well, as the bread honored in the sacrament of the Eucharist symbolizes a spiritual nourishment that is just as crucial as a physical sustenance. No wonder then that Italian superstition brims with warnings against disrespecting the essence of bread, such as the restriction against turning bread upside-down or, even worse, discarding bread. Italians in olden days believed that these actions insulted the Earth's bountiful harvest and affronted one of the most vital cores of their diet. Unfortunately, we have lost this spiritual connection with our food and the Earth which provides it as society industrialized. For this reason, I think it is important to honor seasonal festivities like Lammas, which connect us to our ancestors and teach us that the food which springs from the Earth is a sacred gift.

Celebrate Lammas this August by honoring the grain that forms the building blocks of our lives. Whether you bake a focaccia or quick bread from scratch, or simply remain conscious of the Earth's abundance as you bite into a sandwich roll or cut into a loaf of bread, think about the nourishment that goes into both your body and soul. By reveling in the joys of seasonal food and respecting the signs of the changing seasons around us, we can truly appreciate the glorious rhythms of the natural harvest. Lammas tells us not to mourn over the end of summer, but rather recognize the necessity and the wonder of the cycle of the year. Without autumn, there would be no harvest to sustain us through the dark winter nights. Let the sight of wheat waving in the golden sun and hay bales standing proudly in fruit-laden fields remind us of the way our ancestors lived so close to the Earth, and let us vow to keep that sacred connection even within the busiest moments of our lives.

## Renaming Faneuil Hall Foolishness

I can remember the American Bicentennial Celebration, it was a time when all of us could feel as one as we celebrated America's 200<sup>th</sup> Birthday together. That's a far cry from how we all seem to feel today. I remember that Quincy Market was the site of the 18<sup>th</sup> century pavilion where all of us could go see life in the 18<sup>th</sup> century and where it all began.

Faneuil Hall Marketplace had just opened, and on its way to being the biggest draw for tourists visiting Boston. I remember my visit to this exhibit of 18<sup>th</sup> Century Boston. Even then, I knew as a recent college graduate who majored in history that our past is not perfect but, in spite of our imperfections, we began our national life. Just as no one individual is free of sin, neither is a nation. Over time we grew and changed and became better.

The stain of slavery will always be with us. We shouldn't live in denial but neither should we pretend bad things didn't happen; not even by the will of many of our founders who were trapped in the mores of their own time.

Kevin Peterson and his New Democracy Coalition want to change the name of Faneuil Hall Marketplace and is now calling for a national black-led boycott of this historic tourist site. Peterson has stated that the mayor has "avoided and rebuffed" the idea of getting the place a new name.

According to Peterson, the iconic name is dedicated to Peter Faneuil, a slave owner and is now calling for a boycott because the very name of the place "is an insult to blacks not only in Boston but blacks throughout the country."

He also criticized "the white political and economic hegemony in this city has directed over (blacks) them." Peterson also stated a desire to let all African Americans know that Faneuil Hall "is not a place for blacks to be."

Like everything else in America today, all we see is black and white. Civil discourse has been replaced by preaching some kind of Puritan History. Who condones the American slavery that once was? Is shopping at Faneuil Hall Market place a tacit support of the practice of slavery?

Peter Faneuil, like many of his time, owned slaves. We are no longer the America that Peter Faneuil called home. We are better today from knowing our history and not denying it.

I am often critical of Boston Mayor Marty Walsh, but on the issue of taking down the name of Peter Faneuil from public sight, I am with our mayor. Long after Faneuil the man died, his name meant more to Boston and America, especially when it came to ending slavery. Frederick Douglass called for the end of slavery inside Faneuil Hall. As Mayor Walsh says, "We can't erase history but we can learn from it."

Any boycott of the Faneuil Hall area would be meaningless. Besides those obsessed with Peter Faneuil, the name of this place is just that. It doesn't mean support for yesterday's slavery, but more a mirror of our future as a city and nation.

We can't change the past, but we can today prepare for our future as a nation of people who support the cause of redemption. Yes, many of our founders were slave owners but the most important thing is what we are doing today for America and its future, which is in ALL of our hands.

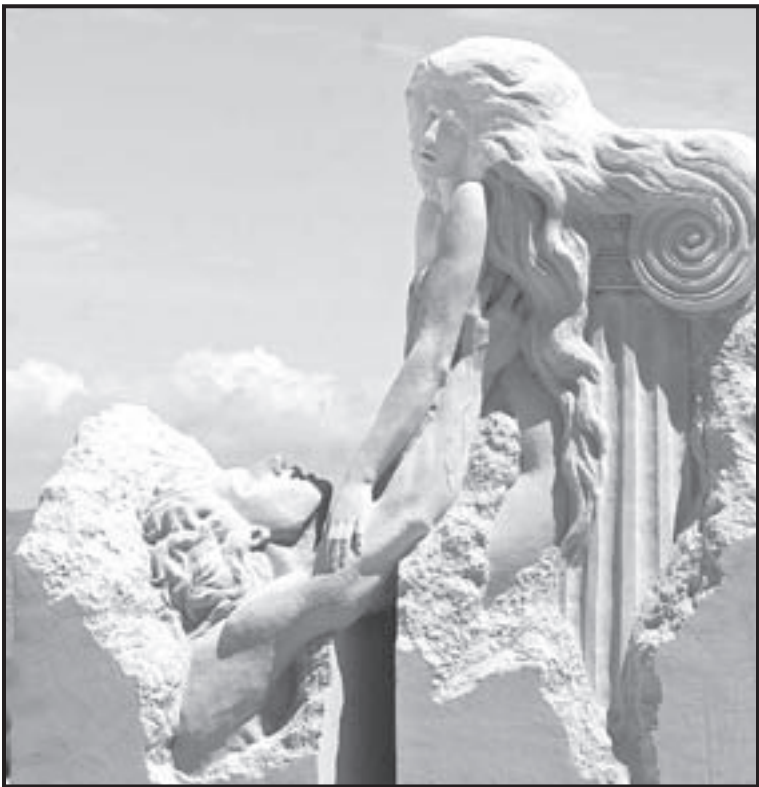








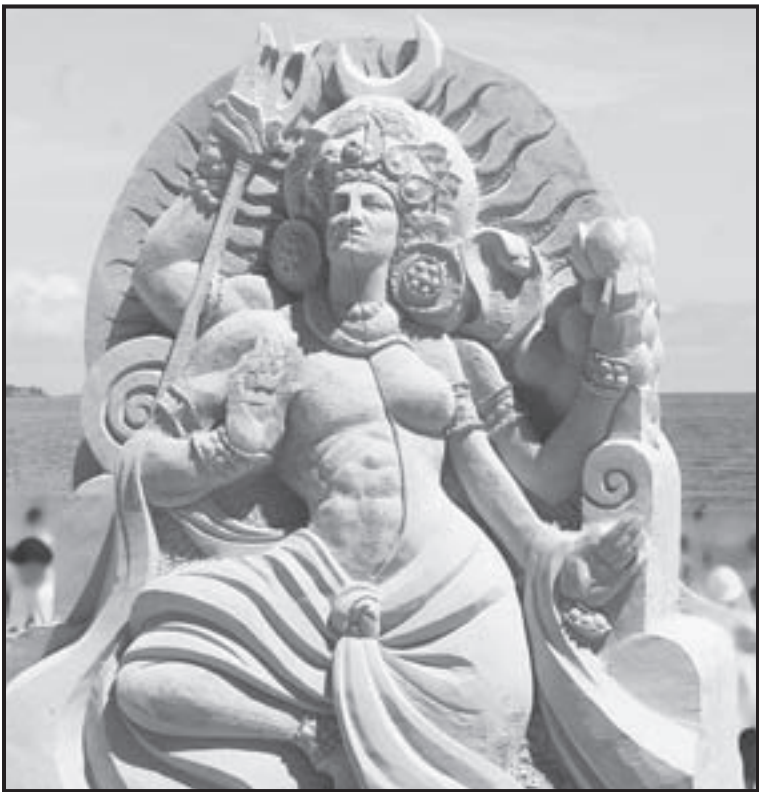

**FRANK ZAPPA – CHUNGA’S REVENGE/Vinyl  
Zappa Records +UME**

Frank Zappa zealots rejoice, as Zappa Records and UME has released on vinyl, Zappa’s 1970 album, *Chunga’s Revenge*, often described as ‘stylistically diverse and subversive.’ Unavailable on vinyl for more than three decades, the last pressing was in 1986. This album is most noted for introducing a new Mothers lineup that included the Phlorescent Leech (Flo) & Eddie, the pseudonyms for former Turtles members Howard Kaylan and Mark Volman who performed under the aliases. The reconfigured lineup included bassist Jeff Simmons, keyboardist and trombonist George Duke, drummer Aynsley Dunbar and multi-instrumentalist Ian Underwood. From the funky guitar work out of opener “Transylvania Boogie” to the bluesy send-up “Road Ladies” to the jazzy “Twenty Small Cigars,” *Chunga’s Revenge* is an eclectic affair that sees Zappa and his band traipse through a variety of genres with ease. “The Nancy & Mary Music,” is a three-part improvisational suite recorded live. Second side includes the hard rocker “Tell Me You Love Me,” trailed by “Would You Go All The Way” and the title track. The album closes with two songs that showcase the vocal talents of Flo & Eddie: “Rudy Wants To Buy Yez a Drink,” and the tropical-tinged “Sharleena,” a soulful ballad with Zappa putting his unique spin on doo-wop and R&B.

The 20-track collection opens with the lengthy title cut riding the musical rollercoaster, followed by the softness of “Don’t Say Anything,” the suspense and fear of “Finding the Cabin,” “I’m Scared,” and “They Can’t Hears You.” Increasing the decibels a bit, Djawadi delivers, “The Photograph,” “Flare Gun,” and “Little Recorder,” before introducing the haunting “Separation,” the despair of “Not Today,” the encouraging “I Feel Alive,” and the string-laden “Where Is The Dog?” The romance continues to flow with “Just Me and You,” the strength of “The Heart is Just a Muscle,” and the appropriate, yet unanswered the “Meaning of Life.”

**MEG BOWLES – EVENSONG: CANTICLES FOR THE EARTH  
Kumatone Records**

The ambient orchestral soundscapes on the synthesist Meg Bowles’ new album, *Evensong: Canticles for the Earth*, are her tribute to all aspects of nature, including the earth and its place in the cosmos, especially exploring the concepts of personal spirituality, time, light, and shadows, as well as the cycle of life and death. The initial track, “Hymnus,” is a meditative cut with a droned invocation, inspired by the sound of the birds’ flapping wings results in “Migration at Dusk,” in a solitary sequence Bowles uses the image of a person walking slowly over the mountaintop, before disappearing beyond the horizon. Drink in the mysterious sounds of “Chalice of Shadows,” as the sky slowly opens up, revealing numerous stars, Bowles continues her heavenly sounds with the lullaby “Berceuse for a Star Child,” and our capability of connecting us to each other and to the Earth, and the Cosmos beyond, - moving on to the title track “Evensong,” as her poetic interpretation touches on passion, grief, and longing as well as praise. The final selection, “Time and Light,” is a battle of harmonies, major and minor, and between consonance and dissonance. The bottom line is pleasurable relaxation of the mind and body!

**YELAWOLF – TRUNK MUZIK 0-60/Vinyl  
Urban Legends + UMG**

Urban Legends is a multi-platform website that honors the past 30 years of Universal Music Group’s (UMG) urban catalog. The label imprint and platform celebrates the artists and music at the heart and soul of hip-hop, with commentary by noted music writers and the artists themselves. In 2010, Alabama native Yelawolf’s *Trunk Muzik 0-60*, was able to garner attention and move crowds partly due to its guest artists. It was basically a mix tape that offered listeners ten new songs and a couple of exclusive remixes from a prior release. The project featured legends like Bun B (of UGK) with “Good To Go,” and Raekwon (of Wu-Tang) serving up “I Wish.” Gucci Mane appears on the anthemic, “I Just Wanna Party.” Yelawolf’s choppy, rapid-fire cadence is a party music lover’s dream, as in “Love Is Not Enough,” a thoughtful, bruised ballad with emotional highs and lows. “Pop The Trunk” is similar sound of early Eminem rapping. 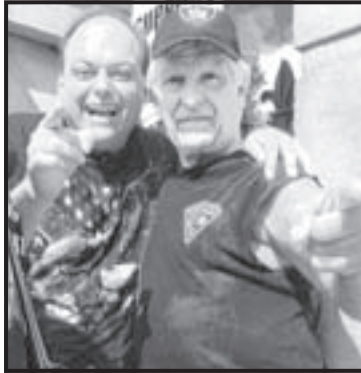

## Medicare Beneficiaries at Risk from Card-Replacement Scams

*AARP Massachusetts Joins in Campaign to Help Keep Scammers from Conning Enrollees*

As a major federal government initiative is underway to issue new identification cards to the 1,289,320 Medicare beneficiaries in Massachusetts and nationwide, an AARP survey finds that a majority of those enrollees are at risk of being victimized by fraud schemes designed to capitalize on the card replacement program.

In response, AARP Massachusetts is participating in an education campaign to raise awareness among consumers about Medicare Card scams.

The yearlong national effort to mail new ID cards to 58 million Medicare recipients began in May. The redesigned cards no longer contain enrollees' Social Security numbers — a move designed to enhance security and help protect against identity theft. Consumer advocates, including AARP, welcome the development but, ironically, the card replacement program has opened these new opportunities for con artists:

- Scammers reportedly pose as Medicare representatives and contact beneficiaries to demand immediate payment via credit card of a processing fee for the new card. No such fee exists.

- In other cases, the scammers falsely say that Medicare needs to "verify" a recipient's Social

Security number or other personal information before issuing the card. Medicare says it does not make such calls and does not initiate uninvited contact.

- Yet another version of the scam tells beneficiaries that they are due a refund on transactions with their old card, and asks them to provide bank account information for the processing of the alleged refund.

Results of the AARP survey, which polled Medicare enrollees age 65 and older, indicate a significant number of people could end up as victims of the scams. Among the key findings:

- **There is little public awareness:** Three-quarters of those surveyed (76 percent) knew nothing or very little about Medicare's plan to issue new identification cards.

- **Six in 10 think they could face a fee:** Although the redesigned ID cards are free, 60 percent of Medicare enrollees did not know or weren't sure if they would be required to pay a fee.

- **Half might not question a purported call from Medicare:** When asked if beneficiaries could expect to receive a telephone call from Medicare asking them to verify their Social Security number, half (51 percent) said they weren't sure.

"The new Medicare cards are a step forward for fraud prevention, but con artists are working overtime on new ways to scam seniors," said Mike Festa, AARP Massachusetts State Director. "That's why AARP Massachusetts is joining with the Fraud Watch Network to ramp up efforts to educate Medicare beneficiaries about the new cards and potential scams."

The AARP education campaign includes social media text and video postings, website content, and articles in recent editions of the *AARP Bulletin*. AARP Massachusetts and other AARP state offices are distributing a handout that details the new card rollout and associated scams.

The AARP Fraud Watch Network launched in 2013 as a free resource for people of all ages. Consumers may sign up for "Watchdog Alert" emails that deliver information about scams, or call a free helpline at 877-908-3360 to speak with volunteers trained in fraud counseling. The Fraud Watch Network website provides information about fraud and scams, prevention tips from experts, an interactive scam-tracking map, fun educational quizzes, and video presentations featuring Fraud Watch Network Ambassador Frank Abagnale.

Abagnale, the renowned fraud expert whose personal story was depicted in the hit movie "Catch Me If You Can," is also host of a new AARP weekly podcast series, "The Perfect Scam," that launched earlier this year.

### Survey Methodology

In March 2018, AARP engaged Alan Newman Research to conduct a national research study among U.S. adults ages 65 and older about their experience and knowledge around the new Medicare cards and potential vulnerability to scams related to the new card and benefits. A total of 800 telephone interviews (560 via landline telephones and 240 via cell phone) were completed between March 12 and March 19, 2018. Survey length averaged 10 minutes. The total sample of 800 respondents yields a maximum sampling error of  $\pm 3.5\%$  at the 95% level of confidence. See the research report for additional information.

## Saint Henry II (Holy Roman Emperor)

The son of Henry, Duke of Bavaria, and of Gisella, daughter of Conrad, King of Burgundy, Henry was born in 972. Henry was a great-grandson of German King Henry I and a member of the Bavarian branch of the Ottonian dynasty. Since his father had rebelled against two previous emperors, the younger Henry was often in exile. This led him to turn to the Church at an early age, first finding refuge with the Bishop of Freising and later being educated at the cathedral school of Hildesheim.

Henry succeeded his father as Duke of Bavaria in 995 as "Henry IV." As Duke, he attempted to join his second-cousin, Holy Roman Emperor Otto III, in suppressing a revolt against imperial rule in Italy in 1002. Before Henry II could arrive, however, Otto III died of fever, leaving no heir. After defeating several other claimants to the throne, Henry II was crowned as King of Germany.

Henry spent most of his reign concerned with imperial territory north of the Alps. His main focus was on a series of wars against the Polish Duke Boleslaw I, who had already conquered a number of countries surrounding him. Henry did, however, lead three expeditions into Italy to ensure imperial dominion over the peninsula. On February 14, 1014, Pope Benedict VIII crowned Henry as Holy Roman Emperor. On that occasion he confirmed the intention, made by his predecessors to the Pope, of the sovereignty of Rome and the



lordship of Byzantine Ravenna

The rule of Henry II is seen as a period of centralized authority throughout the Empire. He consolidated his power by cultivating personal and political ties with the Church. He greatly expanded the Ottonian dynasty's custom of employing clergy as counter-weights against secular nobles. Through donations to the Church and the establishment of new dioceses, Henry strengthened imperial rule across the Empire and increased control over ecclesiastical affairs. He stressed service to the Church and promoted monastic reform. He passed away on July 13, 1024. For his personal holiness and efforts to support the Church, Pope Eugene III canonized him in 1146, making Henry II the only German monarch to be a saint. His feast day is July 13<sup>th</sup>. He is the patron saint of the childless, of Dukes, of the handicapped and those rejected by Religious Order.

After an out and two walks to Ferdinand Carangelo and Nick Caruso, Brennan Bergson dug in and cracked a two-run single into center field. A few batters later, Ben Puopolo and Leo DelloRusso drew back-to-back bases loaded walks before the third out was made. After three innings it was North End 7 - South Berwick 5.

Four hits including a leadoff triple from Brevin Lavin enabled South Berwick to score three more runs in the top of the fourth inning. South Berwick was set up nicely to pile on more runs, but two stellar defensive plays by third baseman Nick Caruso thwarted what seemed to be a very promising inning for the Berwick bats. After snaring a line drive to start the inning, Berwick had a man on first after an RBI single by Sam Gennaro. A base hit to left field by Sawyer Reimels saw the cut off throw go to first base after a very wide turn. Gennaro seeing the ball go behind him dashed for third, first baseman Aidan Previte threw a laser to Caruso who slapped the tag on the advancing runner cutting down a key runner and hanging the second out of the inning on the board. Berwick scored three in the inning, but the defensive

efforts of the North End kept them down only one run after three and a half innings. The North End went 1-2-3 in the bottom of the fourth and entering the fifth inning, it was South Berwick 8 - North End 7.

Down one run, Sapienza gave Coaches Rick Martignetti and Michael DelloRusso exactly what they were looking for. After a leadoff strikeout, the Junior Cardinals Ace outed the next two batters retiring the South Berwick batters 1-2-3 for the first time in the game. Sapienza received some help from fellow minor leaguer Owen Flanagan manning third base. Flanagan put out the next two players. The duo had done their job and given the North End a spark heading into their last at bat.

After a leadoff K, North End players Leo DelloRusso and Nate Ginsburg walked back to back. A pass ball with Payton Fabiano at the plate allowed the runners to move to second and third. With runners still on base and two outs, Javian Vatel stepped into the box. Vatel hit a 2-1 pitch into right-center field, DelloRusso crossed the plate and Ginsburg came in right behind him. The North End had walked off in the inaugural meeting between the two teams. Final score North End 12 - South Berwick 11.

After the game, the teams and coaches celebrated with pizza from Rocco's Waterfront. Special thank you's to: The South Berwick team and coaching staff lead by Gregg Sessler; the overseer of all-things North End Baseball Ralph Martignetti; and to the man who's idea the exchange was, Nolan Previte. Also, the generosity of the Previte and Larson family which led to new uniforms for all players and coaches and delicious pizza after the game. The North End hopes to continue this new found exchange making it a summer staple. This goes to show you, an idea and some action — that is all it takes for some magic to happen!

## Recipes from the Homeland

### BEEF HONEYCOMB TRIPE in Tomato Sauce

#### TRIPE:

4 to 5 pounds beef honeycomb tripe      2 small onions  
5 small dried sprigs bay leaf

#### TOMATO SAUCE:

14 ounces crushed tomatoes      1/4 cup red wine  
1 medium onion chopped      Light sprinkle red pepper  
1/4 cup olive oil      flakes (optional)  
3 small dried sprigs bay leaf      Salt and pepper  
1 tablespoon basil flakes

#### SAUCE:

In an eight-quart pot, heat olive oil over medium heat. Add chopped onion, bay leaf and basil. Simmer slowly, careful not to burn onion. When onion is opaque, add crushed tomatoes and eight ounces of water. Stir thoroughly and cover. Simmer sauce over low/medium heat for about half an hour before adding any tripe. \*

#### TRIPE:

Using an eight-quart pot halfway with cold water. Add peeled whole onions and five small sprigs of bay leaf to pot. Place on burner to boil. When water boils carefully place washed tripe into the water. Cover and boil moderately for about one hour. (One hour is satisfactory for the first boil of four to five pounds of tripe). Check frequently. Covered pot tends to boil over easily. When tripe is tender but not fully cooked, drain from pot. Add cold water to that pot and place tripe into water.

Drain a portion from the cold water and place on a cutting board. Cut tripe portion into long three-inch strips with sharp knife or scissors. Then cut each three-inch strip diagonally into half-inch-wide portions. Place all cut tripe into separate bowl. After all tripe is cut, run under cold water, drain, and set aside.

\*When tomato sauce has cooked about half an hour, add cut-up tripe, salt and a few red pepper flakes (optional). Stir thoroughly. Cover pot and simmer tripe for one hour or until it is tender. (Approx. time - an additional hour). Then add red wine, a sprinkle of red pepper flakes (optional), stir and simmer for one minute before removing from burner.

The tripe and sauce mixture can be reheated before serving. Serves five.

*NOTE: My introduction to tripe was in 1950 when I began preparing this for our Somerville luncheonette customers. I had learned the recipe from watching my mother-in-law, Mary Sinopoli prepare this meal at home. At that time she had to scrape and clean the tripe before boiling it. Today the Tripe is made available already cleaned. This eliminates some of the unpleasant odor and work.*

*Often times I prepare a double recipe of tripe with tomato sauce and enjoy sharing it with family and friends.*

# Nanna & Babbononno

A Nostalgic Remembrance



This is the time of year when Dad played the county fairs throughout the northeast. When I was a kid, county fairs were (and I think still are) quite popular in rural areas in the country. Some were state fairs; others were local, but all were events in which most of the inhabitants of the area became involved. This was the biggest event of the year for many rural folks.

Fair grounds are large open spaces fenced off usually by white painted wooden enclosures. Most have several large buildings where displays are set up or events take place. In the outdoor spaces a carnival atmosphere was quite evident as organizations that specialized in catering to fairs would set up amusements for people to ride on. Games of chance would be located on the impromptu streets set up to resemble the main thorough fair at a public beach like Revere Beach in the old days. A reveler could try his or her hand at throwing a baseball at metal milk bottles, or throwing darts at balloons, or they could try sharpshooting abilities with a rifle fired at moving targets, or try to ring a bell by hitting a block of wood with a large mallet and sending it skyward to reach the bell. Beyond the amusements and games of chance were the food stands. You could treat yourself to cotton candy, burgers, hot dogs, pizza, fried dough, French fries, giant hot pretzels, and if this was a mid-western fair, a fresh ear of corn smothered in butter and salt. Dozens of flavors of ice cream, soft serve or slush could be purchased at a stand that specialized in frozen delights as well as soft drinks. Under a large tent with a portable kitchen and tables and chairs, you could actually sit down restaurant style and enjoy a dinner that was more to your leisure, the most common dish being friend chicken.

Most if not all of the fairgrounds had a race track and stables. One of the main features of the county fairs was sulky racing. This is the type of race where a horse pulls a two wheeled vehicle with a jockey sitting atop the contraption and the horses trot at high speeds attempting to win. If the horse began to gallop, it was disqualified. The nickname for these horses was trotters, as they were trained to trot. Let's see, the track was oval and had a grandstand on one side. Across from the grandstand was a stage. This is where Dad came in. Between races during

the day, they had acts of entertainment or featured selections from the house band. At night they would have the equivalent a variety show with Dad and the boys supplying the background music for the performers.

During the day, the horse players would show up and bet on their favorite trotters. At night, the grandstand was filled with families who came to see the shows, as well as track events like stock car racing and daredevil auto performances. The local fire department would give demonstrations as to how quickly they could put out a car fire that was staged.

Dad's band, the Johnny Christie Orchestra, consisted of about eight musicians or more, and included saxes, trumpets, trombones a keyboard, drums, and tuba. (Dad played the tuba.) Each act would have its own music that corresponded to whatever they were doing. Most fairs hired, a high wire act or trapeze act, a dog or chimpanzees act, a comedy act usually in pantomime, chorus girls singing the pop song of the day and someone who was popular locally, or if they could afford it, known nationally, to MC each evening's events.

Tents would be set up on the inside of the track area and were used as dressing rooms for the entertainers. Another tent might be the commissary where the entertainers could eat or rehearse their acts. I believe it was the summer of 1950, and Dad was booked in four fairs in upstate New York. The first was the Boonville County Fair which took place around the 4<sup>th</sup> of July. Mom, Nanna, Babbononno and I piled into Dad's new '49 Chevy and headed westward. We checked into a motel that Dad had booked in advance for us and the rest of the band. From there we headed for the fair grounds and were issued passes. Dad and the boys set up their instruments on the stage and rehearsed the acts of entertainment that would be featured for the next few days.

I was just standing around observing everything when a man chewing a cigar yelled out, "Hey kid, want a job?" I walked over to him and said, "Sure, I'd like to work." Dad yelled out to the man, "Hey Louie, that's my son." The man introduced himself as Louie from Southie. He was a scenery man who supplied the backdrops for the entertainment. He, from that point on, proceeded to teach me how to put up scenery for the agreed upon salary of \$35.00

for the week. I was in my glory. That first afternoon, Dad's band played several selections of music Dixieland style between the horse races. That evening, I helped Louie with the scenery, bolting each piece into the wooden stage, and after an interlude of music, several acts of entertainment followed each other and captured the crowd's attention. At the end of the performances, Louie and I would take down the scenery just in case a storm might have strong enough winds to do some damage. We would stack them up, cover and secure them and were done for the night. On that first night, most of the entertainers congregated in the food tent getting acquainted with one another. I thought Nanna and Babbononno were going to feel like outsiders until the leaders of a dog act came over and introduced themselves. They were Italian, originally from Avellino, and from that point on, they and my grandparents communicated in their native dialect.

As the week continued, we seemed to become one giant extended family. The wife of the man who starred in the dog act and Nanna started to cook some Italian specialties and the smell of Italian cooking lured all of the entertainers to our table to see what smelled so good. The cooks who were hired to feed the entertainers were locals and I think the most exotic dish they knew was macaroni and cheese. They watched as Mrs. Laddie, and Nanna took over the stoves and began to cook Italian dishes. Johnny Laddie, the husband, reveled in the fact that his wife was a great cook. Once he tasted Nanna's dishes, he compared her offerings to those of his wife and didn't know which were the best. The rest of the entertainers tried to find which dishes were the best, but it came out as a tie. Mrs. Laddie was happy... Nanna was happy.

There were many acts of entertainment that I would meet over the next few years, most from other parts of the world where they had worked as circus performers. A pantomime duo called The Bryants, had numbers tattooed on their arms. They were survivors from a Nazi concentration camp that had made it to the U.S. after WWII. They became friendly with Mom and Dad and would appear at several fair with Dad. I'm out of space, but will tell a few more stories about traveling with folks like these as time goes on. In the mean time, may GOD BLESS AMERICA

SMART'S MOVE: A DEAL DONE AND ONE NOT MADE — That's what the conclusion of the protracted financial discussions between Marcus Smart and the Celtics led to — a deal whereby the C's get to keep their talented player for another four years of duty and Smart gets to pocket the grand sum of \$52 million over the span of those 48 months. In case you are wondering, that works out to \$13 million per year or \$35,616 a day on a year round basis.

But, as it turns out, the most interesting aspect in all of this is that apparently Isaiah Thomas wanted to return to the Celtics — but the time it took to work out the deal with Smart may well have derailed that eventuality.

According to *ESPN's* Adam Wojnarowski, before signing his one-year contract with the Denver Nuggets for the 2018-2019 season, Thomas had called Celtics GM Danny Ainge to let him know he wanted to return to Causeway Street. The article, which was published on *ESPN.com*, states that Thomas told Ainge "that if the opportunity is there, I would just like to let you know that I would love to come back."

Wojnarowski states in his article that Ainge "was open to the idea but the Celtics needed to work through Marcus Smart's restricted free agency discussions before they could consider making an offer to Thomas. Ainge was willing to continue the conversation but Thomas accepted the Nuggets offer before Boston had reached its new deal with Smart."

"I'd have gone back," Thomas is quoted as saying. "I don't hold grudges."

JEREMY ROENICK HOLDS COURT — The Boston native and Thayer Academy graduate was back in Chicago recently to oversee his yearly youth hockey school when he gave a rather lengthy interview with the *Chicago Tribune*.

Roenick, who was drafted by the Blackhawks after graduating from Thayer in 1988, went on to play almost eight seasons for Chicago. Never one to avoid giving his opinion he touched on many topics.

He revealed that he had numerous concussions over the course of his 20-year career with five NHL teams, only a portion of were officially diagnosed.

"I had 13 that were documented where I had actual physicians look at me and put it on the medical form as a concussion," revealed the veteran center. "Four of them I ended up knocked out cold. So, I would say that they are legitimate. But they say that every time you see stars or get a twinkle in your eyes it's some sort of brain injury. I had a lot of those — between 30 and 40."

He also feels that with the concussion protocols that the NHL has in place today, he would miss many more games

than he did during his active playing career.

"There's no question about that," said Roenick, one of only three players to have a 50-goal season in the long history of the Blackhawks franchise. "There were a lot of times I didn't tell people how I felt or didn't let the doctors keep me out. There were a lot of times I talked about my passion to win and be part of a winning team. It was almost like my health was secondary."

Of course, we are in a different era with much more medical information available. Would it have made a difference if he had been more aware of the risks? "We didn't know as much back then," acknowledged Roenick. "I didn't know about CTE, about depression and the things that it causes. I think, looking back, I might have taken more rest and sat out more. But I would not have changed the way I played."

And that way was a rough way. He never backed down and took the game right to whom-ever was in his way. "I loved to hit. I loved to hit hard and when I hit I didn't hit within the rules that they have now. I would go high. I lot of times I would head hunt. I would not fit very well within the rules that they have today at all."

Yes, it certainly was a different time back then. Once in a while, you see someone at the Garden with the words "Old Time Hockey" displayed across the front of a sweatshirt.


Let Jeremy Roenick describe what old time hockey was like nearly three decades ago. The setting is the first game of Chicago's Stanley Cup Playoff series against the St. Louis Blues in 1989. It was the spring of Roenick's rookie season, the first of his lengthy NHL career that would come to also include stints with the Phoenix Coyotes, Philadelphia Flyers, Los Angeles Kings, and San Jose Sharks. And a player who would go on to later join the Bruins was involved in that memorable occasion.

"I got into a verbal war with Glen Featherstone (who would later join Boston during the 1991-1992 season) and challenged him. He went to crosscheck me in my chest. But he was a lot taller than me and crosschecked me in the middle of my face. Earlier, I had been hit with Steve Larmer's skate — that cut me for 15 stitches in the first period. Then I was hit in the mouth. Up to that point, I had never had stitches and had never lost a tooth. I had always said I never wanted to lose teeth. I lost three in my first playoff game."

Roenick went on to recall that "I opened my mouth and all the pieces of my teeth feel out in front of the referee. He gave him (Featherstone) a five-minute major. I got a two-minute minor. When I came out of the box, I tipped in the winning goal. That was pretty cool. I had one of the biggest smiles on my face afterwards. But I was one of the ugliest guys (because of the injuries)."
