Saint Padre Pio Procession in Boston's North End

Honoring one of the newer saints, a group from St. Leonard Church held the fifth annual procession for Saint Padre Pio on Sunday, June 28th in Boston's North End. The statue of St. Pio was carried from St. Leonard Church after an Italian

Mass and walked through the neighborhood streets where devotees pinned donations on ribbons. The procession was accompanied by the North End Marching Band.

St. Padre Pio was canonized by Pope John Paul II in 2002. Pius of Pietrelcina

(1887-1968) was a Capuchin Catholic priest from Italy, born as Francesco Forgione and given the name Pius (Italian: Pio) when he joined the Capuchins, thus known popularly as Padre Pio. He became famous for bearing the stigmata.

Stirpe Nostra

THE LABORS OF HERCULES

The circumstances surrounding the birth of Hercules, his early education, physical training, and the series of events which led to the imposition of his celebrated "Labors" were discussed in a previous issue. Any reader who might wonder why newspaper space is devoted to this Greek demigod is reminded that Renaissance Rome honored his memory in many works of art. Presently I can recall statue entitled "The Farnese Hercules" which is in the National Museum at Naples; a painting of Hercules killing the Hydra (his second labor) and another of Hercules crushing Antaeus, both in the Uffizi gallery in Florence; and a statute of Hercules slaving Cacus, a cattle thief, in the Palazzo Vecchio at Florence near the copy of Michelangelo's David.

The first ordeal imposed upon Hercules was to kill the Nemean lion. This was not an ordinary beast, but one of monstrous proportions. The hero visited Nemea (a valley in ancient Argolis, in southeastern Greece) and proceeded to the lion's lair, a two-mouthed cave. He quickly located the animal and, because his aim was infallible, he sent the arrow straight to its mark. When the arrow bounced harmlessly off the lion's side, Hercules realized that the beast was invulnerable to such weapons. He quickly blocked up one end of the cave and walked in unarmed through the other entrance. serpent out into the open

Hercules stopped the charging animal and strangled it with his bare hands. He then slung the dead lion over his shoulder and went back to the city of Tiryns. The terrified king (author of the labors of Hercules) then decreed that any future trophies were to be displayed outside the city gates. The dead lion was not wanted by anyone, so Hercules skinned it and used the pelt as a garment.

The second labor demanded of Hercules, killing the Lernaean Hydra, was much more difficult. This hideous, many-headed Hydra, or water snake, lived in the marsh of Lerna, near Argos, with its devoted friend, a large crab. The Hydra was so poisonous that even its breath was fatal to humans. It also had nine heads, one of which was immortal. Typical of his usual boldness, Hercules drove the

with a barrage of burning arrows. As he grabbed the monster by one of its necks, it immediately wound itself around one leg of Hercules. The hero started hacking away at the heads with his sword, but soon found the immortal one invulnerable to his blows, while two other heads grew in place of each that was lopped off. Adding to his problems, the crab now came out of the swamp to bite at the foot of Hercules. Realizing that he could not fight both adversaries alone, the strong man called for Iolaus, his nephew and charioteer, who brought burning brands. Now as soon as a head was severed, it was cauterized. Repeating this procedure, the duo dispatched the monster, except for the immortal head, which was severed and buried beneath a huge boulder. The body of the Hydra was slashed open and the arrows of Hercules were dipped into its deadly gall. This is the deadly poison which in future years caused the destruction of many enemies of Hercules. The hero returned triumphant to the City of Tiryns, but found that the king refused to count this as one of the labors because Hercules did not kill the Hydra alone. The next time you're in Florence be sure to visit the Uffizi Gallery to view the painting of Hercules killing the Hydra, by the Renaissance artist Antonio Del Pollaiuolo.

On Independence Day Remember the History of American Freedom and Equality

At ten o'clock on the morning of Saturday, July 4th, the Declaration of Independence will be read out to the assembled people from the balcony of the Old State House just as it first was in Boston, 239 years ago on July 18, 1776. Yes, back in the Revolutionary (before E-mail) Period, it could take two weeks to get a document from Philadelphia to Boston.

The memorable words of the Declaration:

We hold these Truths to be self-evident, that all Men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty, and the Pursuit of Happiness, punctuate one scene in a sweeping drama of history going back thousands of years.

Liberty and equality before law can be traced back to the Great Charter of England (Magna Carta), signed by King John 800 years ago on June 15, 1215, which declared:

No free man shall be seized or imprisoned, or stripped of his rights or possessions except by the lawful judgment of his equals or by the law of the land.

And that medieval declaration of rights echoes an earlier act in the drama of freedom. In the Institutes of the Roman Emperor Justinian (A.D. 535), we read:

The precepts of the law are these: to live honestly, to injure no one, and to give every man his due. Freedom, from which men are called free, is a man's natural power of doing what he pleases, so far as he is not prevented by force or law: Slavery is an institution of the law of nations, against nature subjecting one man to the dominion of another.

A thousand years earlier, Pericles (439 B.C.) said of Democratic Athens:

Our constitution favors the many instead of the few; this is why it is called a democracy. If we look to the laws, they afford equal justice to all.

And our founding fathers, who threw off allegiance to King George, must have agreed with the words of the Hebrew prophet Samuel who, half a millennium before Pericles warned the people that asked of him a king.

This will be the manner of the king that shall reign over you: He will take your sons, and appoint them for himself, for his chariots. And he will appoint him captains over thousands, and captains over fifties; and will set them to reap his harvest, and to make his instruments of war, and instruments of his chariots. And he will take your fields, and your vineyards, and your olive yards, even the best of them. And he will take the tenth of your seed, and of your vineyards, and give to his officers, and ye shall be his servants. And ye shall cry out in that day because of your king which ye shall have chosen you. —

1 Samuel Chapter 8.

As you enjoy the long weekend and all the events planned for Boston Harborfest, take some time out to reflect on the meaning of American Independence and our legacy of freedom. God bless America!

Changes to MBTA Late Night Service

As announced in April, changes were made to MBTA Late Night Service. After closely monitoring ridership levels for the year-long Late Night Service pilot program, the MBTA is implementing a schedule that continues to offer service where demand is greatest.

Service chantges are now in effect:

 Last subway trains will depart downtown stations at approximately 2:00 am on Friday and Saturday nights; this is also the latest time to make connections between subway lines.

• Frequency on all other bus routes and rail lines will be reduced.

The Late Night Service changes were made following a comprehensive review **The following Late Night** and public comment process in February and March.

What services will operate until 2 a.m. Friday and Saturday nights? Rapid Transit — the Red, Orange, Green, Blue, Mattapan, and Silver Lines (except SL2) and some key bus routes. The key bus routes with

extended service are Route Nos. 1, 23, 28, 32, 39, 57, 66, 111, and 116/117.

The RIDE paratransit service will also operate until approximately 2:00 am to areas within ¾ mile of all late night services. Please note that this is only if both the origin of the trip and the destination of the trip are within 34 mile of bus/ subway.

Will the extended service operate like other MBTA services? Service will operate as it does during the day, serving the same stations and stops as the normal routes. Regular rapid transit and bus fares will be charged on late night services.

All late-night trips will be scheduled and will appear on the MBTA website, on phone apps, on Google Transit, and anywhere else that such information is usually available. Real-time information for buses will also be available for the extended latenight service. Real-time information for the Red, Blue, Green, and Orange Lines,

Theodore Roosevelt's 1907 Speech on Immigration

"In the first place, we should insist that if the immigrant who comes here in good faith becomes an American and assimilates himself to us, he shall be treated on an exact equality with everyone else, for it is an outrage to discriminate against any such man because of creed, or birthplace, or origin. But this is predicated upon the person's becoming in every facet an American, and nothing but an American ... There can be no divided allegiance here. Any man who says he is an American, but something else also, isn't an American at all. We have room for but one flag, the American flag ... We have room for but one language here, and that is the English language ... And we have room for but one sole loyalty and that is a loyalty to the American people."

She will be forever missed, but her spirit will live on through Limoncello Restaurant and the never ending stories ... and her meatballs!





No other holiday smells, tastes or feels like summer more than the Fourth of July. It is the scent of fired-up grills emanating from every American backyard, the light swirl of smoke rising up in the hazy heat. It is the taste of



Had Massachusetts representative John Adams been correct, we would have been honoring our country's Independence Day on the second of July. That was the day in 1776 when, during the height of the Revolutionary War, the convention of delegates from the Thirteen Colonies, known as the Second Continental Congress, approved a resolution that declared independence from Great Britain. Adams predicted that this day would forevermore be marked with parades. bonfires and games. In reality, Adams's speculation on the nature of Independence Day celebrations proved accurate, only the date shifted to the fourth, when the Congress finally approved this declaration after much revision. There-



fore, the Fourth of July commemorates a tremendous event-a bold statement of independence, a desire to free oneself from oppression that would inspire revolutions the world over. As a patriotic holiday, the Fourth of July is also a perfect time to honor America's diversity, and during this holiday I often reflect on what it means to be Italian-American. Italians have been involved in America's quest for liberty and equality since the country's early days. The Tuscan physician Filippo Mazzei inspired the Declaration of Independence's statement that everyone has fundamental equality. Giuseppe Garibaldi, the hero of Italian independence, was recruited to fight in the Civil War and though he did not because of his commitment to Italy's freedom, his name inspired a Union Army regiment comprised of soldiers from both Europe and America. The U.S. Capitol dome was painted by an Italian immigrant, Constantino Brumidi. I believe that America's diversity and blend of cultures is precisely what makes our country so great, and on the Fourth of July I celebrate my pride as both an American and an Italian-American.

Along with its history, the Fourth of July is also a revelry in the primordial pleasures of summer, of outdoor festivities and food and fire and the splash of water. In this way, it resembles European Midsummer celebrations, which mark the height of the season around the summer solstice. My family has several Fourth of July traditions which I hold especially dear, all of which

epitomize the unbridled joy of summer. On the night of July 3rd, my husband and I watch a fireworks display put on by our old hometown. As we sit in the stands of the high school football field, we are surrounded by images of vintage

Americana: children playing tag across the field, glow sticks waving like little bursts of starlight brought down to Earth, snatches of classic rock tunes, and streaks of color illuminating the night sky as the crowd hushes with awe. On the Fourth, my family gathers for a festive meal which would not be complete without my two Independence Day mainstays: a Southwestern corn pudding and Zebra Pudding, a delectable dessert consisting of chocolate wafers layered with whipped cream, decorated with chocolate sprinkles, and refrigerated until properly cool and the wafers turn soft. My mother usually makes a panzanella salad and, as an appetizer, a dip of salsa and cream cheese served with tortilla chips. We usually have relatives from overseas visiting us during the Fourth of July, and it makes me proud to share this American holiday with them. As we gather for food and fun, we laugh and share nostalgic and funny stories as the hot summer day descends into a balmy, firefly-filled evening. I will always be thankful for this day of community, love, pride and food!

The Fourth of July grants us an opportunity to pause and reflect on what is most important in life. As we celebrate the freedoms that make America wonderful, we should pause and honor the sacrifices of the men and women throughout history and the modern day who made these freedoms possible. We should take this holiday as a chance to feel proud to be an American but also proud of our ethnic heritage, which contributes to our unique identities. Finally, we should see the Fourth of July as a prime feast of summer, and all of the joys that the season entails. With that, I must take the time to wish everyone ...



WILLIAM McKINLEY

(January 29, 1843-September 14, 1901)

A Forgotten Hero

If the end of William McKinley's presidency, cut short by an assassin's bullet to the stomach, was tragic, so was its immediate aftermath. Not that his successor was a disappointment. Theodore Roosevelt was a great president who, with his ideal of '100% Americanism' (meaning loyalty to your country as a whole above your specific region or demographic), brought the nation together in a way that it hadn't been since before the Civil War and was the first national leader to really put an emphasis on conservation. Roosevelt's legacy was, in fact, too good for the legacy of the president that preceded his and under whom he had been vice president. The popularity of Roosevelt ended up clouding the legacy of McKinley which, even in the years surrounding his death, was complicated. Our 25th president deserved better, however, as he proved to be something of a game changer in the American political landscape.

As a person, McKinley was always spoken of highly and was known for his sense of humor and charisma. It seems a natural way of life for the man who would be called the first modern president. Sure enough, he had to make decisions about for- itself, right at the heart of eign warfare and answer the conflict. Acquiring artilquestions about the growth lery and medical supplies for of imperialism. But he also was the first presidential candidate to use the media, then experiencing a revolutionary expansion into radio and visual media, for campaign advantages.

Up until the latter half of the 20th century, McKinley was widely considered to be an ineffectual leader, easily manipulated by foreign powers and taken advantage of. In the last forty years however, a fuller, more complex, understanding of the man has emerged and the importance of his presidency, when it's even discussed, is harder to place.

The first step in understanding McKinley's political plete defeat of the Spanish strategy is to look at his aid fleet without the destruction to Cuban independence dur-

ing the Spanish-American War. It's seldom discussed today, but the Spain ruled Cuba with an iron fist, sending rebels and freedom fighters to prison camps. The United States sympathized with Cuba, but McKinley wanted to avoid war at all cost, giving every effort to convincing Spain to grant Cuba its independence without a fight. Spain stood firm and made its unrelenting position clear. By January of 1898, McKinley was convinced that Spain would not release Cuba peacefully and so sent over the USS Maine as a sign that the United States also had no intentions of giving up the cause. Even after the battleship's infamous (and somewhat mysterious) bombing on February 15th of that year, which resulted in the death of 266, McKinley still hoped for a peaceful resolution. But by this point had to hand the matter over to Congress. On April 20, Congress declared war against Spain, something that would prove to be the death knell for the Spanish empire, which found itself at a disadvantage. Having lost most of its colonies in Latin America and the Caribbean, Spain's only nearby base was in Cuba the war proved problematic for Spain, something any experienced general on their side could have seen. Ultimately, it was Spain's pride, possibly motivated by an unwillingness to let go of Cuba, its last colony in the region, that brought her to a costly war.

Ironically, the United State's first major defeat of the Spanish Empire was not anywhere near Cuba or any of its former colonies but, rather, at one of its outposts in the South Pacific. The Battle of Manila Bay, led by Commodore Dewey, proved to be one of America's clearest victories; a complete defeat of the Spanish fleet without the destruction of a single American ship.

This was also the first time Spain realized the need for surrender and began taking actions to end the war.

Of course, this opened up the Philippines as a valuable territory for the empirical interests of the United States, something that would become a concern as Japan began expanding its own empire.

Expectedly, victory was more costly for Major General William Rufus on his battle in Santiago de Cuba. But, though both sides faced heavy casualties after the Battle of San Juan Hill, Spain, already crippled and short on supplies, surrendered the City of Santiago on July 17. This left Cuba as another territory open for U.S. interests. Jose Marti, one of the lead freedom fighters in Cuba, was less than grateful for the American intervention arguing, not wrongly, that the United States would be taking control over many of Cuba's resources and finances. Nonetheless, the United States enjoyed a strong and profitable relationship with Cuba for many decades after.

On July 22, the U.S. and Spain began negotiating a peace treaty which resulted in Spain giving up many of its territories, mostly to the profit of the United States. This presented yet another

Blessed Junipero Serra

Miguel Jose Serra was born on the island of Majorca on November 24, 1713. He entered the Franciscan Order at which time he took the name Junipero. Ordained in 1737, he taught philosophy and theology at the University of Padua until 1749.

On January 1, 1751, at the age of thirty-seven, he landed in Mexico City and spent the rest of his life working for the conversion of the peoples of the New World. In 1768, Father Serra was head of a group of Franciscans tasked with evangelizing California, then part of New Spain. He established his first mission at San Diego in 1769. He would go on to help found another eight missions up the coast through the San Francisco Bay Area that would eventually grow to 21 missions all together. In 1769, he established his headquarters near the Presidio (Garrison) of Monterey, but soon moved a few miles south to establish Mission San Carlos Borromeo de Carmelo in today's Carmel, California.

A tireless worker, Serra



was in large part responsible for the foundation and spread of the Church on the West Coast of the United States when it was still mission territory.

Father Serra passed away on August 28, 1784 at the age of 70 near Monterey. He was beatified by Pope John Paul II on September 25, 1988. Pope Francis plans to canonize him at the Basilica of the National Shrine of the Immaculate Conception on September 23, during his visit to the United States. A statue of Father Serra stands in the rotunda of the U.S. Capitol. His feast day is celebrated on July 1st.



Ladies! Ladies! Read carefully! High heels are glorified in advertising and popular culture. But platform pumps, stilettos, or strappy sandals not only make your feet and ankles ache - they may send you to the hospital, a new University of Alabama study has found. Injuries involving highheeled shoes doubled between 2002 and 2012, with heel wearers sustaining more than 123,355 heels-related mishaps including 3,294 requiring a trip to the emergency room. Nearly half of these incidents occurred at home. Most of the women suffered sprained ankles and feet, but 19 percent broke a bone. Some also hurt their knees, shoulders, or head. High heels also negatively affect stride, balance, and range of foot motion, creating chronic problems. "Although high-heeled shoes might be stylish," study lead author Gerald McGwin tells MedicalDaily.com, "it would be worthwhile to understand the risks."

More healthy advice. If you work at a desk, you should get up on your feet for at least two hours a day to avoid the serious health consequences of prolonged sitting, a panel of scientists has recommended. The average office worker sits for 10-hours a day, and then heads home to spend the evening glued to a television or computer screen. A growing body of research has found that hours of sitting trigger a destructive chain reaction in the body, slowing metabolism, altering hormones, raising cholesterol, and weakening muscles. Over time, the result is heightened risk of diabetes, cardiovascular disease, weight gain, cancer, and a shortened life. Scientists say, in fact, that prolonged sitting does as much health damage as smoking cigarettes. And the negative effects of eight to ten hours at a desk can't be undone by exercising before or afterward. But British researchers have found that getting up for short breaks throughout the day can protect desk jockeys' bodies from the effects of sitting. Researcher Gavin Bradley tells The Washington Post that the key is to avoid sitting for more than 30-minutes at a time. He advises "taking your calls standing; walking around; pacing; holding standing meetings; walking over to a colleague's desk instead of sending an email; and using the stairs instead of the elevator. Eventually, Bradley says, people should aim to increase their standing time from two to four hours. "However, you do it the point is to just get off your rear end." 

NONNA MARY'S FISH CAKES

- 1 pound of cod or haddock
- 3 large or 4 small potatoes 1 tablespoon grated Romano
- 2 tablespoons chopped parsley

cheese

- 2 1/2 tablespoons butter or margarine
- 1 egg, beaten
- 1 four-quart pan
- Medium-size Teflon skillet 1/4 cup cooking oil
- 1/4 cup dried bread crumbs (optional)

Peel, cut and wash potatoes. Cover potatoes with water in the four-quart pan and bring to a boil. Boil for fifteen minutes. Meanwhile, remove all skin and bones from fish. Add cleaned fish to boiling potatoes. (If desired, fish may be boiled separately.) Boil fish and potatoes slowly for about ten to twelve minutes. When potatoes and fish are cooked, drain contents in colander for a few minutes. While still warm, place potatoes and fish in a bowl with butter and salt to taste. Add grated Romano cheese, parsley, and beaten egg. Stir and mix well. If mixture is too soft, add some bread crumbs to absorb any extra liquid. Store covered in refrigerator to cool. Mixture is easier to shape into flat fish cakes when cool.

SHAPING: Take a FULL tablespoon of mixture in hand and shape like a flattened meatball. Heat oil in skillet. Fry fish cakes until golden brown. Turn over with spatula to brown on other side. Then remove from skillet and place in paper plate to absorb excess oil.

OPTIONAL: For those who prefer baked food, place the fish cake mixture in a lightly oil-sprayed baking dish. After covering the baking dish with aluminum foil, place it in a preheated 350°F oven to bake for about twenty minutes. Remove cover to lightly brown top before serving.

Serve with vegetable of choice or salad.

Nanna & Babbononno

A Nostalgic Remembrance

Babbononno once told me, "In life, you are stuck with your relatives whether you like them or not, but paesani and friends, you pick them and keep them for life." I guess this is true. As a matter of fact, the only relatives I really associate with are Uncle Gino and Aunt Ninna. Uncle Gino is my mother's youngest brother and the last remaining relative from that generation in the family. (He's 97 as of last month,) I do have first cousins, but seldom see them. My closest relative is Ralph Pepe, a second cousin. Our families spend holidays together, and many a Saturday night. I have a bevy of first cousins but, as I said, never see them. Two live out-of-state and the ones who are local have busy schedules that prevent us from socializing together.

Paesani, that's something different. I have a few close friends that I associate with on a continual basis. You might remember their names from former stories. We are all tied up with the Sons of Italy, the Order of the First Corps of Cadets and a few other organizations that are of interest to us: Dean Saluti, John Silva and Dick DeVito. This is sort of an inner circle. There are several other friendships that I have maintained from years of socializing, but these are the closest: Dean for 40 years and John for 30 and Dick for 10. I have to add in Bill Strachman from Waltham as another close friend, but that's about it. Don't get me wrong, I have many other friends, but these are my adopted brothers and it has been that way for quite a

Paesani to Nanna and Babbononno were fellow émigrés from Italy, people who came over at the same time and networked, or people who were from the same town or provinces. Paesani for the American-born generation were the friends we made from the neighborhoods we came from, East Boston, the North End. etc. ... and the Irish and Italians stopped fighting each other and began to marry one another before they resumed fighting (I'm kidding). The fact is, the close proximity of our neighborhoods and the fact that we went to school together and belonged to the same church parishes together pushed us together.

Some of us were lucky enough to go to college and met other young people with similar interests and this kept us in touch with one another through the years. The same might apply to the work place, too.

As an example of what I'm talking about, I received a phone call from Dr. John Hurley. He is the head of the Psychology Department at Stone Hill College. We were in every class together at Boston State (now U. Mass. Boston) for four years. There were 21 of us that were in all of those classes together and some of us get together periodically. The class was divided into two groups: older students just out of the service and those of us just out of high school. Several are gone, especially the vets who were several years older. One or two from my age group have passed on, but that's to be expected.

John Hurley wanted to know if I could make a luncheon this past Monday. It seems that seven or eight of my classmates wanted to get together, something we try to do a couple or more times during the year. It is a bit easier these days, as most of the guys are retired. John and I are actually the only two out of the crowd that are still working. Most of us started out life teaching industrial arts, which was our major. Woodworking, electricity, electronics, sheet metal, printing/graphic arts and drafting, these were the subjects we were involved in when they were offered in schools other than trade schools. I taught drafting and design in the Boston Schools for over 40 years (43 to be exact).

A few of my classmates headed for the business world or the military and did rather well in life and have a lot of stories to tell when we get together. But the rest of us were in the school shops for most of our careers. After college, I spent the next 20 years at Hyde Park High School, then they were not all Italian. headed to Boston Tech Beginning in my generation, for 10, and the next 8 at the Barron Center and the last 5 at the McCormack in Dorchester.

Being first or second generation, from Italian or Irish families, we lived at home with our parents until we married and then headed out on our own. And we didn't head far. When I decided to head to BU for a doctorate, I

moved back with my parents. I was paying for the continuation of my education and moving back was very helpful financially.

As an example of how times have changed with our children's generation ... how far did my kids move from their parents when the time came to go out on our own? I have one son in New York (235 miles away) and another who spent several years in Zurich, Switzerland, 4,000 miles away. This would have been unheard of when I was young. I had a second cousin around my age. He moved out and got his own apartment when he was about 24 years old. His parents considered it the point in time when their son ran away from home.

Even if I look back at my youthful days when I was playing music seven nights a week, I had a piece of an apartment on Commonwealth Avenue, another on Winthrop Beach and another on West 88th Street in New York. Yet, my driver's license and auto registration indicated that I was at the same address as my

When Loretta and I were married, I bought a house in Arlington, a suburban town next to Belmont where I had been living with my parents during the time period I was working on the doctoral degree. When our son, John, the oldest, decided to settle down and married his longtime girlfriend, Beth, he bought a house in Harvard, Mass., about 25 miles away. Every time we head there, I tell Loretta that I feel like we're heading into Yankee territory. My father used to say the same thing when he and my mother moved from East Boston to Belmont.

Where did the exodus from Boston neighborhoods take us? Many of the Irish headed to the South Shore. The folks from East Boston and the North End headed north, first to Revere, and then Medford. Later, they headed to Malden, Saugus and when they could afford it, Lynnfield and other North Shore locations. Today, this ethnic movement in a particular direction isn't as important as it was years ago. We are more mixed than ever. How many of you are a mix of Italian and _???

THE IMMUNE SYSTEM: A STRONG NEW WEAPON TO SUBDUE TUMORS. At a recent convention of the American Society of Clinical Oncology held in Chicago, a new frontier has opened in the fight against tumors. According to experts, astonishing results have occurred using the immune system, particularly against melanoma. Statements given by Michele Maio, Chairman of the Department of Medical Oncology and Immunotherapy at the University Hospital of Siena (Italy), a new road taken has been in immune-therapy, which focuses on the immune system to keep the tumor under full control. A very important corollary is that we now begin to rely on really solid basis, and can attest that the immune therapy is effective against forms of metastasis, as well as preventing future manifestations of new tumors following surgery. Making use of the immune system certainly opens up unprecedented therapeutic potential in the treatment of tumors by themselves, or in combination with new drugs to fight or eliminate virtually all forms of tumors. Thus the organism itself can provide the necessary weapons by amplifying immune therapies in the fight against tumors. The exciting fact is that the immune-therapy has literally exploded in massive new research worldwide in this field.

One particular study presented at the convention centered on a personalized immune-therapy called "T Cell Therapy," that elicits a lasting remission of skin illness in many patients. There are studies, also presented at the convention, that are focused on forms of lung cancer, resulting in exciting new outcomes by reducing the tumor mass by 80% in patients treated. The same outcome has been achieved in the treatment of mesothelioma-pleurisy, a tumor fostered by asbestos.

A NEW DRONE BY EUROPEAN TECHNOLOGY. At the last air show held recently in Paris, a new generation of drone was introduced. dilemma for President McKinley who was not deaf to the criticisms of anti-imperialists in his own country, though his assassination really ended any sort of development in this field.

Meanwhile, back home McKinley's was having a hard time finding a support base, at least on two fundamental issues.

The first was his support for tariff reform which would overthrow the Wilson-Gorman Tariff Act of 1894 and would increase tariff on wool, sugar, and other items. This did stir many European nations (notably France) who depended on importing such items to America for their economy. Along with this, McKinlev embraced the Gold Standard Act of 1900 as gold became a viable resource following gold strikes in the Yukon, Australia, and British India. Although this met with some resistance, McKinley was able to pass this through the Senate with relative ease thanks to a flourishing economy; largely a result of his terrific foreign policy.

As far as race relations, McKinley greatest sin was that of inaction, though his ideology seemed to be in the right place. He often spoke out against lynching and violence toward Black Americans, but did little to prosecute those responsible for

that violence and while he did appoint a number of Blacks in his cabinet, the number pales in comparison to those recruited by his successor and Vice President after the election of 1900, Teddy Roosevelt. Tellingly, his support by the Black community had diminished significantly by his second term.

For his patient planning of war and embracement of new technology when faced with the first large-scale foreign war the United States fought, William McKinley deserves a higher place in presidency and worthy of bet- our history. ter remembrance. His doin that regard he was with- any comments.

THE BU BRIDGE - The Mass Ave. Bridge is OFF-**LIMITS** to the public. And, due to ongoing construction on the LONGFELLOW **BRIDGE**, there will be no fireworks viewing allowed from that bridge.

MEMORIAL DRIVE/CAM-BRIDGE-SIDE - Cambridgeside features speaker towers, concessions restrooms.

BOAT - Many boaters arrive early in the day and stay overnight on the river. The area between the barge and the Mass. Ave. Bridge will be off-limits to boaters.

New in 2015 - the New Charles River Dam will close to up-river traffic beginning at 7:45 pm on July 4th.

Note: Fireworks produce smoke. Wind direction (or lack thereof) can adversely affect viewing at any of the above locations.

WHAT TO BRING



Free Sunscreen Dispensers Coming to Boston Parks

Mayor Martin J. Walsh announced a joint partnership with the Melanoma Foundation of New England (MFNE), Make Big Change (MBC) and the Boston Parks and Recreation Department to provide free sunscreen dispensers in public parks in the City of Boston.

Boston will be the first major city in the Northeast to initiate this program, currently in effect in Miami Beach, Florida. The partnership will begin with a pilot program of 30 sunscreen dispensers in five city parks, and may lead to a widespread installation throughout Boston, depending on the success of the program.

"Preventing skin cancer is a public health imperative," said Mayor Walsh. "Strategically placed sunscreen dispensers offer the public an easy preventive measure to avoid sun overexposure. We are proud to be the first Northeast city to pilot this program and thank MFNE and MBC for stepping forward as partners.'

The dispensers will initially be placed in Millennium Park, West Roxbury; Jamaica Pond, Jamaica Plain; the Boston Common; Christopher Columbus Park, North End; and East Boston Stadium and Memorial Park, East Boston.

The sunscreen dispensers offered by MFNE and MBC are weather resistant and low maintenance, and hold all-natural SPF-30 sunscreen, which is safe for people age 6 months and up. All of the ingredients will be printed on the machines upon installation, and are available upon request.

MFNE will subsidize the cost and procurement of the sunscreen dispensers at no cost to taxpayers through private and corporate sponsorship donations, and funds raised by MFNE's Running for Cover, one of the Boston Athletic Association's Official Charity Teams for the 2015 Boston Marathon. MFNE will also use this platform to expand their yearround public education programs aimed at melanoma prevention and detection. Since 2014, MBC has worked to place sunscreendispensing devices across high-traffic areas in New Hampshire, including public parks and beaches.

"Skin cancer and melanoma are among the most prevalent cancers," said City Councilor Matt O'Malley, who first proposed a citywide sunscreen initiative. "They're also among the most preventable. I am proud to partner with Mayor Walsh and the Melanoma Foundation of New England to provide sunscreen dispensers to residents and tourists, as well as increase awareness of the importance of protecting your skin. Once again, Boston will lead the way."

"We know that if used correctly, sunscreen decreases the risk of skin cancer," said Deb Girard, Executive Director of MFNE. "We are thrilled to be working with the City of Boston and Make Big Change to make these units

DECLARATIONS OF DOOM WAY TOO SOON — For weeks media members speculated on what they considered to be the desired outcome: that the Celtics and Bruins would somehow and in some way package some of their respective draft picks and offer them in deals to move up selection process.

The NBA Draft took place first, a day ahead of the NHL version. Though the two share some similar features, they are different in significant ways. For the NBA Draft, the front office personnel for all 30 teams remain in their respective cities, merely communicating their picks to NBA Draft headquarters which this year was at the Barclays Center in Brooklyn — the home of the Brooklyn

For the Celtics, that meant that GM Danny Ainge, Head Coach Brad Stevens, the scouts and team owners operated out of a self-declared "war room" at the Seaport Hotel, while season ticket holders partied in a much larger room nearby.

That also meant that there were no communications in person with any of the other 29 teams or with the NBA Draft headquarters. All were conducted by phone or computer. The upside to "staying local" is that team executives can address the fans in person and that many more regional media representatives can cover the team on draft night since no significant travel or other expenses are involved.

The downside is that the team executives lack that inperson communication with their counterparts from the other NBA teams.

However, when the front office executives and coaching staffs from all 30 NHL teams converge for the NHL Draft, in-person meetings are exactly what take place. Want to talk to that GM about a possible trade? He's right over there, just a couple of tables away. Both can take a long walk together down the hall for a "coffee break" and a faceto-face discussion — something that could never happen at the NBA Draft.

They also walked away from defenseman Dougie Hamilton, who was traded and promptly signed a \$34.5 million deal with Calgary. Say what you will, but some of these negotiations are similar to exploring the higher in the first round of the real estate market. Dougie Hamilton's services were for sale, much like a home on the market. The potential buyers (the Bruins) made an offer. That offer was rejected by the seller (Hamilton and his agent). Thus, the potential buyers (the Bruins), rather than offering more money, walked away.

We remember reading once that all potential home buyers had to be prepared to walk away from a home they liked, simply because of the owner's refusal to come down in price. So, too, in this case. The Bruins extended an offer, the Hamilton camp declined it and so the B's front office executives traded him to Calgary and moved on.

Did the Bruins want Hamilton? Yes, they did. How do we know that? They made him an offer. He declined to accept so the Bruins moved on — just like home buyers who move on to consider other houses after their offer on the home they wanted was not accepted by the seller.

And just like a home on the open market, although one set of buyers moved on, others arrived and were willing to pay the price — and so the home is theirs. Welcome to Calgary, Dougie. The Flames met your price.

Dougie Hamilton and his agent had a perfect right to set a price for his services. The Bruins had a perfect right to make an offer. When the Hamilton camp would not budge, the Bruins put the defenseman in the rear view mirror.

There is one other dimension — the term of the contract. Hamilton's contract with Calgary is for six years. Does anyone really know how good any athlete will be six years from now? No one can foretell the future. There's a lot of hope hanging on a \$34.5 million wager, particularly the six-year term of it. That's why we prefer the a bet that the Bruins were not
