Saint Agrippina Benefit Society Celebrates 104th Anniversary Feast

The 104th Feast of Saint Agrippina di Mineo this weekend marked the start of the annual "big" feasts in Boston's North End. After a dedication, blessing, and unveiling, the children's procession led the way on Hanover Street followed by the large statue of Saint Agrippina to the Greenway before returning to her new weekend feast chapel. To carry the statue, 20 men coordinate in a complex rhythm to keep the 1,600-pound statue in the air. At the end of the feast on Sunday night, the society holds its famous "tug of war."

Saint Agrippina was a beautiful blond princess who was

Building the Wall Now or Never?

It does appear that the Republicans running the U.S. Senate have decided to put off financing the wall at the U.S.-Mexican border until after the midterms. That was what Senate Majority Leader Mitch McConnell declared last week. President Trump wants the wall built and is quite frankly frustrated with Establishment Republicans who aren't in agreement with him. It seems those Republicans, the U.S. Chamber of Commerce, and Koch Brothers have problems with the wall issue, because many of those political activists like cheap labor from across the border to make profits on this side of the border.



THE DINNER OF TRIMALCHIO (Continued)



Last week, I presented the first part of a detailed account of a sumptuous Roman banquet provided by "Trimalchio," a boastful, pretentious, and ignorant recipient of newly acquired wealth. I described the hors d'oeuvres, cooked dormice, hot sausages, and European songbirds called "beccaficos."

This week, we are told that after eating their fat songbirds rolled in spiced egg yolk, the guests washed their hands with a good grade of unwatered wine. The wine, which was served for drinking came from Falernos Ager, a district in the north of Campania, which produced the "Falernian" wine, one of the finest in ancient Roman times. This particular wine was 100 years old.

The next dish of the evening was a large round plate containing the 12 signs of the Zodiac. At each sign, the cook had placed some food appropriate to the symbol. At Leo, there was a large African fig, Cancer contained boiled crabs; Gemini contained a giant double mushroom, Taurus had a round of beef, Aries there was a saddle of mutton, Pisces had red mul-

let, and over Aquarius, there was a plump goose. Lobsters were placed over Capricorn, Sagittarius contained a bull's eye, and Libra had a scale with muffins on one side and small cakes on the other.

At the appropriate time, a sign from the host brought in waiters who lifted off the Zodiac dish, to reveal a lower section which contained plump fowl, sows' bellies, and cooked rabbits made to look like Pegasus, the celebrated winged horse of Zeus. In the next course, each of the four corners of the dish contained a figure of Marsyas, the flute player from mythology.

A sharp sauce poured out through the flutes onto cooked fish until they appeared to swim around in the liquid.

Next came a wild boar with a palm leaf basket hanging from each tusk. The baskets contained dates from Turkey and Egypt that were passed out to the diners while bearded huntsmen entered to slash the side of the boar and release a flock of thrushes. Each bird was then caught in a net by the slaves and cooked for a guest. During a stretch period, fresh covers

were spread on the couches and off they went again. This time the servants brought in a boiled calf on a huge dish and laid it on the table. A swordsman rushed into the dining room and attacked the calf with a swinging saber. He then collected the slices on the point of his sword and served them to the astonished guests. A large roasted pig was next on the menu, and when the belly was opened, it revealed cooked sausages and puddings.

The soiled tables were then taken away and replaced by clean ones. Powdered talc and colored sawdust were sprinkled about the floor. Then came the sweetmeats, and an assortment of other desserts fashioned from flour, raisins, nuts, and pork. All guests then took a hot bath, after which they were led into another dining room where wine flowed in rivers and the serious drinking began.

It is said that shortly thereafter some of the guests slid off the couches and onto the floor while others called for their litters and quietly went home. The host just sat there in a drunken stupor mumbling something which sounded like ... I ate the whooooole thing.

L'Anno Bello: A Year in Italian Folklore

Ferragosto: Italy's Great Vacation

There is no use hiding it anymore: autumn is coming. The signs of the changing season pulsate all around me. The evenings fall earlier, a dusky blue mantel of sky covering the Earth, and the air feels crisper as well. The earliest crop of apples has arrived at markets, and I cannot wait to enjoy this succulent fruit in cakes, breads, crisps, and as a simple snack. Even Halloween decorations, smiling pumpkins and arched black cats, begin to wink from store shelves amidst all the notebooks and pencils of back-to-school sales. Although autumn is my favorite season, I am determined to hold on to the rest of the summer for as long as I can, until the school bell rings in September. After all, the days are still warm and the sun still bakes the Earth. Indeed, in Italy, summer vacation remains in full swing. The biggest summer holiday in Italy occurs on August 15th, though Italians extend the celebrations for several weeks before or after. For this feast, named Ferragosto, Italians leave the cities en masse to spend time at the beach or mountains. Caught between the heat and idleness of summer and the rhythmic nature of fall, Ferragosto provides Italy with one last joyous blast of the vacation season.

Visiting Italy during August can sometimes resemble walking through the quiet remains of an ancient civilization. Tourists abound, of course, but many Italians had already escaped the scorching heat of cities and towns once August began, embarking on their Ferragosto vacations until the holiday culminates on August 15th. I remember the slightly eerie sensation of walking through Rome one August eleven years ago and noticing the boardedup restaurants, theaters, and shops. Meanwhile, the Italian coastline brims with colorful beach umbrellas and chic sunbathers, the sands chockablock with impromptu volleyball games and radios blaring the latest hits. Italians even exchange holiday greeting cards emblazoned with pictures of beach picnics and grinning suns. In small Italian villages, such as my father's home outside of Sulmona in Abruzzo, people celebrate Ferragosto with shady al fresco dinners, featuring the seasonal produce of zucchinis, tomatoes, peppers, and herbs. This holiday has been important to Italians since ancient times. It hearkens back to the year 18 B.C., when the Emperor Augustus established the *Feriae Augustae* — Festivals of Augustus — in honor of his reign. Some historians suspect that Augustus's festivals replaced older holidays like the *Vinalia rustica*, which marked the grape harvest. For all of its modern trappings, therefore, Ferragosto remains a seasonal celebration honoring the freshair pleasures of summer and the harvest. August 15th holds

another great significance in Italian culture: it is the feast day of the Assumption, or L'Assunzione. This religious holiday observes the Virgin Mary's physical and spiritual Ascent into Heaven. Italian villages and towns combine Ferragosto and L'Assunzione festivities by holding parades and processions where the statue of the Blessed Virgin Mary is held aloft. In the medieval city of Siena, the famous Palio, or Renaissance horse race, occurs around this time. Around Europe, in fact, the Feast of the Assumption also serves as an important seasonal marker, heralding the start of the harvest. Armenian farmers bring freshly harvested grapes to church on the Sunday closest to the Assumption so that the priest may bless the fruit. In Poland, where the Virgin Mary of the Assumption is also known as the Blessed Mother of the Herbs, people gather herbs and have them blessed in church and later display those herbs around their homes for protection. I honor the harvest qualities of the Assumption by baking cheesy biscuits studded with chives; both the wheat and the herbs symbolize the bounty of Mother Earth. The pungent aroma and simple texture of these small breads remind me that August means far more than the end of summer; rather, it is a time to be thankful for the gifts of nature and to appreciate the cyclical changing of the seasons much as our ancestors

Therefore, August in Italy teaches us to live in the moment. Though we may be worried about the stress of the upcoming cold-weather months, the holiday of Ferragosto encourages us to seize the last few weeks of summer with fanfare and fun, enjoying the cool waters of the ocean or a picnic under the stars, surrounded by family and friends. Meanwhile, the Feast of the Assumption emphasizes the bountiful harvest that characterizes the late summer and fall, as well as the beauty of the changing seasons. Let us allow the lessons of these two holidays to permeate our lives and let us carry the pleasures of August with us always.

P.S. Happy Birthday to my father Rocco Di Censo, who was born the day after Ferragosto. Daddy, I love you always!

Thursday, July 26th, was a red banner day for Engine 50 in Charlestown as folks gathered up by the Monument to honor Boston Firefighters, Engine Co. 50 and celebrate its centennial celebration along with that of the Winthrop Street firehouse.

Boston Fire Commissioner Joseph Flynn delivered a speech across the street from the Bunker Hill Museum where there is now an exhibit on the Boston Fire Department and artifacts from Charlestown's role in Boston's firefighting history. Nearly 200 people attended, including former firefighters, department supporters, and community members.

I believe the 30-day siege of the firehouse made last week's 100th anniversary possible because without it today Engine 50 would be history and the firehouse most likely luxury condos.



Strong and kind with her Irish determination and heart of gold. Ms Fairbanks's Paroo has the twinkle in her eye and just enough skills at manipulation to push her daughter in the right direction.


Perhaps the real stars of this production are the children and young adults who worked endless hours preparing for their moments on the stage. Jonathan Tillen as the withdrawn Winthrop Paroo shows us the growth of the self conscious young boy with a lisp who has sunk into despair since the death of his father but now begins to find himself through Professor Hill. In both "The Wells Fargo Wagon" and "Gary, Indiana" we see him emerge and you can't help but feel touched by young Tillen's performance.

Winthrop's friend Amaryllis who prays for him every night is played by Cate Galante. Cate's Amaryllis is full of life and love. Her feelings for Winthrop warm the heart. She sparkles on stage.

Ye gods! I can't forget Isabelle Miller who takes on the role of Zaneeta Shinn, the Mayor's daughter. UMC/Island/Interscope released three new vinyl reissues from U2, on double LP black vinyl, Achtung Baby (1991), Zooropa (1993) and The Best of 1980-1990 (1998) on July 27th. Achtung Baby: was recorded over six months at Hansa Studio in Berlin and Windmill Lane in Dublin, and is U2's seventh studio album. Produced by long time U2 collaborators, Daniel Lanois and Brian Eno with Steve Lillywhite, Achtung Baby was engineered by Flood and led by The Fly, and also featured four other singles, "Mysterious Ways," One, Even Better Than The Real Thing," and "Who's Gonna Ride Your Wild Horses." Released to widespread critical acclaim in November 1991, the record topped charts around the world, and saw the band take home the Grammy Award for Best Rock Performance. Zooropa: U2's eighth studio album was released in July 1993 and hit #1 in the UK, USA, Ireland, Japan, Canada, Australia, New Zealand, Italy, Sweden, Austria, France, Switzerland, Germany, Holland, Norway, Denmark and Iceland. Produced by Flood, Brian Eno and The Edge, the 10 tracks on Zooropa - inspired by the band's experiences on the Zoo TV Tour - include singles "Numb," "Lemon" and "Stay (Faraway, So Close!)," and were recorded in just 6 weeks in early 1993. And the 1994 Grammy Awards saw the band take home the prize for Best Alternative Music Album. To celebrate the 25th anniversary of the album's release, this vinyl reissue will see Zooropa released in a 2LP format for the first time ever, to include two mixes of "Lemon" and "Numb." The Best of 1980 - 1990 [2LP]. U2's first compilation release, The Best Of 1980-1990 went straight to #1 in the UK, Ireland, and Canada and around the world on its original release in November 1998. The 16-track collection features seminal songs from early in the band's career, as well as many of their biggest global hits.

Stunts, Blunts & Hip Hop is the 2LP vinyl reissue of the 1992 out-of-print album from MC/producer, Diamond D. His forte as a beat maker is featured, while visionaries as The 45 King, Jazzy Jay, Large Professor, and D.I.T.C teammate Showbiz, make stellar appearances on the project. Sped up samples and vocals are the sound that in decades to come, possibly inspired 9th Wonder and Kanye West. The track "Best-Kept Secret" featured lyrical fury from Fat Joe and peaked at No. 2 on the Hot Rap Singles chart. The follow-up single, "Sally Got A One-Track Mind" also did well, charting at No. 12 nationally. The release featured celebrated cameos from Tribe

Called Quest front man, Q-Tip. Crewmembers Lord Finesse and the late Big L also make their presence abundantly felt on choice cuts. Diamond's production was well ahead of it's time, today delivering a sound as fresh now as it did upon its release decades ago, and proved that a producerdriven album could hold it's own. This collection of is a jazzy foray bound with storytelling narratives, battle raps, and light-hearted lyrics. Diamond D remains to this day an underground, and often under-mentioned, rap masterwork.

RICH HALLEY 3 -THE LITERATURE/CD Pine Eagle Records

Rich Halley continues to impress with his string of covers, as the jazz saxophonist delivers a dozen dynamite tracks of covers. Included are a pair of Thelonious Monk tunes "Misterioso" and "Brilliant Corners," tucking in an early Miles Davis piece, "Little Willie Leaps," and the Latin-flavored "Chano Pozo" done previously by Mongo Santamaria, along with a second pair of tracks originally done by avant-garde jazz genius Ornette Coleman, 'Broad Way Blues" and "Law Years." Peppered in between those diamonds are covers as Jimmie Rodgers' "High Powered Mama," Duke Ellington's "Mood Indigo," a couple of bluesy efforts from A.P. Carter's "Motherless Children," and Charlie Mingus' "Pussy Cat Dues." Completing the collection are, Sun Ra's royal "Kingdom of Not," and a former country hit for the late Hank Williams titled "Someday You'll Call My Name." Halley takes these twelve songs and creates covers that seemingly make them his own, with his tasty tones solidifying that thought.

Keyboardist and composer Aleksandra Takala's bio pretty much describes her accurately ... "she weaves a rich tapestry of sounds together to create music deep with feeling in her debut album, Visions & Emotions." Baldassari has been the curator of his own personal shrine to the saints. Above the archway to his little alleyway hangs a sign, "Mock All and Sundry Things, but Leave the Saints Alone."

I wasn't surprised to hear that American-born Baldassari is of Sicilian and Calabrese ancestry. That's a great mix. Just ask anyone with grandparents from Italy. I always thought it was easier for a Sicilian and an Irish person to get hitched. There's a lot of history between Sicily and Calabria. Today, much of it sounds humorous, but not back in the day.

I love talking with Baldassari. He knows so much about the saints and is always willing to pass on his knowledge to one and all. To me, he has become the personification of what the North End has always been.

Kudos to the Boston Herald for doing a great positive story on a great North End character who truly loves his neighborhood and culture! The newspaper ran many cool colored photos with this story, too.

CHANGE ITS NAME TO DIMWIT CENTER?

What was the Dewitt Center in Roxbury thinking? Two Boston police officers attempting to serve a search warrant were met with a fight from two teens at the community center. As other officers showed up they reportedly were denied access by a front desk employee.

According to the Boston P.D., responding officers were forced to watch the altercation through the community center's glass doors unable to gain entry. Both teens, ages 15 and 16, were arrested. Nanna & Babbononno

A Nostalgic Remembrance



Today, everything is disposable. You name the object, and when it wears out, we get rid of it. As a matter of fact, it is often cheaper to get rid of something that needs fixing than to repair it. Let me give you an example. I have to dress up quite a bit. That means I'm in a shirt and tie more often than not. If my shirt cuffs or the collar gets frayed, the shirt becomes a cleaning cloth for one of the cars. If the elbows on a suit jacket become ragged, you have two options, the Goodwill bag or put leather patches on them. Cobblers are almost out of business. I'm told that it is cheaper to buy a new pair of shoes rather than to have new soles and heels put on. It wasn't always like this.

When Nanna and Babbononno were young, nothing went to waste. When refrigerators became popular, the icebox made its way to the cellar and was used to keep my grandfather's beer and wine cool. When the kitchen set had to be replaced with a newer one, the old one found its way to the cellar to be used to eat on in the warm weather. At that point, the kitchen set that had been in the cellar made its way to the backyard and served as a picnic table, or to hold Babbononno's tools when he was working outside.

Back in the day, Brioschi came in a round can with a lid that had to be pried open with a bottle opener or a screwdriver. There must have been at least a dozen cans in my grandparents' cellar with nails, screws, washers, bolts, carpet tacks, and anything else that my grandfather wanted to save that would fit in the can. The same was true with the small can that Secretes came in. (If you've never seen one, it's about the size of the tin can that Altoids breath mints come in). Nanna used them to hold needles, common pins, odd buttons, and maybe another might be filled with pennies.

My grandfather used to dress at night. He was a musician and musicians dressed back in the day ... suit and tie. When the cuffs or collar wore out, he handed the shirt to Nanna and she would turn the frayed collar or cuffs over or inside out, whatever would work and that would give the shirt a second life.

Babbononno had a brown fedora. Over the years, he wore it whenever he went out until sweat stains were visible, but the hat was never out of his possession. It was left in the cellar and worn when he worked in the garden beginning in the spring. It was replaced by a new fedora that could be worn with a suit and tie. Thinking of ties, if I get a gravy stain or salad oil stain on a tie, I swear under my breath, throw it out, and wear another one that compliments one of my suits. Back in Babbononno's day, the tie could be cleaned with one of Nanna's solvents, and no one would know the difference, or if you wanted to splurge, a dry cleaner would take care of it for five cents.

Nothing was ever thrown out.

The cellar contained everything that had seen its day or could be used again. As an example, there were empty gallon jugs and whiskey bottles on a shelf in the cellar. When I asked Babbononno why he kept them, he always said, "Wenna I go a la houza di Zi'Antonio eh buy da wine, maybe heeza no gudda bottles wadda use foh da wine, capice?" Every time Dad or one of my uncles would take my grandfather to Zi'Antonio's, he brought an assortment of these bottles to fill, just in case his brother-in-law didn't have

I guess that their way was part and parcel of being born poor in Italy and living through the Depression in this country. Even Dad had his frugal side, the result of the Depression. When I was a child, he owned a 1937 Plymouth. Whenever he would find a dent in one of the fenders, he would get out a ball peen hammer and a block of wood and take the dent out himself. I remember an incident when I was still in short pants. The right front fender split open over the center of the wheel. The next day, Dad and Babbononno were at the curb with a blowtorch and a bar of solder fixing the problem. When the handle and lock broke off the trunk, the lid was taped shut so it wouldn't flap around when he drove. That car made it to 1949, and when Dad got rid of it, the only thing still working in it was the driver.

I remember a blouse that Nanna had. It had been washed too many times and it was faded. The next thing I knew, it was soaking in a basin in the kitchen sink. The basin was filled with hot water and blue dye. Nanna's faded blouse lasted quite a bit longer, only it was now powder blue. She was happy when everyone admired what they thought was a new blouse.

If a cup or dish became chipped, it remained in the cabinet above the kitchen sink. They were used when we were alone. The good ones came out when we had company or on Sunday afternoons when the family came to dinner. Let's see what else was there ... Orange or tangerine rinds weren't thrown out. They were placed on top of the old black iron stove. The heat would make the smell sweeten the kitchen. During the cold dry days of winter, a pan of warm water sat on the same stove and as the water evaporated, it became a humidifier. Old automobile tires were still used once they were beyond repair. Babbononno and some of the old-timers used to turn them inside out, paint them white, sink them about half way in the dirt of the back yard and grown something in the opening. Babbononno grew flowers because Nanna liked flowers. If you asked him, though, he thought flowers were useless. He would say that if you can't eat what you grow, what good

If a package came to the house and it was wrapped in twine or rope, both of those fasteners were saved, just in case. Babbononno had a tin can in the cellar with pieces of both cut to various lengths. When he planted his tomatoes, the rope and twine were used to hold the vines to the stakes stuck in the ground. Oh, by the way, the stakes were pieces of scrap wood slivered vertically. It worked.

Old pants, shoes, and sweaters were never discarded. They could be worn when making repairs or painting a room. If they got dirty, they were washed. If they became paint stained, they stayed in the closet until it was time to paint something else.

There were things that had to go, things that were classified as junk. Babbononno would wait until he heard the clip-clop of a horse coming up Eutaw Street pulling a junk wagon.

Chelsea was filled with junk yards and workers rode the wagons through the streets of Eastie yelling, "Any old rags; any old junk." Babbononno would stop them, bring out what Nanna forced him to discard and he and the driver would bargain over the price. Babbononno was happy with the money he made, but sad to see something go that he might be able to someday use again. That's the way it was.



The Run to Home Base has raised over \$15 million over the years to assist with post-traumatic stress disorder and traumatic brain injury for veterans.


Since its inception, Home Base has served more than 15,500 veterans and family members. Home Base will be establishing a national center in Boston expected to open later this

Since its inception more than a decade ago, Home Base has expanded, including the first clinical program for veterans in the nation as well as wellness programs in partnership with Benson-Henry Institute for Mind-Body Medicine, the MGH Sports Medicine Team and the Red Sox Strength and Conditioning Team.
