Here Today, Gone Tomorrow???

Massachusetts Department of Transportation (MassDOT) Secretary & CEO Richard A. Davey recently announced that MassDOT has selected Normandy Real Estate Partners as the developer of Central Artery Parcel 9, located on the Rose Fitzgerald Kennedy Greenway at North and Hanover Dtreets in Boston's emerging Market District.

Normandy's proposed development calls for a 180-room, mid-market hotel and a first-floor food market to complement the adjacent weekly Haymarket Pushcart Association produce market. Portions of the building will be founded on Central Artery tunnel structures.

"After a thorough evaluation, we believe this proposal offers the best overall benefit to the residents and businesses of Boston, the Market District and the Commonwealth," Davey said. "Along with the creation of the Boston Public

Massachusetts Departlent of Transportation isting Haymarket pushlassDOT) Secretary & CEO carts, this development will create a new and exciting mounced that MassDOT Market District."

Acting with the Governor's Public Market Commission, MassDOT has designated the Boston Public Market Association as the lessee for the ground floor of the adjacent Parcel 7 building that also houses a garage and Central Artery ventilation building. The Public Market will focus on the sale of Massachusetts grown, landed, and produced produce, fish, and other food products.

Davey complemented the BRA and an Advisory Committee of area residents and professionals for their work during the process. "We thank them for their diligence and patience," he said. "This was a tough decision, with more than one interesting proposal. We respect the community's



The Mayoral Candidate from the North End?

So many candidates for mayor — I don't know whom to vote for. I don't even know all the names! A few weeks ago I took a phone call from someone polling regarding the mayoral race. The voice on the end of the wire had some sort of accent and it certainly was not Bostonian! The woman read out the name of each candidate and asked if I had heard of the candidate and if I have an opinion. Well, as I said, there are several women and men running and some names I had barely heard before. But when she got to the name "John Cannoli" I said, "Now you're just making up names!" So she spelled it out for me. "C-O-N-N-O-L-L-Y." The joke in our home now is that John Connolly must be the candidate from the North End and we're singing "When Irish Eyes Are Italian."

No offense to Mr. Connolly intended. He appears to be qualified for the office and name! But, whoever it was, has some good ideas for the city. But this out-of-state pollster's mispronunciation got me thinking about one of the problems with electoral politics as now practiced in Boston. Aside from the question of how anyone could get a simple name like Connolly wrong, it shows what happens when politics is practiced "wholesale" rather than "retail." By retail we mean the candidate meeting voters face to face. "Wholesale" politics is the use of TV, radio, internet, telephone and other means of manipulating public opinion, rather than persuading individual voters.

Surely there are local polling companies, employing local people who would know how to pronounce an Irish name. I don't know who commissioned this poll — presumably not Mr. Connolly, as one would hope that the people working for you can at least pronounce your some candidate went with a company from out-of-state, or which "farms out" its call center to some other, lowercost region. All candidates make grand pronouncements about good jobs at good wages for Bostonians, but at least one chose to economize by using lower-paid out-of-state workers to make polling calls.

Between now and the election the voters of Boston will be deluged with phone calls on behalf of the candidates. I know, from having, in the 1990s, run for office myself, that in Cambridge, you have to have a "phone bank" to be a competitive candidate. Still, it's so impersonal. Paid out-of-state callers or even worse, recorded announcements, have, to too much a degree, taken the place of individual Bostonians calling to recommend a candidate or remind a friend

opinions and believe the faceted Market District fowork they put into this process will result in a better outcome for all."

In addition to the economic and tourism benefits the hotel will lend to the area, the Normandy proposal will result in more than \$2 million in improvements to Blackstone Street in support of the Haymarket Pushcart Association (HPA) operation, including regrading the street to simplify vendor setup, installation of water and power for use by vendors, introduction of a system of retractable vendor stall covers, creation of a fire lane through the market — all while minimizing changes to existing HPA layouts and operating patterns. In addition, the proposal will provide interior space for trash compaction, pushcart storage, HPA office space and vendor rest rooms.

"These benefits will help ensure the continued viability of this treasured Boston institution for years to come," said Davey. "None of this would have been possible without the active engagement of the BRA, the Pushcart Association, and the Advisory Committee. We look forward to continuing to work with them to shape this development through the permitting process and to realize the vision of a multicused on offering quality food to Boston area residents in a lively, active setting.

In addition to the benefits to the Pushcart Association and the Market District, the proposed 99-year lease to be negotiated with Normandy will result in rent to MassDOT with a present value of between \$7.3 and \$8.5 million, to be dedicated to transportation uses.

Normandy's designation is the culmination of an extensive proposal and selection process. The criteria used in making the decision included: the proposed land use and project design; community benefits; community and City input; and the developer's financial proposal, capacity, and experience.

Normandy's proposed development is now subject to negotiation and execution of a development agreement and lease with MassDOT, as well as standard City and state permitting.

Countdown to the Seasons

My father appeared excitedly at my house earlier today, waving a packet of facts about the feast day of his namesake saint, St. Roch - (San Rocco) in Italian. The feast of Saint Rocco falls on August 16th, my father's birthday and his naming reflects an old-Italian tradition of bestowing monikers based on the saint days. According to my father's research, (la festa di San Rocco), or Saint Rocco's Feast, is celebrated with processions and parades all across Italy. Some places have bonfires and fireworks, reminding me of the heat of summer and the fiery zodiac sign of Leo, whose personality profile of my father definitely fits. Saint Rocco is also associated with dogs and with the curing of the plague. A legend explains that after Saint Rocco contracted the plague, a dog offered him food in the forest. Since then, images of Saint Rocco frequently portray him with a dog in tow.

Saint Hyacinth, called the Apostle of the North, was born in 1185. He was born into the noble family of Odrowaczas the son of Eustachius Konski, his birth took place in the castle of Lanka at Karim in Silesia, Poland. God blessed him with a splendid mind and his parents made certain that he was well grounded in religion. in Rome that Hyacinth met Saint Dominic, greatly impressed, he along with Ceslas and two Germans joined the Order in 1220 and was one of the first to receive the habit of the newly established Friars, Preachers at the hands of Saint Dominic in the convent of Santa Sabina.

After his novitiate, he made his religious profession, and was made superior of the little band of missionaries sent to Poland to preach. On their way back to Poland, they preached the Gospel in many places and received many new members into their Order. He was of his order at Friesach in Carinthia. In Poland the new preachers were favorably received, Hyacinth founded communities at Sandomir, Cracow, and at Plocko on the Vistula in Moravia. He extended his missionary work through Prussia, Pomerania and Lithuania; then crossing the Baltic Sea, he preached in Denmark, Sweden and Norway. He came into Lower Russia, establishing a community at Lemberg and at Haletz, he then proceeded into Muscovy, and founded a convent at Dieff, and came as far as the shores of the Black Sea. He then returned to Cracow in 1231, after two years he set out again to

Ft. Hood Was Not Workplace Violence

"The evidence against me will clearly show I am the shooter. I was on the wrong side of America's war ... I switched sides." — Major Nidal Hasan

Major Nidal Hasan, a 42year-old U.S. born Muslim has decided to renounce his U.S. citizenship and has stated at his court martial that he killed 13 of his fellow soldiers at his Texas base because he wanted to defend Islam. He has gotten to keep his Muslim beard and wear apparently the uniform of the country he now seems to hate. Why is someone who calls himself a "Soldier of Allah" being tried as though he were some whacko mall shooter or a loose-hinged postal employee? The Fort Hood Massacre was as many have called nothing less than the most deadly terrorist attack on the United States since 9/11. However, calling it thus doesn't seem to go along with the president's playbook about Islamic terrorism. When you shout aloud "Allah Akbar" ("God is great" in Arabic) as you gun down 13 unarmed comrades in a packed deployment center, this is clearly not "workplace violence." It is clearly an act of a terror.

On day one of this trial, 50 people sat in a small military courtroom at Fort Hood watching proceedings which are expected to last at least a month. Major Hasan is charged with 13 counts of premeditated murder and 32 counts of attempted premeditated murder. The shooting took place on November 5, 2008 and it has taken this long to get the trial going after a series of delays. The United States government considers what happened at the Texas Army base as one of the worse acts of soldier on soldier violence in U.S. history. The military prosecutor, Col. Henricks said in court Major Hasan had two motives. He didn't want to be deployed and he "believed he possessed a jihad duty to kill as many soldiers as possible."

This Ft. Hood shooting spree by Major Hasan is one of the many scandals of the Obama administration. The shameful designation of the November 5, 2008 rampage as "workplace violence."

One of the victims, Shawn Manning, was shot six times by Hasan and was denied benefits that would accrue to a soldier injured in an act of terror or battle overseas. This "workplace violence" tag has cost him \$70,000 in additional benefits while Hasan keeps receiving paychecks that right now amount to over \$287,000. Because the U.S. Army calls the wounds of the victims non "combat related," benefits are being denied to all the victims.

President Obama needs to do right by the victims at Ft. Hood. Instead of showing up on the Jay Leno Tonight Show or taking yet another vacation to the Vineyard, he ought to be thinking about the pain and suffering still being felt by victims of Major Hasan's attack. It is time to call Fort Hood an act of terrorism because that is what it was. Just ask Major Nidal Hasan, he'll say it again if you missed him saying it the first time.

Centuries before Mozart, music has proven to be universal in uniting people across the planet. Music is timeless no matter the era or culture. Still there are fans of Mozart's Classical Music genre, which cross the generational divide as we baby boomers also love listening to the Big Band era our parents introduced us to.

While I am keenly aware that the Digital Age has ushered in the iPod to upload hundreds of songs without interruption of commercials YouTube, whereby music videos of every genre and time period can be easily downloaded by the hundreds, I prefer turning on my stereo and tuning into (via remote control, mind you) my oldies favorites from The Stylistics to Creedence Clearwater Revival to Heart to name a few.

TONY MARCHIONE

The Last American to Die in WWII

The telegram from the Army read "Killed in Action August 18, 1945". How could this be? The War was over, the Japanese were going to sign the terms of surrender on the USS Missouri. Where was the action? How did he die? These and other questions must have run through the minds of Ralph and Amelia Marchione of Pottstown, Pennsylvania, a small town about 30 miles north west of Philadelphia, concerning their 20-year-old son Anthony "Tony" Marchione, the oldest of the three children in the family and the only boy. Tony was five foot six, good-looking, black hair and brown eyes and weighed 120 pounds. He was a typical young man like all the other young men who signed up to defend their country in World War II.

In 1943, although still in high school, he wanted to sign up to be a pilot in the Army Air Force; instead he was sent for training to be an aerial gunner. In November of 1944 he was transferred to Will Rogers Army Air Force Base in Oklahoma to be trained in photo reconnaissance. Marchione along with fellow gunners Rudolph Nudo, Frank Pallone and Raymond Zech received training to become photographer's assistants and were assigned to a reconnaissance B-32 Dominator when their squadron moved to Okinawa.

The squadron's duties changed when the Japanese surrendered. The crew was now to fly photo-reconnaissance missions during the daytime to insure that the Japanese complied with the cease-fire that was in effect. The terms of the cease-fire allowed for the US planes to fly freely over Tokyo. This was also to insure that the Japanese would not use anti-aircraft fire or send fighters against the planes.

It became known that there was a possibility within the Japanese government, including the military, that due to the recent bombings of Hiroshima and Nagasaki they were ready to go along with an unconditional surrender. On August 15, 1945 Emperor Hirohito went before his nation on radio and announced his intention to surrender to the Allies. This, the military felt, was a dishonor to the country. Many of the Japanese navy fighter pilots at the nearby bases around Tokyo were capable of carrying on the fight to defend the honor of Japan. On August 17, as four B-32 reconnaissance planes made their way up the northeast coast they were attacked. The B-32s were able to fend off the attack without any injuries to the airmen but the planes sustained some minor damage. After filing their reports it was decided by US Commanders that the missions should continue in order to find out if indeed the Japanese were going to abide by the cease-fire or continue the war.

Mission 230 A-8 was to cover the same targets as the previous flight. First Lieutenant James Klein in the *Hobo Queen Il* would lead to be followed by First Lieutenant John R. Anderson in the second B-32. Flying with Anderson would be Marchione, Rupke and Joseph Lacharite, from Massachusetts. As they flew over Tokyo, down below at the Japanese airbases the fighter pilots on the ground ran to their planes to intercept the two B-32 Dominators, including two of Japans Aces, Saburo Sakai and Sadamu Komachi, between them they had shot down 100 Allied aircraft.

One of the gunners on Klein's plane saw a plane on the ground taking off and Klein turned the plane to see them coming up at them. He knew it would take a while for them to reach him since he was flying at 20,000 feet but his concern was for Anderson who was at 10,000 feet. He radioed a warning to Anderson but received no answer. Anderson's tail gunner had spotted the fighter now flying at the same altitude and he was able to shoot him down. Lacharite and Marchione were tying their camera gear when they heard the cry of incoming aircraft. Lacharite went to the starboard observation window to try to see the attacking planes and was hit in both legs. Having the presence of mind to reach for the cord from a barrack bag that carried the camera gear he tied a tourniquet around one of his legs and an intercom cord around the other while Marchione was helping him to a cot on the floor. Marchione got on the intercom and told Anderson what had happened and Anderson said he was sending Rupke. As Marchione turned to Lacharite a 20mm round came through the starboard side and hit him and threw him to the other side of the plane. When Rupke arrived Tony was bleeding with a large hole in his chest. After thirty minutes of giving him plasma and applying compressions bandages to his wound Tony Marchione was dead in Rupke's arms. The Dominators returned to base with minor damages. Anderson had lost an engine and had lost partial rudder control.

That battle was the last air battle of the war. Included in the cease-fire was a passage that required propellers be removed from all Japanese fighters. US planes were now free to fly over Japan without fear of an attack. The last air battle was overshadowed by the attention to the signing of the surrender on board the USS Missouri.

The body of Anthony "Tony" Marchione was brought back to Pottstown, Pennsylvania accompanied by his Italian-American buddies Frank Pallone and Rudy Nudo on March 18, 1949. He was buried with full military honors and was laid to rest in St. Aloysius Old Cemetery.

Albert "Al" Natale

Keeps the Music Going at 90

North End native, trumpetplayer, bandleader and philanthropist Albert Natale will celebrate his 90th birthday on Sunday, August 18th! Born in the North End in 1923, Al is the son of immigrants and youngest of 12 children. A musician all his life, he was first introduced to music by a kind teacher when he was attending St. Anthony's School.

"What happened was when I was 12, I was attending St. Anthony's School and we got called to the assembly hall. So we marched down to the hall and the school's music teacher, Mr. Trangone, decided what instrument to give to each of us. They were organizing a drum corps and the year I think was 1936. Mr. Trangone handed me a bugle. I picked it up and tried it and a hell of a good note came out! He liked it a lot

and I guess I did pretty good with it since the following year I was promoted to the senior band and was then presented with a trumpet. I found out that I could do so much more with the trumpet than with the bugle. It was fascinating to me to see how much I could do. In the 1930s every high school had a band and the band would play every morning just to start the school session. It was great and it's a shame it's not happening today like it was then, says Al.

"Then my dad decided I should take private lessons so he sent me to Ralph Fucillo, the principal trumpet player for all the vaudeville shows at the

old RKO Theatre located at 616 Washington Street in downtown Boston. Under Fucillo's leadership, I began to work with the RKO Theatre Orchestra for many of the acts appearing at the RKO. Then the theater management decided to bring in the 'big name' bands of the '40s — like Benny Goodman, The Dorsey Brothers and Glenn Miller — and I was very grateful that I had learned ear-training from my father who was primarily a barber but who also played clarinet and guitar. That way I was able to sight-read the music and fill in for the traveling bands when they needed a substitute from time to time."

"I'd just go up and play the shows sight-reading! I liked the idea of going on the road with bands, so I auditioned for the Bob Chester Orchestra and joined that band in Philadelphia. This was a whole new experience! One time we played at the Atlantic City Steel Pier Ballroom alternative dance sets with the world-famous Harry James Orchestra! I was thrilled to watch this great band three times a night for three whole weeks with over 800 people in attendance nightly.'

"A few years later when I was 21, I joined the Jerry Wald Orchestra at the Paramount Theatre in New York City where things were really happening and together we traveled to

various theaters around the U.S. playing The Liberace Show, The Three Stooges, Dick Haymes, Margaret Whiting and others. I used to play poker with the Stooges backstage; they were a riot but not as funny as in their movies since their backstage jokes were not accompanied by sound effects!"

"When I decided I'd had enough of the road — a grueling experience on not very comfortable buses and trains, I came back to Boston and worked with society orchestras like Ruby Newman and Harry Marchand. To do all this, I had to know thousands of tunes, what keys they were in and how to improvise. We had to keep playing long segues and modulate easily from one tune to another. Then I started my own band.

I auditioned some young musicians for my six-piece group and discovered a great 16year-old key-boardist whose name Chick Corea. We snagged a super gig at the Mayfair, a big show club with a dance floor and a roof that would roll open on warm summer nights! It was locateda on Arlington Street not far from the Statler Hotel [today the Park Plaza] and the Latin Quarter. Both clubs were owned by the infamous Boston bookmaker and nightclub owner Harry "Doc" Sagansky. There, we worked alongside big acts like Cab Calloway. Julius LaRosa and many others."

"Blinstrub's Village

for one or two years providing music for the comedians. Guys like Henny Youngman, Flip Wilson and George Carlin launched their careers there!"

"In 1962 trumpeter Herb Alpert scored huge radio hits utilizing Mexico's mariachi sounds when he created his Tijuana Brass Band. I picked up that musical thread and was able to match this sexy new sound with my own Boston 'Tijuana' band and we were hot, hot, hot! We were honored to play the inaugural ball for Mayor Kevin White."

in South Boston was another huge club that featured all the biggest stars. I filled in with the band there and got to accompany singers like Johnny Mathis, Sammy Davis, Jr., Paul Anka, Pat Boone, and Vic Damone."

"Boston in the 1950s was also loaded with nightclubs and restaurants that hired groups to perform for the dinner crowds. We had The Ken Club, Wally's, The Savoy, The Businessmen's Lounge. The Stables was created by three well-known jazz guys — trumpet player Herb Pomeroy, tenor saxophonist Varty Hart and pianist Ray Santisi."

Paul's Mall downstairs across from The Stables with my group. The theme of Paul's Mall was that this downstairs two-roomed club was like an 'underground penthouse.' It was unique. I worked there every night

"In the early '70s I was elected as Vice President of the Boston Musicians Union — something I wanted to do so that I would be able to help the young musicians get proper remuneration for their work. One of the greatest moments of my entire career was meeting Frank Sinatra in 1981 and presenting him with an honorary life membership to the Local 9-535 American Federation of Musicians Union."

"While working at the Frolics Club in Revere, Massachusetts I played for the Jerry Vale Show and a week later I played for "I was booked to play at Connie Frances during her first New England appearance when she was just 16 years old."

Local North End resident Lauren Coulson currently has a painting on display. Here is a little insight on the painting from the artist herself. A cosmological and topographical world was created by the layered accumulation of pours, stains and diverse mark-making techniques. Spontaneity and control exercise the form that the painting took on and the world that was created is at once violent and destructive yet delicate and beautiful. There is a knotting and cross-pollination of harmonious opposites within the work that include splendor and disaster, ecstasy and havoc, constructing and deconstructing, transcendence and decay, these are all facets of the internal organization for the painting. Sources of motivation are drawn from the cosmos, natural phenomena (geological, meteorological and oceanographic), chemistry, geology, gravity and chance. By working large-scale, the work can powerfully envelop the viewer into the world that is created. The process I start with is alive and visually changing form by the slow reactions of pigment that hold various chemical makeups and the mixing of pigments with different viscosity levels. Once dry, I assist with the aftermath: the settlement of the pigment: the soot of what once was alive and changing. By working on the floor initially and letting gravity take its role on the paint, gravity becomes essential to each painting being formed. The painting works with the topography of the medium itself and forms a mesmerizing, sensual and forceful yet radiant aftermath. Infinity was created with the co-existence of multiple painting languages as well as tying in a sense of graffiti and comments on the interconnectedness of everything we are familiar

Are you awake? A New Jersey judge ruled that casino waitresses are "sex objects" who can be fired for gaining weight. Waitresses in the Borgata Hotel's "Babe" program sued over a rule requiring them to stay close to their hiring weight. But Judge Nelson Johnson said any woman hired as a "Babe" had voluntarily agreed to become a "sex object to the Bogata's patrons."

An aspiring British pinup model who received a \$7,400 taxpayer-funded breast enlargement is suing the country's National Health Service, claiming her new boobs are too big. Josie Cunningham, 23, underwent surgery earlier this year after convincing a doctor that her flat chest was causing her emotional distress. But Cunningham now says the 36DD implants have turned her into a joke. "They're so big I find them embarrassing and I don't feel I can do any modeling, "she said. Cunningham is demanding \$15,000 in compensation for emotional distress.

A stinking joke! A practical joker unleashed a noxious combination of deer repellent and fart spray into two cabins at a Bible camp in Maryland. Six campers were hospitalized and a local Hazmat team was summoned "to help dissipate the strong odor."

News from Washington, D.C. The FBI cracked down on child prostitution rings in 76 cities across the U.S., arresting 150 men and rescuing 105 children and teens over the course of three days. Most of the victims involved were between 13 and 17 years old, and came from either foster care homes or were considered runaways. Authorities said the youngest victim was 9 years old. Investigators targeted underage prostitutes who sought customers on-line or at places like casinos and truck stops and then used them to track down their pimps. The rescued victims will now be placed in foster or group homes. Child sex trafficking remains "one of the most prevalent, violent and unconscionable crimes in our country," said Ronald Hosko, assistant director of the FBI's Criminal Investigation Division.

San Diego Mayor Bob Filner has announced that he will undergo two weeks of "intensive therapy" at a behavioral counseling clinic, amid multiple accusations of sexual harassment and growing calls for his resignation. "The behavior I have engaged in over many years is wrong," said Filner at a press conference, admitting that he'd been disrespectful and intimidating toward women but denying charges of sexual harassment. "I must become a better person," he added. Eight women have identified themselves as victims of Filner's unwanted advances, which included groping, demands for kisses while he put them in headlocks, and request that they not wear panties to work. Filner's former communications director. Irene McCormack Jackson, has filed a sexual-harassment lawsuit. The San Diego City Council voted unanimously to sue Filner to recover any costs if he is found liable in the lawsuit.

They found that those who regularly skipped breakfast were nearly 30 percent more likely to have a heart attack or to die from heart disease in that period than those who didn't regardless of whether they exercised, smoked or overate. Researchers say skipping breakfast may stress the body in ways that raise blood pressure and the likelihood of diabetes; they say eating erratically can throw circadian rhythms out of whack, making our bodies less efficient at processing food and increasing the risk of obesity and heart disease. Previous research has shown that people who eat late at night have a 55 percent higher risk of heart disease. "Eat in the morning when you wake up, preferably within an hour," study author Leah Cahill tells BBCNEWS.com.

MUSTARD GREENS FRITTATA

(Omelet)

20 ounces frozen chopped mustard greens *

1 cup flavored bread crumbs 3 tablespoons grated Romano or preferred

cheese

- 2 medium minced garlic
- $\frac{1}{2}$ cup canola, vegetable or olive oil
- 2 beaten eggs Salt

Defrost chopped mustard greens in the microwave according to directions on the package or in a saucepan on your stove. Drain liquid and place mustard greens in a bowl. Add bread crumbs, cheese, minced garlic and two slightly beaten eggs. Salt to taste and mix thoroughly.

Add oil to a skillet and heat. Test a teaspoon of mixture in heated oil. When mixture sizzles, place the remaining mixture into the skillet. Oil should remain hot so that the mixture will brown but not burn. Add more oil as needed. With a spatula or fork, turn small portions at a time, careful not to burn. Continue frying and turning until the contents have mostly browned, about fifteen minutes. Then carefully slide contents onto a platter. Return the mixture face down into the skillet. Lower heat slightly and allow mixture to brown on that side. Then slide the contents back onto a serving platter. To remove excess oil, slide frittata carefully from platter onto two paper dishes. Repeat for the other side. Wipe oil from platter before returning frittata to a serving platter.

*FOR FRESH MUSTARD GREEN: Clean, cut, and steam them. What is not used that day can be frozen in a container for the next frittata.

OPTIONAL: Because of the tartness of the mustard greens try substituting ten ounces of chopped spinach for ten ounces of mustard greens, equaling the twenty ounces needed for this recipe. Try it both ways.

NOTE: My children request this frittata often but for them I use the combination of spinach and mustard greens.

My love for this vegetable frittata began when my parents grew mustard greens in their Wilmington, MA vegetable garden. Each summer, as Mama harvested them, she prepared this frittata for our lunch. I enjoyed my portion between two slices of Papa's scala bread.



A Nostalgic Remembrance

Last week, I was talking about a trip to the Dominican Republic. I didn't recognize much as the capital city, the small towns and the roads to get to and fro had changed. Everything was modern, new buildings, new developments, modern multi-lane highways and billboards with David Ortiz in his Red Sox uniform and other Dominican ball players in the majors advertising things Dominican.

The first time I landed in the Dominican Republic things were different, accidental and almost fatal. In the spring of 1966, I headed for Puerto Rico for a week to study Spanish through "Finch College of New York." I found an ad in a magazine for the airfare from New York, an entire week's stay at the Puerto Rico Sheraton, participation in the Spanish course and a few other amenities for \$299. I showed the article to Babbononno and he wanted to go with me. Of course he couldn't. He was in his 90s and in need of assistance at every turn. I told Sal Meli about the package and he jumped at it. Sal and I grew up together in East Boston and since around 1960, had been traveling around the world together.

The 4th of July weekend was when we headed for New York and a San Juan bound flight. Many of the passengers were part of the Finch College group and we made fast friends with the people we would be living and studying with. The flight was uneventful and we checked in at the Sheraton close to dinner time. Later that evening, we checked out the lounge and the main show room. There was a Jamaican folk singer in the lounge and a show band in the main room. I introduced myself to the band leader of the show band his name was Keith Phillips from Nashville. Sal told Keith that I was a bass player of note from Boston and they asked me to sit in for the next show. I knew the tunes that they played during the over the Dominican Repubshow and it was fun. After we lie the headwinds were so finished, Keith asked if I was strong, the fuel gages rapidly available for the summer. It seems that his bass player was having domestic problems and wanted to go home to straighten them out. I only had occasional bookings during that summer, knew I could get a substitute to cover me and said yes to Keith. This meant that I

the summer and get paid for

I'll tell the story of my stay in Puerto Rico at a later date, but I want to get back to the happenings in Dominican Republic. Part way through the summer, we were told to take a week off with pay. A Latin group, famous on the island, was coming in for that period of time. The Jamaican folk singer told us that there was a blind Latin folk singer named Jose Feliciano who would be playing in the side lounge at the same time we had the week off and the Jamaican was told the same thing ... don't work, but get paid. The next day, at breakfast, the folk singer told us that his brother was flying in to pick him up to go island hopping. His brother had his own small plane and flew tourists throughout the Caribbean to their island destinations. He asked if any of us would like to go island hopping for the week. We would share the cost of the fuel and landing fees equally and probably see some of the islands we had never been to. Sal and I were the only ones interested and we awaited the arrival of the singer's brother.

We, for the next few days, did exactly that, island hopped. We didn't listen to a radio, watch TV nor look at a newspaper. We just flew from island to island. When we returned to San Juan, there was a message for the pilot from a friend in Port-o-Prince, Haiti. He was invited to a party. He responded to the message, asked us if we would like to attend and logged a flight plan once we said yes and it was off to

The island of Hispaniola is divided into two countries. Haiti occupies the western 1/3 of the island and the Dominican Republic the other 2/3s. To fly to Haiti, we had to fly over the Dominican Republic. The pilot logged in the flight plan and we headed west from Puerto Rico into Dominican airspace. Once headed toward empty. As a result, the pilot contacted the control tower in Santo Domingo to ask for landing instructions. An American voice responded with a thick southern accent and told us we couldn't land. The pilot, with his Jamaican accent, told him that we had to land

could stay in Puerto Rico for or crash due to the fuel problem. There was a pause and another American voice (northern accent) came on and told us to lower our landing gear and wait for a fighter escort. Within a minute, two World War II P51 Mustangs with Dominican insignias on their wings came out of the sun and were at each of our wings. We were given landing instructions and didn't dare do anything out of the ordinary as each of those P51s had eight wing mounted 50 caliber machine guns that could have converted us into a cloud within seconds.


> Once on the ground, we were told where to stop and once we did, a Jeep came out of a hangar with a uniformed Dominican soldier behind the wheel and an American Marine major next to him. When I heard the major's voice, I recognized it as the southern accent we had heard when we called the control tower. He looked over our flight plan, checked our credentials and chewed us out for what we did. The Jamaicans were scared to death, but being an American, I wasn't going to be intimidated. The major called someone on a walkie-talkie and soon another Jeep arrived, this time with a marine colonel in the front seat. He turned out to be the man with the northern accent. He also checked our credentials and flight plan and then asked us if we knew what we had done. I did the talking again, saying we were island hopping for a few days and didn't know what was going on. He believed me and bluntly said, "You flew into a revolution. We were called in from the naval base at Key West to help out and that's what we're doing." As I said, the colonel believed us.

> We were refueled, compliments of the United States Marine Corps. We were taken into a hangar and fed sandwiches and coffee, compliments of the United States Marine Corps. When we left, we were given a fighter escort (same two planes) to the Haitian border compliments of the United States Marine Corps. I don't remember anything about our stay in Haiti, but when we left, we flew back to Puerto Rico over open water, not over Dominican air space. It was a longer trip, but a heck of a lot safer.

Once back at the Sheraton, everyone was worried because the story of the Dominican revolution was everywhere on the news. Well, the pilot headed back to Jamaica, his brother went back to the lounge next to the hotel's main show room and I stayed for the summer playing with the Keith Phillips Orchestra in that show room and had a story about our ordeal to tell to anyone who was willing to listen, especially my father and Babbononno.

I figli di madri bilingue preferiscono le lingue materne alle altre, ma sono anche capaci di capire che sono diverse tra loro. Lo ha scoperto un gruppo di ricercatori dell'Universita' della British Columbia, Canada. La capacita' di usare i suoni ritmici per distinguere tra le varie lingue non e' l'unica sviluppata dai neonati, che quando crescono usano diversi tipi di percezione per imparare le lingue e tenerle separate. In uno studio condotto su bambini un po' piu' grandi, in cui gli si mostravano video muti con adulti che parlavano, si e' visto che i bambini di soli quattro mesi sapevano distinguere tra le lingue guardando le labbra ed il movimento della faccia, e osservavano con interesse quando la lingua cambiava. A 8 mesi i bambini monolingue non sono capaci di farlo, ma quelli bilingue, si. I bambini che imparano a parlare piu' lingue dalla nascita sviluppano capacita' cruciuali grazie al loro doppio vocabolario, sviluppando modi diversi per risolvere problemi logici e gestire piu' cose insieme. In breve i bambini bilingue, fin dall'inizio hanno uno sviluppo precoce delle funzioni 'esecutive', e sono piu' flessibili, a livello cognitivo, di quelli monolingue.

DID YOU KNOW THAT ...

Learning languages begins while developing inside the womb, thanks to a 'cadence.' In fact, the newborns acquire the ability by listening to the sounds and to the cadence of languages spoken by their parents. They use this quality the moment they are born, selecting the idioms that sound similar by their cadence to those heard during the pregnancy. The children of bilingual mothers prefer the mother's language to any other, but they are also capable to discern their differences. A team of researchers at the University of British Columbia have discovered all that. The ability to use rhythmical sounds to distinguish between the various languages is not the only one developed by the newborn, who while growing up uses a variety of perceptions to learn the languages and keep them apart. In a study conducted on children a little older, when soundless videos were shown to them with talking adults, they noticed that children, barely four-months old, could distinguish the languages by watching the lips and the face's motions and with lively interest paid attention when the spoken language changed. At the age of eight-months, the monolingual children were unable to do it, but those of bilingual parents were.

Children who learn to speak more than one language right from birth, develop crucial skills, thanks to a double vocabulary, developing different ways to solve logical problems and manage different things at the same time. In closing, bilingual children follow a precocious growth from the start of 'executive' functions, show more 'flexibility,' on a cognitive level than the monolingual kids.

Matt Batts Caught for Sox in '49 Pennant Race



Back when I was born, baseball was still baseball. Most players were connected to the fans in the stands and those outside the park waiting for autographs. No one thought of selling their autographs and enjoyed the mere fact somebody wanted theirs. Matt Batts was one of those baseball characters. During his 10-year career, he played for the Red Sox from 1947 to 1951 and ended up being a resource for David Halberstam's Summer of '49, which chronicled the AL race for the pennant between the Sox and Yankees which went down to the season's final weekend. This was a great baseball book, which I have read and re-read from time to time. It is such an easy read and is difficult not to keep reading it page after page. Matt Batts remained close to Ted Williams, Johnny Pesky, Mel Parnell and Dave Ferriss long after their playing careers had ended. Batts passed away July 14th at age 91. He was a .269 lifetime hitter who was adept at throwing opposing batters off their game by messing with their concentration at the plate.

His daughter Denise Claflin said of her father, "He lived a fun life and wanted those around him to enjoy it as well."

Batts came up to the Red Sox in late 1947, hitting .500 with eight hits in 16 at-bats. He hit .314 in 46 in 1948 Indians in a one-game playoff for the pennant. He hit .242 in 1949 and .273 in 1950 as a backup player. He was traded to the St. Louis Browns in 1951 and ended up catching for the great Satchel Paige. The following year, it was off to the Tigers. He started 116 games and batted .278. He was remembered at Fenway Park this past July 20th at a memorial


service one week after his death. His daughter said he always saw himself as a "Red Sox" and enjoyed his Boston years. His nephew, by the way, Danny Heep also played for the Sox back in 1989-90.

HOOPS and HOCKEY in the HUB

He went from Down East to Down Under. Then it was on to the Lone Star State. And now the City of Brotherly Love beckons. And squeezed in among all of those moves was his four-year playing career at Boston University.

Yes, for a basketball person Brett Brown certainly has done his share of traveling over the years. Not during games, mind you, but getting to them — especially when they involved him in a coaching capacity.

And now he gets to fully display his acumen on basketball's grandest stage the NBA — as he takes over the reins of the Philadelphia 76ers from Doug Collins, who resigned this past spring following a 34-48 finish. Brown has been in the NBA for a while, of course, but always in the background as an assistant coach with the San Antonio Spurs.

It's the culmination of a journey, it really is. But when you exam it in totality maybe, just maybe, Brett Brown was destined to reach the pinnacle of his profession, even though he would be 52 by the time he would be called an NBA head coach.

He grew up in South Portland, Maine in a state better known for its outstanding college hockey team the University of Maine Black Bears — than other aspects of athletics.

But his father just happened to be the longtime head basketball coach at South Portland High. And it was there that Brett, while playing point guard, led the team to an undefeated 20-0 season and the Class A State Championship in 1978-1979.

From there it was on to the Big City to the south — Boston — where another young man was also seeking to make a name for himself in the Hub. That would be Rick Pitino, who had just nailed down his first head coaching job, leading the basketball version of the Boston University Terriers in a venue usually associated with excellence in college hockey.

It wouldn't take long for Brown to make his mark, earning team MVP honors by the end of his sophomore season and then leading the Terriers to their first NCAA March Madness appearance in 24 years in 1983. It was the capstone achievement of his senior season.

But there was always a bit

of wanderlust in Brett. In the years following his graduation he traveled around the South Pacific, eventually meeting his future wife Anna and finding a coaching job in Australia.

He would remain there for the next 14 years, far from the rocky Maine coast of his youth but at home with the game that he loved. Hired by the Melbourne Giants of the Australian National Basketball League in 1993, he was named coach of the year the following season after leading the team to the league championship.

He went on to serve as an assistant coach for the Australian Olympic Team at the 1996 Atlanta Games. He did the same for the 2000 Games in Sydney and was named the head coach of the Australian squad that finished seventh at the 2012 London Games.

In between there was the U.S., the NBA and the San Antonio Spurs. He became a volunteer assistant with the Spurs for the 1998-1999 season, a year that they went all the way and claimed their first NBA Championship. He rejoined the team in 2002 as an assistant coach and director of player development and was moved to a full-time assistant position starting with the 2006-2007 season. The Spurs have won four NBA titles and Brown has been involved in some way with each of them.

In fact, he was in line for a promotion for the coming 2013-2014 campaign if he hadn't gone to the 76ers, destined to become the top assistant for the Spurs when training camp opens next month.

But he had his eye on a head coaching job. When the top spot at the Celtics became open in the late spring, Brown was one of a number of coaches and former players who stated openly in the media that they would like to be considered.

As we all know it wasn't to be as GM Danny Ainge conducted a search away from the media glare and came up with Butler University coach Brad Stevens

And like Brad Stevens, who received a six-year guaranteed contract with the Celtics, fellow rookie NBA head coach Brett Brown also has his guaranteed — for four years. Like Stevens, he takes over a team that is in a rebuilding phase, having
