## **Building a Better T:**

### Accelerated Schedule for System Upgrades, Cuts Project Timelines

The MBTA recently announced several planned system upgrade construction projects will be accelerated, shortening some timelines by as much as eleven months for certain projects. System upgrade work to improve reliability for riders on the Green, Red, and Orange Lines that was previously scheduled to take place only during limited overnight hours will now take place during entire weekends, requiring shuttle service around certain stations.

The accelerated work plans approved by the Fiscal and Management Control Board will deliver benefits to riders significantly faster and allow T crews to undertake multiple projects at the same time as opposed to performing projects one after the other during the limited overnight hours.

In June, the Baker-Polito Administration announced as part of the \$8 billion, five-year plan to modernize the MBTA, transportation officials would speed up planned work to improve the system faster. MBTA officials also announced

they plan to undertake additional acceleration plans in the near future.

"Riders deserve a reliable, safe transportation system and while we understand this accelerated plan will be inconvenient for some riders, we believe these temporary diversions are necessary to improve the system that has been neglected for decades," said Governor Charlie Baker. "The MBTA will continue to evaluate upcoming planned projects for this fall and next year for additional opportunities to accelerate work where possible."

"We know that diversions in service are an inconvenience in the short term, but these shutdowns will allow us to quicken the pace of investments in the system more efficiently and effectively," said MBTA General Manager Steve Poftak. "We've heard loud and clear that we need to accelerate the pace of improvements. This is an especially important opportunity for the MBTA to replace track in areas that aren't accessible to

work crews without these shut-

downs. We're taking a holistic approach in getting as much work done as possible, and we're hopeful that customers will see and feel these incremental advances in reliability and the customer experience."

### ACCELERATED PROJECTS:

**Green Line Intersection Upgrades:** The MBTA is making 30 intersection upgrades on the B and C branches to mitigate the risk of service interruptions by replacing aged track.

The acceleration plan condenses planned work by five months, by increasing the number of weekend diversions from 10 to 14 on these branches.

This will help complete the project by December 2019 instead of May 2020.

The T will now also replace 7,000 feet of track during the planned weekend diversions.

Green Line D branch shutdowns are already scheduled for the weekends of September 14-15, September 21-22, September 28-29, October 5-6, October 12-13, October 26-27,

This week we continue with our coverage of the scholars in the Augustan period of the Golden Age of Latin literati, and Quintus Horatius Flaccus is our celebrity. His popular name was Horace and he was born about 65 BC on a farm in a rural area of Italy called Venusia. At the age of 11 or 12, he was taken to Rome where he was educated under a celebrated teacher, and later at the age of 17, he was sent to Athens in order to further his education and poetic interests. Soon after his return to Rome, he declined an offer to become a private secretary to Emperor Augustus because it meant giving up his independence. He started writing poetry and attracted the attention of a wealthy Roman named Maecenas who soon became his patron.

Through the benevolence of his newly acquired patron, Horace came into the possession of a farm and was relieved of any financial responsibilities. He also became very high in the favor of Augustus, was courted by the best of families of Rome, and enjoyed the friendship of other poets like Evergil, Tibullus, and Varius.

Horace died at the age of 58, in the year 8 BC, only a few weeks after the death of his patron. During his fruitful years, he preferred the country life to urban living, and this is

were written late in his career and were also in hexameter. In these letters, he attempted to become a social and literary critic with respect to Roman life

at that time. From an early date, Horace's work has been used in Roman schools as a textbook. The "magister" (teacher) would first read a passage and then make the class repeat it. The passage was then thoroughly thrashed out as to its meter, geography, history, and ethics. Students were also required to memorize much of his work.

Horace has long been ranked as one of the great Roman poets who, incidentally, became the poet laureate of Rome after the death of Vergil.

### Study Calls for Easing MBTA Procurement Restrictions and Beefing Up Project Management Capacity

This year marks the 70th anniversary of the debut of the song "M.T.A.", the sad tale of Charlie, stuck on a Boston Metropolitan Transit Authority subway train. It was the campaign song of mayoral candidate Walter A. O'Brien. Seventy years later, and now named the MBTA, public transportation in Boston continues to vex both riders and the public officials in charge.

According to a new study published by Pioneer Institute, the Massachusetts Legislature must free the MBTA from overly restrictive procurement methods and the T must dramatically increase its project and contract management capacity if it is to reach aggressive capital spending targets aimed at upgrading the system and accommodating more riders.

"The MBTA will need to change the way it does business and the Legislature will have to remove unnecessary restrictions if the T is to modernize and consistently provide riders with high-quality service over time," said Greg Sullivan, who co-authored the report with Ian Ollis.

MBTA heavy rail (Blue, Orange and Red Lines) ridership plateaued around 2014, when it effectively reached rush-hour capacity, and has since been falling relative to population growth. Red and Orange Line modernization plans would change that, with signal upgrades and new trains that would increase capacity on the Red Line by half and on the Orange Line by 40 percent.

But the project has been beset by delays. Orange Line trains expected to enter service this summer were scheduled to be in use last year; none of the modernization plan's big-ticket items are complete; and a new MBTA fare collection system is delayed indefinitely.

According to the Pioneer Institute report, among the causes of the delay are overly restrictive procurement practices. For example, on sub-contracts worth more than \$100,000 that are part of contracts over \$10 million, the MBTA is subject to the so-called filed sub-bid law. Under the law, the Division of Capital Asset Management and Maintenance pre-qualifies subcontractors, then the T must do so again. After sub-contractors submit their bids, general contractors submit their own bids, together with their choice of which sub-contractor they plan to use. If there are fewer than three pre-qualified subcontractors, the process must start over. Unhappy subs can also appeal to the Attorney General's bid protest unit.

The MBTA is the only U.S. transit system that operates under these rules, which discourage subcontractors from bidding, delay procurement, and drive up prices. The Pioneer Institute report urges the Legislature to exempt the T from this procedure, as it has for several other state agencies, and instead allow it to use any procurement procedure the Federal Transit Administration has identified as a best practice.





### **REMEMBERING CAPTIAN RAY BONO**

The North End's Last Commerical Fisherman

Back in the day, the North End's waterfront looked far different than what it looks like today. It was once a bustling port for the commercial fishing industry. Roughly 100 boats lined Packet's Pier, Lincoln Wharf, Lewis Wharf and Union Wharf. No tourists in sight. Just fishermen, dock workers and fish factory workers would be seen throughout the area. The fisherman were mainly Sicilian immigrants from the town of Sciacca such as my Paternal Grandfather Captain Raimondo Bono along with their decedents such as his grandson (my cousin) Captain Ray Bono. Ray learned to navigate the

vessel from his Father Captain Vincenzo. These techniques were passed down through generations. This past May Captain Ray sadly passed away at the age of 83. His passing marks the last North End commercial fisherman of which there was many. They lived in the same area of the North End occupying the tenements on North Street, Fleet Street, Clark Street, and Lewis Street. This area was certainly a "Little Sciacca."

I was privileged to accompany my cousin Ray on one of his fishing trips back in the '80s. It was an amazing experience and one I shall never forget. Ray and his

crew worked so hard in such dangerous weather conditions. It was so easy to see why they had so much faith in the Madonna to guide them in the rough seas. Witnessing this first hand makes one appreciate what it takes for all of us who enjoy eating the fruits of the sea. Captain Ray was a lifelong fisherman until he retired in the early '90s and a lifelong member of the Madonna Del Soccorso Society which sponsors the annual Fisherman's Feast of the North End.

We remember Captain Ray on this the week of Fisherman's Feast.

### L'Anno Bello: A Year in Italian Folklore

Enjoying the Dance of the Seasons

The photos begin to inundate social media around this time of year: coffee ships advertising their wares with well-lit shots of cardboard cups stacked high with a frothy cloud of whipped cream and sprinkled with the reddish glitter of cinnamon, surrounded by the seasonal trappings of orange gourds. After all, the end of August means a plethora of announcements concerning the release dates of pumpkin spice lattes, the ne plus ultra of spicy fall drinks for java lovers. Pumpkin season is still fairly far-off, but these ads serve as yet another reminder that autumn, my favorite season, was quickly approaching. Indeed, I have lately been paying attention to the signs of the changing season all around me, from the prevalence of apples in the supermarket to the ever-soslight hues of red and orange appearing on some leaves. When the days get too humid and sticky - which I am fine with at the beginning of summer but find unbearable when crafting lesson plans or setting up my classroom for the next school year - I think of the harvest decorations I continually see in stores, and shiver with excitement over the crisp days of fall. Observing the signs of the changing seasons not only helps me live in the moment by concentrating on the natural phenomena currently unfolding around me, but it links me in a powerful way to the actions and lives of my ancestors.

Tracking the seasons has been a passion of mine long before I started this column. While clearing out a drawer in my old room, my mother found an old notebook of mine in which I had been charting the natural signs of the changing seasons. For the shift from summer to autumn, I wrote about witnessing my uncle and grandmother planting the bulbs of a daisy, called a margherita in Italian, which would bloom in late September. I mentioned a gnarled tree whose leaves always turned a kaleidoscope of yellow and red a month early and floated to the ground well before the calendar turned to autumn. Baking an apple desert, cool mornings, the color of the early twilight — all of these observations made it into that little notebook. Doing so helped me become a better observer of nature and of the excitement of life around me, and I hope to resume this sort of project again soon. Noticing and recording

the shifting tide of the seasons actually has a scientific name. It is known as phenology, and naturalists often encourage people to sketch or write down their observations and then submit them in order to help scientists track climate data. Therefore, this hobby is both romantic and functional!

This pastime is apparently quite timeless as well. Our ancestors have been discerning the seasonal changes since time immemorial — not because they were eager for pumpkin spice lattes or photographing falling leaves, but rather because they operated in a primarily agricultural society where determining the right time to plant or harvest crops was invaluable to the survival of the community. In Italy, August functions as the month of the grain and hay harvest, and tightly rolled bundles of hay baking under the sun serve as one of the surest signs that autumn will soon descend upon the lovely Italian countryside. Italian farmers also examine their grapes during this month, ensuring they are getting the right amount of sunshine, water and shade to make them perfect for the vendemmia, or harvest, in September. After all, grapes stand as an important cultural symbol in Italy, for the grapes gathered in September will be processed into wine in November, ready to serve as the steadfast staple of Italian hospitality during the holidays and beyond. Finally, Italian farmers of yore frequently used saints' days as milestones for seasonal changes, a trait which is reflected in the proverbs still ubiquitous in Italian society to this day. August 24th is St. Bartholomew's Day, and the Italians repeat a proverb which declares: "A San Bartolomeo montaana mia bella ti abbandono." Translated, this dictum says that one should abandon

the beautiful mountains after the Feast of St. Bartholomew, perhaps a reference to the cooler weather and the end of the vacation period. When we notice even the simplest transitions from one season to another, therefore, we are actually repeating the actions our forebears performed in order to carve out a living from the

As the bright days of summer give way to the cool nights of fall, I encourage everyone to keep track of the unfolding seasonal changes. These transitions do not have to be major, as even the tiniest details like a sip of apple cider or a yellow school bus can signal the start of an exciting new season. Let us become seasonal detectives, paying close attention to the evidence of nature's eternal cycle. By doing this, we become closely attuned to the Mother Earth which has nourished us and our ancestors for so long, and we learn to live in the moment by understanding the natural beauty of the here and now. If we welcome every season with optimism and a healthy dose of respect, then the bounty of the Earth will love us in kind, no matter which latte we drink!

### "Methadone Mile"

Problem: Decades in the Making Can End When it Gets Challenged

Recently, the Boston Herald has been reporting on the troubled area near Boston Medical Center nicknamed the "Methadone Mile." The recent uptick bringing this site back into the news was an attack on a corrections officer going to work at the South Bay facility. However, the issue of the homeless, drug addicts, drug dealers, and the mentally ill has been 50 years in the making.

It all began as a positive strategy in dealing with drug addiction when the first methadone clinic opened in the basement of the Boston City Hospital Out-patient building across from Worcester Square in the South End. It eventually had to be moved over protests from the Worcester Square community and it was re-located over on Frontage Road away from any neighborhood.

Over the years, with or without Long Island as an escape hatch, the drug addicted community grew adding the homeless and mentally ill until it was so visible it became known as "Methadone Mile." Politicians over the years have talked about doing something but mostly it is just sprouting before a TV camera.

Nearby neighborhoods have been complaining for decades to little avail. When the City most recently did something, the choir of critics couldn't wait to attack. Why did the police take wheelchairs away from the homeless? Why did the police arrest so many? Why did the police make a clean sweep of the area? On and on the critics

Something has to be done about this area where addicts just roam day and night making the area unsafe for others and unsafe for those who roam themselves. I was also appalled to hear that Suffolk County D.A. Rachael Rollins herself criticized the police for its latest action

Perhaps instead of becoming the voice of those who call "Methadone Mile" home, she should be offering solutions to this issue rather than slamming the Boston Police Department for doing what it could to make the area safer for all. It is easy to criticize, much harder to offer solutions.

This past Sunday morning, I was over in the South End getting breakfast at Mike's City Diner and as I was passing through the green lawn in front of the Moakley Building at BMC, I noticed a number of homeless smoking and drinking beer right across the street from Worcester Square. Then, I saw a BUMC Police Officer head in their direction. They all got up and left the area. I call this good policing; stopping a problem before it starts. I am sure "Methadone Mile" began with a handful of folks that only grew when they went unchallenged.

It won't be easy or quick for a problem five decades in the making but you have to start somewhere.

### **RAY FLYNN**

A Tribute to Former Mayor of Boston and Former Ambassador to the Holy See. on the Occasion of His 80<sup>™</sup> Birthday

July 22<sup>nd</sup>, in the Curley Room at Boston City Hall, former Mayor of Boston (and former Ambassador to the Holy See) Ray Flynn was given a fitting tribute for his many years of service to the people of the City of Boston. Flynn served as mayor from 1984 through 1993 when he was named by President Bill Clinton to represent the nation as Ambassador to the Holy See. He served in this capacity until 1997.

Not only was Flynn surrounded by many of those who have served and those who still are serving in government but many in attendance were members of Flynn's own family, including Flynn's wife Cathy and son, current Boston City Councilor Ed Flynn who represents District 2 in South Boston (a position Flynn himself held from 1978 to 1984.) And, the former mayor's other children as well as grandchildren were present too.

The acknowledgment of the 52<sup>nd</sup> Mayor' many contributions to the City was well deserved; extending over many years, issues were addressed and solutions ensued. In Flynn's tenure, for example Boston Medical Center - formerly Boston City Hospital, was expanded - and quite appropriate given that Flynn was recognized for his numerous accomplishments in the room named after Mayor James M. Curley, who, like Flynn, also expanded Boston City Hospital during the nation's Great Depression in the 1930s.

As the Proclamation from the City and signed by Mayor Martin J. Walsh indicates, gratitude is offered for the years to the community; not only for the larger, city wide community with respect to such salient issues as job opportunities, affordable housing and economic and justice efforts, but indeed, in terms of local accomplishments too, such as serving as a youth sports coach and helping with those with special needs - a particularly relevant issue with Flynn as the former mayor has being involved in addressing the importance of helping those with special needs as his own grandson Braedon was born with a rare neurological disorder. Flynn himself has become an advocate for parents of children with special needs.

An interesting addition to Flynn's various accomplishments and specifically related to Braeden; at the cusp of the 21st century, Flynn wrote the novel The Accidental Pope (along with Robin Moore.) The book was published in 2000 and interestingly, mirrored several scenarios that actually occurred during following years - related to the Roman Catholic papacy relative to political and other global events. A political thriller with all the elements that truly make a novel a page turner.

Flynn has followed up with a screenplay, albeit with an insertion in the storyline bringing in the controversial topic of Bioethics.


Flynn is confident that the screenplay will be someday made into a film.

### How to Keep Your Dog Cool when it's Hot Outside



When the temperatures rise, you may be able to stay cool by sweating or drinking a nice glass of iced tea, but your dog isn't so lucky. Not only should your dog not drink tea or any caffeinated beverage, for that matter they also really don't have the ability to sweat very well. Dogs mostly cool themselves off by panting. So, how can you help keep your pup comfortable and safe when the mercury starts to rise? Fret not, this article contains some tips, tricks and cool (pun intended) product suggestions that can help.

**Stay indoors:** Obviously if you've got air-conditioning in your home and your dogs are able to hunker down and watch Hallmark with you during any heat spells, that's typically the best option. But not everyone has A/C and not every dog is able to spend all their time lazing indoors, so here are some not so obvious things you can do when your dog needs to spend time outside on walks, hikes or even in the yard during those hotter days.

Watch when you go out: Do all you can to avoid the "heat of the day." Now this period may be different in different parts of the country, but generally speaking, it's often the early and mid-afternoon. So do your walks, jogs, hikes, and any

other outdoor exercise with your dog in the early morning and late evening, when the sun isn't as likely to be as strong and temps are more likely to be cooler. This could mean waking up a bit earlier or adjusting the order you do your morning/ evening routine in to make these safer and more comfortable outdoor excursions happen, but either will be far less inconvenient that an emergency trip to the Vet or ER with your dog suffering from heat stroke.

Provide (reliable) shade: Trees are great, but not every yard has them, or depending on the direction of the sun, they may not help. Portable sun shades, patio umbrellas, and pop-up canopies are great for creating shade in yards. There's even some products that combine the shade of a pop-up canopy with the cooling effect of a misting system.

Provide a cool spot to lie down: Most dogs look for cool places to lie down when they're hot, like a tiled bathroom or kitchen floor, or the lawn outside. But if you want to provide an extra cool spot, the cool pet pad is a great option, not just because it can be used both indoors and out, but also because it doesn't require electricity and it also doesn't need to be wet down or refrigerated to work either.

A cot, that's elevated off the ground, is another option as well. Similar to the shaded pet bed.

Provide plenty of fresh drinking water: Provide several large bowls or buckets of drinking water for your dogs, making sure to check and refill them at least daily. Be sure to place them where your dog can easily reach them and try to put them in areas with reliable shade. You can also encourage your dog to stay hydrated by making them an interactive and icy treat to play with.

Help your dog sweat: Unlike us, dogs don't sweat across their skin when they get hot. So while we humans take advantage of "evaporative cooling" (when our sweat evaporates it cools us down) dogs can't. Dogs predominantly cool themselves through their respiratory system this is why dogs pant when they're hot.

Add water to their play: If your dog loves to play in water, a dog pool is easy to set up and drain. Can be great way to help keep them not just safe and cool in the heat but also quite happy, too.

Work on their weight: Overweight dogs have a harder time keeping cool in the warm weather and are at a greater risk of overheating. Help your dog by working to get them to and keep them at a more ideal body condition. Note that some dogs have an underlying medical condition that can make weigh loss difficult, and all dog weigh loss should proceed slowly. Learn more about helping overweigh dogs and talk to your veterinarian to best help your dog achieve their ideal body condition.

### Saint Gaspar del Bufalo

Gaspar del Bufalo was born in Rome on January 6, 1786. The son of Annunziata and Antonio del Bufalo. He grew up in the servants' quarters of the Altieri family, a noble family, whose palace was across from the Church of the Gesù in Rome, where his father worked as chef.

Because of his delicate health, his pious mother had him confirmed at the age of one and a half years. As he was suffering from an incurable eye condition which threatened to leave him blind, prayers were offered to St. Francis Xavier for his recovery. Through the influence of his mother he became greatly devoted to St. Francis Xavier. In 1787, he was miraculously cured.

As a young man, Gaspar was active in several ministries. He visited the sick and the poor often, and founded a young persons' religious organization whose members prayed and did charitable work together.

Gaspar was ordained to the priesthood on July 31, 1808. At the time, Napoleon had conquered much of Europe, including the Papal States, which were located in central Italy and ruled by the Pope. Napoleon had overthrown governments and was seeking to dominate the Church, demanding that priests,

bishops, and others in leadership roles take an oath of loyalty to him alone. Gaspar refused, saying, "I cannot, I must not. I will not." For this he was sent into exile and imprisonment for several years. Along with other clergy who refused to take the oath of allegiance to Napoleon.

Upon his return to Rome in 1814, he considered joining the Jesuits, who had recently been reestablished. However, in view of the needs of the time and at the request of Pius VII, he engaged in the ministry of preaching missions to the people in order to reestablish some order in the midst of the chaos. He found wide scope for his work, as Rome had for nearly five years, been almost entirely without priests and sacraments. In 1815, Gaspar founded the Congregation of the most Precious Blood with the approval of Pope Pius VII.

In 1821, the pope asked Gaspar to open six houses in Naples. In 1824, the houses of the congregation were opened to young clergy who wished to be trained specially as missionaries. In his lifetime, their work covered the whole of Italy. Journeying from town to town, enduring endless hardships, threatened often even with death, Gaspar always taking the hardest work himself, they preached their message.

His last mission was preached in Rome during the cholera outbreak of 1836. Feeling his strength failing, he returned at once to Albano, and made every preparation for death.

Until his death on December 28, 1837, he worked tirelessly to re-evangelize central Italy, especially the Papal States. Gaspar was Canonized June 12, 1954 by Pope Pius XII. The Feast Day of Saint Gaspar del Bufalo is December 28<sup>th</sup>.





## Nanna & Babbononno

by John Christoforo

A Nostalgic Remembrance



Several of you asked for an update on how my progress is going. Well, I had been using a walker up until the last week in July. At that point, I switched to a cane or as my wife calls it, "A walking stick." The muscles in my legs are healing nicely and I am going to physical therapy a couple of times a week. I will have to live with the battle scars, a six to eight inch scar running vertically across each knee cap. I've been told that weight loss would help speed my recovery and, so far, I've lost 24 pounds.

I decided to head to Florida as our house there is all on one level. At home, I had to install a chairlift to get myself out of the house, first from the kitchen, down to the cellar and then out to the street from the garage. It's actually been cooler here in the tropics that back home in Boston, global warming, or so they tell me. When we had those oppressive days in July, Loretta had the air conditioners on day and night. It was so oppressive that I didn't argue with her.

Thinking back to my early years in East Boston, the only relief we had was from a large window fan that Dad placed in one of the kitchen windows. It could get so hot in our penthouse (3rd floor of an East Boston three decker) that the water pipes would sweat and we would wind up with striped walls in that kitchen. As far as the heat was concerned, you lived with it. None of the cars Dad owned ever had air conditioning. Back in the day, it was an expensive option and the only dealers that offered it were those that sold luxury cars, Cadillac, Lincoln, Packard, and maybe, Buick and Chrysler. I'm not sure about the last two.

From 1949 on, Dad's cars were all Chevys and none had air. If you wanted to cool off, you opened the windows and angled the little fly windows all the way to allow air to blow on you as the car moved forward. If you got stuck in traffic, there was always a chance of the car overheating. Thank God, you don't see this phenomenon today unless the car has a problem with the cooling system.

What did we do to cool off back then? After dinner, we headed outside, we kids played games and the adults sat on the front steps until well after dark. A vacation for some was to sit on a neighbor's front steps instead their own. We kids liked it when it was a hot night because the adults would stay out later than usual which meant we were outside playing long after dark. So, hot nights had their advantages.

There were ways to cool off when I was a kid, family outings to Revere Beach, Nahant Beach, Wollaston Beach, Nantasket Beach, Salem Willows, and Hampton Beach. Later, when Constitution Beach in Orient Heights officially opened, we had a cooling off place closer to home. When it was just me or a few of my preteen friends, we would head for the "penny pool." That was, and I think still is, the pool on Storrow Drive across from the Mass General Hospital. Back in the day, it cost a penny

for kids to swim there, and I loved it. I would sneak in a pair of underwater goggles, put them on when the life guards weren't looking, and dive to the bottom looking for change. More often than not, I would find a couple of dollars in pennies, nickels, dimes and quarters.

When Dad would have a day off, he would take Nanna, Babbononno, Mom and me to Revere Beach. He liked the cement steps which used to exist way down along the beach, near Point of Pines. Nanna and Mom would have to cover up and sit under umbrellas as they both had light sensitive skin and burned easily. Babbononno kept his shirt on fearing that he would get tanned and look like a field hand, in his mind a negative. Dad and I would work on our tans with no problems, an experience I still enjoy.

Within the past couple of years, Loretta made comments on some brown spots on my shoulders and back. She made an appointment with a dermatologist to get them checked out fearing that they might be cancerous. The doctor gave me a clean bill of health, and when Loretta asked about all the brown spots, the doctor's only reply was, "He's old."

On Sundays, Dad was often booked to play at the band stand on Revere Beach or the indoor band stand at Nantasket. He would pack up Nanna, Babbononno, Mom and me for each event and we would make a day of it. When at Revere Beach, a stop at Bianchi's Pizza was mandatory and my family would sit with their slices while listening to Dad play tuba to all of the famous Sousa marches. Depending who the leaders were, I might be allowed to sit next to Dad in the brass section of the band. This I loved, and after the concert, I would fight the waves of Revere or Nantasket providing the tide was coming in. Mom would time it so that an hour had passed between the pizza and the swim. She always thought that you had to wait an hour after eating before going swimming or you might develop stomach cramps and drown.

Years later, when Bernie King became the leader of those Sunday concerts at Revere Beach, I was hired to play bass guitar. (Dad was still on tuba) By then the music included a couple of Sousa marches and lots of pop tunes of the day, and considering the ethnic groups on the beach, a lot of Italian and Jewish tunes.

After Nanna passed away in December of 58, Babbononno stopped coming to the beach concerts. I was in college by then and booked in as many of those concerts as I could. It helped pay my tuition at Boston State. Between what I made at the Seville Theater and the summer concerts, and later, the resorts I played at on weekends when I was with the Ken Reeves orchestra, I never had to ask Dad for financial help. I paid my own way through college, a feat that is impossible with today's tuition costs.

I wonder if they still have band concerts at Revere Beach on Sundays during the summer months. I guess I'll have to call the Musicians' Union to find out. If they do, the crowds are different and I would imagine the music would be different,

This type of entertainment was programmed from the July 4<sup>th</sup> weekend through the Labor Day weekend, and then it was over. To me, the summer was just those two months and then it was back to the old grind, as

Anyway, I hope you are all having a great summer, and God willing, I'll be back next week.





There is no doubt Rocky Marciano was one of the greatest heavyweight champs who ever lived. Though one of the smallest men to lav claim to the crown, he was also one of the hardest punching. Rocky's blows were pummeling and punishing. He hurt his opponents no matter where he landed on them. If

he landed on the arms it wouldn't be long before the man facing him would have trouble holding his guard up. In fact, out of Rocky's seven title fights only one went the entire fifteen rounds. In his 49 fight career he knocked out every opponent he faced either in their first encounter or in a rematch with the exception of Tiger Ted Lowery who twice went the ten round distance with him.

How is it such a small heavyweight would have the power to score so many knockouts? The secret was in the leverage he got behind his punches. It is almost impossible to find a photo of Marciano throwing a punch where he isn't putting his whole body behind every blow. His follow through was such that it appeared as if he were trying to have his hands fly free of arms. He was always on balance, even when he looked awkward.

That combination of balance, leverage, and follow through meant that with each punch he landed every ounce of his185 pounds was behind it. Even if he missed landing he would still move forward with his forearm making contact. This is how he wore opponents down. His fight with Archie Moore is a prime example of this.

Watching Marciano hitting the heavy bag and speed bag, you can see how he perfected his technique. He had one of the great trainers in Charley Goldman who knew just how to bring out the best in the raw prospect who was turned over to him.

I have included a number of photos of Marciano in action. Look at them closely and you will see what a master he was at deriving all the power possible out of his body. I don't think he ever threw a light punch. I doubt he could have if he wanted to.

### HOOPS and HOCKEY in the HUB

MELLOW MOMENTS FOR MELO — When the 2019-2020 version of the National Basketball Association takes to the floor in a couple of months in the 30 franchise cities scattered across America, there will be many familiar faces in the various lineups.

One that fans might not see is that of Carmelo Anthony, a former NBA All-Star performer who has played many times against the Celtics in the Garden over the course of his 16-year career.

But now, as the NBA's free agency period slides into mid-August with the opening of training camps about a month away, Anthony remains an unsigned veteran even though he has indicated he will accept any role.

The latest putdown was not being allowed to join the Team USA squad that will compete in the World Cup in early September — a roster that includes Boston Celtics players Jaylen Brown, Marcus Smart, Jayson Tatum and Kemba Walker.

Anthony let it be known that he wanted to join the squad that is preparing for the tournament that will take place in China less than a year before the start of the 2020 Summer Olympics in that nation.

The rejection by team managing director Jerry Colangelo was somewhat surprising given that NBA stars such as LeBron James, Anthony Davis, James Harden, Kawhi Leonard and former Celtic Kyrie Irving have all declined to participate.

It was also disheartening to Anthony since he had won three gold medals with Team USA in the 2008, 2012 and 2016 Olympics.

Anthony wanted to use the event to showcase himself but Colangelo indicated that USA Basketball's long-term strategy was to go with younger players — make that younger NBA players since the United States squad will still consist entirely of players from the 30-team league. Despite the absence of many current NBA stars, the Americans still are strongly favored to win the gold medal at the event.

Colangelo's denial of the former Olympian's request brought forth a flurry of comments from two of Anthony's most prominent backers — Syracuse University mentor Jim Boeheim and Dallas Mavericks owner Mark Cuban.

Boeheim, who was the coach at SU when Anthony led the Orange to the 2003 NCAA Division 1 National Championship, detailed a way that his former star player could still make a contribution in the pros.

"He's in great shape. He works out every day," Boeheim said on Sirius radio. "He can't go 35-40 minutes and get 25 points but he doesn't want to do that," stated the coach, noting Anthony's willingness to now become a bench player.

"I think he'd be fine doing that. I don't think there's any team that he wouldn't help if he was playing 16-20 minutes a game on a second unit. If he's having a good game, play him a little bit more. If he's not, don't play him at the end."

Although Anthony only spent one academic year (2002-2003) at Syracuse, he has become one of the basketball program's biggest financial boosters. He donated some \$3 million towards the construction of a new basketball practice facility that bears his name — the Carmelo K. Anthony Basketball Center.

Cuban, the often outspoken owner of the Mavericks, talked bluntly of his backing for Anthony, even though he has never played for the Mavs.

"I have to speak up for Melo," stated Cuban emphatically on Sirius radio. "There's absolutely no reason for them not to have him on that team."

Cuban also questioned the relative importance of the World Cup for USA basketball. Although the tournament serves as a qualifier for next year's Olympics, the roster for that team may be very different in 2020. Many of the stars that passed on this year's competition may very well decide to play next year.

"What are they playing for now?" asked Cuban. "This isn't even the Olympics. When the Olympics come along this is going to be a substantially different team." Curiously, Anthony has not been mentioned in media reports as being on the free agent radar of Dallas.

Now 35 with a reported net worth in the neighborhood of \$120 million, Anthony, who earlier played a number of years with both Denver and the New York Knicks, has stated that he would accept a bench role with any team. He has indicated he would be willing to sign the minimum contract for NBA veterans with over 10 years of service (currently \$3.1 million).

That's a marked departure from just a few years ago when the Brooklyn native, Maryland high school standout and Syracuse University star attempted to dictate terms at various points during the earlier stages of his career.

His last full-year stop was with the Oklahoma City Thunder for the 2017-2018 season. Over the summer of 2018 he signed a one-year deal with the Houston Rockets — a pact that reunited him with Mike D'Antoni, his former coach with the New York Knicks.

But he didn't experience a liftoff with Houston. Instead, he only played 10 games with the Rockets before Houston GM Daryl Morey let the former Olympian go via a trade with Chicago in late January that saw the Bulls waive him the very next day. He has not been on an NBA roster since then.

So, now there is twilight surrounding Anthony rather than the glow of the spotlight that was so familiar to him throughout his career. He has averaged 24 points a game over his entire 16-year career in the NBA.

The winner of those three gold medals in the previous three Olympics now sits sidelined as the NBA's engines pick up steam and begin to move toward the commencement of the 2019-2020 campaign.

Whether the sun has set for Carmelo Anthony or remains above the horizon for a bit longer will be determined in the next few weeks. Come October, we'll know the answer one way or the other.
