# 96th Annual Madonna Della Cava Feast

This past weekend, thousands gathered to celebrate the 96th annual Madonna Della Cava Feast, which took place on Hanover and Battery Streets in Boston's North End. The image of Maria SS Della Cava, Principal Patron of Pietraperzia, Sicily, was rediscovered miraculously in the year 1223 by a mute from Trapani who was directed by Our Lady to proceed to the outskirts of the town where the portrait of Our Lady would be found. In the process, his speech and hearing were restored. The first words spoken by the mute were, "VIA MARIA SS DELLA CAVA."

The feast began on Friday evening with the exposition of the image of the Madonna, followed by a blessing and short procession.

A variety of entertainment was provided over the weekend, with special guests Booty Vortex on Friday night, a tribute to Barry White featuring Jourdan Carroll on Saturday night, and the Rule of 3 Band on Sunday night.

The feast concluded on Sunday with a Mass at St. Stephen's Church followed by a procession of the faithful, members of the Madonna Della Cava Society, and two marching bands — St. Alfio's and the Northeast Italian Band.

The Madonna Della Cava Society of Boston was founded by Italian immigrants in the early 1900s.

# **New Emergency Notification System** for the City of Boston

New Emergency Management System Will Allow Residents to Receive Notifications Via Phone, Text or Email in Four Languages

Mayor Martin J. Walsh will now be transmitted in Emergency Management (OEM) Chinese (Hong Kong dialect). recently announced significant system allows residents, businesses and visitors to the City of Boston to be notified and aware in the event of an emergency.

The management system upgrades will now allow residents to receive emergency notifications via phone, text or email. Recognizing the diverse nature of Boston's population, the new AlertBoston system also allows City officials to broadcast information in four different languages. Messages such as severe weather warnings, parking ban announcements, and street closure information

The improvements to the system reflect the feedback the City of Boston received from residents.

The AlertBoston system was developed by a company called CodeRED, a provider of alert systems to cities and towns throughout the United States. emergency notification system, messaging." With tailored CodeRED has a mobile alert app that can be downloaded for free, and allows visitors who are enrolled in their local alert programs at home to receive AlertBoston notifications in

# Stirpe Nostra

### THE ROMAN AMPHITHEATERS



Colosseum Flavian Amphitheatre

The Roman Theater was adapted from the Greeks and was built in a half round or semicircular plan. The amphitheater was exclusively a Roman development. Usually oval in plan, it was built in just about every important Roman settlement in the empire. There were amphitheaters at Verona, Pompeii, Pozzuoli, Pola, Nimes, Arles, and El Djem (near Carthage).

The Colosseum is one of the grandest ruins of Ancient Rome. It was built by the Flavian Emperors and is properly called the "Flavian Amphitheater." Construction was started by Vespasian in 70 A.D., then opened and dedicated by Titus in 80 A.D. with an inauguration that lasted 100 days. During this time, about 5,000 wild animals and many gladiators were killed. The structure was finally completed by Domitian in 82 A.D.

The building is about 600 feet long, 500 feet wide, and 160 feet high and covers six acres. The central combat area was called the Arena and got its name from the Latin because of the sand that was spread to absorb the blood of the humans and animals. The air was kept fresh smelling by spraying of perfumes or spreading costly

powders around the building.

There was seating capacity for 50,000 spectators and standing room for 30,000 more. There were 80 arcaded openings in the exterior walls at each of the first, second, and third story levels. These arched openings were the entrances on the first level, but containing beautiful statues on the two upper floors. A total of 160 statues were displayed in the upper facade.

Seating priority was strictly by social class and all seats and tickets were numbered. The present day system of

## Find Your National Park

The National Park Service turns 100 on August 25, 2016, and they are inviting visitors of all ages to join in the celebration throughout the month with special events across the country, and free admission to all 412 national parks from August 25th through August 28th.

Here are some of the National Park Service attractions nearby:

- Adams National Historical Park in Quincy tells the story of "heroes, statesman, philosophers ... and learned women" whose ideas and actions helped to transform thirteen disparate colonies into one united nation.
- Boston Discover how one city could be the Cradle of Liberty, site of the first major battle of the American Revolution, and home to many who espoused that freedom can be extended to all.
- Boston Harbor Islands where you can walk a Civil Warera fort, visit historic lighthouses, explore tide pools, hike lush trails, camp under the stars, or relax while fishing, picnicking or swimming — all within reach of downtown Boston. Youth programs, visitor services, research, wildlife management, and more are coordinated on the park's 34 islands and peninsulas.
- Cape Cod National Seashore - The great Outer Beach described by Thoreau in the 1800s is protected within the national seashore. Forty miles of pristine sandy beach, marshes, ponds, and uplands support diverse species. Lighthouses, cultural landscapes, and wild cranberry bogs offer a glimpse of Cape Cod's past and continuing ways of life. Swimming beaches and walking and biking trails beckon today's visitors.

The Essex National Heritage Area begins just 10 miles north of Boston and covers 500

square miles of eastern Massachusetts to the New Hampshire border.

- Frederick Law Olmsted Historic Site - Frederick Law Olmsted (1822-1903) is recognized as the founder of American landscape architecture and the nation's foremost park-maker. Olmsted moved his home to suburban Boston in 1883 and established the world's first fullscale professional office for the practice of landscape design. During the next century, his sons and successors perpetuated Olmsted's design ideals, philosophy, and influence.
- John F. Kennedy Historic Site - In 1966, Rose Kennedy, the President's mother, returned to her family's first home and birthplace of John F. Kennedy with the intention of sharing the values and expectations she believed defined her children's early years. Today, visitors travel back in time through Mrs. Kennedy's memories to understand the Kennedy family's early years and how she helped Americans memorialize John Kennedy.
- Longfellow House Washington's Headquarters National Historic Site preserves the home of Henry W. Longfellow, one of the world's foremost 19th century poets. The house also served as headquarters for General George Washington during the Siege of Boston, July 1775-April 1776. In addition to its rich history, the site offers unique opportunities to explore 19<sup>th</sup> century literature and arts.
- At Minute Man National Historical Park, the opening battle of the Revolution is brought to life as visitors explore the battlefields and structures associated with April 19, 1775, and witness the American revolutionary spirit through the writings of the Concord authors.






# Friends of the North End Bocce **Broadcast on FOX 25 News**



# L'Anno Bello: A Year in Italian Folklore

Watching the Seasons Unfold

One morning this time last year, as I sat down to watch the news to start my day, a lighthearted story appeared declaring that Starbucks would, in fact, start putting real pumpkin into their famous pumpkin spice lattes. Pumpkin season is still fairly far off, but this served as yet another reminder that autumn, my favorite season, was quickly approaching. Indeed, I have lately been paying attention to the signs of the changing season all around me, from the prevalence of apples in the supermarket to the ever-soslight hues of red and orange appearing on some leaves. When the days get too humid and sticky — which I am fine with at the beginning of summer, but find unbearable when crafting lesson plans or setting up my classroom for the next school year — I think of the harvest decorations I continually see in stores, and shiver with excitement over the crisp days of fall. Observing the signs of the changing seasons not only helps me live in the moment by concentrating on the natural phenomena currently unfolding around me, but it links me in a powerful way to the actions and lives of my ancestors.

Tracking the seasons has been a passion of mine long be-

fore I started this column. While clearing out a drawer in my old room, my mother found an old notebook of mine in which I had been charting the natural signs of the changing seasons. For the shift from summer to autumn, I wrote about witnessing my uncle and grandmother planting the bulbs of a daisy, called a margherita in Italian, which would bloom in late September. I mentioned a gnarled tree whose leaves always turned a kaleidoscope of yellow and red a month early, and floated to the ground well before the calendar turned to autumn. Baking an apple desert, cool mornings, the color of the early twilight — all of these observations made it into that little notebook. Doing so helped me become a better observer of nature and of the excitement of life around me, and I hope to resume this sort of project again soon. Noticing and recording the shifting tide of the seasons actually has a scientific name. It is known as phenology, and naturalists often encourage people to sketch or write down their observations and then submit them in order to help scientists track climate data. So this hobby is both romantic and functional!

This pastime is apparently quite timeless as well. Our an-

immemorial — not because they were eager for pumpkin spice lattes or photographing falling leaves, but rather because they operated in a primarily agricultural society where determining the right time to plant or harvest crops was invaluable to the survival of the community. In Italy, August functions as the month of the grain and hay harvest, and tightly rolled bundles of hay baking under the sun serve as one of the surest signs that autumn will soon descend upon the lovely Italian countryside. Italian farmers also examine their grapes during this month, ensuring they are getting the right amount of sunshine, water and shade to make them perfect for the vendemmia, or harvest, in September. After all, grapes stand as an important cultural symbol in Italy, for the grapes gathered in September will be processed into wine in November, ready to serve as the steadfast staple of Italian hospitality during the holidays and beyond. Finally, Italian farmers of yore frequently used saints' days as milestones for seasonal changes, a trait which is reflected in the proverbs still ubiquitous in Italian society to this day. August 24th is St. Bartholomew's Day, and the Italians repeat a proverb which declares: "A San Bartolomeo montagna mia bella ti abbandono." Translated, this dictum says that one should abandon the beautiful mountains after the Feast of St. Bartholomew, perhaps a reference to the cooler weather and the end of the vacation period. When we notice even the simplest transitions from one season to another, therefore, we are actually repeating the actions our forebears performed in order to carve out a living from the Earth.

As the bright days of summer give way to the cool nights of fall, I encourage everyone to keep track of the unfolding seasonal changes. These transitions do not have to be major, as even the tiniest details like a sip of apple cider or a yellow school bus can signal the start of an exciting new season. Let us become seasonal detectives, paying close attention to the evidence of nature's eternal cycle. By doing this, we become closely attuned to the Mother Earth which has nourished us and our ancestors for so long, and we learn to live in the moment by understanding the natural beauty of the here and now. If we welcome every season with optimism and a healthy dose of respect, then the bounty of the Earth will love us in kind, no matter which latte we drink!




# Saint Ambrose Barlow

Ambrose was born at Barlow Hall near Manchester, England, in 1585. He was the son of the nobleman Sir Alexander Barlow and his wife Mary. The Barlow family had been reluctant converts to the Church of England following the suppression of the Roman Catholic Church in England. Ambrose was baptized at Didsbury Chapel and went on to adhere to the Anglican faith until 1607, when he converted to Roman Catholicism.

Ambrose, after spending time as a page in the stewardship of Sir Uryan Legh, realizing that his true vocation was for the priesthood, travelled to Douai in France to study at the English College there before attending the Royal College of Saint Alban in Valladolid, Spain. In 1615, he returned to Douai where he became a Benedictine monk and was ordained a priest in 1617.

After his ordination, Ambrose returned to England, taking up residence at the home of Sir Thomas Tyldesley where a pension was made available to Father Ambrose that would enable him to carry out his priestly duties among the poor Catholics within his parish. He secretly catered to the needs of Catholic "parishioners," offering daily Mass and reciting his Office and Rosary for the next 24 years.



Ambrose was arrested four times during his ministry and released without charge. King Charles I signed a proclamation on March 7, 1641, which decreed that all priests should leave the country within one calendar month or face being arrested and treated as traitors, resulting in imprisonment or death. Ambrose's parishioners implored him to flee or at least go into hiding, but he refused. Their fears were compounded by a recent stroke which had resulted in Ambrose, who was 56 years old, being partially paralyzed.

On April 25 1641, Easter Day, Ambrose and his congregation of around 100 people

were surrounded at Morleys Hall in Astley by the Vicar of Leigh and his armed congregation of some 400 people. Father Ambrose surrendered, and his parishioners were released after their names had been recorded. Father Ambrose was restrained, and then taken to Lancaster Castle where he appeared before the presiding judge, Sir Robert Heath, on September 7th, professing his adherence to the Catholic faith and defending his actions. On September 8th, Sir Robert Heath found Ambrose guilty and sentenced him to be executed. Two days later, he was taken from Lancaster Castle to the place of execution, hanged, dismembered, quartered, and boiled in oil. His head was afterwards exposed on a pike.

On December 15, 1929, Pope Pius XI proclaimed Father Ambrose as Blessed at his Beatification ceremony in St. Peter's Basilica, Vatican City. In recognition of the large number of British Roman Catholic martyrs who were executed during the Reformation, most during the reign of Elizabeth I, Pope Paul VI decreed that on October 25, 1970, he was canonizing a number of people who were known as the Forty Martyrs of England and Wales of whom Ambrose was one.

## Fun in the Water with Your Dog

Trying to beat the heat this summer? Hit the water, and bring your dog!

It's well-known that most dogs love water. Many breeds, such as labs and retrievers, are natural swimmers, and love to get wet. This can make for truly memorable summer experiences. Some dogs aren't quite as at home in the water. Never fear, though, because most dogs can be trained to swim.

Teaching your dog safety first: If your dog is not used to the water, consider using a pet flotation device; basically a life jacket for your dog.

Take it slow: Start out in shallow water; try letting your dog walk in the water first. Then, you can ease him into swimming, holding up his back end first while he paddles with his front. As he gets more comfortable in the water, you can let him swim on his own.

Don't forget: Use sunscreen on his nose and ears. Light colored dogs are particularly susceptible to sunburn.

### Tips for Water Safety:

Be a lifeguard: Always be there to watch over your dog when he's swimming. If you're at a lake or ocean, try to keep an eye on the current and how far out your dog is swimming. Dogs can get tired while swimming and you don't want to let him get out of your reach.

Don't drink the water: When dogs are swimming, they like to lap up the water that they're doing laps in. This can be bad for them, as chlorine, salt or pollutants will be present in pools, oceans, or lakes. When you go swimming, try to bring plenty of fresh water for your dog to drink so he won't be tempted to drink unhealthy water.

Stay clean: After swimming, make sure to rinse your dog off with clean water. If you want him to get extra clean, bring dog shampoo. Don't forget to rinse and dry his ears, to protect him from ear infections.

### Fun Ideas:

At home: If you have a pool, feel free to let your dog swim around. Just be sure he knows where and how to exit the pool. and try not to play rough with him. If you don't have a pool, many dogs have plenty of fun playing with hoses, sprinklers, or kiddie pools.

In the wild: Lakes and rivers are great places to play with your dog in the water. Try playing fetch; but be careful not to throw the ball too far out. You can bring your dog to the beach, too, but be careful of the surf and other factors, like jellyfish. Before you venture out, check to make sure the spot is "dog friendly."

On the boat: If you can, another fun idea is to bring your dog boating. Before you try this, though, make sure your dog is a strong swimmer. Always outfit him in a pet flotation device and make sure he's wearing identification. On the boat, try to provide him with non-slip surfaces, a shady spot, and a place to rest. Also, make sure your dog responds well to commands, as this can be essential on the water. Like swimming, start slow with your dog. Go on small boat trips in gentle water before getting more adventurous, and always make sure he's comfortable.

Enjoy this wonderful heat wave we are having and remember--pick up after your pet.

# BEWARE of IRS SCAMS

## IRS-IMPERSONATION TELEPHONE SCAM

Con artists can sound convincing when they call. They use fake names and bogus IRS identification badge numbers. They may know a lot about their targets, and they usually alter the caller ID to make it look like the IRS is calling. Victims are told they owe money to the IRS and it must be paid promptly through a pre-loaded debit card or wire transfer. If the victim refuses to cooperate, they are then threatened with arrest, deportation, or suspension of a business or driver's license. Or, victims may be told they have a refund due to try to trick them into sharing private information.

NOTE THAT THE IRS WILL NEVER: 1) call to demand immediate payment, nor will the agency call about taxes owed without first having mailed you a bill; 2) demand that you pay taxes without giving you the opportunity to question or appeal the amount they say you owe; 3) require you to use a specific payment method for your taxes, such as a prepaid debit card; 4) ask for credit or debit card numbers over the phone; or 5) threaten to bring in local police or other lawenforcement groups to have you arrested for not paying.

Lucia di Lammermoor — August 27, 2016. World debut for Juan Diego Flórez in the role of Edgardo in the second most performed Donizetti opera (the first is L'Elisir D'Amore). The staging is based on a leaning glass tower in a landscape of destruction and desolation, recalling that the country is at war, torn by the ambitions of rival clans. The opera premiered on the 9th of September, 1835, at the Teatro San Carlo in Naples. The first performance at Barcelona's Liceu was on September 15th, 1859. Among two enemy clans in Scotland, a love is born. Lucia and Edgardo secretly vow to marry each other. Nevertheless, Lucia's brother convinces her that Edgar has forgotten her and she is forced to marry another man. She becomes crazy, kills her husband and finally dies herself. Hearing the news, Edgardo commits suicide so that he can rejoin his lover.

Le Nozze di Figaro — August 28, 2016. Mozart and da Ponte's very first collaboration resulted in a masterpiece Le nozze di Figaro — that represents a highlight in the entire history of opera. In his stage play on which the opera is based, Beaumarchais broached the topic of the class struggle between the Count and his servant on the eve of the French Revolution. However, only the brilliance with which Mozart captured the character of each and every figure made the work a classic: "Each one changes, is changed, ground, threshed, torn apart and sewn back together again, until he finally stands before himself as himself and, astonished and rejoicing, finds himself again as a completely new person," says Sven-Eric Bechtolf, who has set his production in the 1930s, thus bringing the plot closer to our own time.

Pendergrass and Melvin have both passed away, but the group carries on and today consists of Donnell Gillespie, Rufus Thorn, Anthony Brooks, John Morris, and Sharon Paige.

# Recipes from the Homeland

## **VEAL KIDNEYS**

1 or 1 1/2 pounds veal kidneys

- 3 cloves garlic chopped
- 2 small potatoes
- 1/3 cup olive vegetable or canola oil

3 tablespoons red or white cooking wine of choice (optional)
Salt and black pepper.

Remove any fat from the kidneys, wash and dry. Cut kidneys into one-inch portions and set aside.

Peel potatoes and cut into one-inch portions, wash and dry and set aside.

Heat oil in skillet to medium heat. Carefully add the cut-up kidney portion. There may be some splattering. Fry kidney portions until all are seared before adding the potato portions. Add chopped garlic and stir. Cover and fry over medium/low heat until potatoes and veal are fork tender. Stir occasionally.

Optional: Add the wine, stir thoroughly and cover.

Simmer over low heat about thirty seconds. Add salt and pepper to taste. Remove from burner. Serves two.

NOTE: As a youngster, I remember Mama cleaning and boiling chicken feet to add to her homemade chicken soup. When I questioned the use of chicken feet, Mama told me that in her homeland it was customary to use as many parts of the slaughtered animal as possible — like chicken feet and livers, pig's feet, veal kidneys, and tripe. They had lived during difficult economic times. Ironically it prepared them for life in the United States during the Great Depression. The meat markets of Boston's North End supplied them with all cuts of meats.

After I married my husband in 1949, my mother-in-law frequently prepared the above kidney recipe for us, knowing that it was a favorite of my husband. Today, veal kidneys are scarcely seen in supermarkets. Beef kidneys, more often available, can be prepared in this same manner. However, our family still prefers veal kidneys.



# Nanna & Babbononno

by John Christoforo

A Nostalgic Remembrance



The longest stay of our 1972 Italian extravaganza was about to begin. Sal, Jose, Franny, and I settled in at a hotel that catered to Italian people. This may sound strange to some of you, but the fact was, and still is, that Europe is very small and people travel to different countries the same way we travel to different states. The only difference is that ethnicities differ, languages differ, and cultures differ. Many tourist hotels are set up to cater to people from particular countries. I did not experience this phenomenon or didn't realize it until we got to Rome. Anyway, we were checked into the Hotel Cristina just off the Via Nazionale and within walking distance to the geographical center of Rome.

Once we were all settled, Jose and Franny pulled out the travel brochures and maps so that we could plan out an itinerary. The concierge, who happened to speak English, helped us out over a cup of coffee and gave us a head's up on where to go, what to see, and where to eat. We basically divided Rome into the ancient sites to see, the religious sites to see, and the Renaissance sites to see, and off we went. That first full day in the Eternal City, we headed to the Roman Forum, the Coliseum, the other forums built by emperors during the heyday of the empire, and walked under the Arch of

Constantine. Later, the driver took us on the Appian Way to see the Christian catacombs that dotted the road outside of the city. On certain parts of the road, the original cobblestones had not been covered over and, as we bounced over them, I wondered if any of my ancestors had ever ridden or walked over them. When Jose asked me why I was smiling, I told him that 20 generations earlier, my people sold used chariots and I wondered who might have ridden on them over those cobblestones. It was a good thing I told him in Spanish, because if I said the same thing in English, the rest of my crowd might have wondered about my sanity.

The plans were to visit St. Peter's and the Vatican the next day. But once back at the hotel from our excursion to the ancient sites, it was time for dinner. We asked the concierge where he would eat if he had to pick a restaurant that catered to locals, not tourists. He mentioned one that was within walking distance and we headed there once we had cleaned up. The place was on a side street right near the Vittoriano, a big white building that is the tomb of Victor Emmanuel II, one of the last kings of Italy. As we walked in, I noticed that most of the patrons were in groups of Italian families, and not seeing any tourists, I knew that this was where we should eat. The wait staff was composed of the owner's children and wife. The person who sat us down was the wife who welcomed us, and told us what they were

cooking that day, and to let her know if there was anything we wanted that wasn't on the menu. Franny asked, "What menu," The woman replied, "I am the menu."

After we ordered, the owner, who did most of the cooking, came out of the kitchen to see who we were and joined us for a quick conversation. We told him that we were in Rome for three weeks and had been given the name of his restaurant as the best place to eat. Surprisingly, he told us to eat the dinner he was preparing, but for the next few days, head to other restaurants to make comparisons. His final comment was, "Once you've eaten elsewhere, you will return and eat your dinners here for the rest of your stay in Rome." He was right. The food was fantastic, reasonably priced and, with the great service we received, insured that we would return each night for the remainder of our stay. After we left, we walked to the Piazza Venezia, the geographical center of Rome, where the Victor Emanuel II tomb was located and saw the balcony of the building where Mussolini spoke to the population of Rome on many occasions.

The next day, our chauffeur picked us up and brought us to Vatican City. We crossed the bridge that led to the Castel St. Angelo and headed left into St. Peter's Square. Back then, you could park there. I don't think you can now. We toured St. Peter's and were awestruck at the size and beauty of the world's headquarters for the Catholic faith. Among the things that amazed me was the statue of Mary holding the body of Jesus, Michelangelo's Pieta. It was carved from 1498 to 1499 for the Basilica and looked as lifelike as the day it was finished. An hour or so later, we were in the Sistine Chapel viewing the ceiling and wall paintings started by Michelangelo and finished by his students. Jose had a camera and took pictures of everything we saw. Later, we visited the underground tombs of many of the popes who were buried there. It was so aweinspiring that 44 years later I can remember everything as if it all happened yesterday. Later that day, we visited St. Mary Major cathedral (Santa Maria Maggiore). This is the largest church in Rome after St. Peter's. Fast forwarding to just a few years ago, it was the church Cardinal Law was given to run after he left Boston.

We visited several more churches famous in Christian history, but there are 900 places of worship in the Eternal City and it would take us months to visit all of them, so we stuck to the major ones. Along the way, we had picked up a group of American tourists who wanted to join us on our tour. After about the 5th church we visited, one of the women said, "We are Jewish. Can you show us the Roman Synagogue?" Jose looked up the location on one of his maps, and off we went. The synagogue was built in 1904 on the same

site where a Jewish house of worship had been built during the Roman Empire, something I knew nothing about. As we were standing in front of the building, a wedding party exited. One of the women in our party looked at the members of the wedding party as they exited the temple and blurted out, "They don't look Jewish; they look Italian." One of the groomsmen heard her and understanding English, replied, "Lady, we are Jewish. Lady, we are Italian," and walked away.

Looking around, I discovered that we were in a Jewish neighborhood. Out of curiosity, I headed back to the synagogue and found someone who could give me information on the neighborhood and the Jewish house of worship. For the next hour, I received a history lesson that I never saw in history books. Jews have been in Rome since biblical days. Romans were more accepting of Jews than people elsewhere, and many of the people who exited the Middle East during the Roman occupation (the time of Christ) headed for Rome. Once our personalized tour was at an end, we invited the group of Jewish tourists to join us at our now favorite restaurant, but they declined. That was the last we saw of them. Sal didn't like the attitude of the woman who was outspoken and might have said something he shouldn't, but he never got the opportunity. Over dinner, we planned the next day's adventure, and that was to visit the piazzas that dotted the Eternal City. I now had a couple of stories for Babbononno that he could identify with.



# HOOPS and HOCKEY in the HUB

On the day LeBron James agreed to a three-year, \$100million deal to remain with his hometown Cleveland Cavaliers, the Celtics also announced some high profile news of their own.

They will appear some 22 times on national television this coming season, meaning that nearly one quarter of the C's 82-game regular season schedule will be shown from sea to shining sea.

That's pretty good for what many people feel is an up and coming team, fresh off a 48-34 (.585) mark that was good enough for a fifth place finish in the Eastern Conference last year.

It was the team's best record since the 2011-2012 season when the squad logged a 41-40

In addition, the Celtics were the only team other than the Toronto Raptors to post a winning record in the Atlantic Division last season. The Green posted a very fine 28-13 record at home and were only a game under .500 on the road (20-21).

The Celtics also ended Golden State's 54-game home winning streak 109-106 back on April 1st after losing in double overtime to the Warriors (124-119) at the Garden on December 12<sup>th</sup>. They also won on the road at Cleveland, 104-103, via an Avery Bradley buzzer-beater on February 6<sup>th</sup>.

Thus, the Celtics defeated both teams that made it to the NBA Finals on their respective home courts.

All that meant that the executives at NBA headquarters in New York took notice and the Green went from virtual banishment on the nation's airwaves last year to becoming regulars on the TV screen this coming season.

The Celtics will open the 2016-2017 campaign at home on October 26th against the Brooklyn Nets. A big test will come a few weeks later when the Warriors come to town on November 18th. The C's will play at Golden State on March 8th.

Fans will have to wait a bit to see LeBron James and the NBA Champion Cavaliers. Cleveland won't make its first appearance in the Garden until March 1st, with a second game coming on April 5th.

The C's will also host former Celtic Rajon Rondo and the Chicago Bulls on November 2th. If the Patriots do not make it to the Super Bowl then that day (February 5th) will have a different meaning here in the Hub as former Celtics Coach Doc Rivers — and possibly Paul Pierce (if he is acquired) will come to town with the Los Angeles Clippers.

In addition, the Minnesota Timberwolves will play on Causeway Street on March 15th, meaning former Celtics star Kevin Garnett will be back in Boston (for one night) unless he chooses to retire before then.

And yes, the Celtics will be in action on March 17th — St. Patrick's Day — but you'll have to travel to Brooklyn if you want to see them play the Nets that night.

The regular season will conclude with a pair of home games — against Brooklyn on April 10<sup>th</sup> and Milwaukee on April 12th. Overall there are 15 Wednesday games and 13 Friday games — traditional nights for Celtics home games over the decades.

Finally, a comment on the Celtics playing on Christmas Day against the New York Knicks in Madison Square Garden in New York City at noon.

We remember back in the 1990s when then Celtics head coach Chris Ford referred to Christmas as "the number one family day of the year."

We also remember another time when the C's were scheduled to play the Knicks in New York on Christmas. Teams normally arrive at their hotel the night before, but C's star Kevin McHale, who had very young children then, received special permission from team executives to delay his departure until late on Christmas morning (that year, the game started later in the afternoon).

The point is that there should be a couple of days set aside for family days — times when everyone can be together celebrating a special occasion. In America, that's Christmas.

Some will say that basketball millionaires should play and coach on those days. But those few we see on TV are only the tip of the iceberg when it comes to staging a game. There are also many people that are doing duties as a part-time job or second job — so many that are receiving minimum wage or just above it.

There are parking lot attendants, ushers, food service employees, people staffing concessions, building maintenance people and those that clean up the premises — yes, even the restrooms.

They're not making a lot of money — but they have to have their Christmas curtailed just because some league executives (who are probably home with their families) decreed that there should be games on Christmas Day.

We always liked the fact that that the National Hockey League now has a Christmas break. After the games of December 23rd there can't be any games until the evening of December 26th. That gives everyone (players, coaches and people who work in the arenas) the opportunity to observe Christmas with their families.

But it wasn't always so.

Bob Wilson, the late Bruins radio play-by-play announcer, once told us about the era when the Bruins did have a Christmas night game at the Garden. Bob and his family lived in New Hampshire and had to rush through what amounted to a Christmas lunch so Bob could arrive at the Garden early to tape an interview with the coach that he would use as part of his pre-game program. It was one harried and hurried day for Bob and his family.

The NHL eventually saw the light and stopped the practice. We don't watch sports on Christmas Eve or Christmas Day. We're having a better time experiencing the warmth, caring and sharing of Christmas with family members and relatives — on "the number one family day of the year." Will the NBA come to embrace those values and extend them throughout the league as the years go on?
