Mayor Michelle Wu announced the appointment of Roxbury native and former Dorchester resident Michael Cox as the 44th Commissioner of the Boston Police Department.

Cox served as the Chief of Police of the Ann Arbor Police Department in Michigan. Prior to his appointment to that position in 2019, Cox was a 30-year veteran of the Boston Police Department. He began serving in his new role on August 15, 2022.



Orange Line Shutdown Begins

The City of Boston Taking Steps to Mitigate the Impacts of The MBTA's Upcoming Orange Line Shutdown



Beginning **August 19, 2022**, the Orange Line will shut down for a month for safety repair work. The City of Boston is taking a cross-departmental approach while working closely with the MBTA, regional partners, and commuters. Our goal is to support immediate planning and ongoing monitoring of alternative shuttles and diversions.

The Orange Line is an essential service for Boston residents. The City of Boston is finalizing shuttle routes with the MBTA to replace service along Orange Line stops. This shuttle service will be at no cost to riders, ADA compliant, and help connect riders to Green Line service to fill-in service gaps.

ONGOING WORK

Transportation Department officials are planning bus priority lanes in key areas. The City of Boston is also working on pop-up transit mobility hubs at Government Center and Copley Square. These locations

will have extensive dedicated curb space and clear signage. Our goal is to help commuters navigate transfers to the Green Line and bus connections, and access to Bluebikes.

On the first day of the shutdown, Neighborhood Services liaisons will be present at impacted stops along the Orange Line to help travelers navigate alternative routes. We're using a cross-departmental approach to put together and distribute neighborhood-specific user guides on alternative routes. We're also prioritizing translating materials into the City of Boston's most used languages.

ALTERNATIVE FORMS OF TRAVEL

In addition to the shuttle bus routes, the City of Boston is helping residents access other modes of accessible, affordable travel. We strongly encourage residents not to drive in downtown Boston at peak times.

COMMUTER RAIL:

During the 30-day shutdown, riders can use the Commuter

Rail within the City of Boston at no charge simply by showing a CharlieCard or CharlieTicket on board. This encompasses Zones 1A, 1, and 2 on all Commuter Rail lines.

The CharlieCard does not need to be loaded with funds to access the Commuter Rail. Simply show your CharlieCard to the conductor. The City of Boston distributes CharlieCards at Boston Public Libraries through its CharlieCard Access Initiative.

BLUEBIKES:

To keep everyone moving during the Orange Line shutdown, the City of Boston is offering free 30-day passes to Bluebikes, the City of Boston's public bike share, during the upcoming MBTA Orange Line shutdown. Starting on August 19, passes will be available at bluebikes. com/join and in the mobile app. We have links to more information about this program, as well as tips for riding bikes in the city below.

Pressley Backs Sullivan Campaign

Recently, Tanisha Sullivan was in Mattapan Square firing up volunteers ready to go door knocking in support of her run for secretary of state. The morning of door knocking took place during the recent heat wave with U.S. Rep. Ayanna Pressley and State Rep. Russell Holmes at her side.

Sullivan is taking on 28-year incumbent William Galvin in what many view as a long-shot bid. However, Pressley said "Tanisha will be a bold, inclusive, collaborative secretary of state" and reminded everyone that a week before her own 2018 campaign, she too was a long-shot. She was polling 13 points behind Capuano before beating the incumbent congressman by 18 points in that year's primary.

Stirpe Nostra

A weekly column highlighting some of the more interesting aspects of our ancestry . . . our lineage . . . our roots.



CALIGULA

A study of all the stories, events, and characters associated with the rise and fall of the Roman Empire would be like reading an entire library, and would probably take 100 years to fully understand and record its beauties. A capsule explanation divides the history of Classical Rome into three distinct periods: 1. The Regal Period (the legendary kings like Romulus), 753 to 510 B.C. 2. The Republic (the time of the great Roman Senate, ending with the death of Julius Caesar), 510 to 27 B.C., and 3. The Empire (the period of Roman emperors starting with the great Augustus and ending with the pitiful Romulus Augustulus), 27 B.C. to 365 A.D.

During the period called the "Empire," there were many good emperors like Nerva, Trajan, Hadrian, Antoninous Pius, and

Marcus Aurelius. Unfortunately, along with the good, they also had to contend with the bad. There were rulers like Caracalla, who not only built one of the world's largest bath tubs, but was also noted for his brutality; Heliogabalus, who was noted for his debauchery; and Commodus, the son of Marcus Aurelius, who was reported to have been the most bloodthirsty and unruly emperor that has ever been recorded in all of history. Those of us who are in good health pay a daily tribute to the memory of this character.

Then there was Nero, the archenemy of all Christians, who was one of the cruelest, depraved, and despotic emperors that ever ruled Rome.

Finally, there was a nutcake named Caligula, who was just plain off his "Roman rocker." His reign got off to a pretty good start, but the finish just defies description.

Caesar was the family name of Gaius Julius Caesar, and after his death, the title of Caesar was given to all of the Roman emperors from Augustus to Hadrian. References are still being

made to these 12 Caesars whose popular names, in chronological order, are: Julius Caesar, Augustus, Tiberius, Caligula, Claudius, Nero, Vespasian, Titus, Domitian, Nerva, Trajan, and Hadrian.

Caligula was born of Germanicus and Agrippina in an army camp in the year 12 A.D., and was brought up among the legions. The name Caligula was given to him by the soldiers because of the "caligae," or army boot, that he was required to wear. His proper name was Gaius Caesar Augustus Germanicus and it was the name he preferred. As a young man, while in the court of his grandfather Tiberius, he displayed a naturally mean and vicious temper, a wanton love of cruelty towards persons of lesser rank, and a most abandoned and unprin-

cipled debauchery. He became a most eager witness to tortures and executions of prisoners, and he reveled at night in adultery and gluttony.

Greek and Roman mythology tells of Phaethon, the son of Helios the sun god, who borrowed his father's sun chariot and was about to set the world on fire through reckless driving when Zeus destroyed him with a thunderbolt.

Tiberius often said that to allow Caligula to live would prove to be the ruin of all men and that he (Tiberius) was breeding a viper for the Roman people and a second Phaethon for the destruction of the world.

The will of Tiberius made his two grandsons, Druses and Caligula, joint heirs to his private property. (What a mistake that was!) There are some conflicting reports about the death of Tiberius. One sure bet was that he did not die of natural causes. It was known that his death was not too far off and one day he fainted, consequently he was thought to be dead.

BOSTON PUBLIC SCHOOLS

BPS is communicating with families on a weekly basis to ensure that students who rely on the MBTA can:

- Access the support they need, and
- Identify and navigate alternative transportation routes if needed.

In addition, BPS is surveying all staff, with more than 700 respondents to date, to assess the impact of the Orange Line shutdown. BPS will continue working closely with the City of Boston and MBTA to ensure students and staff receive the support they need in the weeks to come.

ACCESS FOR PEOPLE WITH DISABILITIES AND SENIORS Shuttle Buses

While some low-floor buses with ramps at the front of the bus will be in use, the majority will be high-floor coach buses with wheelchair lifts near the rear of the bus.

Accessible Vans

Approximately 20 wheelchair accessible vans will be available upon request at Orange Line stations. Anyone with a disability can request a van. These vans will be a combination of ramp-equipped and lift-equipped vehicles.

Accessible vans (including MV1s) will service all Orange Line stations, including those not serviced by the shuttle buses.

Shuttle Stops

The City of Boston is designating curb space that is dedicated to accessible vans in addition to the curb space designated for shuttles. The City of Boston has assessed the shuttle stops for accessible routes and level landings for lifts and ramps of shuttle buses and vans.

The RIDE

RIDE trips that begin and end within ¾ mile of the Orange Line will be free for RIDE users during the 30-day shutdown.

Commuter Rail

TAP passes can be used in place of Charlie Cards for access to the Commuter Rail at no charge. For more information on accessibility, see the Commuter Rail Access Guide.

The City of Boston is committed to transparency throughout the shutdown. We will provide regular updates as plans are confirmed on the municipal level.

The 102nd Madonna Della Cava feast honoring Maria SS Della Cava, took place August 12–14, 2022 in Boston's North End. The three-day celebration culminated in a grand procession carrying the image of the Madonna through the streets accompanied by society members and marching bands.

On the second week of each August, the North End celebrates the Feast of Madonna Della Cava, which coincides with the festival held in honor of the Principal Patron of Pietraperzia, Sicily.

The traditional use of a cloth banner of the saint – rather than a statue – is based on the belief that a statue will fall and crack, just like the stone bearing the image of the Madonna once did so many centuries ago.

For over a century, the Feast of the Madonna Della Cava has been celebrated in Boston's North End, initially by members who were all first-generation Italian-Americans. Today, the Feast is celebrated by loyal members, family, friends, and tourist.

The Madonna Della Cava Society's membership now includes people from several of Boston's neighborhoods and the surrounding suburbs, many of whose relatives first settled in the North End.

The events held by the Society during the year sponsor several community children and religious organizations.
















L'Anno Bello: A Year in Italian Folklore

Celebrating the Season Cycle

The photos begin to inundate social media around this time of year: coffee shops advertising their wares with well-lit shots of cardboard cups stacked high with a frothy cloud of whipped cream and sprinkled with the reddish glitter of cinnamon, surrounded by the seasonal trappings of orange gourds. After all, the end of August means a plethora of announcements concerning the release dates of pumpkin spice lattes, the ne plus ultra of spicy fall drinks for java lovers. Pumpkin season is still fairly far-off, but these ads serve as yet another reminder that autumn, my favorite season, was quickly approaching. Indeed, I have lately been paying attention to the signs of the changing season all around me, from the prevalence of apples in the supermarket to the ever-soslight hues of red and orange appearing on some leaves. When the days get too humid and sticky - which I am fine with at the beginning of summer but find unbearable when crafting lesson plans or setting up my classroom for the next school year — I think of the harvest decorations I continually see in stores, and shiver with excitement over the crisp days of fall. Observing the signs of the changing seasons not only helps me live in the moment by concentrating on the natural phenomena currently unfolding around me, but it links me in a powerful way to the actions and lives of my ancestors.

Tracking the seasons has been a passion of mine long before I started this column. While clearing out a drawer in my old room, my mother found an old notebook of mine in which I had been charting the natural signs of the changing seasons. For the shift from nmer to autumn, I wrote about witnessing my uncle and *mia*, or harvest, in September.

grandmother planting the bulbs of a daisy, called a margherita in Italian, which would bloom in late September. I mentioned a gnarled tree whose leaves always turned a kaleidoscope of yellow and red a month early and floated to the ground well before the calendar turned to autumn. Baking an apple dessert, cool mornings, the color of the early twilight — all of these observations made it into that little notebook. Doing so helped me become a better observer of nature and of the excitement of life around me, and I hope to resume this sort of project again soon. Noticing and recording the shifting tide of the seasons actually has a scientific name. It is known as phenology, and naturalists often encourage people to sketch or write down their observations and then submit them in order to help scientists track climate data. Therefore, this hobby is both romantic and functional!

This pastime is apparently quite timeless as well. Our ancestors have been discerning the seasonal changes since time immemorial — not because they were eager for pumpkin spice lattes or photographing falling leaves, but rather because they operated in a primarily agricultural society where determining the right time to plant or harvest crops was invaluable to the survival of the community. In Italy, August functions as the month of the grain and hay harvest, and tightly rolled bundles of hay baking under the sun serve as one of the surest signs that autumn will soon descend upon the lovely Italian countryside. Italian farmers also examine their grapes during this month, ensuring they are getting the right amount of sunshine, water and shade to make them perfect for the vendem

After all, grapes stand as an important cultural symbol in Italy, for the grapes gathered in September will be processed into wine in November, ready to serve as the steadfast staple of Italian hospitality during the holidays and beyond. Finally, Italian farmers of yore frequently used saints' days as milestones for seasonal changes, a trait which is reflected in the proverbs still ubiquitous in Italian society to this day. August 24th is St. Bartholomew's Day, and the Italians repeat a proverb which declares: "A San Bartolomeo montagna mia bella ti abbandono." Translated, this dictum says that one should abandon the beautiful mountains after the Feast of St. Bartholomew, perhaps a reference to the cooler weather and the end of the vacation period. When we notice even the simplest transitions from one season to another, therefore, we are actually repeating the actions our forebears performed in order to carve out a living from the Earth.

As the bright days of summer give way to the cool nights of fall, I encourage everyone to keep track of the unfolding seasonal changes. These transitions do not have to be major, as even the tiniest details like a sip of apple cider or a yellow school bus can signal the start of an exciting new season. Let us become seasonal detectives, paying close attention to the evidence of nature's eternal cycle. By doing this, we become closely attuned to Mother Earth which has nourished us and our ancestors for so long, and we learn to live in the moment by understanding the natural beauty of the here and now. If we welcome every season with optimism and a healthy dose of respect, then the bounty of the Earth will love us in kind, no matter which latte we drink!



We left Grandma's flat and headed toward the church. Saint Theresa's procession was just minutes away. "Angie, here comes Saint Theresa," Grandma announced. Her voice tinged with a sense of anxiety and expectation. "Ma, let's stand near the entrance of the church. I want to see Father Francesco greet Saint Theresa," Auntie Angie responded. "Angie, keep an eye out for Pietro. I want to get to him before he does something foolish. Remind Stella and Carmela to keep an eye out for him," Grandma warned.

The procession was now entering North Square; the familiar strands of "Mama", played by the band, heralded the coming of the Saint to the faithful gathered in the square. Saint Theresa was hoisted high on the shoulders of the litter bearers. Blue silk streamers pinned with money, donations from the faithful, each streamer held by a Society member, radiated out from the front, sides and back of the Saint. It was a sight from Southern Italy recreated in America. Carla walked to the right of the Saint, gracefully holding one of the streamers in her left hand. needs to look like the communities which we serve and include every resident to hear what is important so we can serve better. I took on public service because I wanted to help the public and give back to the communities in which I lived."

Cox's appointment follows a six month search spear-headed by the Boston Police Commissioner Search Committee chaired by retired Justice Geraldine Hines of the Massachusetts Supreme Judicial Court.

After a series of interviews, the Committee recommended finalists to the Mayor, who made the final selection of Michael Cox to be the Commissioner of the Boston Police Department.

"I am confident that Michael Cox is the right person for the moment in our city's history and that he will serve with the utmost integrity," said Justice Geraldine Hines.

Cox last served in BPD as the Bureau Chief and Superintendent of the Bureau of Professional Development, overseeing the Boston Police Academy, the Firearms Training Unit, the Police Cadet Unit, Recruit training and in-service training for all sworn Boston Police personnel.

He served a total of 15 years on the Command Staff in a variety of positions.

Before his Command Staff assignments at the Boston Police Department, Cox worked as a Sergeant Detective in the Intelligence Unit where he performed Dignitary Protection duties, served as the liaison to the U.S. Secret Service, and as a supervisor assigned to the Joint Terrorist Task Force. At this rank, he also served assignments in the Internal Affairs, Recruit Investigations, and Audit & Review Units. As a Police Officer, Cox worked in Area B-3 until joining the Citywide Anti-Gang Violence Unit. He was promoted to Sergeant in 1995. Cox is a two-time Medal of Honor recipient and received numerous other Commendations and awards while serving in the Boston Police Department.

Cox is a graduate of the FBI National Academy, Police Executive Research Forum and holds degrees from Providence College in Business Management, Curry College where he obtained a Master's in Criminal Justice, and Boston University's Questrom School of Business where he obtained an MBA.



ITALIANS: Our Origins

Without a doubt, all people who have come to Italy have left their mark. Their blood has mingled with the original inhabitants of the Italian peninsula for more than 200,000 years before the founding of Rome in 753 B.C. The Villanovan culture (c. 900–700 B.C.), regarded as the earliest phase of the Etruscan civilization, was the earliest Iron Age culture of Central Italy and Northern Italy. Other inhabitants who lived in Italy thousands of years ago were the Sicans, Sicets, Elymians, and Romans.

Many groups entered Italy as invaders and/or settlers. The list below represents some of these groups but does not include others who have immigrated to Italy in modern times including Ethiopians, various nationalities from North Africa and other refugees from around the world. The island of Sicily was particularly attractive to some of these groups.

Normans – French from Normandy who are descended from the Vikings

Greeks, Saracens – Arabs Phoenicians – modern Africa Spanish, Carthaginians – northern Africa Byzantines – Turkey Aragonese – Spain

Serbs, Franks - Germany

Spartans – Greece Austrians, Vandals, Goths, Croats, Slovenes, Ostrogoths, Swabians – Germany Angevines – western France Jews, Albanians, Etruscans – Middle East

Many Italians that you meet do not necessarily fit the Italian stereotype. Some Italians have blonde, red, brown, or black hair. If you travel to Italy you encounter some Italians with a light complexion while others are on the dark side. I often hear, "you don't look Italian." How could we "look Italian" when our ancestors came from

An Italian is a citizen of Italy who shares a common cultural heritage. Italians have a certain common way of viewing the world and of handling social interactions. For example, the building block of all Italian society is primarily the family. Italians are a people in possession of a common standard language, heritage, traditions and customs.

A majority of Italians look to the cities and urban life for models of behavior. Religion, education and migration have all had an effect on the degree to which Italians evidence a national consciousness. Italy is a mosaic of different peoples and customs on the surface; but Italy is divided to a greater degree on a socioeconomic level rather than cultural-linguistic influences.

Contrary to most views, Italians relish their uniqueness as a people. It is still possible to state that Italians have many shared characteristics while at the same time acknowledging the existence of so much diversity. In fact, the Romans ruled a large part of the known world for around 500 years, mingling their blood with the French, Germans, Spanish, English, North Africans, Middle Easterners, etc. Italians have married into many other ethnic groups across the continents resulting in a vast amount of humanity around the world that have legitimate claim to "roots in the boot." Even though Italians are related to people spanning the globe, a much larger number of them have adopted Italian food, fashion, music, art, architecture, etc. Italy has the fifth largest economy in the world and thus carries a commanding influence. Italians to this day continue to have an effect on the whole of society through their great contributions to the entire world.

While today's Italians come from many origins, they have more in common than most believe. You see and feel a thread that unites a people when you travel throughout Italy's many regions. You know you're in Italy no matter what part you choose to visit. Today, 96% of the Italians speak the standard Italian language. A common language, education and modern media and communication have helped to unite the Italian people. The diversity that exists in Italy doesn't bother the average Italian. Italy and the Italians have become true models for *unity in diversity!*

Saint Donatus of Arezzo

According to the account of Bishop Severinus, as a child Donatus came to Rome with his family from Nicomedia. He was orphaned, during a persecution, and named by the bishop of Arezzo. The Latin name Donatus translates into English as donated. Donatus was educated by a Christian priest named Pymenius, his friend and companion in these religious studies was a boy named Julian — who would later become Emperor Julian the Apostate. Julian rose to the position of sub deacon; Donatus became a lector. Saint Peter Damian would later write in his

Sermons that "in the field of the Lord two sprigs, Donatus and Julian, grow together, but one will become a cedar of Paradise, the other coal for the eternal flames of Hell."

On February 4, 362, Julian issued an edict to guarantee freedom of religion. This edict proclaimed that all the religions were equal before the law, and that the Roman Empire had to return to its original religious eclecticism, according to which the Roman State did not impose any religion on its provinces. Christian historians considered that it had as its purpose the restoration of paganism at the expense of Christianity. Catholic tradition states that Julian also persecuted individual Christians, and that



Donatus' parents, as well as his teacher Pymenius, would die during these persecutions. Donatus escaped to Arezzo and would work with a monk named Hilarinus to preach the Christian faith, as well as perform penances and miracles.

Donatus was ordained a deacon and priest by Saint Satyrus of Arezzo, bishop of that city. Donatus continued to preach in the city and in the surrounding region. At the death of Satyrus, Donatus was appointed a bishop by Pope Julius I.

During a celebration of Mass, at the moment of the giving of Communion,

in which a glass chalice was being administered, some pagans entered the church and shattered the chalice in question. Donatus, after intense prayer, collected all of the fragments and joined them together. There was a piece missing from the bottom of the cup; miraculously, however, nothing spilled from the cup. Astounded, seventy-nine pagans converted to Christianity.

A month after this episode, the prefect of Arezzo, Quadratian, arrested Hilarinus the Monk and Donatus. Hilarinus was martyred on July 16, 362 and Donatus was beheaded on August 7th at Arezzo. The Feast Day of Saint Donatus of Arezzo is August 7th.

A Nostalgic Remembrance



Son Michael and daughterin-law Kathy recently hosted a baby shower. In September, Loretta and I will become grandparents once again. Their first baby will be named Dante, and he will be our third grandchild and second grandson. Son John, our oldest, and his wife Beth, have two children, Lina and Nathan.

Anyway, Mike and Kathy recently hosted a baby shower that included their friends from my generation. Some of their friends from their generation came all the way from Florida to the south and Hollywood to the west, but considering our ages and health conditions, the only old folks from Boston who could attend were Loretta's brother, Mike ... who my son Michael is named after, his wife, my sister-in-law, Lin, and my closest friends: Dean Saluti and his wife, Margie Cahn. Kathy's parents and a few cousins came in from California and Nevada, so the gang from Boston decided to stay at a nearby motel rather than crowding in at Mike and Kathy's place.

For a couple of days before we left for the event, Loretta began cooking her Italian specialties for the entire crowd. Kathy's mother did the same thing only her specialties are Korean. My sister-in-law, Lin made rigatoni Sicilian style (There was enough food to feed the entire crowd for several days.) I found it difficult to eat Loretta's Chicken Parmigiana and Lin's pasta with chop sticks and switched to a knife and fork when the Italian food was served.

I spent a lot of time with Dean and Margie. Dean and I have been "hanging out" together since Labor Day weekend in 1973, when I met him vacationing on the Cape. That was almost 49 years ago, but considering what's been going on the past couple of years with COVID, we've been apart from each other to a great degree. It felt like old times for the few days we were together. I was extremely happy.

After we returned home, I needed something from a Walgreen's. I headed to the one nearest me, and accidently ran into a second cousin of mine, Elizabeth Beatrice. Her mother and mine were first cousins due to her grandmother and Nanna being sisters. I hadn't seen her since my mother's funeral a few years back and we blocked an isle at the drug store, just standing around reminiscing. Elizabeth mentioned that she had a bowl that belonged to Nanna. It was either loaned or given to her mother by

Nanna and it was only used on Christmas Eve in the old days. She added that she wanted to return it to me seeing it was my grandmother's. The next morning, I headed to her house for coffee and a peek at the bowl. When I saw it, it looked familiar and I remembered it being used only on Christmas Eve when Nanna was alive and well.

I brought the bowl home and stared at it for quite a bit, my memory banks going full blast. Finally, it came to me ... It wasn't Nanna's originally, it was her mother's. In retirement, Nanna's parents came to the U.S. and settled in with Nanna and Babbononno. I don't remember my greatgrandmother as she passed away before I was born.

But, I do vaguely remember Nanna's father, my great-grandfather, a short bald headed man. They had all of their belongings with them when they arrived and the bowl was part of the shipment. So, I am the 4th generation in my family to have the bowl, and maybe someday, one of my sons will inherit it to make it 5 generations in a row. The one thing that puzzles me is what it was used for ... eggnog or food ... I'm not sure.

Unfortunately, there is no one to ask as no one from my grandparent's or parent's generation is left, they've all passed on.

The important thing for me is reconnecting with cousin Elizabeth. She doesn't know this, but when I first started out as a musician and needed a ride to a job, her father would either drive me or loan me his car. Before they moved to the suburbs, Al Beatrice, (her father) would drive from Jefferies Point to Eutaw Street in the Eagle Hill section of East Boston, pick me up and drive me to wherever I was playing. If he had something cooking, I would drive him to his hangout, the Progressive Club located (I think) on Cottage Street in the First Section (another name for East Boston's Jefferies Point).

If Al had something cooking at the club, I would borrow the car and return to find him at 1:00 or 2:00 a.m. When I would arrive at that hour, it would seem like 1:00 or 2:00 in the afternoon with all that was going on. I wonder if the club still exists ... back then, it was just a storefront like many that existed in East Boston and the North End.

I remember one night when Al gave me the car; I had a problem when I finished the job I was playing. I packed up and planned to head back to Eastie and the Progressive Club. I

turned the key to start the car and the battery was dead. It was 2:00 in the morning, and luckily, I had the phone number for the club in my wallet. Before the function facility closed, I went back inside and called the club and asked for Al. When he picked up the phone, I explained my predicament. Al didn't have an AAA card and told me not to move from my location. A half hour later he and another man showed up with a new battery. They installed it and the car started, making us all happy. Once back in East Boston, Al insisted we head for the Progressive Club before he brought me home. I don't remember if he wanted to finish a card game or a drink he had left behind. Thinking back, those were fun days in spite of any problems.

While visiting with second cousin Elizabeth, I gave her my condolences. A while back her younger brother, Allen, passed away due to coming down with Leukemia. Loretta and I were in Florida when he passed on and I didn't find out until a bit later when I had a conversation with my late Aunt Ninna, Uncle Gino's widow and the last member of my family from that generation.

Somewhere in the cellar, I have pictures of everyone I've mentioned and many more family members. What I plan to do is sort them out, identify everyone and make copies, either hard copies or electronic copies for each one of my sons. For years, they've heard the stories about the Christoforo and Contini families and I want them to know where their roots came from. Neither of my boys has married an Italian and the cultures of my daughters-in-law might be different. Not having any brothers and sisters, I guess it's up to me to make sure my boys know who their ancestors were. I kiddingly once told my sons when they were children, "I can go back to Roman days; our ancestors sold used chariots in downtown Rome." You know something, this could be true.

One of Italy's most famous confections are "biscotti". Biscotti, plural for biscotto, translates to biscuit or cookie. Named "bis" and "cotto" or twice baked, after their original method of baking; the second bake draws moisture out of the dough and increases shelf life. Food historians credit Tuscany, specifically Antonio Mattei for creating the first biscotti, Cantuccini (made with almonds). The biscotti you find in this country range from soft and crunchy to dry and hard; and plain to flavored. The varieties are endless, and there isn't an Italian coffee bar that doesn't serve them. Italy's preferred method of eating hard, dry biscotti has always been to 'dunk" them in a glass of Vin Santo. Today, "dunking" them in coffee is also widely accepted. Those on the softer side tend to go well with an espresso or cappuccino.

My Nonna has countless recipes for biscotti, and because most of my family preferred a soft crispy over a hard dry version, many she made reflected this preference. She used numerous recipes that included various ingredients. It was hard to choose a specific dough recipe or flavor to share, because one is honestly more delicious than the next. So, when a reader reached out and asked if I had a good recipe for "Almond Biscotti", I knew immediately which one I would share. "Nonna's Almond Biscotti" are crisp, crumbly and full of flavor. Firm enough to dunk in a Vin Santo, and an even better the perfect accompaniment to a Caffe Freddo or a Shakerato. Enjoy!

NONNA'S ALMOND BISCOTTI Biscottio alle Mandorle della Nonna



1 stick butter, softened 3/4 cup sugar

3 eggs

2 ½ teaspoons almond extract 1 teaspoon vanilla extract

3 cups all-purpose flour 2 ½ teaspoons baking powder

½ teaspoon salt 3/4 cup sliced almonds

Line a baking sheet with parchment paper and set aside. Preheat the oven to 350°.

In a large mixing bowl, cream butter and sugar until light and fluffy. Add eggs and extracts and beat together well.

Sift flour, baking powder and salt together. Gradually add this dry mixture to the wet, mix together and then fold in the almonds.

Split dough in half and roll each section into a log the length of the cookie sheet. Place two logs, spread apart, on each of the prepared cookie sheets. Pat down so they are even in height and width. Bake at 350° for 25 minutes. Slice and place slices face down on the baking sheet and second bake for about 8 to 10 minutes on each side. Store in a cookie tin to retain crispness.





Looking for the Knockout A Lesson from Watching George Benton in Action

Recently, I wrote about the fight between Holly Mims and Ruben Hurricane Carter. In it I explained how this fight was a great learning experience for the up and coming Carter in that he found that he could not rely solely on his awesome punching power as he moved up against more experienced opposition. Many fighters with a big punch became overconfident in the belief that because they had been able to kayo a lot of opponents they could fight their way to the top by flattening all those they face. These boxers became headhunters and were always in for a rude awakening when faced with talented fighters who could neutralize their power.

It wasn't usual to hear good fighters respond when asked about whether or not they would knock out an upcoming opponent with the answer "I'm prepared to go the distance, if the opportunity for a knockout presents itself I will take advantage of it". Good trainers always taught their charges to be prepared for whatever distance the fight is scheduled for; to not go out there looking for a knockout. To focus on winning the fight by boxing smartly and that a win by a decision is just as good as a win by a knockout.

A fighter looking to flatten his opponent from the opening bell would become frustrated and tired out when he couldn't deliver the coup de grace and found himself swinging at air. One shining example of that was the Ali/Foreman fight where Big George thought he could do to Muhammad what he had done to Ken Norton and Joe Roman. By the seventh round Foreman was sucking wind from throwing so many punches that missed their mark. In the eighth he went down as much from exhaustion as from the punches Ali landed on him. He was on the canvas unable to get up while gasping for air.

This would not happen to Ruben Carter as he moved along in his career. While never winning a title, and still scoring a large number of knockouts, he was always able to go the distance because he was prepared mentally to do so. I credit the Mims fight with setting him on the path of developing the mental toughness to adapt his style.

Now, let's look at another fighter: George Benton. George had a solid punch but was also a cagey boxer. While knocking out almost half his opponents, Benton was never a headhunter. He was methodical and was content with going the distance, but if Benton saw an opening he knew how to take advantage of it. I would also argue that while he was a solid puncher, a lot of his kayo wins came because of his accuracy in delivering punches. George didn't just throw a lot of punches hoping to land the big one. No, he would set his opponent up. A perfect example of this was his fight against Johnny Smith at the Olympic Auditorium in Los Angles on August 31, 1963.


Smith was a hard punching middleweight who was on a roll having just scored four straight knockouts and was looking to break into the big time. A win over Benton would assure him of the notoriety he was seeking.

The fight is a perfect example of a great boxer seeing an opening and taking his time while making the moves to set his opponent up and score the knockout.

When the bell rang for the first round the rangy and taller Smith came out boxing smartly and moving forward behind a sharp jab. Benton fought out of a half crouch. Benton parried some of the jabs but was more focused on slipping them by leaning to his right, getting to the outside of the straight shots. He was being patient but you can see that he was picking up on a flaw in Smith's attack.

As Benton kept leaning away and making himself a smaller target, Smith began to reach with his jab. Benton using a mental ruler was working to place himself in a good position to throw a counter right hand in response to the jab. He was also making himself a smaller target for Smith by getting down lower in his crouch.

In the second round Benton's moves were working. Smith continued to throw the jab, but was now starting to punch down at George, a very bad move for a fighter. Watching Benton you can see how he was now getting ready to counter with the right hand. What is surprising and what really caught Smith off guard, is Benton did not counter over the jab. Instead, he slipped inside of it and landed the right hand

straight on Smith's jaw. It was a short, perfectly timed punch that put the young Smith down for the count.


It is very interesting to watch this fight. Pay close attention to what Benton is doing and it is almost as if you can read his mind. He is patient and methodical. He doesn't get hit with even one decent punch, yet he is staying just within range of the taller Smith. That final punch was really a great move in that it appeared George was going to throw a counter right over the jab, instead slipped inside with that short right. He very well may have done this as insurance just in case Smith was expecting the overhand right and had a plan to counteract that, though I doubt Smith did.

This fight ended with a solid knockout in less than two rounds, yet it was still a display of brilliant boxing. Benton picked up on a flaw in Smith's style early on. He took his time, if needed he would have taken a few more rounds to set up the counter, but he didn't have to. Smith took the bait by reaching down right away. Benton could have started throwing right had counters from the onset, but if he did before getting his range, the punches may have missed the mark and Smith would have had a warning to watch out for them. By biding his time, Benton was able to put himself into just the right spot to be successful when throwing the punch.

Instead of reaching down in his attempts to reach the crouching Benton, Smith should have bent his legs and gotten on the same plane as George. This would have made it much more difficult for Benton to move in. Johnny would have been much better protected and his punches would not have had to travel as far, thus keeping him from reaching and leaving his chin vulnerable.

George Benton went go on to become one of the great boxing teachers. He and Eddie Futch were in the corner with Joe Frazier for the third Ali fight. He also worked with Wille Monroe and accompanied him to Boston for his second fight with Joe Frazier. George died in 2011 at the age of 78.

This fight is on YouTube and is worth watching. It's another display of just how much boxing is a game of mental chess.



It sure is nice to have Patrice Bergeron back in the fold on Causeway Street. The veteran center will begin his $20^{\rm th}$ season when the Bruins face the Capitals on opening night in Washington. It will be the 1, $237^{\rm th}$ NHL game for the all-star who was born and raised in Quebec.

His story has been well-chronicled in Boston media over the years. It is a bit surprising to recall that he was drafted a bit low — being selected in the second round (45^{th} overall) in the 2003 NHL Entry Draft.

Perhaps more surprising, however, is that the Bruins also had a first-round pick in that draft — and did not use it to selected Bergeron. Instead, they chose to go with Mark Stuart, making him the $21^{\rm st}$ selection overall in the draft.

We all know what happened to Bergeron. The stellar center is still with us, at least for another year. But whatever happened to Stuart, the one selected some 24 places ahead of Bergeron? After all, Bergy has turned out to be one of the best players in the history of the franchise. Whither went Stuart?

The answer is that Stuart's selection started him down a path of what has become a long and somewhat winding road, one that did include a significant NHL career of his own that comprised 12 seasons, six of them with the Bruins. That made Stuart and Bergeron teammates for a half dozen seasons early in the 21st century, a time when the Bruins were still searching for that Stanley Cup title that had eluded them since 1972.

By the time it was captured in 2011 Bergeron would be there to experience the euphoria with all his teammates. Stuart, however, would be gone, missing out on the big moment by only a few months. He had been traded, along with Blake Wheeler, to the Atlanta Thrashers (now Winnipeg Jets) in a February trade deadline deal.

Before the move he had played in 283 regular season games for the Black and Gold, dating back to the start of the 2005-2006 season. Following his selection in the 2003 draft, Stuart had chosen to delay moving on to the National Hockey League, opting instead to remain with Colorado College.

That turned out to be a productive decision in its own way. First, because by remaining in the college ranks, he missed the 2004-2005 NHL lockout. In addition, he was elected team captain and proceeded to lead Colorado College to a berth in the 2005 NCAA Frozen Four. There the Tigers were beaten by the University of Denver and finished with a 31-9-3 record.

A defenseman who had offseason knee surgery during the summer of 2005, Stuart split his first two seasons with the Bruins and their American Hockey League affiliate in Providence. In the following two seasons (2007-2008 and 2008-2009) Stuart played in all 82 games for the Big B's on Causeway Street, collecting nine goals and 20 assists in the process.

During the 2009-2010 campaign he saw action in 56 games. He then played in 31 games during the 2010-2011 season prior to his being dealt to Atlanta. While not being with the Bruins when they raised the Cup in triumph that June had to be a major disappointment, there was a silver lining. Less than two weeks after the trade, the Thrashers (who became the Jets later in 2011) signed him to a three-year \$5.1 million contract. Then in 2014 came the real bonanza: a four-year \$10.5 contract extension.

Those two financial windfalls essentially set up Stuart for the time that would follow the conclusion of his playing days, a career that included 673 regular season games, 26 goals and 67 assists for 93 points.

Free from the financial concerns that many have, he could turn to a career behind the bench, even though at first he would have to do so on a voluntary basis.

So, after playing in Europe during the 2017-2018 season, he took some time to attend to some unfinished business. He completed his college degree and was able to spend more time with his wife Christina and children.

During Stuart's final year in Winnipeg, Todd Woodcroft had been an assistant coach with the Jets. Woodcroft would move across North America to become the head coach at Vermont. In the fall of 2020, Stuart became the coaching rookie on Woodcroft's staff, a volunteer assistant with the Catamounts. The new coach was also able to learn from another experienced NHL mentor. Serving as a volunteer advisor to the UVM coaching staff that season was Mike Babcock, who had been dismissed by the Toronto Maple Leafs four years after signing a reported eight-year, \$50 million contract.

Following a year in Vermont's Northeast Kingdom, Stuart was hired by his alma mater (Colorado College) for the 2021-2022 season. That was also a one-year stop. This spring the phone rang once again and Stuart was back in the NHL — this time as an assistant with the Edmonton Oilers.

And how did that happen? Well, we think the fact that Jay Woodcroft, the current head coach of the Oilers, who also happens to be the brother of Vermont coach Todd Woodcroft, had a bit to do with it

Jay Woodcroft said he wanted "a former NHL player, someone not too far removed from playing at the highest level." He added that he was "looking for someone who spoke the language of today's players. Someone who can relate to the pressures that today's players go through."

He added that Stuart "had a very good perspective on the game. He was a first-round draft pick, played for different organizations in different cities and is hard working and very intelligent."

Quite a career for the man who was picked higher than Patrice Bergeron by the B's in the 2003 NHL Draft. Bergeron has the glory and the fame. And Stuart, like his former teammate, is still in the game. Truly a positive outcome for both after all these years.
