104th Annual Fisherman's Feast

The 104th annual Fisher-man's Feast in honor of the Madonna del Soccorso (Our Lady of Help) took place last weekend on North, Fleet and Lewis Streets in the North End. The festival is sponsored by the Fisherman's Club, a society founded in 1910 by immigrants from Sciacca, a city on the west coast of Sicily.

The tradition of honoring La Madonna del Soccorso dates back to the 16th century. The festival culminated with the traditional flight of the angel was held on Sunday evening. A young girl, normally a descendant of an original member of the society, was lowered from a third story window and recites prayers and a greeting to the Madonna. This year's Flying Angel was Serina D'Amico, with side angels Haley Graffeo-Dufresne and Angelina Palazzolo. The festival also featured Italian-American entertainment with Boston's own DooWop Acappella Group Street Magic on Thursday and Sunday evenings, The Bronx Wanderers on Friday, Saturday night's performance was by Angelo Venuto and the Voices on the main stage and Lynda Rose on Sunday afternoon. The North End's own DJ Sal Bartolo provided entertainment throughout the weekend.


Holder says, race is a component, but so too is ideology. He is playing the blame game. It is either racism or those fanatical tea baggers.

SATURN



Our journey into mythology has now covered its origin and the Primeval Beings. These Beings represented darkness, earth, day, night, atmosphere, the heavens and Hades. We also noted that the "Titans" who followed, were giant deities, forerunners of the mythological gods. Cronus, the leader of the Titans, used a great sickle of stone to castrate Uranus (heaven), and from his blood sprang up the three avenging deities that became known as the Eumenidies. Their function was to pursue or hound anyone who was guilty of shedding a kinsman's blood.

Before continuing with the Greek Titans, I feel obliged to mention some interesting facts about Saturn (not Satan), the Roman counterpart to Cronus. Saturn was also the Roman god of agriculture and of the sowing of the seed. The remains of his temple still overlook the rostrum in the Roman Forum. It was here, under the protection of Saturn that the Romans kept the flags of restraint. Every homeowner their legions, the public maintained "open house" treasury, and the bronze and invited to his table, tablets containing the engraved decrees of the Roman Senate.

A great festival in Saturn's honor was celebrated each year, starting on December 17th, just after the harvest was completed. The affair was called the "Saturnalia," originally a one-day festival which grew to six or seven days.

Many historians consider

it to have been the prototype for our American Thanksgiving Day, Christmas Season, the Mardi Gras and the typical Italian Carnevale, all rolled up into one great big bash. It became a period of joy and good will, many banquets were held, people visited friends and exchanged gifts.

Slaves were allowed temporary liberty to do as they liked, granted freedom of speech, and were permitted to treat their masters as social equals.

Normally, the Saturnalia in old Rome was one of relaxation and merriment. No business was conducted, no punishment was inflicted, and schools were closed. All classes of people exchanged gifts. The most common being little wax candles called "cerei" and clay dolls, called "sigillaria," which were given to the children. Garlands of ivy were worn by people who filled the streets shouting "Ho Saturnalia." Mirth and frolic were usually indulged in without any as many guests as he could find. Throughout the season there was unrestrained eating, drinking, and an abundance of sweetmeats. Everywhere people greeted each other with "Bona Saturnalia." Remember it all started about 500 years before the birth of Jesus Christ. Buon Natale!


Saint Anthony's Grand Procession


Jim Luisi, CEO of North End Waterfront Health, has been a key player in providing affordable health care options to the citizens of the North End of Boston for over 40 years.

ANNOUNCEMENT COMITES ELECTIONS

Please note that in the Official Gazette n. 179, released August 4th 2014, Decree-Law n.109 was published and included, in article 10, provisions regarding the renewal of the COMITES (Committees of Italians Living Abroad).

As provided by Law 286/2003, the right to vote in the upcoming COMITES will be exercised by correspondence. Electoral ballots will be sent ONLY to voters who meet the requirements of the law and which have expressly requested to be registered by their closest Consulate, having filled out the registration form at least fifty days before the set date for voting.

The Consulate General of Italy in Boston will communicate the exact date of the elections, tentatively they will be held in the month of **December**.

It is noted that the above mentioned measures, albeit laws now, are subject to parliamentary changes and thus may, at some point, be amended.

As of now, requests pertaining to the inclusion and registration to the electoral lists of the upcoming COMITES elections can be presented by attaching a signed non-certified copy of the identity card of the applicant. These may be submitted by:

Helena or Flavia Julia Helena Augusta, was a native of Bithynia, (Asia Minor), she was born in the year 248. Helena was of humble parentage; St. Ambrose refers to her mines and to recall persons from exile. In as a stabularia or innkeeper. only son, Constantine (Constantine the Great), was born in Naissus in Upper Moesia, (Serbia) in the year 272 A.D.

In the year 292, Constantius for reason of ambition and politics, divorced Helena in order to marry Theodora, the step-daughter of Emperor Maximianus. He was made Caesar, deputy emperor of Rome. Despite his father's divorce, Constantine remained faithful and loyal to his mother Helena.

On the death of Constantius in 308, Constantine, who succeeded him as emperor, summoned his mother to the imperial court, conferred on her the title of Augusta, ordered that all honor should be paid to her as the mother of the sovereign, and had a coin struck bearing her effigy.

Her son's influence caused her to embrace Christianity after his victory over Maxentius at the battle of Milvian Bridge.

The Roman historian, Eusebius speaks of her youthful spirit when, at the age of 80 in fulfillment of a vow, she made a pilgrimage to the Holy Land. Helena received almost unlimited funds from her son and spent it on royal charities to the poor of the region. She used her power to free prisoners and criminals condemned to the

> and adorned the buildings with costly offerings. She was also generous to the poor of Rome. Helena is believed to have died in Nicomedia. She is credited with having discovered the True Cross while on pilgrimage in the Holy Land. The feast of Saint Helena is celebrated on August 18th. Helena is depicted in art as an empress holding a cross.



The Golden Age of Animation Part 1: Disney's Beginnings



"The Mouse that Built an Empire."

The Golden Age of Animation began when Mickey first spoke in Steamboat Willie, but the early sound years were also the time when the pantheon of cartoon stars that have become emblems of classic animation began to evolve and take shape into the stars we know today. Today, the cartoons of the early to mid-30s (at least those produced by the main studios) are interesting for, among other things, origin points for the animated stars we got to know so well. Mickey Mouse himself didn't start life in his moreor-less recognizable appearance seen in Steamboat Willie. While he was still trying to work out an agreement with Charles Mintz for his Oswald cartoons, Walt Disney had secretly made two cartoons featuring the Mouse in case he would have to give-up his lucky rabbit. In both Plane Crazy (a tribute to Charles Lindbergh a year after his famous flight) and *The Gallopin' Gaucho*, the mouse and his sweetheart Minnie appear more rodent-like than they would in Steamboat Willie, their third short produced but first released (a form they would inexplicably revert to in the following year's *When the Cat's Away*).

As Walt observed in a retrospect of his beloved creation's career, in Plane Crazy Mickey has neither shoes nor much of a voice (sound effects were added when the cartoon was finally released post the introduction of sound), but it did mark something that would become a Disney staple. It gave the mouse a staple of barnyard buddies that would join in his adventures. Eventually they would morph into Horace Horsecollar and Clarabelle Cow, whose cartoon careers were relatively short and are best remembered today for their parts in the Mickey Mouse comic

The Depression years saw more cartoon births that continue to enjoy a strong popularity today. Pluto, the Mouse's dog and loyal companion, made his debut in 1930, ironically, as a foil for Mickey in the atypical short The Chain Gang. Goofy was first seen by audiences in 1932's Mickey's Revue and, though he was then known as Dippy Dawg and sported an uncharacteristic beard and glasses, it was love at first sight the moment audiences heard his trademark laugh.

By the early 30s Mickey Mouse was as popular as any human star, a point Walt was fond of making and did so with his tongue in his cheek in *Mickey's Gala Premier* (1933), where the mouse at-



tended a screening of one of his own shorts with a heaven of Hollywood stars. By the end of the short, everyone from Charlie Chaplin to Universal's movie monsters are floored with laughter and the Mouse is fondled by Garbo.

It wasn't until the arrival of Donald Duck in 1934's The Wise Little Hen (voiced by Clarence Nash, a milkman with a legendary talent for animal voices, who became a Disney legend providing the Duck clan with their unmistakable voices) that Mickey had a serious rival in popularity. Donald with his rash temper and constant proximity to frustrating circumstances offered both animators and fans a greater array of opportunities for gag development and humor. This caused Walt some dismay. He owed everything to Mickey, and for the rest of his life he saw the Mouse as the symbol of his triumph, raising him from a poor Missouri farm boy to a cartoon mogul. But Walt's love for his Mouse was something deeper than a mere reverence for the symbol of his rise. Disney always spoke of Mickey as his partner, the one that never betraved him, even after UbIwerks's temporary test of loyalty and the animator strike that would devastate him in 1941. Walt, in turn, could not betray Mickey by allowing his popularity to be eclipsed. His solution, he allowed the Duck's appearances in Mickey's cartoons, but always as second-banana. In the early teamings, Donald's relation to Mickey varied from bumbling sidekick (The Dognapper and Mickey's Service Station) to antagonistic (Mickey's Amateurs and The Band Concert). It wasn't until 1937 that Donald got his first official cartoon, Donald's Ostrich. Goofy, too, was morphing rapidly thanks largely to the genius of one of Disney's best animators, Art Babbitt, whose departure from the studio after the animator strike was one of Disney's sorest losses, whether Walt admitted it at the time or not.

But Disney's biggest critical in the '30s was his Silly Symphonies series, almost singlehandedly pushed the art of animation to unprecedented boundaries. From the start they were creating awe, beginning with the legendary first title in the series, 1929's The Skeleton Dance. It's a virtually plotless short about skeletons that emerge from the graves come nightfall and cavort till dawn, filled

Young Pups
During the first few months

During the first few months of your puppy's life, vaccinations are very important. During a puppy's first visit with a vet, it will receive the first of a series of puppy vaccinations, and your puppy will need booster shots every three weeks until they are four to five months old. These vaccines protect your puppy against distemper, hepatitis, leptospirosis, parvovirus, parainfluenza, and rabies.

Another early health care need is spaying and neutering. If you are not planning to breed your dog, you should

get them spayed or neutered prior to six months of age. Early spaying or neutering prevents accidental pregnancies and diminishes the likelihood of health and behavior problems like mammary cancer (in female dogs)

and marking (in male dogs.) More early life necessities for healthy pets until two years of age, your dog is considered a puppy. These formative years are the time to develop good dog health care habits. For instance, you should start protecting your dog from fleas and heartworms, which are potentially fatal parasites that can live in the heart of dogs. Depending on the part of the country that you live in, your pet may need to be placed on flea control and will be started on heartworm prevention. Dental health is also very important to keep your dog's teeth strong and healthy. The current recommendations are to brush their teeth daily and have their teeth cleaned by a veterinarian yearly.

Adult Dog

(ages two through seven)
During adulthood dog
health care revolves around
preventing health problems
and treating any problems
that arise. You will want to
take your dog to the vet every year for a physical exam.
This will allow the veterinarian to look for things that
you might have missed at
home, talk with you about
any issues and boost vacci-

nations. Rabies vaccinations generally need to be given every one to three years, and your vet may determine that your dog needs other vaccinations as well. Even though heartworm preventatives are 100 percent effective if given as directed, most vets like to repeat a heartworm test every year or two to make sure we haven't had a break in the coverage.

Senior Dog

They reach this point at seven years of age. That is when we may start recommending yearly blood work to look for any disease processes, like kidney disease, that are just starting to show up. If your dog develops any health problems, you may need to visit the vet more than once a year.

In addition to regular health care visits, call your vet immediately if your dog is acting unusual or showing worrisome symptoms like inactivity, changes in appetite, limping, lameness, having uncharacteristic accidents in the house, vomiting, diarrhea or severe itching. Regular check-ups and following your vet's advice will help ensure you have a happy and healthy pet.



Socially Scene

Socially Scene Preview ... The Isabella Stewart Gardner Museum has some of the most famous art and historical stories that the City of Boston has to offer. The following is some of the amazing history along with insight to the current exhibits.

The museum which bears her name also stands as a testament to her vision. Isabella Stewart Gardner, known also as "Mrs. Jack" in reference to her husband, John L. ("Jack") Gardner, was one of the foremost female patrons of the arts. She was a patron and friend of leading artists and writers of her time, including John Singer Sargent, James McNeill Whistler, and Henry James. She was a supporter of community social services and cultural enrichment. She was an ardent fan of the Boston Symphony, the Red Sox, and Harvard College football. Isabella Stewart Gardner was also the visionary creator of what remains one of the most remarkable and intimate collections of art in the world today and a dynamic supporter of artists of her time, encouraging music, literature, dance and creative thinking across artistic disciplines.

three decades, Over Isabella Stewart Gardner traveled the world and worked with important art patrons and advisors, Bernard Berenson and Okakura Kakuzo to amass a remarkable collection of master and decorative arts. In 1903, she completed the construction of Fenway Court in Boston to house her collection and provide a vital place for Americans to access and enjoy important works of art. Isabella Gardner installed her collection of works in a way to evoke intimate responses to the art, mixing paintings, furniture, textiles, well-known European paintings and sculptures.

Isabella Gardner placed her portrait by John S. Sargent in the most prominent corner of the final gallery in the museum. Most of the other objects displayed

there were made in Europe during the late medieval period, around 1300 to 1500. Her painted presence emphasizes her role as creator of the museum. The Gothic Room was not open to the public during Mrs. Gardner's lifetime and in 1903, she allowed Sargent to use the space as a studio. He painted several portraits there, including that of violinist and composer Charles Martin Loeffler, which hangs in the Yellow Room. The museum's Artist-in-Residence program stems from this legacy of an artist working in the galleries.

John S. Sargent painted a portrait of Isabella Stewart Gardner at the Gardners' home, 152 Beacon Street, Boston. Gardner appears as an iconic, almost religious, figure: her symmetrical posand objects from different ture is rigid, her arms and cultures and periods among the strand of pearls circle her body, and the patterns on the textile behind her suggest a crown and halo. Perhaps because of this unusual presentation, critics and viewers were shocked when the portrait was exhibited in Boston. Isabella's

husband was not pleased, and asked that it not be exhibited again. As a result, this room was closed to the public during Isabella Gardner's lifetime — but visitors could get a glimpse of the portrait from the hall at the top of the stairs.

Giotto (Italian, about 1267-1337), The Presentation of the Christ Child in the Temple, about 1320. This painting depicts the moment when Simeon and the prophetess Anna recognize the infant Jesus as the savior. The Christ Child reaches across the altar towards his mother in a natural gesture. Giotto's ability to create believable space within the picture and his skill at depicting emotion made him one of the most famous artists of his time. Isabella Gardner set the painting on a table, perpendicular to the window to get good light for viewing, with a chair placed as if a visitor could sit and contemplate the work. This arrangement occurs in other galleries, helping to focus attention and break up large spaces in the museum.

August is also the final month of Carla Fernández: The Barefoot Designer. See it this month, and celebrate summer's end with the artful flourish of Mexican fashion!

That was just a brief bit of history and art that portrays the walls of one of the most historical and well-known museums. Stay tuned for next week as Socially Scene will stop in and give a full on site review.

to the brim with artistic innovations involving closeups, great use of sound effects and cartoon movement. Then, in 1932, Flowers and Trees was almost as much a milestone as Steamboat Willie when it became the first cartoon in Technicolor. Work on Flowers and Trees was well underway when Walt became confident enough in the future of color films that he had all completed footage scrapped and refilmed in color. It was a success and Flowers and Trees became the first winner of the Best Animated Short Award, beating out the

Mickey Mouse vehicle Mickey's Orphans. The mystery is why Disney waited three years before giving Mickey his first color cartoon (The Band Concert). Be that as it may. Flowers and Trees was the start of a virtually unbeatable trend of award winning cartoons from the Silly Symphonies series, most of them spins on a popular fable. The best of them are considered animated classics; The Three Little Pigs (at one time, the Pigs and the Big Bad Wolf were as popular as Mickey and the gang appearing in toys, literature and the

Disney parks), The Tortoise and the Hare, Three Orphan Kittens, The Country Cousin, The Old Mill (the first use of Walt's innovation, the multiplane camera), and The Ugly Duckling.

Not all was roses for Walt Disney, however, in the early days. Max Fleischer presented a serious rival and was forming a formidable cartoon army of his own. But Walt had a trick up his sleeve and no one saw the first animated feature coming until it took the world by storm. But first, let's make plans to explore Fleischer's cartoon world.

through their pre-season Halfway schedule, the New England Patriots find themselves with a .500 record. The 2014 pre-season started with a disastrous performance in Landover, Marvland as the Washington Redskins rolled to a 23-6 win.

"I don't think we really did very many things the way we wanted to do them." said head coach Bill Belichick, who elected to rest many of his core players. In fact only 9 of the 22 projected opening day starters took the field. The New England bench resembled an all-star team as Quarterback Tom Brady, Wide Receiver Julian Edelman, Cornerback Darrelle Revis, and Linebacker Jerod Mayo sat out the game. Tight End Rob Gronkowski, who is still recovering from knee surgery, was also expectedly absent.

The game started off as a way for the team to showcase Quarterback Ryan Mallett, in the final year of his contract, to the other 31 teams in the league; however that backfired as Mallett completed only 5 of 12 pass attempts for 55 yards. It wasn't pretty. Many of his incompletions bounced into the ground, completely missing targets. In the second half, Belichick sent out 2^{nd} round draft pick Jimmy Garoppolo, despite managing only a late touchdown pass demonstrated poise in the pocket and a sense of leadership that Mallett hasn't shown in his four years with the team.

However to pin the blame entirely on Mallett would be foolish. The offensive line, in particular left tackle Nate Solder, had a brutal night. "I don't think our protection was good enough," Belichick said of his offensive lines performance. Potential third down conversions that may have jumpstarted the offensive unit, were negated by ill-advised and sloppy penalties. The defense, which had dominated during training camp looked sluggish as well, allowing key third down pickups during Washington's first half drives.

"I don't think our passing game was good enough. I don't think our running game was good enough. I don't think our run defense, pass defense, kicking game were good enough — they all need to be improved. We just weren't very good in any phase of the game."

With the Redskins debacle behind them, the Patriots returned home in preparation for a week of joint practices and a Friday night game versus the Philadelphia Eagles.

Many of the starters that missed game one were on the field versus the Eagles at Gillette Stadium as the Patriots topped Philadelphia 42-35.

The game started with quarterback Tom Brady, in his pre-season debut, leading a solid opening drive that ended in an interception that loudmouth Eagle cornerback Cary Williams returned for a touchdown. The pass was intended for newly signed reserve tight end Steve Maneri, who never turned around for the ball. "It was just miscommunication." said Brady, "I'm glad it happens in the preseason."

However, New England would win the turnover battle, a 4-1 ratio for the game. "We always try to aggressively attack the ball, those can be game-changing plays so when you get a chance to make them, you need to make them," said Coach Belichick.

Rookie quarterback Jimmy Garoppolo continued to impress as he threw two touchdown passes, one to running back James Develin and a second quarter strike to wide receiver Brandon LaFell.

Even Ryan Mallett had a decent night, as he threw for one touchdown and ran another in himself. Although Mallett displayed some nice footwork running the ball, he still failed to impress in the areas that Belichick wants his QB's to excel; passing the football. He played the entire second half and only mustered 92 yards passing. He was also sacked twice. Unless Mallett shows drastic improvement Garoppolo should be the teams backup Quarterback for the regular season.

The Patriots next game is this Friday night versus the Carolina Panthers. Regular season starters should play well into the second half, meaning that this third preseason game will give us the best insight as to what type of team the 2014 Patriots will be. Tight end Rob Gronkowski most likely will continue to be sidelined, even though he participated in light contact drills this week. Friday's game will also offer fringe players the opportunity to carve out a spot on the final 53-man roster.

Parla Come Mangi!

(Speak as You Eat!)

Benvenuti! As we are well into the Summer I would like to celebrate one of the most versatile vegetables of the season: il peperone (pepper) and, in particular, il peperone rosso di Calabria (the Calabrian red pepper). This glorious yet simple traditional dish is one of my mother Anna's top ten recipes. Peperoni ripieni (stuffed peppers) is a dish that incorporates the intense roasted pepper's flavor into the seasoned ground meat. Sometimes topped with sugo al basilico (red sauce with basil), peperoni ripieni are often considered tastier the day after their preparation. Our family recipe uses seasoned ground beef to stuff the peppers and doesn't call for sugo al basilico. Meatless versions of this dish can be found in the region: each pepper is stuffed with a vegetable filling made out of capers, garlic, breadcrumbs, basil, parsley and topped with some mozzarella or provola (a local variety of provolone) of course! On August 15th "Ferragosto" (Assumption Day) is celebrated all over Italy with fireworks, town festivals and with the traditional lunch at the beach where you can be sure that plenty of peperoni ripeni will be eaten on those stunning Calabrian beaches! A very tasty way to conclude Summer!

Peperoni Ripieni

(serves four)

1 pound ground beef 2 whole eggs + 1 yolk ½ cup plain breadcrumbs ½ cup grated Pecorino Romano

½ cup grated Parmigiano

Reggiano

4 large red peppers Salt Freshly ground black pepper Italian seasoning mix Extra Virgin Olive Oil Mozzarella cheese (diced)

1 clove of garlic finely minced

Preparation: Put the ground beef, cheese, breadcrumbs, garlic and eggs in a bowl or mixer. Season with two pinches of salt, some ground black pepper, the Italian seasoning mix and incorporate until the consistency is smooth and compact, then set aside to rest. Wash the red peppers and cut them in half lengthwise discarding the stems and the seeds. In a large pot, bring some water to a boil, add a pinch of salt and drop in the red pepper halves. Boil for 5 minutes then drain well. Oil an oven dish and place the pepper's halves empty side up. Fill each pepper vessel to the top with the meat mixture and garnish with some diced mozzarella. Make sure that the filling is nice and packed into the peppers, try not to leave empty spaces. Drizzle with some olive oil and cook for 45 minutes in a 425 degrees oven. Buon appetito!

Peperoni Ripieni

(serve quattro)

500 g carne trita 2 uova intere + 1 tuorlo 100 g pane grattugiato 100 g Pecorino Romano grattugiato 100 g Parmigiano Reggiano grattugiato

1 spicchio d'aglio finemente 4 peperoni rossi grandi Sale Pepe nero macinato

Mix di erbe "Italian seasoning" Oilo extravergine di oliva Mozzarella a cubetti

Preparazione: Metti la carne trita, il formaggio, il pane grattugiato, l'aglio e le uova in una terrina o in un mixer. Aggiungi due prese di sale, del pepe nero macinato, il mix di erbe e combina il tutto fino a che il composto risulti amalgamato e abbia assunto una consistenza corposa quindi mettilo da parte e fai riposare. Lava i peperoni e tagliali a meta' per lungo eliminando il picciolo, i semi e la parte interna. In una pentola grande fai bollire dell'acqua, aggiungi una presa di sale e fai cuocere i peperoni per 5 minuti quindi scolali bene. Cospargi il fondo di una pirofila da forno con dell'olio d'oliva e disponi i peperoni vuoti. Riempi ogni "barchetta" con il preparato di carne e guarnisci con dei cubetti di mozzarella. Assicurati che i peperoni siano ripieni di carne fino all'orlo e che non ci siano spazi vuoti. Cospargi con un filo d'olio ed inforna a 425 gradi per 45 minuti. Buon appetito!

Nanna & Babbononno

A Nostalgic Remembrance

I attend as many old car get togethers as I can during the summer. I have a few old cars that I like to show off and bringing one of them to the planned or impromptu shows allow me to do just that. Over the years, people

have asked me why there are certain cars that have become collector's items. My replies usually include the period of time when the owners were teenagers. In my own case, I was a teenager in the 1950s. From about 1954 through 1960, some of the most flamboyant

cars ever produced by the auto manufacturers were on our roads. I didn't start to look at cars

until I was about 14. Let me backtrack and say that before I went to work at the Seville Theater at age 13, I washed and waxed cars in my neighborhood. But beginning at about the age of 14, I fell in love with cars. I could smell October 21^{st} coming all year. October 21st is my birthday, and each year, I knew that the age of 16 was coming closer and closer, and this meant I would be able to get my driver's

license.

Today, one of the icons of that '50s era is a Chevrolet. The most popular being from 1955, 1956 and 1957. As an example, a '55 Chevy convertible was somewhere around \$2,500 to \$2,800 back then. Today, one in good condition will bring upwards of \$40,000. The reason is simple. Most of us who were teens back then, couldn't afford the cars or weren't old enough to drive. Those cars were part of our dreams, especially when we saw older teens or adults driving them. Today, we can afford

them and many enthusiasts

own a sample from that

period of time.

Babbononno hated cars. They were his enemy. He preceded the advent of automobiles by many years. He was born in 1875, and by the time autos became a practical means of transportation, he was well into his adult years. Horses, he knew. Trains, he could understand, and the trolley, it was a train without the loud noises, but cars, he hated every one of them, and they hated him. My grandfather would have trouble getting in and out of cars, always knocking his hat off and banging his head upon entering. A good part of my Italian vocabulary, which I can't use in this column, I learned from listening to Babbononno trying to enter Dad's or Uncle Nick's car. Once he was in, he would slam the door and hold onto the handle or arm rest for dear life. If he was sitting in the back seat, he would grasp the strap that hung on the post that separated his rear seat window from the door window. He would grasp things so tightly that his hands would turn red. Upon exiting one of the cars, he would have the same or a similar problem and curse everyone's sister, brother, aunt or uncle. He never cursed anyone's parents, even he had his principles when it came to cursing people.

To the next generation, cars were transportation, especially to the men in my family, all of whom were musicians. Just as an example, when I came along, Dad owned a 1937 Plymouth. He had bought it used from the local mailman in 1938. It wasn't until 1949 when the car had had it, that Dad thought of a new car. Dragging me along, and his bass violin, we headed to Reese Chevrolet in the Day Square area of East Boston.

A neighbor, Tony Patti, had bought a new '49 Chevy Deluxe fast back at the same place and Dad loved his car. However, we had to settle for a regular two-door sedan, as the bass wouldn't fit in a fast back. Babbononno had less trouble getting in compared to the '37 Plymouth, but he wasn't impressed. This was just a new example of an enemy.

Dad kept the '49 until 1954. One day he came home from work driving a two-tone, robin's egg blue and white four-door Chevy Belaire. When Babbononno asked the price, he mumbled under his breath, "Mi genero e' pazzo e stupido." (My son-in-law is crazy and stupid)

Dad began to slowly lose his Depression mentality from that point on. His next car was a '57 Pontiac. Uncle Nick had bought one at an agency in Brookline and brought Dad there to see what they had. The next thing I saw in front of 74 Eutaw Street was a blue and white '57 Pontiac fourdoor hardtop. Next came a 1962 Chevy Impala, then a 1966 Cadillac, a 1974 Ford, and his last car a 1979 Buick. He fluctuated between the more expensive cars back to what used to be called "The Low Priced Three."

As I said, cars to that generation were means of transportation. To me and the next couple of generations down, they became part of our lives. We washed them, waxed them, scrubbed the white walls and made sure that they ran perfectly. Speaking for myself, I have always had a love affair with my cars. They were not just a means of transportation. They were part of us, but this was later.

When we were teens and admired the new cars the older people drove, we secretly wished we could too, but knew the reality of the situations. The light at the end of the tunnel was the fact that someday, we would be old enough or making enough money to afford what we wanted.

I knew Babbononno had changed his attitude a bit when he was in his 90s and in an assisted living home. I picked him up for Easter Sunday dinner, and at the time I had an Imperial convertible. He saw that it was a convertible and asked me to put the top down. I did. He then asked if the front seat went up and down. When I said that it did, he asked me to push it up all the way. This made him look tall. In his old age, he was 4' 11" tall.

With the top down and his seat up, I was asked to drive to the Star of the Sea Church. As I arrived, Easter Mass was just exiting and Babbononno made me slow to a crawl. Spotting several elderly people he knew, he tipped his hat, and yelled out, "Buona Pasqua, Buona Pasqua." (Happy Easter, Happy Easter)

As far as Nanna and my mother were concerned, a car was driven by a man and they were passengers. Once for kicks, Dad tried to teach Mom how to drive. It didn't work, but on that day, Dad became religious. Mom took the hint and never climbed behind the wheel of a car again. Things are a bit different with my generation. My wife drives a newer car than I do. Oh well, GOD BLESS AMERICA.





WHERE THEY FOUGHT

Boston's Great Boxing Venues



Mechanics Hall, 1959

There was a very long period of time in Boston when you didn't have to go far to see a live professional boxing match. Fights were held at least once a week. This activity died out in the 1970s with the death of Sam Silverman who had done his best to keep local boxing

Today, when people hear of a boxing match being held in Boston, the first place they think of is TD Garden, though most of us of a certain age will never stop calling it the Boston Garden. The House of Blues has also become a popular venue for the infrequent cards that are promoted in the area. However, there was a time that if you heard of a fight promotion you had to check carefully on the location to be sure you went to the right place. Bouts were held in Mechanics Hall, the Boston Arena, Fenway Park, Braves Field, and the Boston Garden.

The oldest of these arenas was Mechanics Hall, which opened in 1881. It was located on Huntington Avenue at the corner of West Newton Street, on what is now the location of the Prudential Center. The main hall sat 8,000 people for boxing matches. Mechanics Hall was originally built to be an exhibit hall and also housed the Aleppo Temple, better known as the Shriners. I had heard that Jake Kilrain fought Charley Mitchell there in 1884, but upon further research I discovered they fought in the New England Manufacturer's and Mechanic's Institute also on Huntington Avenue, so that explains the confusion. The Manufacturing Institute building was not in operation for long and burned to the ground in 1886. I can't find any records of other boxing matches being held there.

Even though it was not intended as a boxing arena, Mechanics Hall remained a popular site for matches up until it was closed to make way for urban renewal in 1958. Just about every local pro during that era fought there more than once, and I still hear the old timers fights they saw there. Jack Arena 1932.

The Boston Arena

Not far from Mechanics Hall, on St. Botolph Street, stood the Boston Arena. This venue, opened in 1910, was built specifically for sporting events and was the original home of the Boston Bruins. Now in the possession of Northeastern University it is still standing and has been renamed Mathews Arena. The annual Bean Pot Tournament is held there, but it was a major place for boxing for many years. In addition to the hundreds of pro fights that took place under its roof, the Arena was also the site of the annual New England AAU Championships. During these amateur tournaments, there would be two rings set up with fights taking place in both rings at the same time. It shows just how popular boxing was in those days to have had so many young men enter into the New England competition. The talent pool was very deep.



The Boston Garden 1940s.

The first Boston Garden opened in 1928. It was originally named Boston Madison Square Garden, and was built by the great boxing promoter Tex Rickard. > For years Sam Silverman dreamt of holding a Heavyweight Title bout in the Garden, and his dream nearly came true in 1964 when he signed Muhammad Ali and Sonny Liston for their rematch. Tickets had been printed and it appeared Sam was about to realize his dream when, at the last minute, Ali pulled out because of a hernia. The commission would not allow the bout to be rescheduled for Boston and it was moved to Lewiston, Maine. The rest is history.




Ticket to the cancelled Ali-Liston Fight

Boston's two ballparks were also popular places to see boxing matches. Future Heavyweight Champ Jimmv Braddock fought in both parks. Braves Field, now owned by Boston University and renamed Nickerson Field, saw much action throughout the years. Jack Sharkey, Tony Shucco, Jimmy Maloney, and many other great fighters stepped into the ring there. A young Rocky Marciano stopped Gino Buonvini in 10 rounds in the ballpark. On the undercard of that bout, a tough young amateur who had embarked on his pro career scored a one round knockout in his bout. That hard punching kid would go on to become Welterweight Champion of the World. His name was Tony DeMarco.

Tony would also go on to fight in the last venue I will mention here, Fenway Park. As a matter of fact, Tony is the only person alive to have fought at all of the sites mentioned in this article. In 1954 he kayoed George Araujo in the 5th round in the
