VOTER REGISTRATION DEADLINE

Wednesday, September 4th

The deadline to register to vote, update your address, or to change your political party for the Tuesday, September 24, 2013 Preliminary Municipal Election is Wednesday, September 4, 2013.

Residents who are looking to register to vote or make a change to their current registration may do so by applying in person at City Hall, requesting an application by mail by calling the Boston Election Department at 617-635-3767 or by downloading a mail-in registration form off of our website.

The Boston Election Department (City Hall - Room 241) will be open until 8:00 pm on September 4th to accommodate last minute Voter Registrations. Those looking to fill out a Voter Registration form after 5:00 pm on that date should enter City Hall by the Congress Street entrance. All registrations that

are mailed to the Election Department must be postmarked by September 4th in order to be eligible for the upcoming election.

All registrations postmarked after the 4th will be unable to be processed until after September Preliminary Municipal Election and will not be eligible until the Municipal Election on November 5, 2013.

Benjamin Harrison was our twenty-third President, Came in between Cleveland, was a White House President; Ben's great-grandpa William, our ninth C.E.O., Died of pneumonia as our records will show.

They say Ben reduced the public debt, Was the best supporter civil service could get; He even improved the Army and Navy, But this rivers and harbors was just pork and gravy.

To annex Hawaii, was his fondest of dreams, But his bill under Cleveland fell apart at the seams; Some characteristics men keep, even when they get old, His patronage was limited and his personality was cold.

When speaking in public he ranked with the best, Always sincere, got it all off his chest; When speaking in private there was no connection, And because of this there was no re-election.

The first Mrs. Harrison, was born Caroline Scott, The daughter of a minister and they liked her a lot; She conducted a school exclusively for girls, Then married Ben Harrison after just a few whirls.

Charlie (or Mike) on the MTA

When Walter A. O'Brien, Jr. (December 19, 1914 - July 1998) ran for mayor of Boston in 1949, he could not have foreseen that his campaign song would, a decade later, reach #15 on the Billboard chart, in a recording by the Kingston Trio.

I've long thought it would be swell if the tradition of campaign songs were to be resurrected. Many politicians today have a "theme" song associated with the campaign - think of how the 1992 Bill Clinton campaign employed, to good effect, the Fleetwood Mac song "Don't Stop." In the 2012 presidential race Messrs. Obama and Romney each had a "play-list" of popular songs to set the mood at campaign rallies and sell the candidate. What Clinton's, Obama's, and Romney's uses of music as a motivational tool have in common is that they all turned to hit songs, not a campaign song, written by a local person and with local references relevant to the race. The lyrics, "Charlie on the MTA," were written by O'Brien supporters Jackie Steiner and Bess Hawes, and have become so emblematic of the MTA (now MBTA) that our fare cards are, even officially, called dates back the 1865 song "The Ship that Never Returned," by Henry Clay Work.

As an MBTA rider (I haven't owned a car since I moved to Boston nearly a quarter century ago, a move prompted, in part, by Boston's good subway, trolley and bus system) I am pleased to see that mayoral candidate Mike Ross has pledged to be "A Strong Voice for Improving the MBTA."







L'Anno Bello: A Year in Italian Folklore

Each and All for Almanacs!

If you step in to my parents' home on any given day, you will most likely hear the television tuned in to the Italian language channel. I no longer bat an eye, for I have been used to this since practically the day I was born. Due to my father's love for the Italian channel, practically every day of my life has consisted of some variation of a silly variety show, hour-long quiz game, soccer match, Italian soap opera, or news program. While I used to find these shows rather goofy when I was little, I now appreciate them for helping me learn the Italian language and about Italian culture — I especially love the travel and science programs. However, my favorite show on the Italian channel has not aired for four years, though I watch it regularly online. It is called Almanacco di Domani, or Tomorrow's Almanac, and like most good things in my life, it was introduced to me by my dad. This quaint little fifteenminutes provided folkloristic, astronomical, and fun fact information pertaining to the upcoming day — birthdays, history, recipes, notable quotes, you name it! Even saying the name in my mind conjures images of cozy dark evenings spent curled up on my couch at home, listening to the zany music announce the details of the

I just love almanacs because they celebrate seasonal time and tradition, which anyone reading this column knows I wholeheartedly embrace. Italian almanacs, whether in the form of the aforementioned television show or quick writeups in local newspapers, are especially useful for anyone trying to find out more about the customs, beliefs and values that characterize his or her heritage. In Italian almanacs, you will almost always find the following:

1) The Saint of the Day: The calendar of saints is very important to Italian culture. Until not too long ago, this calendar often determined the name of the child born on a particular day. In this month of August, for example, you could have babies named Lorenzo (St. Lawrence's Day, August 10th), Assunta or Maria (Assumption of the Virgin Mary, August 15th), Elena (St. Helen's Day, August 18th), Bartolomeo (St. Bartholomew's Day, August 24th), or, as is the case in many a family, Rocco (St. Roch's Day, August 16th). The feast days of saints are also interesting for the holiday and seasonal lore associated with them. The Assumption, for example, acquired many customs related to the start of the grain and first-fruits harvest, which, like the feast day, occurred around mid-August.

2) The Sun and Moon: Like American almanacs, Italian almanacs will also tell the rising and setting times of the sun and the moon. In olden times, farmers would have found this information very useful. Superstition parceled out various agricultural tasks to certain phases of the moon, such as planting crops during the period when the moon grows in the sky to ensure a similar result. Of course, nights with a full moon promised magic and mischief of all kinds. I like checking the rise and set of the sun in order to gauge seasonal changes. When the sun no longer sets after eight o'clock, as is happening now, I know autumn is on its way. Similarly, I love watching the sunset time progressively grow longer after the winter solstice with the anticipation of the coming spring.

3) Household Hints: Trust me, Italians seem to have more practical uses for everyday household items like rubbing alcohol, baking powder, lemon juice and candle wax than I have ever heard. These little hints are cheap, environmentally sound and just like having a wise grandmother next to you dishing out advice! They definitively represent the more whimsical side of almanacs, true to the Italians' tradition of never taking themselves too seriously.

I love almanacs because they remind me that every day is special. Each day arrives laden with its own lore, history and curiosities. Almanacs teach us to always look forward, to keep hope and to always count even the smallest pleasures that a day can bestow. Now that I have been bitten by the almanac bug, I know that I will continue to pore over these olden bundles of wisdom and humor, whether in the form of Almanacco di Domanior or The Farmer's Almanac website. So thanks to my dad for introducing me to these cultural curios, and happy (almanac) reading to all!

Entertainment at the Opening Reception consisted of Thai Dance performed by the Wat Boston Temple and music provided by NMR Thai Cultural Council of MA.







M.G.L. c. 93A 'Consumer' Protection Act May also Provide Relief to Commercial Tenants

In a recent decision of significant import, a Massachusetts Superior Court judge found that Chapter 93A, the so-called "consumer protection statute," can provide a remedy to a commercial tenant for failures by the tenant's landlord to provide commercial space free of serious defects. In Kuong, et al. v. Wong, et al. Suffolk Superior Court No. 10-0285-BLS2 (Roach, J.), Judge Christine Roach awarded double damages to three plaintiffs (the commercial tenants) who had sued their landlord after complaining for a decade about serious health and safety problems with their leased commercial space.

The plaintiffs, all refugees from Vietnam, rented space on the first floor of a building in Boston's Chinatown neighborhood. The three plaintiffs each ran, respectively, a hair salon, a seamstress shop and a Vietnamese restaurant on the first floor of the Chinatown building. Directly above them, on the building's second floor, the landlord ran a Chinese restaurant known as Empire Garden.

In 1999, after a serious fire damaged the first floor, the landlord chose to rebuild by only providing a 'shell' space, hoping to rent to tenants that would do their own 'build-out' and thereby improve the property at their own expense. The plaintiffs rented the shell space, investing thousands of dollars into the build-out and then opened their establishments only to discover major problems with the leased space, including serious violations of the state sanitary and building codes. Such problems included water leaking from the ceiling that often contained debris and smelled like sewage and the presence of rats, mice and other vermin. The tenants regularly complained about the problems with the commerial space but their complaints went unheeded by from the unfair and decepthe landlord. Given the substantial investment they nesses. Although a section had made in renovating the of Chapter 93A deals with

space, the tenants were unable to move and simply had to put up with the poor condition in the rented space.

In April 2009, after a decade of complaining to the landlord about the problems with their commercial space, the ceiling in two of the tenants' spaces came crashing down. Along with the collapsed ceiling came moldy plaster, various debris and the dead carcasses of rats and mice. The collapse destroyed the businesses and property of the tenants, including a hand-made wedding dress that had taken the seamstress 90 days to create. After the collapse, the City of Boston shut down the building.

With no other recourse, the tenants filed suit against the landlord in Suffolk Superior Court, alleging a number of contract and tort claims as well as a claim under Chapter 93A. After a jury trial, the plaintiffs won a damages award of several hundred thousand dollars. After the jury had rendered its verdict, the judge considered the tenants' 93A claim and doubled the jury's award. The judge found that the landlord's conduct, in ignoring, over the course of a decade, the tenants' complaints about bad conditions in the property constituted willful and reckless behavior that violated Chapter 93A. The judge found that the landlord "thoroughly and consistently [demonstrated] utter indifference to the plight of [the] tenants and to the wellbeing of the consuming public" in her order doubling the jury's already substantial award.

While clearly justified by the facts of the case, the judge's decision to impose Chapter 93A liability on a commercial landlord is perhaps unprecedented. Chapter 93A is known as the consumer protection statute because it is primarily designed to protect consumers tive acts or practices of busiunfair and deceptive practices in a business-to-business (as opposed to a business-to-consumer) context, 93A liability in a businessto-business dispute is far more rare and normally requires egregious conduct on the part of a wrongdoer before a 93A claim will have a chance of success.

It is important to note that the judge's ruling in this case does not create a common law warranty of habitability in for commercial tenants. The warranty of habitability applies in residential landlord/tenant contexts and very basically, states that a landlord must warranty that a space is safe for human habitation if he wishes to rent it out for that purpose. A violation of the warranty of habitability is automatically a violation of Chapter 93A. For example, if a residential tenant had experienced the same problems in an apartment as the commercial tenants in the Kuong case described above, the tenant would have a clear and powerful legal claim against his or her landlord. However, because the warranty of habitability is not recognized for commercial tenants, the plaintiffs in Kuong had claims that were far from certain. This is why the imposition of 93A liability in Kuong is an important development in commercial landlord/tenant law. It stands for the proposition that a commercial landlord cannot contract his way out of all responsibility for his property and shift that burden onto his tenants, particularly where the tenants are unable to control a fundamental problem with the property, such as the structural defects in the Kuong

Because most residential tenants, unlike commercial tenants, are not sophisticated business people, it is understandable why the law offers residential tenants greater protections. Nevertheless, when justified by the facts, a commercial landlord should be held to account for his egregious or unconscionable behavior. The Kuong case is an important development in this area of law.



The Greenway Continues to Grow The Institute of Contemporary Art/Boston and the Rose F. VEAL AND CABBAGE STEW

- 1 1/2 pounds veal shoulder
- 1 small cabbage
- 1 medium onion chopped
- 3 small garlic cloves chopped
- 2 ripe tomatoes
- 4 small white potatoes
- 3 carrote
- 2 pieces dried bay leaf 4 whole cloves
- 1/4 cup canola, vegetable or olive oil
- 1/2 cup minute or regular
- rice (optional) Salt

Heat oil slowly in saucepan before adding veal shoulder to sear on both sides. Remove meat from saucepan and set aside in a platter.

Add chopped onion and chopped garlic to saucepan and simmer until onion is opaque. Do not burn garlic. Add chopped fresh tomatoes or ten ounces canned crushed tomato. Stir, cover and simmer for about ten minutes.

Meanwhile, peel potatoes and carrots. If potatoes are large, cut into two-inch portions and set aside. Cut carrots into two-inch portions and set aside separately. Remove spoiled outer leaves of cabbage. Cut cabbage in half. Cover one-half with plastic wrap and store in refrigerator. Cut second half into three portions, wash and set aside.

Add veal to the saucepan. Cover and simmer about five minutes. Add carrots, bay leaf and whole cloves to the saucepan. Stir, cover and simmer slowly about ten minutes. Then add potatoes to the mixture. Place cabbage portions over potatoes and carrots. Spoon the tomato mixture over cabbage. Add a little water if needed. Cover and simmer until meat and vegetables are fork tender. Salt to taste. Remove bay leaf before serving. Serves two.

OPTIONAL: Cook rice of choice according to directions on the package. Serve rice plain or with some tomato mixture over it. Then add a serving of meat and vegetables to the platter.

NOTE: I loved watching Mama create different recipes during the years. Now I encourage others, including my children, to be creative and vary meats and vegetables in recipes. For instance, this meal can be prepared using Italian pork sausages, or shoulder pork chops in place of veal shoulder. The meat used in preparing this will determine the flavor of the stew.



A Nostalgic Remembrance

Last week, I was talking about my first time in the Dominican Republic when Sal Meli and I flew into a revolution without knowing anything about it. Four years later, I had the opportunity to head back there for a February school vacation. Sal couldn't make it that winter. but a fellow teacher showed interest and decided to join me. A friend who worked at a Latin American travel agency booked me at the Hotel Hamaca in the town of Boca Chica, about an hour from the capital city of Santo Domingo. She told me that the hotel had a beautiful beach with a barrier reef just off shore that kept the sharks at a distance. I said OK and on that Friday evening when school let out for the February vacation, we were on a flight to Santo Domingo. A Hertz rental was waiting for me when we landed, and we headed for Boca Chica and the Hotel Hamaca.

When we checked in, the rooms we were expecting were not ready and we were given the penthouse of the four story hotel. Part of it was being refurbished, but the two main bedrooms were not involved and my companion and I unpacked for a week in the sun and surf. The only problem was that there was nothing in Boca Chica, just a hairdresser, a small restaurant, a police station, a grocery store and a public square with a TV for everyone without one to watch at their convenience. As a result, for entertainment, we had to drive into Santo Domingo each night, almost an hour away.

There were only two guests at the hotel with cars and everyone seemed to become our close friends. The other couple that had the other car were Dominicans from New York City. The man ran one of those "Going Out of Business" stores" in Times Square that sold tourist junk. The rest of the guests, who were not Dominicans were on their honeymoon, there were Americans who asked when we were heading to Santo Domingo so they could hitch a ride from us. One was an American girl who was under psychiatric care and displayed the behavior that indicated she should stay there. There was another young couple who were stiffs. They wanted everything to be American in what was a laid back Latin environment. My new friend and I discussed the situation, but his wife insisted we help out the people without cars and we had the folks I described join us when we went to Santo Domingo.

Lent was coming early that winter and Ash Wednesday was that week. My friends from New York had been invited to a Mardi Gras party (Carnival) at the palace of the Mayor of Santo Domingo. They were related if I remember correctly. They obtained invitations for my friend and me and we said no to the others looking for rides. It was after 1:00 am when we left the party and headed back to Boca Chica.

About five minutes after I was in bed, my companion knocked on my door. He asked if I would come to his room which faced the forested area near the hotel. My room faced the ocean. After entering, he said, "Look out the window and listen." I could see flickers and could hear jungle drums beating a continuous rhythm. My friend asked what it was and I explained that it might be a Voodoo Ceremony. Voodoo was, and I think still is, against the law in the Dominican Republic. Even though about 3/4ths of the Dominican population is of African or mixed African-Spanish origins, their culture is basically Spanish and Voodoo is from Haiti, with African roots and outlawed. In spite of this, it was practiced in parts of the island especially among the poor.

My friend wanted to head out and see what was going on. The guard at the front of the hotel gave me a loaded shotgun and told us to be careful. We headed toward the sound of the drums and into the jungle following the sounds and the flickers of light. When we got close enough to see what was going on, we saw people dressed in white with white powder or flour on their hands and faces. Many of them were dancing around the fire in a trance while others played the drums for them. My friend stumbled or tripped on something and wound up standing in the middle of the Voodoo ceremony. The participants saw him, let out gurgling cries and screams and the next thing that was evident was that we were the only two outsiders there. We left in almost as much of a hurry as did the Voodoo worshipers. When we were back at the hotel, I gave the shotgun back to the guard, and seeing it was now about 4:00 am, we headed for our respective rooms and some sleep.

The next morning we sat at the outdoor café of the hotel which was actually on the beach. Along came the hotel owner and I called him over to ask him if he could explain what had happened the night before. He told us that he was Cuban and not sure. He called over the day manager who happened to be passing by and we related the story of the night before. He began to laugh when we finished and said, "They thought your friend was one of their gods that had come down to Earth. They have a

god that is a light skinned giant with curly blond hair and when they saw him, figured he was there for a reason, maybe to take them away. We laughed and the manager left. You see, my friend was a former NFL football player who returned to Boston for knee surgery which didn't work out too well. As a result, his football days were over and he became a coach in the Boston Schools. He was 6'7", had light skin and had blond curly hair. He was a Voodoogod come to Earth.

Later that day, we were of light in the distance sleeping on the beach and the hotel owner's wife woke us up to introduce us to two airline stewardesses who were taking time off from their jobs. They were both from Puerto Rico, spoke English, they were our age and quite attractive. All thoughts of things Haitian and all things Voodoo were put on a back burner and we now had two more riders who could join us on our evening journeys to Santo Domingo.

I bought presents for my folks and Babbononno before I left the country and my friend bought everything a tourist might buy. He got Tshirts, a Dominican Flag and Dominican Rum, which by the way, isn't bad at all. I bought cigars at the little grocery store near the hotel. Dad, Babbononno and I enjoyed a good cigar (I still do). Looking at the display of cigars, I asked the store's owner the prices. He replied, "I have expensive ones and cheap ones." I asked how much the expensive ones were and he replied, "Twelve cents." When I asked about the cheap cigars, he said, "Six cents." I bought several

Late that Sunday night we went through customs in New York and then took the last shuttle to Logan. Our parents picked us up and we divided all the things we bought before we left the airport. I don't know about my friend, but I had several good stories about the Dominican Republic that would go rather well with a sip of Dominican rum and a good Dominican cigar. Mom liked the stories, Dad and Babbononno appreciated them, too, but only with the rum glasses filled and the cigars lit.

THE ITALIAN NATIONAL ANTHEM: NOW PART OF THE SCHOOLS' CURRICULUM! The law to introduce the study of the Italian National Anthem in all schools was approved in the fall of 2012 by the Italian Senate, despite the blistering opposition of the Northern League, which incidentally is promoting the famous chorus "Va Pensiero" from Verdi's opera 'Nabucco' as the national anthem instead of the present one ('Fratelli d'Italia'). The present anthem was written by Goffredo Mameli with music of Michele Novaro. The new law also provides for the celebration of the 'National Unity and a date: March 17. The obvious purpose of this new law is also to promote the basic values of citizenship and consolidate the national identity. Of course, the Northern League doesn't endorse the principles of 'national unity', for it strongly and ideologically supports the principles of federalism. In fact, the former Minister of the Justice Department Roberto Castelli has recently stated that he also of the Northern League feels close to 'his land' rather than to the peninsula, which he feels has been coercively imposed on all of Italy by the Kingdom (of Italy) 150 years ago. Frankly, Castelli's view isn't isolated at all. It is shared by others along the entire peninsula and outside of it, namely the islands.

OPERATION "FORT KNOX" IN ITALY! The year 2012 has been fatal (at the end) to a secret, busy organization that was headquartered in the city of Arezzo. There was the center of operation that purchased all kinds of gold jewelry that was then sent to Switzerland to be smelted into ingots and then returned to Italy. The major activity operated in the ubiquitous stores — "We buy gold and silver", scattered all over Italy. It was a vast, egregious underground activity that produced, annually, profits in the millions of euro. The traffickers used a villa, well protected and secure, located in the town of Monte San Savino where the basic operations were conducted. The investigating authorities, in Arezzo, have since looked into the activities of 118 people in 11 Regions and conducted 250 searches as well as the confiscation of 163 million euro and 500 checking accounts in several banks by the Fiscal Police (Guardia di Finanza). In addition to the 'buy and sell stores,' traditional jewelry stores have also been investigated and some of them charged as part of the doings of the criminal organization, including recycling of euro, fraud and abuse of illegal gold transactions. Over the last year alone the gang members were able to smuggle 4,500 Kg of gold and 11,000 Kg of silver. The gold sent to Switzerland was made into ingots and brought back to Italy. The silver was made into bars right in Italy. Beside Arezzo there were other operation centers, in Marcianise and in Valenza Po.

BONFIGLIO PERINI

Founder of the Perini Corporation

A Look at an Italian Inspiration

We can look at many projects constructed in Massachusetts, Rhode Island and in other states throughout the country and you will find the name of Perini Corporation. Walter Kirchenberger, the construction industry analyst, said to the Providence Business News, "they specialize in the tough stuff - bridges, tunnels and very difficult innercity projects". For example in Massachusetts, we can see the Prudential Building; looking out into Boston harbor we can see the MWRA water purification system. PERINI was involved with expansion of La Guardia airport in New York, the building of the Trump Taj Mahal Casino in New Jersey and in California, the San Francisco Bay Area Rapid Transit System known as BART. All these, and many other construction projects came about because of an Italian

immigrant born in Gottolengo, Italy who started the PERINI CORPORATION in 1918. In 1892, five years after he emigrated from Gottolengo, where he had been a stone mason, Bonfiglio Perini won contracts to build waterworks projects in the eastern United States. One of his first large contracts was a 20-mile bluestone wall in the Catskill Mountains of New York. Historian Bob Steuding praised it in Constructor as "a majestic project when you think about it, a giant piece of sculpture." In 1917 and closer to home, in Rhode Island, he was the first to build one of the nation's first hotmixed asphalt highway. Soon Mr. Perini involved his sons into the family business in 1918.

Bonfiglio Perini and his wife Clementina were blessed with ten children

five girls and five boys four of which took over the company after his death in 1924. Louis Perini acted as president, Joseph as treasurer, Ida as secretary, and Charlie, the youngest, eventually became vice-president of equipment. They were not just handed the company, they worked with Bonfiglio on his construction sites performing jobs such as carrying water when they were as young as six years old. No, this was not a case of being born with a silver spoon in your mouth, they earned it. In 1930 they showed their merit by getting their first million dollar contract, paving the Boston-Worcester Turnpike and setting new paving records. Under the new name of B. Perini and Sons they began to take on larger construction jobs that included civic projects and highways. Louis, although twenty one and possessing only an eighth grade education when he took over the company; much of the success came from good progressive thinking and good business instincts on his part. The contracts began to come their way under Lou Perini including large civic projects, highways and other types of construction. Moving their headquarters from Ashland to Framingham brought them additional contracts to update the Worcester Turnpike, Route 9, their largest project

Louis's son David Perini, the third generation of Perini's, graduated from Boston College with a law degree and served as assistant to general counsel in 1962. Later as vice president, general counsel and vice-chairman and went on to head the company in 1972 as president and chairman. Under David's leadership the company now concentrated on growth. As things got better the company moved from their second floor offices to new headquarters they formally used as equipment shops.

at the time.

They began to acquire interest in other companies and expanded through investing. The 1974 merger of the Wiley Oilfield, Ltd. with the Perini-owned Canadian Pipeline subsidiary, Perini was able to control 74 percent of Majestic Contractors, a Canadian pipeline construction company that was

instrumental in building section two of the of the Trans-Alaska Pipeline, which consisted of 149 miles of pipe (82 miles above ground and 67 below).

In 1980 the company began to concentrate on purchasing companies whose interests, such as civil projects and large-scale urban construction, fitted well within the Perini business model. They included the following as subsidiaries: Perini Building Company, Inc.; Pioneer Construction, Inc.; Perini International Corporation; Perini Land and Development Company; Paramount Development Associates, Inc.; Perland Environmental Technologies, Inc. (90%). In San Francisco the Perini Land and Development Company constructed a neighborhood of 1254 units and hired the advertising agency of Mulhauser and Young who came up with a different approach to sell the project. This included a direct mail campaign that included "cans of spaghetti, a bar of chocolate in the shape of the new logo and a shopping bag that listed the neighborhood shopping attractions." In addition, they did not advertise in the usual trade journals and consumer oriented papers but in the papers of the Sunday San Francisco Examiner and Chronicle and the western edition of the Wall Street Journal." Thus, they were able to reach a larger audience.

Work in twenty countries began in 1985 by Perini International Corporation building mainly U. S. embassies in countries such as Zaire, Gabon, Brazil, and Paraguay. They continued construction for the U.S. State Department in Djibouti and Venezuela. Soon they were looking to move into new markets and began exploring possibilities in Mexico and Latin America. Their reputation as a company was now reaching global proportions.

In his message to stock-holders, David Perini focused on Perini's reputation. He noted on that day in 1992 that "a company and its reputation are like a building. They take much longer to build than to demolish. Build your image and reputation and do nothing to damage your good name."

But there was another side of Lou Perini that was also very inspirational. He loved baseball and dreamed of one day owning his own baseball team. So in 1943 along with two other contractors, Louis



Sad Story of Tony C

The Boston Globe's Bob Ryan penned a great story on Tony Conigliaro remembering what happened on the long-ago Friday night at Fenway on August 18, 1967 when Jack Hamilton of the Baltimore Orioles threw a fastball that hit Tony C in the face and right into his eye. Tony C was 22 years old and Hamilton 28 years old. It led to a lifetime of vision problems. That season, he missed the final six weeks of play as the Red Sox won the pennant on the final day of play. He missed all of 1968 and somehow came back in 1969 hitting 20 homers and knocking in 82 RBIs. He won that year's Comeback of the Year Award. In 1970 while his average fell, he still managed to hit 36 homers and knock in 116 RBIs. The Sox traded him to the Angels where he didn't last long and retired much too young.

Tony Conigliaro was someone who was that classic could-have-been player. He was the youngest player ever to hit 100 home-runs at age 22. His rookie season 1964 he hit a home-run at Fenway in his first major league at bat. He ended up with 24 homers that first season. In 1965, at age 20, he led the American League in home runs with 32. He could have broken Babe Ruth's lifetime HR mark everyone thought. Could have but didn't because of that one at-bat, one Friday night in August back in 1967 when he crowded the plate as usual challenging the pitcher. Hamilton took the challenge and tried to push him back but the ball apparently got away and landed in Tony C's face.


As Bob Ryan wrote, "The Tony C story is sad on every level. It's a 'Life Isn't Fair' story. It's a what-if-he-had-listened-to-people-and-stopped-hanging-over-the-plate story."

Did you know that Jack Hamilton only hit one batter in 1967 and got crucified for it while Gentleman Jim Lonborg on his way to the Cy Young that season hit 19 batters in 1967? Did you also remember that back in 1965, Conigliaro got beaned as he crowded the plate during an at bat? He liked crowding the plate. He took the risk. Sometimes your luck runs out. August 18, 1967 wasn't Jack Hamilton's fault for hitting Conigliaro nor was it Tony C's fault for crowding the plate. Some call it just fate which isn't often fair to anyone in either baseball or life.

Perini, son of an Italian immigrant, who went on to become a millionaire, realized his boyhood dream and purchased the Boston Braves baseball team. The Braves, we found out, were one of the first baseball teams to play at night under the lights. 1948 was a great year in Boston. The Boston Braves were going to the World Series. Braves fans and all Bostonians were in a state of exhilaration. But good fortune would not last, for on October 11, 1948 the Braves lost the series to the Cleveland Indians - 2 games to 4. Boston would have would have to wait another 56 years to see the Boston Red Sox compete and win the World Series.

Dr. Stanley Farber of Boston Children's Hospital was treating a young boy of 12 years with cancer. Lou Perini took an interest in Dr. Farber's research into cancer. After hearing about the 12 year old Braves fan named "Jimmy," he had several members of the team visit him at the hospital. The visit was on national radio and hosted by Ralph Edwards, well-known radio star. After the radio broadcast hundreds of contributions were received at Children's. Kids across the country were setting up stands and selling lemonade, movie houses were showing promotional films and who can forget the ushers passing around the cans collecting money for the Jimmy

Fund. I don't think anyone refused to drop in some coins or dollars into the can. On March 13, 1953 The Braves moved to Milwaukee and the Jimmy Fund was taken over by the Boston Red Sox. The tradition lives on thanks to Louis Perini.

Bonfiglio,(in Italian meaning "good son") Perini, a common laborer, along with his sons and daughters have built a national and international company that has provided structures that truly have been inspiration to all as one man's vision of providing quality while preserving his good name. Truly, Bonfiglio Perini was a good son to his mother and father, as well as a good son to America and a good son of Italy.

HOOPS and HOCKEY in the HUB

The moving vans were rolling again, just as they have several times since he was the head coach of the Bruins.

This time they would pull up down in Florida — the Sunshine State — about as deep as you can go in the Lower 48 and more than a few degrees different (both in winter temperature and in latitude) than the native land of the man who had grown up in the Canadian province of New Brunswick.

And when the movers stopped they had arrived at the new address of one of hockey's most veteran itinerants — a man who got his first full-season NHL head coaching here in the Hub and has been on the move ever since.

Welcome to your new home Rick Bowness. And welcome to your new team — the Tampa Bay Lightning — who once did set the hockey world on fire by winning the 2004 Stanley Cup.

But that was then and this is now. And now might be a rebuilding year down by The Bay. But no matter. It's another team, another town and a chance for Bowness to stay active in the game he loves.

And yes, it's another major move, this time all the way from Vancouver, a city blessed with some of the mildest weather in Canada to one in the states that has some of the warmest year round temperatures.

Shown the door as part of a changeover when Canucks coach Alain Vigneault was fired after San Jose eliminated Vancouver in the first round of the playoffs, it was time once again for Rick Bowness to hit the road. The coaching veteran with 24 years of service in the NHL landed in Tampa this time, the seventh NHL team of his career.

For, you see, long after leaving our town, Richard Gary Bowness is still chasing his dream. How many 58 year olds can say that? Darn few. But Bowness is one of them. The dream: to be affiliated with a Stanley Cup winner. "I want to win the Stanley Cup. That's my goal," he told the Tampa Bay Times. "I don't care what my job description says under my name. If it's assistant skate sharpener, I don't care. I want to win a Stanley Cup."

And so for more than two decades he hasn't given up. He's chased the dream — and never lost sight of it.

Ironically, the two biggest disappointments of Bowness' life in hockey so far have involved the Boston Bruins. Bowness was promoted to the B's head coaching job back in the summer of 1991 after serving for two years as the lead mentor of the Maine Mariners — then the top AHL affiliate of the Bruins.

It was a somewhat stressful year on Causeway Street with the roster constantly in flux. By the time the regular season had come to a conclu-

sion some 55 different players had worn the Bruins uniform at some point during the campaign.

But somehow it worked as Bowness managed to squeeze a 36-32-12 record out of the group at the old Garden and proceeded to have an interesting run in the 1992 Stanley Cup playoffs. The postseason saw the Bruins eliminate archrival Montreal, for example. But things came to a halt in the conference finals in late May when the Black and Gold were swept by Pittsburgh.

Still, it was a fine run — with the B's making the NHL equivalent of the Final Four. But apparently it was not good enough for some. Bowness was fired in early June, an action that hit the coach hard. He remained inside his North Shore home for several days, declining to make a public appearance.

But there was life after Boston. Hired by the expansion Ottawa Senators, he beat Montreal on opening night of the 1992-1993 season. He would remain in Canada's national capital until 1996.

Over the years there would be other teams in other cities. A good many would make the playoffs but only one came very close to winning it all. That would be the 2010-2011 edition of the Canucks, a team that won the Western Conference and faced the Bruins in the Stanley Cup Final. The odds seemed to favor Vancouver, especially after the Canucks had had the B's up against the wall, with Boston needing to win games six and seven to claim the Cup.

It was a tall order but the B's accomplished the feat, downing the Canucks and dashing the dream of Bowness.

So now it's on to Team Seven for the former B's mentor who will serve as associate coach behind head man Jon Cooper. According to media reports, Bowness was given the nod over five other candidates.

And it certainly won't be long before Bowness gets to visit Causeway Street with his new team. The Lighting will be in the Hub on October 3rd — opening night for the B's. They'll also make a return visit on November 11th. Those games will be the first in Boston for Bowness in over a year since the B's didn't play Vancouver in last season's abbreviated 48-game schedule.

It's another team, another place and very much another time for Bowness since he led the Bruins to the Eastern Conference finals so long ago. But the dream remains the same: to hold the Cup. The next chapter in his quest begins when NHL training camps open next month. Whether it ends with him clutching the Cup remains to be seen. But one thing's for certain: Rick Bowness and his dream continue on.
