# 109th Madonna del Soccorso - Fisherman's Feast

The 109th Fisherman's Feast kicked off last weekend continuing the tradition of the North End's oldest running Italian festival. The feast honors Madonna Del Soccorso Di Sciacca with ceremonies at the Fisherman's Club on North & Lewis Streets.

Opening ceremonies fell on Assumption Day, August 15th, so all the Madonna groups joined for a special procession and blessing including the societies of Santa Maria Di Anzano, Madonna delle Grazie and Madonna Della Cava.

For the annual Blessing of the Fishing Waters, the statue of the Madonna di Sciacca was carried by society members to Boston Harbor to the waterfront where a blessing was made by Fr. Brian on the site of the former Italian fleet in Boston Harbor.

A special tribute was made this year to the late "Capt" Ray Bono with speeches by family members. A large crowd filled the park for the ceremony that concluded with the throwing of flowers into the harbor.

On the night before the Red Arrows flew over Boston Harbor, it was a flight of a more spiritual kind in Boston's North End with the annual Flight of the Angel capping off the grand finale of the 109th Fisherman's Feast

# Stirpe Nostra

#### OVID

Publius Ovidius Naso, more popularly known as Ovid is our next scholarly Roman from the Augustan period. He was born in 43 BC in Sulmo (modern Sulmona), central Italy, into an equestrian (bourgeois) family, and received his early education from two of the most famous rhetoricians of his time. While studying for a career in law he developed such a strong interest in poetry that the oratorical exercises required in his legal studies turned out to be poems in prose. Ovid attempted to get involved in a political career but his love for poetry forced him to abandon that life in favor of the companionship of contemporary poets. His three marriages ended in divorce, but the influence of his third wife turned his attention from licentious poems to those of a more serious

Through chance, he happened to be an eyewitness to an offense on the part of a frivolous young relative of Augustus. Because he neglected to inform the emperor, he was banished for life to a city called Tomi located on the Black Sea. All Statue of Roman F of his efforts to be repatriated Constanta, Romania were to no avail, and he died in exile about 17 or 18 A.D.

The works of Ovid have been divided into three periods or groups. The first group was called *Amores*. These were erotic poems which were written in his youth and were originally contained in five books, but later reduced to three.

He wrote didactic (instructional) poems on the art of making love, and during this same youthful period, he also wrote 21 love letters, fictional of course, supposedly sent from mythological heroines to their lovers.

During his middle age, or second period, he wrote the *Metamorphoses*. This work was in

15 books dealing with mythology and legends from the creation of the world to the time of Julius Caesar. The *Metamorphoses* are

considered to be his masterpiece. He also wrote the *Fasti* which told of the many Roman festivals, along with an account of their origin according to Roman legends.

The third period of his work was written during the time that he was in exile. This is when he wrote the *Tristia*, which were poems of lament, and were sent to his family, friends, and to Augustus. He also wrote the *Ibis*, which was a strong denunciation of a personal enemy, and

this was followed by another didactic poem about the fish in the Black Sea. He was quite prolific in his poetic works but these are most of his important works.

Not unlike many of the ancient greats, recognition and fame came mostly after death for Ovid. His poetry seems to have become most popular and influential hundreds of years later during the Middle Ages and the Renaissance. His works

served as inspiration to late greats like Boccaccio, Chaucer, Shakespeare, and Milton.

Ovid is distinguished above all other Roman poets by his ability to put pen to paper and dash off poetry with little or no effort, while at the same time it is said that no one has ever directed such a fine talent towards so much trivia. He was a master of language and of rhythm in verse, and was a born storyteller with inexhaustible powers of invention. His every-ready wit, elegance, and charm have endeared him to generations of readers.

## Blessed Rupert Mayer

Rupert was born and grew up in Stuttgart, one of five children, the son of a prosperous merchant. He was well educated, having attended the universities of Fribourg, Munich, and Tubingen. Feeling called to the priesthood, he entered the seminary at Rottenburg and was ordained a

diocesan priest in 1899, but in 1900 entered the Jesuits and went on to further studies.


When his ability as a preacher was discovered, he was assigned to preach parish missions which he did from 1906 to 1912, traveling around Germany, Switzerland, and the Netherlands. In 1912, he was assigned to Munich where he worked with migrant workers.

Father Rupert volunteered as an Army chaplain in World War I. He worked for a while in a camp hospital, but was promoted to captain and sent to the front lines in France, Poland, and Romania to minister to soldiers in the trenches. He lived with the soldiers, and was accepted by them. During combat he would crawl unarmed and under fire from man to man, encouraging them, praying with them, administering the Sacraments to them. In December 1915, he was awarded the Iron Cross for bravery, the first chaplain to receive the honor. In December 1916, he was injured on the Romanian front by an exploding grenade, and lost his left leg.

Back in Munich after the War, Father Rupert returned to preaching, teaching, youth ministry, and leading retreats for priests. He was the leader of the Marian Con-

gregation in Munich in 1921. Beginning in 1923, he publicly announced that Nazism was incompatible with Christianity, and no Catholic could be a member of the party. This led to several arrests by the Gestapo including a six month period in "protective custody" beginning on May 16, 1937, after which he was sent for seven months to the Sachsenhausen concentration camp. In 1939, with his health failing and fearing his death would make him a martyr and a rallying point for anti-Nazi Catholics, he was released from the camp on condition that he stay in the Benedictine Abbey of Ettal and not preach. He was set free by Allied forces in 1945 and returned to Munich to spend his last few months back in his old ministry. He passed away in Munich on November 1, 1945 at the age of 69.

Rupert Mayer was venerated on May 3, 1987, by Pope John Paul II. The Feast Day of Blessed Rupert Mayer is November 3<sup>rd</sup>.

# **Dennis F. Stoler, M.D.**

March 19, 1945 – August 9, 2019



Dennis "Denny" F. Stoler, M.D., 74, of Boxford, MA, passed away unexpectedly on August 9, 2019 at Lynn Union Hospital from a heart attack while swimming.

He was born in St. Louis, MO on March 19, 1945, the son of Joseph and Vivian (Weiss) Stoler. Joseph emigrated from Russia and Vivian was born in St. Louis, MO. Dennis grew up in Youngstown, OH, graduating with honors

in 1963 from The Rayen School. Even though he left Youngstown in the 1960s, he particularly treasured and maintained many close friendships developed in Youngstown.

Dennis obtained his bachelor degree in science from Western Reserve University, (aka Case Western Reserve University) in June 1967. Dennis moved to Boston where he graduated Tufts Medical School in 1971. He interned at Boston City Hospital followed by a neuro-ophthalmology fellowship under Dr. Simmons Lessell. He did his residency in Ophthalmology at Boston University (1973-1976). In 1976, Dr. Dennis Stoler opened his own practice under the name of Microsurgical Eye Consultants in Danvers, Massachusetts. In 1985, Dr. Stoler took on a partner, Dr. William Orenberg. They moved their practice shortly thereafter to 31 Centennial Park in Peabody and have been there until present. Jeffrey Sorkin, M.D. joined the practice in 1999 and Richard Rodman, M.D. joined in 2010. Dr. Dennis Stoler held admitting and surgical privileges at both Beverly and Salem Hospitals.

Dr. Dennis Stoler loved individual sports. He was a third degree karate black belt and a triathlete. He enjoyed distance bicycling, hiking, running, and swimming. He was a licensed scuba diver. He participated in numerous fundraising events including the PanMass Challenge and completed the Boston Marathon in 2006.

In August 2011, he married Attorney Janis Stanziani of Lynnfield, MA and they lived on the North Shore of Boston until his passing. In addition to his wife, Janis, he leaves his step-son, Alex Markakis of Maine. From Dr. Dennis Stoler's previous marriage he leaves his three sons and their spouses, Craig Stoler (Melissa), of Salem, MA, Bradford Stoler (Cindy) of Spenser, MA, and Alan Stoler, Boxford, MA and three grandchildren, CJ Stoler, Kayleigh Stoler, and Brenna Stoler.

Dr. Dennis Stoler leaves behind two sisters and their spouses, Patti Schear (Lee) of Dayton, OH and Cathy Ginocchi (Frank) of N. Westerville, OH. Also left to cherish his memory are numerous cousins, nieces, and nephews. He was predeceased by his late sister, Peggy Stoler Wyman.

A funeral service for Dr. Dennis Stoler was held on Tuesday, August 20, 2019 at Stanetsky-Hymanson Memorial Chapel, in Salem,

### L'Anno Bello: A Year in Italian Folklore

A Love for Almanacs

If you stepped in to my parents' old home on any given day, you would most likely have heard the television tuned in to the Italian language channel. I no longer batted an eye, for I have been used to this since practically the day I was born. Due to my father's love for the Italian channel, practically every day of my life has consisted of some variation of a silly variety show, hourlong quiz game, soccer match, Italian soap opera, or news program. While I used to find these shows rather goofy when I was little, I now appreciate them for helping me learn the Italian language and about Italian culture — I especially love the travel and science programs, and I now subscribe to this channel myself. However, my favorite show on the Italian channel has not aired for seven years, though I watch it regularly online. It is called *Almanacco di Domani*, or Tomorrow's Almanac, and like most good things in my life, it was introduced to me by my Dad. This quaint little fifteenminute show provided folkloristic, astronomical, and fun fact information pertaining to the upcoming day — birthdays, history, recipes, notable quotes, you name it! Even saying the name in my mind conjures images of cozy dark evenings spent curled up on my couch at home, listening to the zany music announce the details of the next day.

I just love almanacs because they celebrate seasonal time and tradition, which anyone reading this column knows I wholeheartedly embrace. Italian almanacs, whether in the form of the aforementioned television show or quick write-ups in local newspapers, are especially useful for anyone trying to find out more about the customs, beliefs

and values that characterize his or her heritage. In Italian almanacs, you will almost always find the following:

1) The Saint of the Day: The calendar of saints is very important to Italian culture. Until not too long ago, this calendar often determined the name of the child born on a particular day. In this month of August, for example, you could have babies named Lorenzo (St. Lawrence's Day, August 10th), Assunta or Maria (Assumption of the Virgin Mary, August 15th), Elena (St. Helen's Day, August 18th), Bartolomeo (St. Bartholomew's Day, August 24th), or, as is the case in many a family, Rocco (St. Roch's Day, August 16th). The feast days of saints are also interesting for the holiday and seasonal lore associated with them. The Assumption, for example, acquired many customs related to the start of the grain and first-fruits harvest, which, like the feast day, occurred around mid-August.

2) The Sun and Moon: Like American almanacs, Italian almanacs will also tell the rising and setting times of the sun and the moon. In olden times, farmers would have found this information very useful. Superstition parceled out various agricultural tasks to certain phases of the moon, such as planting crops during the period when the moon grows in the sky to ensure a similar result. Of course, nights with a full moon promised magic and mischief of all kinds. I like checking the rise and set of the sun in order to gauge seasonal changes. When the sun no longer sets after eight o'clock, as is happening now, I know autumn is on its way. Similarly, I love watching the sunset time progressively grow longer after the winter solstice with the anticipation of the coming spring.

3) Household Hints: Trust me. Italians seem to have more practical uses for everyday household items like rubbing alcohol, baking powder, lemon juice, and candle wax than I have ever heard. These little hints are cheap, environmentally sound and just like having a wise grandmother next to you dishing out advice! They definitively represent the more whimsical side of almanacs, true to the Italians' tradition of never taking themselves too seriously.

I love almanacs because they remind me that every day is special. Each day arrives laden with its own lore, history and curiosities. Almanacs teach us to always look forward, to keep hope and to always count even the smallest pleasures that a day can bestow. Now that the almanac bug has bitten me, I know that I will continue to pore over these olden bundles of wisdom and humor, whether in the form of Almanacco di Domanio or The Farmer's Almanac website. So thanks to my dad for introducing me to these cultural curios, and happy (almanac) reading to all!

My nephew is strong and has become an example to his Uncle Sal. Sadly, it is a time for me to say goodbye once again to a loved one.

Murder, Mayhem, and Laughs On This Express Out of Ogunquit

The Ogunquit Playhouse is well known for the musicals performed on its stage each year. They are consistently good and among the best to be seen anywhere. In fact, they are so good it is all they have presented for over 12 years. Why tinker with success?

Well, this year Artistic Director Brad Kenney has decided to do just that. For the first time on his watch a nonmusical has been included in the lineup. Brad has chosen Agatha Christie's *Murder on the* Orient Express, and it is proving to be a very wise move.

Adapted for the stage by Ken Ludwig and directed by Shaun Kerrison, this is a not to be missed production which may very well turn out to be the high point in what has been a very strong season at the Playhouse.

The set design by Beowulf Boritt and costumes by William Ivy Long are magical. It is amazing to watch what is created on stage as the Orient Express

rolls into the theater. The use of projections and the framing of scenes are spectacular, the colors are vivid, and the costumes would be the envy of Edith Head. Most of the sound effects are created through the use of music, a touch that is extremely effective.

While the mise en scene alone makes this is an extremely strong piece of theatre, the actors put it over the top. Led by Steven Rattazzi in the role of Hercule Poirot, the cast is just amazing.

Mr. Rattazzi is brilliant as Poirot. It is almost surreal to see how he embodies his character. His accent is impeccable, his movements purposeful yet effortless, his timing absolutely perfect, and his mustache exquisitely groomed. Agatha Christie would be very pleased.

I mentioned Mr. Rattazzi's accent, I was also fascinated by the panoply of accents used in the play. From Swedish to French to Hungarian, to

Russian, to American they are all fascinating and musical. The dialog is crisp and fast with many witty one-liners that are quite funny.

The play is fast paced and has a rhythm to it that never skips a beat. Each player is perfectly on time with his and her lines. Anita Gillette as Princess Dragomiroff is captivating. On the night I attended Ms Gillette was celebrating her 83rd birthday, and she has the energy of a person half that age. Known for her role in Moonstruck as well as numerous stage, screen, and television roles she is the consummate professional.

All 11 members of the cast give solid performances. Ruth Gottschall, Christopher Gurr, Kate Loprest, Stephan James Anthony, Andrew Dits, Patricia Noonan, Olev Aleksander, and Anna Tempte each put their own special stamp on the character they play. Each deserves special praise for bringing the audience such a varied array of personages who all in the end have something in common.

The train is also a star. It is stunning when the light from it first shines through the theater. Watching the scenes as they move from the different cars is amazing. It is remarkable to see what is done on the stage at the Ogunquit Playhouse; really breathtaking. With so little downtime between productions, it is hard to comprehend how the crew was able to create such a complicated set so quickly. The people behind the scenes deserve a standing ovation for the work they do.

While the story is intriguing and also quite funny, it is about a murder, actually two murders, and it ends with a moral dilemma. Many are already familiar with the story so are aware of this, but when Mr. Rattazzi's Poirot steps forward to address the audience about making such a choice it is quite moving and thought provoking.

*Murder on the Orient Express* is only playing for two weeks. Tickets will become scarce, so I suggest you don't hesitate and get down to the station to book your seat for this incredible ride. I hope the success of this non musical will lead to another next year. I have a suggestion: Why not go with Agatha Christie again; perhaps Witness for the Prosecution.



# Nanna & Babbononno

by John Christoforo

A Nostalgic Remembrance



On several occasions, I have written about Babbononno's fear of automobiles. He was born in 1875, several years before the advent of the auto, and as a result, he didn't understand them, feared them, and hated riding in them even though someone he trusted was driving.

A generation later, my mother had a similar problem. Her problem wasn't with cars it was with flying. Mom was born in 1909, and didn't know anything about the concepts of aviation. After WWI, she and her brothers would go to the airstrip in East Boston, which would eventually become Logan International Airport, and watch the biplanes takeoff and land. She never actually thought she would ever fly in a plane.

Air travel in this country became a practical way of transportation during the mid-1930s, but a few years later, WWII would interfere with its development. After the war, air travel took off, figuratively and literally.

One night in 1948, the phone rang about 3:00 a.m. The collar was the booking agent for the Guy Lombardo Orchestra. They needed Dad on tuba in New York for a few upcoming dates due to the illness of their tuba player. Dad had been called by Lombardo, himself, a year or so earlier, but he couldn't accommodate him due to the fact that he was teaching school in Boston five days a week and could only play locally. If things had been different, I might have grown up in New York City, and God forbid, been a Yankees fan.

Dad checked his engagement book and the dates were open. And so, the arrangements were made, Dad was to fly to New York, would be picked up at the airport, and would stay at the Hotel Taft in midtown Manhattan. It sounded great, but there was one glitch, Mom had never been to New York and Dad wanted to bring her along. The booking agent agreed and for the rest of the week, Mom prepared for the 211-mile trip, or by air, 188 miles (as the crow flies).

By 1948, there was something akin to a shuttle that flew from Boston to New York and New York to Boston. I believe the price was \$12.50 each way. Toward the end of the week, Dad and Mom were on that shuttle flying to the Big Apple. Mom had only seen planes from a distance, but had never been in one until that point in time. The shuttle planes were converted DC3s, troop transports left over from WWII. The planes sat on a tail wheel which made their body's angle upward toward the cockpit. There were two engines, one on each wing and were very loud when you consider that there was no air compression inside and the planes might even have a window or two open while in flight.

Dad packed his suitcase with a tuxedo, street clothes, pajamas and underwear, and made accommodations at the airport for his Sousaphone to be transported in the luggage compartment.

Mom, on the other hand,

packed for a trip into the wilderness of America. Dad assured her that, if she needed anything, New York had two competitive stores, Macy's and Gimbals', their version of Filenes and Jordan Marsh Department Stores, both of which Mom shopped at in downtown Boston quite often.

Fearing the worst, Mom packed two large suitcases with everything she might need to survive in the wilds of New York City. Nanna helped her to pack and made sure she had a St. Christopher medal somewhere in one of her suitcases. St. Christopher was then the patron saint of travelers. I'm not sure, but I don't think Our Lady of the Airways had been invented as of yet. Packed in her other suitcase was a pair of Rosary beads, just in case.

When they were finally seated on the American Airlines DC3, a flight attendant gave them all of the instructions for flying to New York. Mom fearing the worst gripped her pocketbook and then opened it to see if Nanna had placed her Rosary in it or had packed it in her suitcase. After the flight attendant assured the passengers that the flight would only be about an hour long, Mom relaxed and enjoyed a complimentary cup of coffee.

After taking off, Dad told me that Mom was silent, and he suspected that she, in fact, was saying the Rosary, but he couldn't be sure. An hour later, the plane landed and Mom and Dad were met by a representative from Guy Lombardo's Orchestra, someone who was to drive them to the Hotel Taft. When Mom asked Dad if he knew who was picking them up and the answer was, "No," she then asked how they would know who they were. Dad's response was, "How many people fly to New York carrying a tuba or Sousaphone?" Mom then relaxed. A half hour later, they were unpacking their suitcases in their designated room at the Hotel Taft. Lombardo's driver handed Dad an envelope with

the instructions for the rest of the week. Nothing was planned for the rest of the day, and Dad decided to take Mom sightseeing, as he was familiar with New York City and she wasn't.

Mom was hungry and told Dad that the only New York restaurant she knew of was Mamma Leone's, then the most famous Italian restaurant on the east coast. There they had an early dinner. Of course, Mom had to compare their gravy with Nanna's and their meatballs with her own. She was satisfied that everything was authentically Italian, and all was well.

Later in the day, as they were walking through midtown Manhattan, Dad headed for a stationary store and bought something for me, Mom and himself, a new invention called a ballpoint pen. Up until the late forties, everyone was still using fountain pens. The invention of the ballpoint pen changed writing from that point on.

The flight home was a bit rough, lots of turbulence above Providence. Mom was a bit airsick after they landed, and swore she would never fly again. Years later, after the jet age began, she and Dad would fly down to Florida or the islands of the Caribbean, and Mom became an expert traveler. Unlike Dad or me, she would never fly alone or without her St. Christopher medal and Rosarv.





#### Jose "Mantequilla" Napoles

All Time Great Welterweight Champion Passes at the Age of 79



Jose Napoles

Former alltime great welterweight title holder Jose Napoles passed away on August 16th at his home in Mexico City. He had been in failing health for some time suffering from diabetes and Alzheimer's Disease. A native of Cuba, he defected to Mexico in 1962, when Fidel

Castro banned professional boxing. He was welcomed in Mexico where he became a national hero.

As an amateur, Napoles compiled a record of 114 wins and just one loss. He turned pro in 1958, competing first as a feather weight and then a lightweight and junior welterweight. Even though he beat many top contenders, he was never given a shot at the title. It was a case of being too good for his own good. It is a shame he never got to challenge Carlos Ortiz for the title as that would have been a matchup of two all time greats.

Napoles moved up to welterweight, where ten years after turning pro he finally got a shot at a world title when champion Curtis Cokes agreed to defend the title against him. In a one sided



bout Napoles defeated Cokes when the champion was unable to answer the bell for the 14<sup>th</sup> round. Two months later the two squared off again with Napoles winning this time when Cokes was unable to continue after the 10<sup>th</sup> round.

Napoles, who was nicknamed Mantequilla which means butter in Spanish, because his style was smooth as butter, went on to hold the title for seven years with the exception of a brief period when he lost it on cuts to Billy Backus in 1970. He regained it six months later.

In his first time as champion he defended the title 4 times, and went on to defend it 10 more times in his second reign. He met and defeated all the top contenders including Hedgemon Lewis,

Ernie Lopez, Emile Griffith, Clyde Gray, and Armando Muniz.

In 1974, he moved up in weight to challenge middle-weight champ Carlos Monzon. Monzon proved to be too big and strong for the aging Napoles and the fight was stopped on cuts after the 6<sup>th</sup> round.

In 1975, at the age of 35, he lost

the title on cuts to British Champion John H. Stracey. Napoles retried after the fight and lived out his life in his adopted home of Mexico. In 1984, he was inducted into the World Boxing Hall of Fame.

Jose Napoles was one of the all time great fighters. A boxer puncher who slid about the ring without effort, his power came from his accuracy when landing blows. He would slip punches with ease and counter punch beautifully, often while placing himself almost completely beside his opponent.

Napoles would have been a top fighter in any era and would have given any champion more than he could handle. He most likely would have become champion years earlier if he had been given a chance.

Personally, he was a quiet and humble man who never bragged. He smiled easily and never had a bad word about anybody. He was a true champion in and out of the ring.

### HOOPS and HOCKEY in the HUB

EVERYTHING IS ON SCHEDULE — If you like your hockey to start early and end early then perhaps the 2019-2020 National Hockey League schedule is for you.

It won't be long now until training camps open in September. In fact, the Bruins prospects will actually be participating in the Prospects Challenge Tournament in Buffalo the weekend following Labor Day — at the same time that one Thomas Edward Patrick Brady is calling signals for the Patriots in their season opener against the Pittsburgh Steelers over at Gillette Stadium.

In fact, the Bruins, one day might actually get the jump on the Pats when they meet the hockey representatives from the Steel City (the Pittsburgh Penguins' prospects) in the tournament's opening contest on September  $6^{\rm th}$ —two full days before the Pats go to work for real in Foxborough.

Yes, it is that early. Hockey arrives just in time to jostle a bit for space on the NFL's opening weekend. The veterans arrive in the Hub a few days after the September 9<sup>th</sup> conclusion of the Prospects Tournament and things really get down to business quick.

Such as the opening week of the preseason that features three games in the first six days with all of them on the road.

The opener is at New Jersey on September  $16^{\rm th}$ , followed by contests at Philadelphia on September  $18^{\rm th}$ , and at Chicago on September  $21^{\rm st}$ . That schedule is essentially reversed in the second week of the preseason with three home games at the Garden — against the Flyers on September  $23^{\rm rd}$ , followed by a matchup with the Devils on September  $25^{\rm th}$ , and a contest against the Blackhawks on September  $28^{\rm th}$ .

Thus, the busy preseason schedule constitutes a fortnight's peek at what the Bruins just might look like before — grab your mittens — the NHL regular season opens on October  $2^{\rm nd}$ , a scant three days following the conclusion of Major League Baseball's regular season.

At least the B's will be spared a rather agonizing moment when the St. Louis Blues raise their Stanley Cup Championship banner just prior to facing off against the Washington Capitals on Opening Night.

The Bruins actually open the next night (October  $3^{rd}$ ) in Dallas, the first action in a four-game road swing against Western Conference opponents that lifts the lid on the 2019-2020 campaign for the Black and Gold.

In fact, the B's have a somewhat delayed home opener, their regular season debut not taking place until October 12<sup>th</sup>, against New Jersey.

There might be a tendency by some not to pay full attention to the early portion of the schedule because of the Patriots and the baseball playoffs. But this year a trio of top tilts come early with the B's facing three quality opponents at the Garden in October.

First up is Tampa Bay on Thursday, October 17<sup>th</sup>. Yes, everyone can remember what happened. The Lightning were the best team in the regular season last year and then promptly got swept (not just defeated, but swept) by Columbus in the first round of the playoffs.

So lightning struck the Bolts when they least expected it. But don't let that aberration fool you. They still are a strong team and pose a formidable threat as one of the NHL's top squads.

Following the game with the Lightning, the Bruins play two games in a row against Toronto, with the game at the Garden set for Tuesday, October  $22^{\rm nd}$ . The Maple Leafs could once again prove to be a strong challenge for the Bruins this year.

Recall that Toronto actually held the upper hand against the Bruins in the first round of the Stanley Cup playoffs last spring, leading three games to two.

One more Toronto victory and the Bruins would have been done in April — and never would have seen May, let alone June. That did not happen, of course, as the Bruins rallied to win games six and seven. But the fact remains, it took all the Bruins had to get by the Maple Leafs.

And then there is the rematch — the game with St. Louis at the Garden on Saturday, October 26<sup>th</sup>. It is the only appearance at the Garden by the defending Stanley Cup Champions, in contrast to Tampa Bay and Toronto who will pay return visits in March.

Another game of note in the 2019 portion of the schedule will come on Friday, November 29<sup>th</sup>, when the Bruins clash with the New York Rangers in the annual day-after-Thanksgiving game at the Garden.

The matchup with the Rangers will be the first meeting of the two teams in the new season and will serve as an interesting marker for both.

Bruins President Cam Neely is a big believer in the adage that how teams stand at Thanksgiving gives a pretty good indication concerning how they will wind up when the regular season ends. That comes on April 4<sup>th</sup>, the earliest concluding date in quite some time.

Given that the B's play virtually one third of their games in October and November this time around, the old saying may have an even stronger validity than in the past.

In addition, the game with the Rangers will also serve as a checkup on David Quinn, the former Boston University coach now in charge of the Blueshirts. It is his second year of a multi-year contract. Management probably expects a few more wins this time around after New York failed to qualify for the playoffs last spring.

We'll have to wait a bit to see Montreal. The Canadiens don't come to Causeway Street until December  $1^{\rm st}$ . Their only other appearance will come on March  $12^{\rm th}$ .

Just a thought about the schedule as a whole, which has the B's playing four games per week over six different stretches. That's a lot of hockey squeezed into short periods of time. Could adding a week to the regular lessen that reality? Think about it.

Whatever. It is almost here — your 2019-2020 National Hockey League extravaganza. Get ready to enjoy!
