Rick Perry: A Fire and Brimstone Kind of Governor?



VESPASIAN'S COLOSSEUM

79 A.D. after a brief illness, just one month before the eruption of Mt. Vesuvius. He was a hard-headed man, of great common sense, ambitious for power, shrewd, determined and above all he was practical. Although his reign was marked by great economy, the Colosseum or Flavian Amphitheater that he started in 70 A.D. was probably the most extravagant expenditure for public amusement ever made in the world. It was opened and dedicated by his son, Emperor Titus, in 80 A.D. and finally completed by his second son, Emperor Domitian, in 82 A.D. These three emperors, a father and two sons, all carried the family name "Flavius" as part of their imperial title and are known to us today as the Flavian Emperors. Consequently, this structure is properly called the Flavian Amphi theater. The name Colosseum came into use because of the colossal statue of Nero that stood near it in ancient times.

The Colosseum is oval shaped, about six hundred

Vespasian died on July 23, feet long, five hundred feet and seats for government wide, one hundred and sixty feet high and covers six acres. The central combat area was called the arena which, interestingly enough, is the English translation for "harena," the Latin name for the sand that was spread to absorb the blood of the contestants or the animals. The air was kept fresh smelling by spraying perfumes or by spreading costly powders around the structure.

Eighty arched openings in the exterior walls of the first story formed the entrances, but these corresponding arches in the second and third stories contained beautiful sculptures. A total of 160 statues were displayed in the upper facade alone. There was seating capacity for fifty thousand spectators and standing room for about thirty thousand more. Seating priority was strictly by social class and all seats and tickets were numbered. The present day system of numbered seats and tickets in places of amusement began here. The emperor's ringside platform or box contained the imperial throne

officials and dignitaries. The lowest range of regular seats were reserved for the noble and wealthy, while the second range was reserved for the middle-class. The third range was for poor people, and the last, most upper range was for unescorted women.

A skillful arrangement of corridors, stairways, ramps and wall made it possible for each class of spectators to reach their own seats or to exit without coming in contact with their social inferiors. The eighty exits were referred to as "vomitoria" because they permitted the spectators to spew or flow right out into the street. A full Colosseum could be emptied in less than ten minutes. The structure was intentionally built as an arena where the wholesale destruction of human and animal life took place for the amusement of the spectators, and they witnessed these scenes of murder hour after hour, day after day, and month after month.

TIME TO CURTAIL THE EPA AT HAND

The EPA is the biggest detriment American business has to confront. If American business is to survive, the EPA has to be curtailed. Alternatively, if I had my way, it would be abolished altogether and left up to Congress to issue any further regulations that will not hurt our economy. Otherwise, the EPA will continue their assault on business.

Bernie Marcus, co-founder of Home Depot, says Home Depot "would never have succeeded" if it launched today due to onerous regulations. Marcus went on to indicate, "I can tell you that today the impediments that the government imposes are impossible to deal with. Home Depot would never have succeeded if we tried to start it today. Every day you see rules and regulations from a group of Washington bureaucrats who know nothing about running a business. In addition, I mean every day. It is becoming stifling."

In addition, this from the man who played a major role in revitalizing Las Vegas is bashing President Barack Obama as "the greatest wet blanket to business, progress and job creation in my lifetime."

Speaking recently to investors on a conference call, casino developer Steve Wynn — calling himself a "Democratic businessman" — went on a rant against Obama and his policies.

His customers and the companies he works with "are frightened of this administration," he said, "and it makes you slow down and not invest your money. Everybody complains about how much money is on the side in America."

"Until we change the tempo and the conversations from Washington, it's not going to change," added Wynn. "And those of us who have business opportunities and the capital to do it are going to sit in fear of the president. Moreover, many people do not want to say that. They will say, 'God, don't be attacking Obama.' Well, this is Obama's deal, and it is Obama that is responsible for this fear in America."

If we could open up the National Wildlife Refuge (ANWR) in Alaska, the U. S. Geological Survey estimates there is 7.7 billion barrels to be realized. Think how many thousands of jobs that would create. You have to ask why we are not going after it, especially considering the people of Alaska are in favor. The answer of course: the EPA is the culprit.

Another factor every American citizen should be concerned with; do not be surprised to see your electricity bill jump 40 to 60 percent in the near future. Pending EPA regulations are prompting some coalfired power plants to close and more energy that is expensive will likely fill the cap. At present, coal fired plants provide nearly fifty percent of our electricity.

Freedom Works recently advised me: The Obama Administration's EPA has been working to enact a backdoor cap and trade scheme through greenhouse gas regulation that would further drive up already skyhigh energy costs.

Freedom Works members have sent over 153,000 letters and emails and made over 2,300 phone calls urging targeted lawmakers to pass legislation that would put a halt to EPA's cap and trade nightmare. This groundswell of grassroots pressure has helped

Pino, the Chef/Shaman of Boston

The North End, the oldest residential area in Boston, is home to many Italian shops and restaurants. In the heart of this historic neighborhood is Piccolo Nido Restaurant, owned by Castelvenere native, Pino Irano. The restaurant has been visited by famous Italians such as Roberto Benigni, Gugliemo Epifani and former goalkeeper Walter Zenga. The restaurant was practically the second home of the "Spider Man" Walter Zenga when in 1997 he came to play for the New England Revolution, the team he finished his soccer career with.

with important people such as Richard Gere and Katie Couric, to name a few. But the memories that are most dear to him are those he shared with Zenga. He remembers, "Walter would call me for whatever problems he encountered. I enjoyed accompanying him in becoming familiar with the City of Boston and together we shared moments that I will truly never forget." Throughout the years, Pino's restaurant has become popular in Massachusetts, not only because of its authentic Italian cuisine but also because of a Pino has many memories particular practice, remov-

ing "Il Malocchio" or the evil media and an article was eye. In fact, Pino is recognized for helping the Boston Red Sox overcome the "Curse of the Bambino". This superstitious curse began in 1918 when the Red Sox sold Babe Ruth to the New York Yankees despite having been the strongest team in baseball during the tenure in Boston. After selling Ruth, 86 years had passed since the Red Sox last won the World Series with him in 1918. "The curse was interrupted when Red Sox President Larry Lucchino came to visit me", explains Pino. "I understand that the Red Sox had been stricken by "Il Malocchio" and after a few visits from Lucchino I was able to remove the evil eye." Then in 2004 the Red Sox championship drought came to an end as they were once again crowned World Series champions. From that moment something special arose in the Boston sports world. A few years after helping the Red Sox, Pino was able to help the Celtics to their first NBA championship in 20 odd years by using the same techniques with players such as Brian Scalabrine and Coach Doc Rivers, who believed in Pino's practice. By this point the story began to draw attention from the

written about it in New England's most popular newspaper, The Boston Globe. Then, this past June after 39 long years without a Stanley Cup, Boston was once again recognized as world champions in the hockey world. Not surprisingly, even this victory stemmed from Boston Bruins players visiting Piccolo Nido. One can witness it themselves as the "Boston Channel" news cam-eras caught footage of Bruins Captain Zdeno Chara placing the prestigious Stanley Cup in Pino's hands. Pino, authentic shaman in the kitchen, has put forth not only his good Italian tastes but also the magic and beliefs typical of rural southern Italy. Thirty years ago, when he began his great adventure around the world he brought along the knowledge of the great Italian cuisine from his region.

FROM CASTELVENERE TO BAHRAIN AND ONTO **MASSACHUSETTS**

Boston is not the only traveling experience that Pino has had. After graduating from the school of hospitality he worked as a chef on a cruise line and eventually landed in Bahrain. Eventually he made the longest journey of his life by crossing the Atlantic and arrived in one of the most beautiful cities in the United States: Boston. Pino frequently made trips back to his home village of Castelvenere. However, when he settled down and had a family these trips became less frequent. His mother, Antonietta, and brother, Carlo, still reside in his native Castelvenere. Carlo works as a professor in a school of hospitality. His youngest brother, Angelo, has always been involved in politics and at one point even held the position of provincial general secretary of the left wing political party. Pino's childhood friend, Barbato De Risola, recalls that politics has always been one of Pino's true passions. "In the years of our youth, when the ideologies were strong, we had many heated discussions about politics," said Barbato. Another strong friendship Pino holds back in his hometown is with former Mayor and physician of Castelvenere, Mario Scetta. Scetta explained, "The thing that I admire most about Pino is his willingness to help others." Those who visit Pino claim he was always remembered for his hospitality and great dinner conversations, especially the ones about Castelvenere.







Moving to a new area and how does my pooch friends feel about leaving the North End? Here is an article I found very interesting, and it may help you and your pet.

Moving with your dog, most dogs take moving in stride but others have difficulty settling in to a new home. Pets easily pick up on body signals and emotions, so if you're anxious, your pet can become more anxious as well. The main issues to consider in moving are the change in routine and the new home itself. To help your dog adapt to any change in daily routine, changes in scheduling and how family members might interact, should begin before the move.

If the dog is not already on a fairly structured program, introduce a more predictable daily routine that can continue in the new home. While you are preparing for

the household move, try to minimize disruption to your pet's schedule and environment as much as possible. If your dog becomes overly anxious, you may want to consider having someone care for it elsewhere while you pack up your belongings.

On the actual moving days, the dog should be securely confined or out of the home to avoid anxiety, injury or escape. You should set up an environment for your dog in your new home that is as similar as possible to the dog's previous environment, especially with regard to the dog's sleeping, feeding and play areas.

Show your dog the new areas and spend some time with it until it becomes familiar with the new environment. Accompany your dog while it explores the rest of the new home so that you can reinforce desirable behavior and interrupt

or deter any undesirable behavior such as marking or chewing. Because dogs are strongly scent oriented, investigating new odors and spreading their own odors gradually throughout each room can be important for them to become familiar and comfortable with the new home. The length of time it takes a dog to adjust to a new home varies, because every dog reacts differently. Most dogs start to relax within a few days of moving, while some seem to immediately enjoy the stimulation of exploring a new environment and others may take weeks to adjust. When first leaving your dog alone in the new home, it's best to match the time when the dog is normally sleeping or playing with its toys.

What do the numerous feasts that are held in Boston's North End represent? From early May through the final weekend of August, the residents of the North End don't merely trot out carts filled with Italian foods of all manners, nor do they only seek to support the various vendors whose

The feasts are a reverent force of a neighborhood steeped in faith. They are also openly sharing their faith in their rich Catholic heritage and proud Italian traditions. Faith in each other to live, work and socialize in a close-knit community, committed to helping others. Theirs is a love of the faith that has proven unwavering during difficult times that have hit over the past 150 years in America.

A swarming display of faith is seen up close and personal at the Saint Anthony Feast, which begins on Friday, August 26th. Tables filled with pins of St. Anthony's likeness are easily available in front of St. Leonard's Church. Rosaries and prayer cards honoring St. Anthony of Padua are spread across the various chapels and grottos that dot the narrow, lively streets of Boston's oldest neighborhood.

Faith is the testament of the tens of thousands of visitors to the North End during the four-day feast. Many folks flock to the feast to honor Saint Anthony, while others vacationing from all over the world make it a must-stop on their itinerary. Still more are friends of the North End's cozy coffee shops, restaurants, trattorrias, shops, stores, bakeries and Catholic churches.

Votive candles, rosaries, scapulars and reassuring icons of Our Lady of Perpetual Help, lovingly holding the child Jesus, adorn every area of the North End. These are not simply symbols of one's Catholic heritage. Indeed, they are a direct connection to the early leaders of Catholicism. They inspire, comfort, elevate and deepen one's belief in the eternal powers of Jesus, Mary, St. Joseph and all the saints. Looking into the eyes of a saint, Jesus or his blessed mother Mary is an edifying experience.

Marching bands move along some streets of the North End at the Sunday noon procession. The bands are followed by throngs of the faithful, as they converge on Hanover Street, the main thoroughfare stretching west Boston Harbor.

The culmination of the

final feast of summer joins the faith community to their revered Saint Anthony. Dollar bills are pinned to the anointed robe that covers the statue, carried securely on the shoulders of Italian men sweating under the labor of their love.

The notion that Catholics praying before statues of their beloved saints is idol worship misses the obvious outpouring of their deep and abiding faith. Statues resemble the saints who were once upon a time human, yet fallible. Worshipping a saint by viewing the statue shows that faith is innately divine and can only be taught to a finite degree. The rest is up to Catholics to carry on that faith, despite life's inevitable challenges.

The un-interrupted testament to saint Anthony, who died in 1231 A.D., can be viewed in real time in the off Atlantic Avenue, east to North End. Join the commu-Commercial Street to the nity of the North End and witness a faith that keeps on giving.





Ten people will be recognized, led by Lynden B. Miller, who will receive the George Robert White Medal of Honor for her work as a designer of urban parks.

Ms. Miller is a public garden designer in New York City and director of The Conservatory Garden in Central Park, which she rescued and restored beginning in 1982. Her work includes gardens for the Central Park Zoo, Bryant Park, The New York Botanical Garden, Madison Square Park and Wagner Park in Battery Park City as well as many smaller projects in all five boroughs and beyond.

Also being honored is Wesley R. Autio, professor of pomology in the Department of Plant, Soil and Insect Sciences at the University of Massachusetts, Amherst. When it comes to foreign policy and national defense, the Perry doctrine is clear, "If you try to hurt the United States, we will come and defeat you." Bachmann may have been the latest big winner in Iowa but the GOP race maybe coming down to a Romney-Perry showdown.

Sex strike gets results: The women of a small town in southern Colombia have succeeded in getting their highway paved by withholding "love" from their husbands. Some 300 women in Barbacoas are more than a month into their "strike of crossed legs," to force authorities to improve the road that connects their town to the rest of Colombia. The road is so abysmal that it takes up to 14 hours to reach the nearest hospital, 60 miles away — far too long to save a mother or infant in a complicated childbirth. Well, after national coverage of the strike, authorities announced that paving would begin in October.

Jerry Lewis remains as cantankerous as ever, said Amy Wallace in GQ. Now 85, he's been in show business since the age of 5, when as the son of vaudevillians, he kicked out a stage light and got an accidental laugh. He was tight with Charlie Chaplin. He's met nine presidents. He still refers to Dean Martin as his "partner," even though their act broke up 55 years ago. His films have grossed millions and his work for the Muscular Dystrophy Association is one of America's great philanthropic stories. Along the way, he's earned a reputation as a control freak and narcissist. He's certainly not afraid to toot his own horn. "I'm smarter than a pig in s___, I'll tell you. I just don't like everybody now." He's had more than his share of women including, he claims, Marilyn Monroe. "I was crippled for a month," he says of the encounter. Recently Lewis was ousted as MDA chairman and host of the telethon, ending a nearly 60-year run — but he is undeterred. "I've got so much to do." His goal is to live longer than George Burns (who died at 100), because he told Burns he was going to. "It was a joke," says Lewis. "That's all it was. Now it's no joke."

Great idea! The Crowne Plaza hotel chain started testing its first "snore absorption rooms," with soundproof walls and "snore patrols" to knock on the doors of those who are snoring thunderously.

Achtung! In an attempt to prevent neo-Nazi rallies, German officials have dug up the grave of Adolf Hitler's deputy, Rudolf Hess. The bones were secretly exhumed at night, cremated and scattered at sea last week. Hess was captured in 1941 when he parachuted into Scotland, and he hanged himself in a West Berlin prison in 1987 at age 93. His grave in Wundersiedel became a pilgrimage site for neo-Nazis who held annual rallies on the anniversary of his death. This year, with the burial plot lease up for renewal, the Lutheran church that administers the cemetery persuaded Hess's family to remove his remains. "The Nazi shadow over Wunsiedel has finally come to end, "said Charlotte Knobloch, a local Jewish leader.

Will people choose healthy food? Not necessarily. Many Americans have little experience eating or preparing broccoli, asparagus and other produce; in fact, only 26 percent of the nation's adults now eat three servings of vegetables a day. The poor in particular have become so accustomed to salty packaged foods and sugary beverages that they find fresh food bland, strange and offputting. "It's simplistic thinking that if you put fruits and vegetables there, they'll buy it," said Barry Popkin, author of the UNC study. "You have to encourage it, you need advertising, you need support." Changing Americans' diets, in other words, won't be as simple as telling them to eat their peas.

Today, more than one-third of adult Amer-

icans are over weight. Why do people choose the "bad" food? Fast food is



cheaper and doesn't need to be prepared and cooked, so it's more convenient. Studies have also shown that the huge jolt of fat, salt and sugar fast food delivers can be almost as addictive as hard drugs. Then there's the advertising factor: fast-food companies spend about \$4.2 billion a vear marketing their products as life's ultimate rewards, through saliva-producing ads depicting cheese-and-pepperoni-covered pizzas, juicy double cheeseburgers and steaming French fries.

Stinking mess! A Washington state man fleeing police after a car crash doused himself in human excrement to evade police dogs. Gordon Flavia, 56, allegedly was drunk when he backed his Jeep into a condominium's carport, demolishing it. When police showed up to investigate, Fluvial fled into a portable toilet and doused himself with a bucket of human waste. Grandparents have a reputation for being riskier, but a study in the new issue of Pediatrics shows children are 50% less likely to be injured in a crash if a grandparent is behind the wheel than if their mother or father is at the controls. The study thinks older drivers are more nervous and cautious.

No matter what kind of father he was, that is shocking. If my children ever pulled that on me, I would come back and haunt them! Of course. I've been a very good mother and am not likely to die broke as poor Peter did." And from the lips of Carol Channing, "I've enjoyed wonderful health. The only time I ever got sick was when I watched Barbra Streisand in Hello, Dolly! on an airplane." Bette Davis was so outspoken! She once said this about Joan Crawford; "I wouldn't sit on her toilet!" According to Natalie Wood, "I asked Bette Davis if she'd ever wanted to meet the Queen of England. She snapped at me: 'What for? I am a queen.' I wasn't going to argue with her!" And Judy Garland was singing to a photograph of Clark Gable at a birthday party for Clark when she first sang "You Made Me Love You." And when Harry James discovered and subsequently hired Frank Sinatra, he wanted Frank to change his name. Frank wouldn't budge.

LINGUINE WITH CLAMS IN BIANCO

(White Sauce)

2 dozen freshly steamed littleneck clams* 4 or 5 garlic cloves chopped 1/4 cup of olive oil, canola oil, or a mixture of both

1 tablespoon chopped parsley (preferably fresh) Romano or Parmesan grated cheese

1 pound linguine

*OPTIONAL: In place of freshly steamed clams, use two cans of chopped or minced clams and two bottles of clam juice available in supermarkets.

TO STEAM CLAMS: Wash clam shells thoroughly several times. Add about one quarter of an inch of water to saucepan and place on burner to heat. Then add clams. Cover and allow steaming until the clamshells open. Remove saucepan from burner. Remove clams from shells and set aside. Save the broth.

White sauce preparation: Skin and chop garlic cloves. Heat oil slightly in two-quart saucepan over medium heat before adding chopped garlic. Simmer slowly. Do not brown garlic. Remove pan from burner for a few seconds before adding parsley and clam broth from steamed clams. Return to burner and bring to a boil. Add clams, chopped or whole. When mixture comes to a boil, turn off burner. Cover and let stand.

Follow directions on package for cooking linguine or pasta as desired. After draining cooked pasta in colander, place in serving bowl. Pour clam broth from saucepan over linguine. Top each serving with one or more tablespoons of clams. Serve with preferred grated cheese.

Use directions above for preparing oil and garlic mixture. Remove saucepan from burner and let stand a few seconds before adding parsley, bottled clam juice and clams. Bring to a slow boil for a few seconds. Turn off burner. Cover and let stand. Then follow directions above for serving the clams in bianco with the cooked pasta. Serves four.

NOTE: One of my delights is to prepare this meal for my family and friends with fresh steamed littlenecks whenever possible. It always reminds me of the many times we experienced the pleasure of digging for littlenecks along various north or south shore beaches during my childhood. We couldn't wait to return home for Mama to prepare this meal for us.

Whenever I use fresh steamed littlenecks today, I make sure to save some in the shell after steaming. I top each serving bowl of linguine with the chopped littlenecks and a few littlenecks in the shell.



Nanna & Babbononno

A Nostalgic Remembrance

For the past few weeks, I have been writing stories about spending the month of August in Maine. For my father, it was a break from working two jobs all of his life. Regardless of what he did during the day throughout the years, he also played music at night. For Babbononno, it was a rural get away. My grandparents had never taken a vacation and now it was time to relax. For both my mother and Nanna, it meant moving their kitchens from East Boston to Winthrop, Maine. For me, it meant getting away from the street corner and the Seville Theater.

Last week, I mentioned that Dad let me invite my friends, one at a time, to the cottage. When you are an only child, there are many concessions that are granted, and this was one of them. I mentioned a buddy and fellow employee from the Seville, Carl Sinatra. There were a few others that were included at various points in time: John Manfredonia, whom I had grown up with, John Alaimo, one of my closest childhood friends and today a jazz pianist on Martha's Vinyard, my cousins Anthony and Ralph Pepe and a few other teens that I chummed around with back in the day.

There were the children of summer residents that were there every summer. Next to Mike and Nara's cottage was the Lemeux family. Lionel Lemeux was a writer for the Lewiston Sun, a daily newspaper that was popular in central Maine. He and his wife had several children, the oldest of which I was friendly with. To the other side of Mike and Nara was the Brailey cottage. They had a daughter who was a few years older than us mid teens, and of course, she barely acknowledged us. Next to them was the Roache family. Both parents were college professors and fit the stereotype. Their two children couldn't play with the rest of us because they had to study all summer. Their teenage son walked around all day talking to himself in a dialect of French that was spoken before the time of Joan of Arc.

Across the road from the lake side cottages were the homes of the local inhabitants. The only family that was that close to Mike and Nara or my parents was the

Gordon family. Arthur Gordon and his wife had two older boys and two daughters, who were in their mid teens. There was Arthur's father whom we all called Old Vic. He and Babbononno were about the same age and hit it off right from the beginning in spite of the fact that Babbononno couldn't understand what was said through a thick Maine accent and Vic couldn't understand Babbononno's fractured English. Vic's homemade apple jack and Babbononno's homemade red wine did the translation.

There was the Andy family from Augusta. Actually, Irene Andy was the sister of Lionel Lemeux. She had married Emil Andy (Emelio Auidi), who ventured north from Connecticut years earlier. The locals referred to him as the Eve-tal-ven. They had three girls and one boy. Two of the girls were about my age, Earline and Judy. Judy and I were a year apart and I was smitten from the moment I saw her. We dated during the summer months for about three years, but her idea of a "dreamboat" was Pat Boone. As a matter of fact, the year after I graduated college we headed for Maine, not to spend August at the cottage, but to attend Judy's wedding with her Pat

Boone look alike. I was on my own by this time but accepted the invitation to Maine for the wedding. Even though Nanna was gone by this point in time, Babbononno came along. My folks never said anything to me about Judy's intended. Later in life, Dad mentioned that he and Emil had once talked about Judy and me and how nice it would be if we all became one big family. My mother was oblivious to the whole thing. Although I never mentioned anything to Babbononno, when we were at the Andy home for a prenuptial party the night before the wedding, Babbononno looked at the happy couple as they were being photographed, leaned over to me and whispered, "Jenny, datsa suppoz-da be you, not il Americano wadda looka da same in da face azza da singer, Pat-a Boone." I didn't think anyone was aware of my feelings for the young lady, least of all Babbononno. I guess he was more perceptive than I gave him credit for being.

The day of the wedding

came, and we all watched the Pat Boone look alike and Judy take their vows. The reception was held at the Andy house and the house of a neighbor next door. As we toasted the newly weds, Babbononno and I clinked champagne glasses after the best man proposed a toast. After the clink, my grandfather looked at me and said, "Stupido, mi nepoto, tu sei stupido." (Stupid, my grandson, you're stupid.") My grandfather didn't mince words.

That night, I just wanted to be alone. The families decided to head out to an ice cream parlor in downtown Augusta, and I chose to stay at the Andy house and watch TV. Judy had a cat who never liked me. Every time I was close to him, he would hiss and turn away. That night, as I watched the Ed Sullivan Show, the cat jumped on my lap and cried out loud as I cried inside. I'll never forget that cat. He must have sensed my emotions all those years and was just jealous.

Looking back in retrospect, things happen for a reason. My concentration headed toward my careers and I made sure there were no loves in my life. If I had been the groom that day, I never would have played with some of the jazz greats, I would never have made it to Hollywood, and later, I never would have gone back to school for an advanced degree and met Loretta, whom I've been married to now for 34 years. Oh, also, I never would have become a writer for this paper, and there would never have been a column called, "Nanna and Babbononno." So, I guess things happen for a reason.

As we teens became young adults in our twenties, we all stopped accompanying our parents to Maine during the summer months. After Babbononno passed away, it was just Mom and Dad heading north during the summer. It got to a point where the summer place got to be too much for my folks, and Dad sold the cottage at Frosty's Point in Winthrop, Maine. Looking back, though, those days were some of the most memorable of my life. I'll never forget the wonderful summer months of my youth.

THE SEARCH FOR WELLBEING AND HAPPINESS IN ITALY. Economists and statistic experts in Italy have been quite busy of late. They are trying to find the real formula that could indicate the level of economic development which can also indicate the growth, or stagnation, of a nation and detect what the indicators tell about the social conditions of the nation, ITALIA, for the year 2011. The experts seek to identify the level of the economic wellbeing of the people. Essentially, the search is focused on the health conditions of the country, as a result of a study on the psychophysical status of the people who live there, their level of education, their overall knowledge, their understanding of "labor," wellbeing, environment, interpersonal relations and their intermingling in society. Also, they will try to find out what the citizens' sense of insecurity is, as it relates to economic and social conditions. We will learn more when the results of the study will be made public in June 2012.

In the meantime, we would like to introduce our readers to the level of happiness in relations to residents of a country: Costa Rica; Denmark; Ireland; Switzerland; Finland; Holland; Norway; Sweden; Panama; Mexico (in that order, from place 1 to 10). Where do we find Italy? 31st place! Now let's match the above statistics with the one issued by the UNO (from 1 to 10): Norway; Australia; Canada; Ireland; Holland; Sweden; France; Switzerland; Japan. This time Italy comes up better: in 18th place!

On the other hand, Costa Rica drops from first place to 54th! According to UNO officials the latter list was the result of the answers given to three questions: living a long and healthy life; higher education; living generally a good

WASTE OF TALENTS IN SOUTHERN ITALY: 150 YEARS LATER THE GOVERNMENT IS STILL ABSENT! Mario

Moretti Pelegato, not a southerner, a prominent entrepreneur, after looking at the data on youth unemployment, stated that "In order to change direction it is imperative to show political will, which has been absent for many decades". He added that Italy keeps losing talented youth because it is unable to offer better conditions than other countries. He said also that he offers to the young people who work in his companies a school education within one company, where youngsters can follow formative training to various levels, a free company-run child care center, for children aged 3 to 6. Despite their high qualifications, the northern industries offer them only menial jobs, at low pay!

Boston recommendation to change the designated route of pass-through hazmat trucks from the North End/ Waterfront to Route 128 and the other highways outside the city. Battelle's study analyzed 18 alternative routes within and outside the city. In the North End/Waterfront, designated streets currently include Atlantic Avenue, Commercial Street, Cross Street and N. Washington Street experiencing an estimated 100+ hazmat trucks per day.

After a review of the public safety study by the Battelle Institute at the meeting, City of Boston Transportation Commissioner Tom Tinlin spoke on behalf of Mayor Menino who has long supported a ban of hazmat trucks in the city. The proposal also has support from the entire Boston delegation of legislators.

"The facts are on our side," testified State Senator Anthony Petruccelli speaking in support of the recommendation to ban hazmat passthrough trucks from Boston. "The trucks are too dangerous to come through the North End.'

"Every night, the people in my district live in fear," said Boston City Councilor "These Sal LaMattina. trucks do not belong in the North End or Charlestown."

State Representative Aaron Michlewitz testified, "The numbers speak for themselves. The routes through downtown Boston are significantly more risky than Route 128 and the highways around Boston. We all know about the recent tragedy along Route 1 this summer. Imagine if such an accident had taken place on the dense populated streets of Boston'

In addition to elected representatives, several community organizations spoke in support of the re-routing proposal including the North End/Waterfront Residents' Association (NEWRA), the North End/Waterfront Neighborhood Council (NEWNC) and the North End/Waterfront HazMat Task Force.

By the numbers, the Battelle safety analysis concluded there is 4x more risk from hazmat trucks in downtown Boston than on Route 128 during the day and 2.2x more risk at night. The risk is higher during the day as suburban commuters and tourists are also put at risk in the city. Federal routing criteria dictates a routing change when the risk ratio is over 1.5x (i.e, 50% more risk). Thus, the current routes through the North End/Waterfront are well above the recommended risk ratios, strongly justifying a route change outside downtown Boston to other existing routes on I-95/I-93/ Route 128. Although multiple parameters are considered, the primary basis of the risk assessment is the density of population surrounding the route.

Hazmat trucks are not doing business or delivering in routing change.

considering the City of Boston, but rather passing through to save time rather than use the highways around the city that were designed for commercial vehicle traffic. The fuel trucks previously used the overhead artery expressway before the Big Dig tunnel which prohbits hazmat vehicles. According to Battelle, nothing in the report would restrict the local delivery of gasoline, diesel fuel or home heating oil in the City of Boston.

> Several trucking companies and lobbyists testified at the public hearing, including large gasoline trucking operators and the Massachusetts Motor Transportation Association (MMTA) that represents the industry. The trucking companies expressed concerns about the added time and expense of the re-routing proposal. Traffic on Route 128 can get congested and several expansion proposals have been delayed.

> Trucking executives, including Larry Noonan of J.P. Noonan, cited the risk of highway speeds causing rollovers versus the slower city traffic pace in downtown Boston. MMTA lobbyist, Anne Lynch, said "We are fraught with high speeds on highways when its not congested and we have an average of 8-10 miles per hour going through the city with traffic lights on every block.

> Debra Boronski of the Massachusetts Chamber of Business & Industry testified about concerns of increased costs to the truckers being passed on to the consumer. As required by its guidelines, the Battelle study addresses the question of whether the re-routing would cause an unreasonable burden. Their analysis tallies an insignificant increase in costs, translating to under a penny on each gallon of gasoline transported.

Monika Tibits from the Route 128 Business Council testified about traffic congestion encountered by the shuttles the organization runs on the highway. "We cannot handle any more traffic on our overtaxed roadway," she said.

Representing businesses in the city and speaking in favor of the re-routing to highways outside Boston were Richard Dimino from A Better City and the North End's own Joanne Prevost Anzalone who said, "Cost is not the issue, safety is the issue." The Freedom Trail Foundation's Mimi LaCamera also reminded attendees that tourism is the largest business in the State, centered in the North End and downtown Boston.

The public hearing process now moves to the suburbs where similar meetings will be held in Quincy, Waltham and Stoneham. The pubic comment period is open until September 23, 2011. Residents and businesses can email bostonhazmat@ state.ma.us to express their own views on the proposed


