United We Stand, Divided We Fall

The big brouhaha enveloping the North End's narrow streets and cozy restaurants, bakeries, shops and stores took a startling turn recently as coffee corporate giant Starbucks showed up to steal away the charm and way of life from Boston's oldest neighborhood. But longtime neighbors and business owners – some dating generations residing and working in Boston's "Little Italy" – pushed back vociferously.

For nearly 20 years, I've been going to the North End for feasts and to attend Mass at two Catholic churches and, of course, to eat. Having tried the various Italian delicacies at several restaurants, I do admit that a few are my favorites that I return to during the warm weather months. Getting to these wondrous places involves meandering down old quiet side streets where numerous apartment houses are packed tight in neat rows. Much of the sprawling neighborhood's architecture reminds me of old world Europe.

Two weeks ago on a hazy Saturday, I spent a few hours with my twin enjoying a refreshing sea breeze along a few spots of the Harbor Walk at the edge of the North End. We ate lunch at a popular neighborhood grocery market — the Golden Goose, on Commercial Street.

Older residents of a multiapartment complex across the street sat on the sidewalk discussing the issues of the day. The outdoor tree-shaded spot proved peaceful from the ever-buzzing Hanover Street, its sidewalks crammed with visitors, vehicles slowly moving, and a steady stream of hungry people eagerly waiting to enter the many busy street's restaurants, coffee shops, bakeries and pizza parlors.

I admire people who jump into the fray of controversial matters that impact their way of life. For weeks, Starbucks grabbed headlines in Boston's daily newspapers, the lead news story on local TV news stations, and stirred heated conversations throughout the North End.

Longtime residents took to the front of the lengthy building on the corner of Cross Street. and Hanover Street, where the proposal for Starbucks to buy a stretch of privately owned businesses sits. The angry faithful held signs, walked in groups chanting "No Starbucks in the North End," and happily gave interviews to harried TV reporters.

The collective opposition openly pleaded with Boston Mayor Marty Walsh to act swiftly to join them in saving the

unique neighborhood known and revered by generations of Italian Americans, whose ancestors settled there upon entering the U.S. in the late 19th century. Other folks who know the North End by regular visits also clamored a resounding no to Starbuck's intended invasion.

One grand element is the consistency found in the North End as frenzied change strikes other neighborhoods around Boston. Imagine the fever-pitch by residents on stony Marlborough Street in the Back Bay if Starbucks appeared ready to open a shop?

Upon listening to a few residents of the North End share their candid views, I learned that four Starbucks coffee shops can be found within less than a mile from the neighborhood.

One of the more interesting moment of our day occurred after leaving the Golden Goose to find another familiar breezy oasis along the Harbor Walk: my twin and I discovered a Starbucks at 2 Atlantic Ave., a few short blocks from one of the several venues to reach the North End.

So there's your popular coffee shop, Starbucks fans. I'll gladly head a bit farther north to sip my coffee at Caffe Vittoria. *Ciao!*

THE DINNER OF TRIMALCHIO



Throughout all of early Roman history, there were mostly temperate men, moderate in all of their indulgences including their appetites for food and drink. These were the persons who were satisfied with their coarse breads, the normal vegetables, fowl, cheese, fruits, and local wines. Invited guests were also treated to moderate meals, served and eaten under moderate conditions.


There were also those few who attempted to impress their friends by a show of wealth which was ridiculous, absurd, and vulgar.

There can be no discussion of lavish Roman dinners without making reference to a story of the "Dinner of Trimalchio" and to its author "Gaius Petronius." Petronius was the "Arbiter Eleganatiarum" or probably much better described as the Director-in-Chief of the imperial pleasures at the court of Nero and one of the emperors' chosen companions. He enjoyed an exalted position during much of Nero's reign. Petronius passed judgment on the merits of any proposed national game, feast, enjoyment, or pleasure in any way, shape or form and his deci-

display of hors d'oeuvres. Later,

sion was final. Jealous rivals succeeded in having him falsely accused of plotting treason against Nero and he was condemned to death. He cheated the executioner by committing suicide in a slow and graceful manner. He opened up his veins and then applied bandages to check the flow of blood as he chatted with friends until death came. He is credited with being the author of a remarkable literary work, part of which describes a famous dinner. It was a detailed account of a sumptuous banquet provided

by "Trimalchio," a boastful, pretentious, and ignorant recipient of newly acquired wealth. The story tells of the invited guests to the domus of Trimalchio being met at the door by slaves who accompanied them to the bathhouse where they were offered precious vases containing water in order to wash their hands. They were then shown into the tricilinium (dining room) where they were directed to their places and reclined on a sofa before a magnificently arranged

waiters brought in a bronze donkey carrying two panniers (baskets) filled with large green and black olives. The donkey supported silver dishes which were engraved with the name of Trimalchio and also the weight of silver in each dish so that guests could estimate their value and the host's wealth. The dishes contained dormice (squirrel-like rodents) seasoned with honey and poppy seeds. The edible European variety is consumed when plump, just before hibernation. Next came hot sausages lying on a silver grill. Underneath the grill were black prunes with red pomegranate seeds to simulated a charcoal fire.

While musicians played, slaves entered bearing a great dish which contained a wooden hen hatching large eggs. One egg was passed to each of the guests who soon discovered that the shells were actually cooked flour and each contained a fat "baccafico" rolled in spiced egg yolk (a baccafico is a European songbird usually fattened on fruit and grain in autumn). At this time, one of the serving slaves dropped a silver platter and because it had a slight dent, the host had it thrown onto a rubbish heap.

Saint Francis Xavier Bianchi

Francis was born in 1743, in Arpino in the Lazio region of Italy. His mother taught him to care for the poor around them, giving him example by setting up a small clinic in the family home. He was educated at Naples and wanted to enter religious life, despite his father's opposition, the conflict with his father prompted a long illness, in striving to overcome his opposition. Francis persevered and entered the Congregation of Clerks Regular of St. Paul, or Barnabites.

Bianchi was admitted by the Barnabite Order into their novitiate in Zagarolo in 1762, professing religious vows as a member of the Order the following year. He was ordained a priest in 1767, and was immediately appointed the Superior of the College of Santa Maria in Cosmedin in Naples remaining in that office for 12 years

He was then assigned to the Barnabite monastery attached to the Church of Santa Maria di Caravaggio, Naples, where he was to spend the rest of his life. In 1778, he was appointed a professor at Regia University (now the University of Palermo), as well as a member of the Royal Academy of Science and Letters of the Pontifical Ecclesiastical Academy. Despite his academic honors, Bianchi became known for his deeply ascetic way of life and contemplative prayer life, and for his constant concern for the poor of the cities where he lived.

Bianchi became part of a circle of notable religious figures living in Naples in that era. His



life changed in 1800, when he fell into a state of religious ecstasy while praying before the exposed Blessed Sacrament on Pentecost. Shortly after this, he developed an illness which left his legs twisted and with open sores for the rest of his life. During the last three years of his life, he continued to preside daily at Mass, despite the agony of having to stand. Mostly bedridden, Bianchi also began to tremble and experience palpitations of his heart whenever he prayed, similar to that which had been experienced by St. Philip Neri two centuries earlier.

Bianchi was still living in the Barnabite monastery of Naples when it was closed in 1809, as part of the suppression of all monasteries and religious houses under the Napoleonic Kingdom of Naples. He passed away in 1815. He was canonized by Pope Pius XII on October 21, 1951. The Feast Day of Saint Francis Xavier Bianchi is on January 31st.



As a young child, San Rocco showed great devotion to God and the Blessed mother. At an early age, his parents died leaving him an orphan under the care of his uncle, the Duke of Montpelier. Soon after. San Rocco distributed his wealth among the poor and took a vow of poverty.

Live Racing Returns to Suffolk Downs this Weekend

Suffolk Downs will host the third scheduled live racing and food truck festival weekend of the summer this Saturday and Sunday, August 4-5. On Saturday, the average field size is 11 horses per race and 148 total horses have been entered for the day which features over \$500,000 in total purses and awards.

The \$100,000 Jill Jellison Memorial Dash will highlight the 13-race card on Saturday. Scheduled to be run at about five furlongs on the turf, the black type event has drawn a field of ten fillies and mares including D'Boldest, the winner of the 2017 edition of the race for trainer Jose Camejo. Regular rider Abel Lezcano has the mount on the eight-yearold daughter of D'Wildcat. In addition to the stakes race race, there are six other turf races carded for Saturday.

Over the course of the weekend, there will be two stakes races restricted to horses foaled in Massachusetts the \$50,000 Massachusetts Sire Stakes on Saturday and the \$50,000 George Brown Memorial Turf Mile on Sunday.

The track will also continue the \$5,000 Jockey Challenge for the third weekend. The jockeys will be awarded points based on the their finish position in a race with six points for finishing 1st, five points for 2nd, four points for 3rd, three points for 4th and two points for 5th. For any finish between 6th and last place, one point will be awarded. At the end of the weekend, the three jockeys that accumulate most points will be awarded a cash bonus of \$2,000 for 1^{st} , \$1,500 for 2^{nd} , \$1,000 for

3rd and \$500 for 4th. Dylan Davis took home the top prize in June and Pedro Monterrey, Jr. got top honors in July.

Post time for the 13 race card is at 12:55 pm. and gates open at 11:00 am. In addition to live racing, the track will be hosting a food truck festival featuring food trucks from numerous local vendors, craft beer, live music and family fun activities.

Live racing will continue on Sunday with 12 races.

Suffolk Downs has a request pending before the Massachusetts Gaming Commission to add another weekend of live racing to its 2018 schedule, September 15-16. It is expected the MGC will take up the request at its August meeting.

We can take a cue on how to celebrate August from the Italians, who honor the month with a plethora of feasts and proverbs that highlight the pleasures of this special time.

August in Italy contains several unique festivals that emphasize the communal spirit of summer. Many of these festivals are actually medieval tournaments and jousts, hearkening back to the days of old when Italy was a collection of city-states and such pageantry served as a means of displaying the power and might of one's city. At the Medieval Palio in Felire, Veneto, held on the first weekend of August, spectators can watch a parade of costumed locals and participate in an archery competition. Those who wish to witness an exciting joust can head to the La Quintana tournament at Ascoli Piceno, a city in Italy's Le Marche region, or the Giostra di Simone at the Tuscan town of Montisi, where "knights" representing the four neighborhoods of the village compete. When I spent an August in Italy eleven years ago, I saw a similar medieval parade at my father's hometown of Sulmona in Abruzzo. As I watched noblewomen float by wearing elaborate dresses of crushed velvet and stately knights in glistening chainmail, I felt as if I had been transported to the early days of my ancestors, when life was harsh and people clung to the bounty of

However, the most famous August holiday in Italy is Ferragosto, which occurs on August 15th the day of the Assumption of the Virgin Mary. Many Italians take the whole month off for Ferragosto, and visitors to the country will find the cities largely deserted as nearly everyone has flocked to the beach or mountains. Italians also reference a wide

array of proverbs relating to the weather or agricultural conditions of August. These bits of folklore are remnants of the past, dictums left over from the epoch when society was dependent on agriculture and people's survival depended on the quality of the harvest. However, these nuggets of wisdom still find a home among Italian farmers and folklorists who preserve them for generations to come. Many of these proverbs refer to specific crops, as August is a month of abundant harvest. One such saying intones: "Acqua d'agosto, olio, miele e mosto." Translated, this means that the rains of August prepare the important Italian staples of olive oil, honey, and must, or the juice of grape skins and seeds which comprises the first step of winemaking. Another proverb declares: "Agosto matura, Septembre vendemmia," referring to the fact that grapes ripen during August in order to be ready for the vendemmia, or grape harvest, the following month. Other maxims allude to the fact that August serves as the entry point for autumn and the colder period of the year. "Agosto annunzia il inverno" means that August announces winter. Meanwhile, the proverb "Alla Madonna di Agosto si rinfresca il bosco" roughly translates to the fact that after the Feast of the Assumption of the Virgin Mary (August 15th), the forest becomes chillier. These types of truisms are well known to my grandmother, who often admonishes that the first rain of August ushers in the winter. Of course, much of Italy remains very warm throughout August and into September and October, yet these aphorisms brim with the readiness and knowledge of a people aware that they must prepare their crops and livestock early in order to weather the difficult winter months.

So there you have it: a folkloristic compilation of feasts, holidays and proverbs relating to August. This cultural heritage can teach us a lot about how to enjoy this beautiful month. Let us revel in its warm weather and its sunflowers, in the last burst of summer before we step into our fall routines once again. Let us pay homage to harvest and prepare ourselves for whatever life has in store. These are the timeworn and much honored lessons of August, a month which even today bridges two seasons with abundance and a wealth

The day passed quickly, it was close to 4:00 pm, and I just sat there nursing my caffè latte grande with skim milk and a touch of whipped cream. Sitting next to me was my old friend Kenny Hall. I remember him from the days of Lorraine's coffee shop in the rear of Starbucks today. Kenny, like me, is a good talker and time flew by. I met a new friend named "Brady" (his first name most likely Tom but he wasn't talking too much). He was an English Bulldog or maybe a French Bulldog. It's hard to tell them apart but he was very friendly towards me, especially the more I patted him while his owner went inside to buy a caffé something.

As I said, it was a lazy day for me as are many of my days since retirement. People passing by say hi and I say hi to them, too. Lots of young mothers and dads were there pushing baby carriages. I remember when this spot was the U.S. Post Office back in the day before the Bunker Hill Mall popped up. Next door on my right was Wiley Funeral Home. My mother grew up with Danny Wiley and I was there for many wakes for family members. Today, everybody in that row house is alive and well but looking at the bay windows, I could imagine the caskets right there behind the curtains.

Next door to that was the First National supermarket at the corner where my dad often sent me to buy his cigarettes. Back then, he gave me a quarter and I got to keep the penny change. No one got carded. Across the Square was Tilkins Shoe Store where 7-Eleven is now. In the middle of the Square was Thompson Square Station up in the air

I have always believed that Charlestown will always survive as it always has. Generation after generation has called Charlestown its home because it is a special place with special people who care about their community like no other place.

Keeping Charlestown alive is in its motto; "A trust transmitted to its future." We all journey through life and those who take their journey in Charlestown take it seriously. We pass on to the next generation what was passed on to us. It's a culture thing and it comes with a fighting spirit.





Occupying Your Dog in the Summer time

As warmer weather and vacation approach, your thoughts have likely turned to filing this all too brief time with outdoor activities, day trips, and at least some rest and relaxation. A Nostalgic Remembrance



My last few stories have been about summertime activities. When I was a kid, the men on our block of Eutaw Street would plan a gathering at the house next door to ours, 76 Eutaw Street. I believe it was owned by a man named Mando Sinabaldi. He, Dad and Ralph Manfredonia, the landlord of our house at 74, sat down one night and planned a middle of the week shindig that would include the families that were close. Everyone would chip in and they would consider the cost of steaks, sausages, potato salad, corn on the cob, salad, desert, and beer and wine. If the head of each clan approved the cost per family, they preliminaries would begin. Let's see, there would be Mom and Dad, Mando Sinabladi, his wife Reenie, Ralph and Grace Manfredonia. Joe Balabona and his wife, Molly, Danny and Rose Gallo, Bert and Mary Marotta, Sal and Angie Romano, Libby and Ann Annise, Nanna and Babbononno, some of the Pedro family from across the street and all us kids. With the youngsters included, it brought the total to well over thirty people. This wasn't planned to be a block party, just the closest families on our block of Eutaw Street. If anyone is reading this that was part of that crowd and not mentioned, please forgive me and let me know who you are.

Most of us kids were ten or twelve years old around then and I've long since lost touch with all of them. My closest friends John Manfredonia and Bob Romano are long gone. I'm aware of where the rest of the Manfredonia family is, due to maintaining contact to some degree, with John's son. I have no idea what became of the rest of the children, but we were there for that back yard barbecue, and several others that took place in the warm weather.

Ceruolo would plan a cookout for our families. Zi'Antonio was Nanna's oldest brother and Babbononno's best friend. Usually. the cookout would take place in a central location, the picnic area at Mystic Lake. Many of the family still lived in East Boston and the North End, but the rest resided in Medford, Revere, and Saugus. Dad would reserve a barbecue pit and a picnic bench or two, as was necessary and the invitations would be sent out via phone calls or by visiting the families.

Now, American summertime cookouts are a tradition in the U.S., and we were traditional, but we did it Italian style. Dad was always the cook (I think he missed his calling. He was as good a cook as he was a musician.) He would figure out how many steaks, pounds of sausages, chunks of lamb and slabs of pork ribs were necessary to feed the number of relatives who had said yes to the invite. Each of the ladies were given lists of things they would have to make or buy that accompanied the meat, and the rest of the men would consider how much beer. wine and hard liquor would be necessary. Above and beyond this, the women of our extended family would cook. As an example, Nanna might make ravioli and gravy. Zi' Antonio's wife, my great aunt Zi'Mariuccia, would make cutlets and vegetables, Mom would bring the fixin's for a salad and an antipasto. Others would be assigned things to bring, like pastries, pots and pans and eating utensils. Of course, Zi'Antonio would have several gallons of his home made wine, both red and white. A cousin-in-law of my mother's, Al Beatrice, would be in charge of the hard stuff and the soda for the kids.

The anticipation would build up as the picnic day approached, with everyone praying to St. Anthony for good weather. Our side was usually well represented. Two out of three of Mom's brothers would be there, with their kids. Zi'Antonio and Zi' Mariuccia had nine children and only two or three would join us with their children. Nanna's sisters and their husbands would show up, but usually not with their adult children, just alone. I would await my two cousins, Anthony and Ralph Pepe. They were about my age, and although 2nd cousins, were my closest relatives at that time. As soon as they arrived with their parents, all thoughts of a picnic would leave us as Mystic Lake was a few yards away and there was a public beach. With Anthony and Ralph's older sister, Lulu, watching over us, we would head for the water and not come out until an adult would drag us back to a picnic bench because the food was ready.

While we were splashing at the water's edge, Dad and one or two of the adults would cook the meats that were supposed to be the main sources of food for the barbecue. Once the steaks, sausages, chunks of lamb and pork ribs were ready, the picnic tables were covered by red and white checkered oil cloth table cloths. Place settings were already situated for seated dining, and serving dishes filled with ravioli, gravy, salad, vegetables, cold cuts and cheeses lined the center of the tables. They often had to be moved to make room for the serving dish filled with sizzling meats just off the grill.

Even though this was a cookout, there were no hotdog or burger buns. The bread was Italian and it, too, was on the table within reach of the adult population.

The family would begin with the cheeses, cold cuts, marinated mushrooms, marinated artichoke hearts, olives, hot peppers and chunks of bread. Zi'Antonio would fill every-one's glass with wine to help wash down the food. The next course was the pasta, then the meats that Dad had cooked accompanied by vegetables, and later salad. We kids would wolf down our food as fast as we could and attempt to return to the lake. It was then we would hear the famous saying, "You kids can't go in the water for an hour after eating, or you'll get stomach cramps and drown just like your cousin." We would obey, but we never found out who this cousin was that drowned by not obeying his mother.

After everyone had eaten and downed the wine, beer and soda that was available, the men would decide to engage in a sports activity. Most traditional American picnics find the games of baseball or softball an entertaining follow up to eating and drinking, but we were Italian. Out would come the set of bocce balls, and an imaginary court would be outlined. Teams would be picked and the men, with gallons of wine would play bocce. Of course, the women would clean up. They were Italian, and that was their job. (Don't tell my wife I said that.)

Late in the afternoon, everyone, except us kids, would be tired and blankets might be spread out for relaxing in a horizontal position. For those not prone to an afternoon siesta, they would bring out the decks of cards. Italian cards games of Scopa, Briscola and Sette Belle would be played by the older men. If Dad or my uncles played cards, whist or hearts were their fancy or penny ante poker. The ladies would sit on the benches and gossip. We kids would anticipate the end of the hour following eating, so we could return to splashing in the waters of Mystic Lake.

When it was time to leave, everyone would pick up their belongings and say goodbye to one another. This would take an hour due to hugs and kisses that accompanied the exit salutations. We kids would be dried off and stuffed into the backseats of our father's cars. Within five minutes, we would be asleep. The same could be said of Babbononno and his generation. For them, it was too much wine. That's the way it was, and I loved every minute of those summers of old.



"This film has no acts. It doesn't do any of the things you're supposed to do. At the same time, I was able to make this film the way I wanted, with the cast I wanted, and nobody at any stage said, 'What are you doing? You must be out of your mind!"

If anyone did have doubts, however, it was the studio heads at Twentieth-Century-Fox, the initial studio backing the film.

"It was such an ambitious enterprise — a period film with a primarily European cast — and the studio, understandably, got cold feet," the director said. "Crisis is too calm a word to describe what happened. We were on our knees. I thought the film was over."

As it often did in its early days, Miramax stepped in with \$30 million to rescue the production while letting Minghella do it his way.

"It was a screenplay that took all my wit and resources to fashion," Minghella said. "I felt in a way very prosaic in what I was doing, making something so dry and desiccated from a book so rich. But ultimately a screenplay is not a piece of art, but an architectural map that says, 'Here's the building I'm going to make.'There were days when I thought, I must be out of my mind doing this film. But Saul has this fantastic ability to make you think you can do anything. He was so confident of what I could do, or he pretended he was, that I didn't feel I was being adjudicated every day. And so I did them."

The result paid off. *The English Patient* is a most beautiful work that inspired Miramax to assign more epic romances to Minghella and has become a modern classic.

But perhaps the best praise of all came from the author of the novel that first caught Minghella's eye, Sri Lankan native Michael Ondaatje.

"Somehow each version deepens the other," he said. "It's as if people I knew when I was writing a book at midnight, full of dreams, now appear in a new country in daylight and the wonder is ... that I recognize them so well and that I am once again enthralled by them. That was the gift I never expected."

Sonny Liston Vs Floyd Patterson What If There Had Been A Third Fight?

Sonny Liston and Floyd Patterson spent some time in the ring together, but not much. Their two fights combined lasted a total of only 4 minutes and 16 seconds with Liston winning by knock out in the first round on both occasions. The first fight took place in Chicago on September 25, 1962, and Sonny floored Floyd once, with that one knock down being for the ten count. Ten months later on July 22, 1963 in Las Vegas Liston dropped Patterson twice the with the second time being for the full count.

In the two fights, Patterson landed only one blow of any consequence, and that wasn't much. He grazed Liston with a right hand during the second fight. Other than that, it was all Sonny. It is interesting to note that while the fights were blowouts, Liston did not come out swinging wildly. He took Floyd apart methodically, setting his man up with left jabs and solid body shots. Sonny showed fast hands, using an accurate left jab, along with hooks and uppercuts. He had a definite game blame and executed it perfectly. If they fought a hundred times during that period, the result would have been the same.

Patterson won the crown that had been left vacant when Rocky Marciano retired. He fought Archie Moore as the two were considered the leading contenders, and it was agreed the winner would be named the new heavyweight champion. After winning the title Cus D'Amato, Floyd's manager, steered the new champ clear of any serious contenders. He had him fight second raters who appeared to pose no threat to Patterson. Fighters such as Roy Harris, Brian London, and Tom McNeeley. He even took on Olympic Champ Pete Rademacher who was making his pro debut the night of their title fight.

Floyd did run into one contender who proved himself to be underestimated; Ingemar Johansson. Johansson won the title by defeating Patterson by kayo in the third round. Floyd would come back a year later to become the first man to regain the heavyweight championship when he flattened Ingemar in the sixth round. The two would meet a third time with Patterson winning again.

From 1956 through 1961, the top contenders for the title were shut out from getting their deserved title shots. Men such as Cleveland Williams, Zora Folley, Eddie Machen, and Sonny Liston had to sit on the sidelines. It was not a good period for boxing, nor was it a good time for Patterson. It turns out that even though Floyd was making money and winning fights, he felt he was not proving himself as a man. In a high testosterone, profession such as boxing that can cause feelings of shame.

Floyd pushed D'Amato to make the match with Liston. Floyd had to prove to the world, and to himself, that he was a true champion. Unfortunately, the outcome of both fights only left

Patterson feeling more shame. The losses deeply embarrassed him. You think he might have given up boxing and taken up a more peaceful profession, but he soldiered on.

Free of D'Amato's protective hand he started fighting top contenders. He beat guys like Eddie Machen, George Chuvalo, and Charlie Powell. These wins put him in line for a shot at Muhammad Ali and the championship. Ali did not like Patterson and wanted to punish him. Floyd, unfortunately, went into the fight with a bad back and was limited in his movement. The one sided fight was stopped in the 12th round.

Once again, Floyd did not let this stop him and he continued fighting. It was at this point in his career that Patterson started to mature as a fighter. He would not lose a one sided fight again for the rest of his time in the ring. He kayoed Henry Cooper in two rounds, fought a draw with Jerry Quarry in a fight many believed Floyd had won. It was also thought he got a raw deal in a rematch when Jerry was given the decision over him. He beat Oscar Bonavena.

In a shot at Jimmy Ellis for the WBA Heavy-weight Championship Floyd was robbed of a decision after fifteen rounds. He broke Jimmy's nose in the first round and appeared to have captured at least a portion of the title for a third time. The sole judge, referee Harold Valan, thought differently

During these same years Sonny Liston was on the comeback trail as well. He was also seeking to prove himself after his two embarrassing and suspicious losses to Ali. And, while Patterson was growing as a fighter, Sonny was taking on mostly journeyman and starting to age. He was hardly leading a life of health and fitness. He got wrapped up in the Las Vegas nightlife and was hanging out with shady characters. Photos over the years depict the aging in his face. In 1969, he took on Leotis Martin, and in the early going was having the better of it. However, when Sonny came out for the 9th round he suddenly looked like an old man. It was apparent age and bad living had finally caught up with him. Martin flattened him in that round.

Sonny would have one more fight six months later when he stopped Chuck Wepner. Six months after that he was dead.

I have heard Floyd Patterson always wanted a third fight with Sonny Liston. He still wanted to prove himself and show he could take the Big Bear. If the two had fought a rematch in, say, 1969 or so what would have happened? Patterson was fit and clean living, Sonny was old and had slowed down. It can be argued Floyd was stronger at this point in his life, though he hadn't really grown much physically. However, he had grown a lot emotionally.

A case can be made that Floyd would have won a third matchup. After losing to Ali in 1965, Floyd had 16 more fights with only three losses. Two of those three losses were considered bad decisions that should have gone in Patterson's favor. He was not stopped again until his last fight, which was against Muhammad Ali, and that stoppage was because of a cut eye. In the rematch with Ali, Floyd was doing much better than in their first encounter. He was competitive and it was too bad his eye was cut. It was an interesting fight.

A third fight with Liston would also have proven to be very interesting, and I think Floyd could have pulled out the victory. Now, wouldn't that have been something?

HOOPS and HOCKEY in the HUB

I'M LOVIN' IT — Yes sir, those must be the words that Cleveland Cavaliers star Kevin Love is saying every day since he signed a four-year, \$120 million contract extension.

But before that starts on July 1, 2019, Love has to play out the final year of his current contract, the one that is paying him \$24.3 million right now. Oh, by the way, that's the one that works out to \$66,575 a day until June 30, 2019.

Then it is on to bigger and better things: such as \$28.9 million for the 2019-2020 season, \$31.3 million for both the 2020-2021, and 2021-2022 campaigns and \$28.8 million for 2022-2023.

It all averages out to \$82,191 per day over the four-year period.

"I'm super excited and I couldn't be happier," said Love concerning his extended financial blessings as he pledged his loyalty to the Cavs and the Greater Cleveland community. Well, wouldn't you be if you had an employer who was so generous. But it sounds to us that it's just the long way of saying "I'm lovin' it."

SABAN'S SAVORING IT — Unfortunately, big paydays are not confined to the professional ranks. They've also filtered down into the Division I college level for some of the football and men's basketball coaches.

For example, let's look at Nick Saban, the head football coach at the University of Alabama, who just signed a contract extension that will last through the 2025 season. That's eight years and is good for at least \$74 million or an average of \$9.25 million per year.

That means that Saban will be averaging some \$25,342 a day on a year round basis.

And remember, these are not the total expenses for coaching. There are also all those additional full-time salaries for the numerous assistant coaches.

Granted, Alabama has won the national championship five times in the last nine seasons, including last year. Still, doesn't it send dubious messages when someone is paid that amount of money to coach a supposedly "amateur" team? Think of how many additional scholarships could be underwritten with that amount of money or how many academic facilities could be upgraded or expanded.

Nowadays Saban is often mentioned in connection with Alabama's legendary football coach — Paul "Bear" Bryant. But the Bear had one trait that is lacking among today's coaches. You see, for all his success, Bryant always insisted that he be paid a little less than the president of the university. His reason was that no one running a program at the school should be paid more than the leader of the overall institution. Could you imagine any Division 1 football or basketball coach holding to those values today?

SWEET SIXTEEN — Yes, it really will be a great time when former Bruins stalwart Rick Middleton's number 16 is retired and raised to the rafters at the Garden on November 29th — just a few days before his 65th birthday on December 4th.

Middleton, a native of Toronto, was drafted by the New York Rangers in 1973, following a spectacular year in Canadian juniors, where he scored 67 goals in 62 games and amassed 70 assists for a total of 137 points.

But that proved to be his introduction to New England since the Rangers farm team at the time was the Providence Reds.

"I lived in Cranston, Rhode Island, when I was 19 years old and played against the Boston Braves (in the Garden). So, I got a taste of New England right away," said Middleton in a conference call.

Following that season in Providence, he played in New York for two years. He was traded to Boston in May of 1976 for Ken Hodge and never looked back.

So, less than three years after his time in Providence he was playing on Causeway Street — a location that he would call home for a dozen seasons.

"It was great to be able to stay here and play here for 12 years with such a great organization as the Bruins," stated Middleton, who has served as the president of the Bruins Alumni Association for the past 10 years.

And because of that, Rick Middleton may have come to a location near you over that span. Through playing games against local teams the Bruins alumni "help raise money for a lot of different charities and youth hockey across New England every year," he explained.

Maybe it was just a coincidence but the man who last had his Bruins number retired was the one who informed Middleton that he had been selected for the honor.

That would be Cam Neely, the president of the B's, who had his number 8 raised to the rafters back in 2004.

"He just caught me off guard with it," said Middleton of the phone call that signaled the capstone of his career. "I actually got emotional when he said it because it was a dream come true. I'm still in shock."

But he really should not have been. Middleton, a 5-11, 175 pound right winger in his playing days, scored 402 goals and assisted on 496 others while compiling 898 points in 881 games played for the B's from 1976 through 1988.

He ranks third all-time in goals scored for the B's, sixth in assists, plus fourth in total points. He is only one of five players to have a 50-goal season for the Bruins. He also had two 100-point seasons — in 1980-1981 when he went 44-59-103, and in 1983-1984 when put up 47-58-105 totals.

Middleton thanked several coaches who were instrumental in his career — including his youth hockey coach in Toronto, his junior league coach plus Emile Francis, the former coach and GM of the New York Rangers. "He gave me my first chance," said Middleton.

He noted that Don Cherry "saw something in my game and helped me realize what the complete NHL game was."

He also put in a good word for Gerry Cheevers. "He gave me all the ice time in the world. I never would have been able to put up the numbers I did without that."

And he has a high regard for Terry O'Reilly. "He always showed me what it took to be a Bruin and the guts you have to bring to the game every night."

It was, all in all, a most satisfying career. "Hockey was fun for me growing up. I never remember any bad moments from the game and I don't think a lot of people can say that," he noted in conclusion.
