# One year short of its centennial, the 99th annual St. Anthony's Feast brought thousands of devotees to Boston's North End on the last weekend in August. The gold-adorned statue of San Antonio emerged to the faithful under the glory of confetti and streamers. A blessing by Fr. Antonio of St. Leonard Church was followed by a short procession before the statue

was placed in its feast chapel for the weekend festivities. During the opening nights of the feast, several bands marched through the streets while friends and families gathered for the annual celebration.

On Sunday, a ten hour Grand Procession brought the statue of San Antonio to nearly every street in the neighborhood. It all started on Endicott Street at noon when multiple bands paraded through the feast and the statue emerged to streams of confetti high in the air. During the day, society members took turns carrying the saint and collecting charitable ribbon donations. As day turned into night, the statue made several notable stops including Caffe Paradiso and of course, Pizzeria Regina. At the end of the night, a grand finale with confetti raining down ends the Saint Anthony's Feast. The "Feast of all Feasts," as described by National Geographic, is organized by San Antonio di Padova da Montefalcione, Inc., also known as the St. Anthony's Club.



#### **SPIT ON IT**



Just about every old-timer I have ever met had a special cure for any ailment under the sun. The amazing thing is that many of their cures worked. I had read an interesting article in one of the Boston papers regarding the healing qualities of saliva. Through another series of coincidences, I came upon a listing of old-time cures and superstitions, so I thought I might share my good fortune.

When we come upon a dead animal in the street or in a field, we spit upon it and say, "Don't pass my family." We ward off witchcraft by spitting on the

person or things that suggests it to us. If we should happen to be too presumptuous in some of our hopes or desires, we can tone ourselves down by spitting into our bosoms. The best way to insure the success of a new remedy is to first spit upon the ground three times. Doctors will be very happy to learn that the best way to get rid of a new boil is to rub it with spit three times.

If you punch another person on the nose, you can lessen his pain and resentment by spitting in the palm of your own hand. Chopping wood or digging a ditch is made easier by first

spiting on the hands. Sores or skin eruptions are kept in check by a continual application of spit. Fast relief for a pain in the neck is obtained by applying saliva with the right hand to the right knee and then with the left hand to the left knee.



Upgrade Book Sale Procedure



About a year ago, the Friends of the North End Library improved their daily book sale at the library by adding more book shelves, sorting the books for sale, and maintaining the sale area in a pleasant and orderly manner. The results were an immediate increase in sales. The sales have helped the Friends donate funds to the North End Library to buy furniture and other needed items and to sponsor library programs.

The prices of the books are still a bargain. Paperbacks are \$1.00 each and five paperbacks are \$4.00. Hardcover books are \$2.00 each and three hardcover books are \$5.00.

The book sales are so successful that we needed to upgrade our payment system. Instead of taking the time of going to the desk to pay for your books, you can now pay for your books by placing your money, or a check, in the small red cash box hanging near the books for sale. # Saint Agnes Tsao Kou Ying

Agnes Tsao Kou Ying was martyred for preaching the Gospel to the Chinese in Guangxi. Like most other Chinese Martyrs, she was a layperson, not a member of the clergy. Agnes Tsao Kou Ying was born in the small village of Wujiazhai in Guizhou Province in 1821. Her family was a traditional Catholic family originally from Sichuan Province

Agnes left her hometown to work in the city of Xingyi after her parents passed away. There she met a Catholic woman who let her live with her. Soon, Bishop Bai came to visit Xingyi and found out that she was without family so he took her to the local parish to learn more about Christianity. The bishop found Agnes to be clever and a quick learner.

Agnes at eighteen married a local farmer, but because she was a Christian, she was treated as an outsider by her brother and sister-in-law who did not consider her a part of the family. Things became worse for Agnes when her husband died after two years and



she was driven out of the house. In order to support herself, she took odd jobs. A Catholic widow invited Agnes to stay with her. Whenever a priest visited them the widow received the Sacrament of Reconciliation and the Eucharist. Her example enabled Agnes to cultivate her own spirituality.

Fr. Ma, a missionary, discovered how well Agnes knew the faith and asked her to do some missionary work. In 1852, she went out to the town of Baijiazhai in Xilan County and

made it her preaching headquarters, teaching the Catholic faith throughout Guangxi. She also taught cooking and household management, and in her spare time helped babysit.

In 1856, when she was helping out in Yaoshan, Guangxi the local government decided to take some measures against the Christians living in that area. Agnes was taken into custody along with many other Catholics who were soon released; only Agnes and Father Ma remained in prison. Father Ma later died in prison. The county magistrate tried to persuade Agnes to deny her faith under the promise that if she did, she would be released. However, Agnes refused. He then had her locked in a cage so small that she could only stand, but her spirit never failed. She prayed repeatedly, "God, have mercy on me; Jesus save me!" She died

Agnes was Canonized on October 1, 2000, by Pope John Paul 1I. The Feast Day of Saint Agnes Tsao Kou Ying is celebrated on March 1st.

#### **CHRISTOPHER COLUMBUS PART 2**

#### CHRISTOFORO COLOMBO

Setting the Record Straight

There have been claims that Columbus was French, Jewish, Basque, Catralonian, etc. ... A local reporter stated on Columbus Day that "Columbus didn't discover America — Lief Ericson did — Columbus never set foot in the United States."

Webster's Dictionary defines "discover" as "to make known or visible." If Lief Ericson visited North America, we aren't even sure where he landed. Some historians say it was Newfoundland. In any case, there is no absolute proof he landed in the United States. The bottom line is that neither Columbus nor Ericson ever visited the United States. On the other hand, Columbus made it known that the New World existed. His discovery led to a lasting relationship between the Old World and the New. Columbus is honored for discovering America, not the United States. Those who may have come to America before Columbus never impinge their deeds upon the consciousness of the known world.

Columbus' own statement, in his will, states conclusively that his origin and birth place were in Genoa. His original Roman family name was "Colonus," which he abbreviated while he was in Spain to "Colon." His numerous references to Genoa in his will leave little doubt as to his birth place. Notorial records and statements of Genoa make reference to and recite many deeds, acknowledgments, and transactions made by his family. In an April 2, 1502 letter to the Bank of San Georgio in Genoa, he made the city of Genoa the beneficiary of one tenth of his revenues from the industry.

Columbus had no depth charts, no navigational charts, no means of speed measurement, and no clocks. He was able to accomplish what no other man was able to do. Columbus never lost a ship at sea while sailing. No one has been able to cross the Atlantic with a sail boat in the record time it took him 484 years ago. Columbus' discovery closed the door of the Middle Ages and changed the history of the world. According to author John Stewart Collis, "To equate Columbus and Ericson as supposed rival heroes in the imagination of mankind may serve in a thesis, but it remains claptrap."

Christopher Columbus was conscious to the end. Just before he died, he joined in the prayers for the dying, repeating with his last breath, "Into your hands, O Lord, I command my Spirit." Columbus is buried in a vault in the Cathedral of Santa Maria la Menor in Santo Domingo, in the Dominican

In 1979, Prof./Cav. Philip J. DiNovo gave birth to the idea of a Italian American Cultural Organization. He invited eight Italian American professors to a meeting at the Law School, Syracuse University, Syracuse, NY. Those attending agreed to organize the American Italian Heritage Association to record and preserve Italian heritage.

High school students and other donors 18 years of age and younger must requirements.

# L'Anno Bello: A Year in Italian Folklore

The Rhythms of September

Lately, I have been paying special attention to the trees in my backyard. If I look at the leaves closely enough, I can detect the slightly perceptible hues of fall — crisp reds and golden yellows tickling the borders of still-green fronds. The other day, a small breeze lifted a few orange leaves and blew them gently to the ground as they swirled around like tops. These sights, both the delicate colors and the falling of the leaves, are reminders that autumn is here, the season of cooler weather and harvest and the rhythms of nature. The month of September starts this wonderful season, bringing with it the smell of juicy apples and the purring motors of big yellow school buses. The beginning of September is always a very busy time for me, as it coincides with the commencement of the school year and all of the preparations that that entails. Nevertheless, when I stop to pause and really think about September, I feel a rise of excitement bubbling inside me. This is a month chock full of rustic holidays and old-country proverbs that highlight September's prominence as a seasonal turning point.

The first September holiday to occur in America is Labor Day, falling on September 3rd this year. A festival honoring the contributions of working people, Labor Day also signifies the unofficial end of summer, as many schools return to their sessions after this long weekend. As such, Labor Day is often celebrated with a picnic or barbecue, and this year I will add to the food tradition by baking a sparkling apple cider pound cake to honor the asonal flavors of this month. Over in Italy, September heralds farmers to pay attention to the a flurry of feasts and activities weather and the crops in order

season in the winter. It begins in a regal fashion, with Venice's Regatta Storica occurring on the first Sunday of the month. In this renowned boat race, a parade of elegant gondolas introduces an intense competition where skilled rowers in various different categories vie for first place. This event has a royal pedigree, as it is modeled after the welcome procession given to the queen of Cyprus, Caterina Cornaro, when she returned to Venice in 1489. Later in the month, the people in Naples celebrate the feast day of Saint Gennaro on September 19th, when spectators wait to see the mysterious liquefaction of the saint's blood, and then hold an eight-day party as stalls selling trinkets and candy line the streets. This holiday has become so popular that many Italian-American communities hold their own Festa di San Gennaro. As autumn intensifies, the fall equinox arrives on the 22nd of the month, after which the balance between daylight and night tips towards the edge of darkness. Finally, the Feast of St. Michael the Archangel, or San Michele l'Arcangelo, closes out the month on September 29th. Also known as Michaelmas, this ancient feast features the autumnal themes of balance the scales of St. Michael echo the equal hours of day and night during the equinox - and harvest, as ingredients like carrots and ginger are traditional on this day.

For our Italian ancestors of yore, September meant collecting the harvest, enjoying the bounty of the Earth, and preparing food for the winter. In this deeply agricultural society, proverbs reminded that will last until the holiday to ensure a successful harvest.

Rain in September proved a mixed blessing. One proverb bluntly states that "La pioggia di settembre è veleno per l'uva," meaning that September rain is like poison for grapes. However, another proverb happily declares "A settembre pioggia e luna, è dei funghi la fortuna," advising farmers that rain and moonlight made favorable conditions for collecting mushrooms, such as the delectable Italian truffles. Other dictums reflect the changing weather of the month, as summer turns to autumn. A delightful little ditty proclaims: "Aria settembrina fresco la sera e fresco la mattina." According to this proverb, September air is cool during both the evenings and the mornings. This axiom reminds me of the autumnal mist I often see rising above fields like lace on crisp mornings, or dark evenings huddled under a blanket and drinking a cup of apple cider. Italian truisms even mention the autumn equinox. "Di Settembre la notte col dì contende" roughly translates that night competes with day during September, a reminder of the long winter evenings to come.

From holidays to proverbs, September is a month brimming with great significance as a seasonal milestone. Whether you enjoy the changing foliage or admire the taste of a fresh apple, be sure to pause and be grateful for all that the autumn has to offer. For it is autumn that teaches us humility before the gifts of the Earth and an appreciation for the cycle of the year. So no matter how you desire to honor September, let's toast to a month full of bountiful blessings and new beginnings!

#### City Evicts Homeless from Storage Bins, Case Solved?

Recently, a news item in a local newspaper pointed out how the city of Boston evicted a number of homeless people who showed some initiative about their plight living on the streets of our city. It seems a number of these folks were renting storage bins on Massachusetts Avenue not far from 1010 Mass. Ave., once the home of Mr. Boston, now the home of Boston Inspectional Services. Some moved their belongings: couches, tables, chairs, lamps and electrical cords. The only thing they didn't have was a bathroom or windows.

On Tuesday, August 14th, Inspectional Services police, firefighters, and health department workers went to CubeSmart Self Storage and shut the place down, cleaning out the cubes and evicting the homeless back into the streets. Let's see, these folks were smart enough to rent a cube for \$230 per month, had a place to crash and feel safe and now they are back on the streets of Boston. Is this what you call an improvement for

If you have cash, you could go over to Southie and rent a cube studio apartment at the Seaport District for only \$2,100 per month. I'd say the homeless are pretty smart.

The fact that some folks were

forced to rent a storage cube to stay safe tells all that we have a housing crisis since rents only go higher. I can see why the city had no alternative but to end this housing situation, but the bottom line is that people who found shelter no longer have access to it.

A long-time friend of mine from my Quincy days is Joe Finn, executive director of The Massachusetts Housing & Shelter Alliance and former Quincy City Councilor. In talking about folks living in storage facilities he stated, "That just indicates the desperate nature of housing here in Boston."

People living in desperation will try to find housing alternatives wherever they can. Many folks in our shelters actually are working, but don't earn nearly enough to have an apartment with rents so out of reach.

We, as a society, need to be working overtime to deal with this housing crisis. We can't have folks thinking that living in a storage bin is necessary. Politicians talk up a storm but actions speak louder than words. So far, in this housing crisis, we have had far too many words hurled at the issue and far too little action toward making things better for those unable to find affordable housing.



What to do if You Find a Stray Dog



As a child, I always hoped I'd find a dog. My thought was that he would be mine. I never stopped to consider the original owner's or the dog's feelings. If you find a stray dog, your first thought should be to find his owner as quickly as possible.

**Use Caution:** First approach all stray dogs cautiously. It's best to coax the dog to you. A fearful or concerned dog may bite if you approach him. If you can't collect the dog yourself, call your local dog warden (they may be connected with your police department or a local animal shelter).

Look for Identification: If you can approach the dog easily, check to see if he has any ID tags. Finding the owner may be as easy as calling the phone number on the tag. If he only has a rabies vaccine tag, call your veterinarian to see if she or he can use it to trace the owner. Describe the dog and ask her or him to contact you if they get any calls. If the dog doesn't have ID tags, have him scanned for a microchip either at the vet or a local animal shelter.

Survey Your Neighborhood: Have you ever seen this during your own walks around the neighborhood? You might remember seeing the dog in someone's yard. Ask your neighbors if they know of anyone who's lost a dog. Children are especially good resources because they tend to spend the most time outside.

Contact a Shelter: You can, of course, just take the dog to your local shelter. But if you have the time and the resources, there are some other steps you can take first. You can opt to keep the dog in your home until the owner is found, but you should still call a local shelter. Give them a descrip-

tion of the dog and your phone number so they can call you if they hear from someone who's look for a dog of the same description.

Advertise: You can spread the word about a lost dog in the newspaper, on social media, or with posters. When you describe him in these pots, leave a detail out that only the owner would know to prevent someone else from claiming the dog. For example, you can mention that the dog is wearing a collar, but don't mention its color. Vaguely describe the dog's color so that you can ask about something specific, like the color of his or her ears.

**Newspaper Ad:** Generally, there is no charge for lost-and-found newspaper ads. Read through the other lost-and found ads to see if the owner has posted an ad about her or his lost dog.

**Social Media:** Let people know that you've found a dog with these popular platforms so others can share your post. Again, when describing the dog on social media, omit a distinguishing factor so you can identify the true owner.

**Posters:** You can also hang posters in your neighborhood with a description and your contact information. If you want to put a photo on the poster rather than writing a physical description of the dog, use a black-and-white photo. If you're using a written description, remember to be vague. Don't mention the specific breed: use "small terrier" instead of "West Highland White Terrier."

If no one claims the dog after two or three weeks, you can either take him to the shelter or welcome him into your family.



# Create a Healthy Foundation for Fall Plantings

Fall is a great time to start a garden or renovate an existing planting bed. The soil is warm while the air is cool – a perfect combination for establishing new plantings. It is also a great time to prepare gardens for the next planting season. Investing time up front to create a healthy foundation for your plants will pay off with years of beautiful, healthy and productive gardens.

When you read plant tags and seed packets you'll find that the majority of plants prefer moist well - drained soil. Unfortunately, most gardeners aren't growing in plant - friendly soils. Heavy clay, sandy and droughty soils are much more common. Understanding what you have is the best place to start when creating a healthy soil foundation for new and existing gardens.

Start with a soil test. Contact the local office of your Extension Service or state certified soil testing lab for details. They can direct you on how to take a soil test and where to send the sample. The test results will tell you how much, if any, fertilizer, lime, or sulfur is needed. Following soil test recommendations can save you money spent on and time applying unnecessary soil additives. Plus, following the results will increase your gardening success.

While waiting for the results you can do a bit of analysis yourself. Soils are made of clay, sand, and silt particles. The feel and cohesive nature of this sample will tell you a bit about your soil. Take a handful of soil and create a ribbon by rubbing it through your thumb and index finger to get a feel for your soil type.

If the soil easily forms a ball or rolls into a sausage shape, feels slippery when wet and smoother when dry, you have a high percent of clay in your soil. Soils with a high percent of the very small clay particles are often called heavy soils. They stay wet longer and hold onto soil nutrients. Clay soils are slow to dry out and warm up in the spring. Avoid working them when wet. This leads to compaction and clods you will be contending with all season long.

Soils with a larger percent of sand particles don't form a ball when moist and feel gritty to the touch. The much larger sand particles create bigger pores in the soil for water and nutrients to move through quickly. They tend to be nutrient deficient, fast draining and dry. But they warm up and dry quickly in the spring.

Silt feels smooth like flour when dry and soapy slick when wet. They are the middle - sized particles that hold water and nutrients longer than sand, but not as much as clay particles. Silty soils drain slower and stay colder longer than sandy soils in the spring. Overworking soils with a high percent of silt leads to crusting and compaction, decreasing drainage and water infiltration.

Consult your soil test report when preparing your new garden beds. Prior to planting is the easiest time to add organic matter to any of these soil types. It increases the water-holding ability, the infiltration rate so less water runs off the soil surface and builds plant-friendly soil structure. Incorporate several inches of compost, aged manure or other organic matter into the top eight to twelve inches of soil.

Further improve your soil by using a slow release fertilizer with a high percent of organic matter like Milorganite (milorganite.com). The 85% organic matter feeds the soil microorganisms and your plants as it improves all soil types. You get multiple benefits with this type of fertilizer.

So, as you plan your new landscape additions this fall, include testing and amending the existing soil into your plans. Understanding your soil can help you create a strong foundation important to the health, longevity and beauty of your gardens and landscapes.

A Nostalgic Remembrance



Here it is another Labor Day weekend. This means that school vacations are over and family trips and gatherings are just memories of warm days past. We did the same things during the summers that followed WWII, but, as the decade came to an end, Dad began to book in playing with the bands that catered to those county fairs that were so common throughout the northeast.

Labor Day weekend of 1950 was approaching, and Dad was booked to play at the Schaghticoke Fair in upstate New York. (pronounced skaatee-coke) When he saw the itinerary, he told Babbononno that Johnny Laddie and his dog act would be playing there, and if he, Babbononno, and Nanna wanted to come with us, they could hang out with the Laddie family who came from nearby towns in Avellino. Everything was packed by that Friday morning and we headed west on Route 2 toward New York.

Several hours later, Dad checked in at the central office of the fairgrounds, and from there, we headed for a local guesthouse that was booked for us in advance. That night, there was a gathering of all of the entertainers, musicians, stagehands, etc. ... in the tents that were set up right behind the stage. Dad and the band went over the music each act was to use, and when the Laddies were finished, they hurried over to Nanna and Babbononno to renew a friendship that had been formed at another fairground the summer before.

These tents were set up one as a commissary and the other with dressing rooms. The commissary had stoves to cook on, food lockers to house anything the entertainers might want to eat and tables and chairs to create a restaurant atmosphere. The commissary tent was the

me to the headman of the carnival concession. He told me to report to their novelty salesman the next morning and I could work as his helper for the entire Labor Day weekend. The next morning, following directions, I found the man behind a kiosk filled with kewpie dolls, stuffed animals, junk jewelry, balloons, and many other pieces that could be purchased and passed off as prizes that had been won at games of chance located somewhere on the fairgrounds. The man in charge introduced himself as Norman and he gave me instructions as to how to sell his merchandise.

That afternoon, Dad and the band played Dixieland favorites between sulky races, and that night, they backed every act that was booked to play the fair. Mom, Nanna, and Babbononno hung out with the Laddie family in the commissary tent and I sold junk to the people who were unlucky at the fair's games of chance.

There was a concession near the novelty kiosk. People pitched nickels into cups, dishes, and glasses that filled the large display area. If their nickel stayed in its target, the person won the article. If the nickel slid off and landed on the display table, they lost. A waist high fence separated the players from their targets, and for the three days of the event, hundreds, if not thousands, of people tossed their nickels trying to win tableware.

This was not a rich area of New York, on the contrary, it was farm country, but many of the folks who attended the fair saved their money all year for this annual event and some spent their dollars liberally.

At around six o'clock, Mom and Dad showed up, Dad to see the operation and Mom to bring me my dinner. When they left, Norman turned to me and said, "Hey kid, you Arabs really take care of each other." From that point on, I kind of knew where the man was coming from. When he left because nature called, one of the young men from the nickel pitching concession came over to me, and asked me if I spoke Greek. I said, "No I am Italian." The youngster said, "We are Greeks, that's close enough.

Be careful of that guy you're working for, he is a drunk and sometimes disappears. Make sure you get paid each night." I thanked him for the information, just as the man, Norman, returned. That night, he decided to close up at 10:30, twelve and a half hours of work on my end. As we were ready to leave, Norman told me that he would pay me the next day, Sunday.

I arrived at 10:00 am on that Sunday morning and waited for two hours before Norman showed up, and when he arrived, he was definitely hung over. We, or should I say, I, worked all that day and night. At quitting time, Norman handed me a twentydollar bill and told me that it was all I was worth for the two days, and to make sure I showed up all the earlier the next day, Labor Day. I was upset and felt that I had been cheated, but showed up at 10:00 am on the next morning and waited three hours for Norman to show up. When he did, he was hung over again, and for the rest of the day, I did most of the work. When I had to use the bathroom, he made me empty my pockets before I left. He didn't have a cash register, and all moneys that came in went into pocketed aprons that both of us wore. I emptied out the pockets, gave him the money, and returned to work within five minutes.

At the end of that Labor Day, the young Greek came over to me stating that he and his brothers had made \$8,000 in nickels just for that day. I congratulated him and kept on with my final chores of packing up. I gave Norman the money in my apron pockets and said goodbye. He gave me a \$10 dollar bill for the day and I left. Later, when I was in the commissary tent with Babbononno and Dad, Dad asked me how I did. I explained the entire weekend and Dad was upset enough to head out and take matters into his own hands. I told him not to bother, as when the pockets of my apron became filled with cash, I had to use the pockets in my pants, but forgot to give Norman what was in them before I left. Dad reminded me that stealing was a sin, but Nanna overhearing the whole conversation said and I translate, "Stealing is a sin, but sometimes it is justified. Leave him alone." Dad nodded, mumbled something under his breath, and headed to the coffee urn to pour himself a cup. Nanna told me to count my money to see if it covered the time I put in as a novelty salesman. When I said, "No," to both, he gave me five Our Fathers and five Hail Marys to say, blessed me and sent me off to

#### ALMOND-FLAVORED BUTTER COOKIES

3 eggs

½ cup sugar 2 sticks softened butter(½ lb)

3 cups flour

 $1\frac{1}{2}$  cups flour - separate 2 teaspoons baking powder Cookie cutters of choice

\*1 teaspoon almond flavoring (optional)

ICING:

1/3 cup melted butter 1 box Confectioners sugar

"Jimmies" (sweet toppings)

or nonpareils

\*1/2 teaspoon almond flavoring



In a bowl, cream sugar and softened butter. Add beaten eggs and mix thoroughly. Measure out three cups flour and place in a separate bowl. Add baking powder to flour and stir. Gradually add this to the sugar, butter and egg batter. This will become soft dough. Spray two cookie sheets with vegetable or butter spray and set aside.

Spread some flour on a pastry board. Spoon a portion of pastry dough onto floured pastry board. Sprinkle some flour over dough. With your hand or rolling pin spread dough out to about 1/4 inch thickness. Before cutting each cookie, dip cookie cutter into flour. Then place cut out cookie onto greased baking sheet. Continue until all dough has been used. Bake in preheated 350°F oven. Baking time is about ten minutes. Bottoms will brown slightly. Remove from oven and place baked cookies on a tray to cool. Makes about four dozen.

ICING: Melt butter in top pot of a double boiler. Add almond flavoring. Gradually add confectioner's sugar to mixture until you have soft icing. Using a pastry brush, spread icing on one cookie at a time. Immediately sprinkle your choice of "Jimmies" or nonpareils over the icing. Set cookie aside on a tray. Continue icing in this manner.

#### Goodbye, Mr. Chips





Often overlooked in the canon of classic literature is James Hilton's 1934 short novel *Goodbye*, Mr. Chips, which spanned the life of a boarding schoolmaster during the latter half of the  $19^{th}$  century and the first decade and a half of the  $20^{th}$  century.

It was popular enough, however, to spur two film adaptations, the first one being the best remembered. Like many British films from the 1930s, *Goodbye, Mr. Chips* was a trans-Atlantic production with *MGM*'s British division overseeing the shoot.

The production caused great excitement in Derbyshire when filming began on location at Repton School, a preparatory school for boys.

The film was a significant milestone in the career of rising star Robert Donat in the title role, winning him a Best Actor Award. But the greatest work is seen in the make-up department when Donat aged 63 years (covering the film's time frame of 1870-1933).

Donat would later recall, "As soon as I put the moustache on, I felt the part, even if I did look like a great Airedale coming out of a puddle."

Likewise, the film was an early success for lead actress Greer Garson who was first offered a part in 1937 along with a contract, which she withheld accepting until being cast in the lead. She was nominated for Best Actress and, though she lost to Vivien Leigh for *Gone with the Wind*, saw her way paved for *Mrs. Miniver*.

The film was a financial success and was nominated for awards in all the major categories including Best Picture (then called Outstanding Production), Best Director for Sam Wood, and Best Screenplay. It lost all of them to *Gone with the Wind* but, 1939 was a hard year anyway, a fact made obvious by a casual glance at the competition (*The Wizard of Oz, Of Mice and Men*, and *Dark Victory*).

But *Goodbye*, *Mr. Chips* remains a charmer and among the best performances of the two leads.






#### **MAX SCHMELING**

#### Germany's Greatest Fighter as also an All-Time Great Heavyweight

This September 28th would have been Max Schmeling's 113th birthday. The former heavyweight champion passed away in 2005 just 7 months short of his 100th birthday.

Schmeling began his boxing career in 1924 in Germany. He fought exclusively in Germany until 1928 when he traveled to the United States in search of a shot at the title. He brought with him a record of 38 wins, 4 losses, and 2 draws. Of his 38 wins, 30 came via knockout.

Max's arrival in the States was greeted with great fanfare. Much was made of his resemblance to Jack Dempsey and the two were seen together quite often. At this time boxing was in a bit of a slump. Gene Tunney had taken the title from Dempsey and retired after a rematch with Jack and a defense against Tom Heeney. The search was on for a matchup that would decide who the next champion would be.

His next fight would be a brutal affair. Jack Dempsey had now ventured into the fight promoting business and for his first big event he matched up Schmeling with Max Baer. Baer was making quite a name for himself at this point in his career and

looking to add another former title holder to his record. Max had other ideas. He said that he saw a fatal flaw in Joe's style and would exploit it for the win. The two met on June 19, 1936.

In one of the great upsets in boxing history, Schmeling dropped Louis in the 4<sup>th</sup> round and put him down for the count in the 12th. It was a stellar performance by Max who utilized his powerful right hand as a counter over Louis's jab. Watching this fight you see a Schmeling who shows no fear and sticks to his plan. He is methodical and lethal. He fought out of a crouch and lean a bit to Louis's left where he would be in Joe's blind spot just outside the jab. From here he would throw right hand counters with deadly precision.

The two would meet again in 1938, when Louis was champ and the outcome would be much different. I have written about that fight in an earlier column.

Max Schmeling would not have many fights after his second bout with Louis. WWII would devour Europe and leave

Germany in a shambles. Max would go broke but would show his acumen as a businessman becoming president of Coca Cola in Germany. He led a full and prosperous life and showed no signs of damage from his years in the ring.

Max Schmeling's name is not often mentioned when the greatest heavy-weights of all time are discussed, but it should be. He was one of the hardest right hand punchers who ever donned a pair of boxing gloves, and more importantly, he was brilliant at setting up that right hand. He would have

HOOPS and HOCKEY in the HUB

It was the official announcement that the Boston Bruins Foundation has entered into a new partnership with Special Olympics Massachusetts. The partnership comes as Special Olympics kicks off its 50th anniversary year with the B's donating a total of \$1 million to the organization over the course of the next three seasons. The donation is the largest the franchise has made to any single charity since the Foundation was established back in 2003.

The Foundation has raised \$30 million over that 15-year span with some \$3 million being distributed to over 150 charities within the past year.

For those visiting the Garden this season there will be a display featuring Special Olympics Massachusetts near the Garden Pro Shop. In addition, Special Olympics athletes will be involved in a number of activities when the Bruins host Ottawa in the home opener of the 2018-2019 season on October 8 at the Garden.

The athletes will take an active role in a number of experiences during the evening — serving as bench assistants as well as partaking in high five lines and ice resurfacing rides. Athletes will also be featured in additional games throughout the season.

A CLASSIC CONTEST--Irish eyes may or may not be smiling depending on the weather conditions but come New Year's Day the Boston Bruins and the Chicago Blackhawks definitely will be playing as they take to the ice for the 2019 NHL Winter Classic

The venue will be one of the most storied locations in all of American sports — Notre Dame Stadium — located directly on the campus of the famous Indiana institution.

It will be different, of course, since this will be an NHL regular season game played on a temporary ice sheet that will be spread across a portion of the historic field.

In the stands, there will also be a different audience since the Notre Dame students will be home on Christmas-New Year's break and the usual alumni crowd will also be dispersed — either across the Midwest or flocking to a southern location should the Irish football team be fortunate enough to secure a bid to a big-time bowl.

That leaves a great big stadium for the two Original Six franchises to fill — a facility that seats approximately 80,000 people. It opened in 1930, just six years after the Bruins played their first game.

Having been out that way a number of times while driving to and from Wisconsin, we can tell you that South Bend, Indiana is considered to be an outer suburb of Chicago — even though it is approximately 90 miles from the Windy City.

Thus, although it will be a neutral site game, in reality, it most likely will be a Blackhawk friendly crowd that files in for what has become an annual tradition in the NHL.

To get in gear (and we mean that literally) the Bruins and Blackhawks recently revealed the throwback sweaters they will be wearing as they take the ice on the first day of 2019. The B's will be sporting a version of their logo that was worn by players from 1934 to 1950. The design is a brown-colored block B with a yellow outline. Chicago players will skate wearing the team's black and white logo that was used from 1926 until 1935. It features a circular design with the name Black Hawks (two words back then) around the upper half of the crest.

Fans from this area wanting to attend should realize that the game will be played in a facility built for football, not hockey. That means that the closest seats may actually equate to the farthest seats from the action in the TD Garden. Plus, those seated in very low levels near the field may have their view compromised because of the height of the boards. You can avoid that by buying tickets for seats higher up (and thus further away) but then the view of the action becomes smaller. You might wind up watching most of the game on the Jumbotron.

As always bring binoculars and dress warmly since you will not have access to an indoor area unless you are fortunate enough to have a ticket for a luxury box.

FROM THE BIG STAGE TO THE SMALLEST — This may well be a record of sorts, at least in the modern era. When the Buffalo Sabres take on the Columbus Blue Jackets in an NHL preseason game on September 25 there won't be too many people on hand.

That is guaranteed. Why?

Because the game will be played at Clinton Arena in Clinton, N.Y. (near Utica), a facility that seats only about 2,000 fans and can accommodate only about 300 more utilizing standing room.

The teams will play before their smallest crowd of the 2018-2019 campaign as a result of the village of Clinton being declared the winner of this year's Hockeyville USA contest this past spring.

Smaller communities across America enter by submitting a package that includes an essay plus photos and videos indicating their area's passion and pride for the game of hockey. The winning town receives funding to upgrade its hockey facility (62-year-old Clinton Arena in this case) plus the opportunity to host an NHL preseason game.

In addition to the small town and the small crowd, the rink will also be small. It measures 190 feet by 86.5 feet with a 14-foot corner radius. An official NHL surface is 200 feet by 85 feet with a 17-foot corner radius.

A new refrigeration system was already being installed when word was received in April that Clinton had won the contest. Higher glass partitions will be put in place for the game while the locker rooms also will be spruced up.

Unlike Notre Dame Stadium, where's there's plenty of seating, you have absolutely zero chance of obtaining a ticket for the Sabres-Blue Jackets game. But for the favored few that do get in they'll be right on top of the action, being part of an experience they will never forget.

Schemling made his American debut at Madison Square Garden against Joe Monte whom he kayoed in the 8<sup>th</sup> round. After a decision win over Joe Sekyra and knockout over Pietro Corri, Max was matched with the very tough Johnny Risko. Schmeling proved his worth by stopping Risko in the 9<sup>th</sup> round after having him on the canvas in the 1<sup>st</sup>, 7<sup>th</sup>, and 8<sup>th</sup> rounds.

His next fight would be a decision win over Paulino Uzcudun. These wins would set him up for a match with Jack Sharkey for the vacant heavyweight title. In that fight Max became the only man ever to win the title on a foul when he claimed a low blow by Jack in the 4<sup>th</sup> round. In fact, this would make Max the only man to have won the title while on the canvas and lost it while on his feet as he was defeated in a return fight with Sharkey by decision.

Before his rematch with Sharkey he defended the title one time against the great Young Stribling. Max flattened Stribling in the 15<sup>th</sup> round. This was the only time in 253 bouts that Stribling had ever been stopped, a testament to the power Max possessed.

After his loss to Sharkey, Max went on to fight former middleweight champ Mickey Walker. He gave Walker a terrible beatthis was seen as a great opportunity for him to advance. The fight was a brawl with Baer eventually administering a terrible beating to Schmeling. Baer knocked Schmeling down in the 10<sup>th</sup> round and then pummeled him along the ropes until the referee finally stepped into to stop the match. It is amazing Schmeling wasn't killed as he took an awful beating. Baer went on to win the title in his next fight.
