Major Orange Line Revitalization Work to be Accelerated During 30-day Shutdown of Entire Line

The MBTA announced its plans on Wednesday, August 3, 2022 to accelerate major track and maintenance work on the Orange Line during a 30-day shutdown of the entire line beginning at approximately 9:00 p.m. on August 19th through September 18th with service resuming on Monday, September 19th, to improve service, safety, and reliability on a faster timeline.

The major revitalization work to take place on

the Orange Line during this 30-day shutdown will deliver a number of projects over five years faster than originally planned, and will result in track replacement, upgraded signal systems, and station improvements. The MBTA will also be able to accomplish required track maintenance associated with Federal Transit Association (FTA) directives as quickly as possible.





TIBERIUS THE PLUNDERER



During the reign of Tiberius as emperor there were no public works projects even worthy of mention. He gave no public shows and seldom attended shows that were given by others. He exhibited generosity to the general public on only two occasions; the first was when he offered to lend a large sum of money without interest, during a period of recession, and the second was when he gave financial grants to homeowners after a major fire on the Caelian Hill. He seldom permitted veteran soldiers to retire, but instead kept them

Emperor Tiberius in service until their death to avoid payment of retirement income. As Tiberius grew older, he became more brutal and even resorted

to plunder. He was successful in having himself made the sole heir of a wealthy estate and then caused the person so much fear and mental anxiety that the man took his own life. There were many wealthy men in the provinces that had their property confiscated on any minor charge that could be trumped up. Some were accused of nothing more than having a portion of their estate in ready cash. Wealthy foreigners who sought refuge on Roman soil were treacherously stripped of their fortunes and some were even executed. He developed an intense dislike for his own mother, Livia, and permitted only short and public meetings with her to avoid any appearance that he might be seeking her advice. He did not visit with her during her illness nor did he pay his respects to her in death. He set aside the provisions of her will, confiscated all of her property, and even condemned one of her designated heirs to a life on the treadmill.

There was a complete falling-out with his daughter-in-law Agrippina and eventually he had her beaten until one of her eyes was destroyed. When she went on a hunger strike, he had her mouth pried open and food forced into it. After her death, he violently attacked her memory and had her birthday added to the days of ill omen.

A man was accused of removing the head from a statue of Augustus and substituting the head from the statue of another person. During the trial that followed, some of the evidence was conflicting, so all of the witnesses were examined by torture. The accused was eventually condemned for having committed a capital crime. Laws were passed making it a capital crime to beat a slave near a statue of the emperor, to change one's clothes in the vicinity of his statue, or to wear a ring or carry a coin with the image of the emperor to a toilet or a brothel. Criticizing any word or act of Tiberius was a sure cure for "ring-around-the-collar," and a man was executed for nothing more than permitting an honor to be voted to him in his home town on the same day that honors had been voted to a previous emperor in years past. Many harsh acts and deeds were committed and passed off as the strictness necessary to improve the public morels.

As the days went on, Tiberius grew crueler. Not a day passed without some form of execution. Sacred and holy days were no exception. Many persons were condemned by their children and people were forbidden to mourn for their relatives.

Sometimes special rewards were voted for witnesses or accusers, and the word of an informer was always accepted as true. Even the utterance of a few simple words was treated as a capital offense. Persons awaiting trial chose to open their veins or to drink poison to avoid certain condemnation and execution. The wounds of those less fortunate were quickly bandaged, as they were hurried off to prison. All who were executed were thrown out upon the infamous "Stairs of Mourning" and then by means of hooks were dragged to the Tiber for one last drink on the house.

Saint Afra

There are many different accounts of Saint Afra's life. The most widely known is The Acts of St. Afra, which dates from the Carolingian period (8th century AD). In the opinion of most critics, this is a compilation of two different accounts, the story of the conversion of St. Afra, and the story of her martyrdom.

In the late 3rd century, Afra's pagan family journeyed from Cyprus to Augsburg (Bavaria). Afra was dedicated to the service of the goddess Venus by her mother, Hilaria. According to this source, she originally led a disrepu-

table life in Augsburg, having gone there from Cyprus. She is reputed to have run a brothel in that town. As the persecution of Christians during the reign of Roman Emperor Diocletian began, Bishop Narcissus of Girona (in Spain) sought refuge in Augsburg and lodged with Afra and her mother, Hilaria. Through his teachings,

Bishop Narcissus converted Afra and her family to Christianity.

She continued to hide the bishop from the authorities. When it was learned that Afra was a Christian, she was brought before Diocletian and ordered to worship to the pagan gods. She refused, and was condemned to death by fire on a small island in the Lech River, with her remains being buried at a distance from the place of her martyrdom. Her mother and her maids, Ligna, Eunonia, and Eutropia, later suffered the same fate, for interring her in a burial vault.

According to an alternative account in an earlier document, Afra was beheaded, rather than having been burned. The Martyrologium Hieronymianum (a compilation of martyrs) mentions that Afra "suffered in the city of Augsburg" and was "buried there." Her feast day is August 5th.

of business experience makes him the right person for the job. He touted his hands-on managing style and would not blame the current administration except to say he had plans that would make the system work better. He also noted ridership is down for many different reasons but would seek to increase ridership to at least 80 percent of pre-pandemic levels by 2023 and increase revenue for the system.

There were many in the crowd who remembered the days when Governor Michael Dukakis was taking the Green Line to work on a regular basis out of the Brookline Village T station. Many also hoped that Doughty would be just as committed to public transit as Dukakis had been during his three terms in the Corner office.

DA Warns of "Generational Calamity"

The Suffolk County DA warned the rise in shootings is devastating the lives of young Boston residents. DA Kevin Hayden says he fears that "I am looking at a generational calamity of the kind we have not witnessed for decades."

The DA's statement came in response to the shooting of three teens this past weekend which followed the fatal shooting of a 15 year old three days earlier also in Dorchester.

Hayden's office is now attempting to work with Greater Boston Chamber of Commerce to engage the business community to work in a comprehensive approach to the issue.

As Hayden stated, "We need a full-front, all-segment response that puts all of society's attention on the issues driving these shootings and the resources necessary to reduce them."

The Massashusetts Order of the Sons and Daughters of Italy in America, the Italian American Alliance and many other organizations are happy to report two bills (House Bill 3191 and Senate Bill 2027) that would have replaced Columbus Day with Indigenous Peoples Day in Massachusetts on the second Monday in October have died in committee. The Legislative Session ended for the year on July 31, 2022.

There is some success this past year fighting at the city and town level to protect the recognition of Columbus Day on the school and municipal calendars, the State bills would have completely eliminated Columbus Day as a legal holiday across the Commonwealth.

Diane Modica, the Commission for Social Justice of Massachusetts OSDIA Chair, stated: "We commend our local lodges, numerous Italian American organizations, the local Knights of Columbus members and individuals who made certain their collective voices were heard. They wrote letters, called and spoke to legislators which was critical to the success of the effort this year."

Order Sons and Daughters of Italy in America State President, Denise Furnari added: "We are pleased that our hard work helped preserve the legal celebration of Columbus Day in Massachusetts. Both the man Christopher Columbus and our Italian heritage deserve the respect and recognition that this legal holiday provides".

While this legislative outcome is a victory all Italians who care about our heritage must remain vigilant against any new attacks on the Columbus holiday.

We have never opposed a special day to acknowledge Indigenous Peoples who have suffered their own discrimination and tragedies. However, we have, and will continue, to oppose the wholesale removal of our special day which resulted from the accomplishments of Columbus and the many injustices perpetrated against Italian Americans.

Tom Damigella of the Italian American Alliance would like to thank all again for your support, hard work, and dedication in this effort. We will be vigilant at the state house and inform you if these bills come back in a future session We believed that this bill was unjust, unfair, and divisive, not only to the 800,000 strong Italian American community of Massachusetts, but also to the scores of other Massachusetts residents who support and celebrate this National Holiday.

The many personal contacts and emails that were made to House Speaker Mariano and other legislators made the difference to Save Columbus Day in Massachusetts! Thanks go out to all the people and organizations who took up this cause and supported it with your actions!

In the meantime, we need to make it clear to our own legislators that we will not support them with our votes if they insist on supporting this bill in the future.

L'Anno Bello: A Year in Italian Folklore

The Golden Sunshine of August



The month of August is like a sunflower for me: big, bold, warm and colorful. Indeed, I know that August has arrived when I see these cheerful flowers carpeting the fields of the small farm near my home or beckoning happily from behind white picket fences on someone's front lawn. Just like the butter-hued sunflower, August is a month where the light seems more golden and the sky bluer. However, August also brims with bittersweet nostalgia. I know that soon school will start again, and I will need to readjust myself to the order and rhythm of my teaching job. Store shelves begin to sport decorations of scarecrows and hay, and even pumpkins for Halloween, signaling the commencement of fall and the busy nature of the harvest season. For these reasons, August truly teaches us to live in the moment, to enjoy the beautiful weather that accompanies the end of summer and the early autumn, and to revel in the bounty of Mother Earth. We can take a cue on how to celebrate August from the Italians, who honor the month with a plethora of feasts and proverbs that highlight the pleasures of this special time.

August in Italy contains several unique festivals that emphasize the communal spirit of summer. Many of these festivals are actually medieval tournaments and jousts, hearkening back to the days of old when Italy was a collection of city-states and such pageantry served as a means of displaying the power and might of one's city. At the Medieval Palio in Felire, Veneto, held on the first weekend of August, spectators can watch a parade of costumed locals and participate in an archery competition. Those who wish to witness an exciting joust can head to the La Quintana tournament at Ascoli Piceno, a city in Italy's Le Marche region, or the Giostra di Simone at the Tuscan town of Montisi, where "knights" representing the four neighborhoods of the village compete. When I spent an August in Italy years ago, I saw a similar medieval parade at my father's hometown of Sulmona in Abruzzo. As I watched noblewomen float by wearing elaborate dresses of crushed velvet and stately knights in glistening chainmail, I felt as if I had been transported to the early days of my ancestors, when life was harsh and people clung to the bounty of the Earth for survival. However, the most famous August holiday in Italy is Ferragosto, which occurs on August 15th, the day of the Assumption of the Virgin Mary. Many Italians take the whole month off for Ferragosto, and visitors to the country will find the cities largely deserted as nearly everyone has flocked to the beach or mountains.

Italians also reference a wide array of proverbs relating to the weather or agricultural conditions of August. These bits of folklore are remnants of the past, dictums left over from the epoch when society was dependent on agriculture and people's survival depended on the quality of the harvest. However, these nuggets of wisdom still find a home among Italian farmers and folklorists who preserve them for generations to come. Many of these proverbs refer to specific crops, as August is a month of abundant harvest. One such saying intones: "Acqua d'agosto, olio, miele e mosto." Translated, this means that the rains of August prepare the important Italian staples of olive oil, honey, and must, or the juice of grape skins and seeds which comprises the first step of winemaking. Another proverb declares: "Agosto matura, Septembre vendemmia," referring to the fact that grapes ripen during August in order to be ready for the vendemmia, or grape harvest, the following



month. Other maxims allude to the fact that August serves as the entry point for autumn and the colder period of the year. "Agosto annunzia il inverno" means that August announces winter. Meanwhile, the proverb "Alla Madonna di Agosto si rinfresca il bosco" roughly translates to the fact that after the Feast of the Assumption of the Virgin Mary (August 15th), the forest becomes chillier. These types of truisms were well known to my grandmother, who often admonished that the first rain of August ushers in the winter. Of course, much of Italy remains very warm throughout August and into September and October, yet these aphorisms brim with the readiness and knowledge of a people aware that they must prepare their crops and livestock early in order to weather the difficult winter months.

So there you have it: a folkloristic compilation of feasts, holidays and proverbs relating to August. This cultural heritage can teach us a lot about how to enjoy this beautiful month. Let us revel in its warm weather and its sunflowers, in the last burst of summer before we step into our fall routines once again. Let us pay homage to harvest and prepare ourselves for whatever life has in store. These are the timeworn and much honored lessons of August, a month which even today bridges two seasons with abundance and a wealth of lore.

When the calendar changes from July to August, it becomes a bit complicated for me. It is when I think of my life and my life's experiences. I remember endless summers of my past. Revere Beach, Franklin Park Zoo, parades and everyday regular family life. You think about how you once were and how little time you had for sadness or tears. When you are a kid, you think like a kid but when un-kid things start happening to you, you start to wonder.

August brings two bad days and two happy days. I will start with the bad:

August 5, 1989: my dad retired from Boston City Hospital after 12 years and passed away over at Brigham & Women's hospital at age 76 on August 5^{th} He worked hard his whole life and always tried to be the best he could be like most of us do. Watching him die and feeling so helpless, it made me question the hardness of life we all must eventually face. I laugh now because in 1989 I was 41 years old and I thought 76 was old. Not so old now when I am 74.

August 6, 1947: if my Cousin Nicky were alive today, he would be turning 75 this coming Saturday. However, he passed away in May 1962, sixty years ago, and only 14 years old. He was happy and alive one day, then cancer struck and he never made it to his 15th birthday. Being only nine months younger than him, I often still wonder what kind of relationship he and I would have had being so close in age.

Okay, before I send everyone to their medicine cabinets, for all the bad August seemed to be for me, let me say that not everything was depressing as hell.

Take August 10, 1947: That was the date my mom from Charlestown married my dad from the North End over at the Cathedral of the Holy Cross. The next year, I was born, and my brother Dominic in 1950. We grew up in the South End and then St. Philip's Parish in lower Roxbury. We had so many good times as a family. Summertime was always fun. Endless trips to the amusement rides at Revere Beach, trips to Franklin Park Zoo and visits to family members both Sicilian and Irish.

We all are given a life to live. The hope is to live it well. We did. Can't really worry or obsess over possible future endings. Can't live life that way or you'll end up going crazy. Too many happy months of August to cry over this month when sadness rears its ugly head.

Finally, August 24, 1909: the day my mother and her twin brother George were born. She had a good life growing up in Charlestown and Malden before my mom and dad found each other working over at Boston City Hospital.

My dad worked and my mom took care of the house. That was the norm in the '50s and '60s and they did it together. I remember how much my Ma looked forward to family birthday parties. She loved her ice cream, bananas, and cake. She would laugh and smile, and she had the best sense of humor. I credit her for my own sense of humor. I realized growing up, you had to have a good sense of humor or you could end up in Mattapan as she always said.

Back in my childhood, most parents would tell their kids to stop fooling around or "You'll drive me to Mattapan." We knew she wasn't talking about the neighborhood but the crazy house as everyone called it back in the day.

While I always seem to think of August as being very complicated, is it really different from the other 11 months? After all, life is always complicated and the older we get, the obvious is clearer.







Maximizing the amount of work able to be accomplished, this shutdown will progress a number of projects and maintenance along the entire Orange Line on an accelerated timeline, which will improve service, safety, and reliability for riders, including:

- The replacement of over 3,500 feet of 38-year-old Orange Line track and tie replacement work that will allow for the removal of speed restrictions, improving travel time for Orange Line riders;
- The replacement of two crossovers that facilitate the movement of Orange Line trains, allowing for improved reliability and future capacity improvements;
- Track repair, tie replacement, concrete work, and more along the Southwest Corridor of the Orange Line, which will improve reliability; and
- The installation of upgraded signals and associated systems at Oak Grove and Malden stations, allowing for improved safety and reliability.

To keep riders updated about this upcoming Orange Line work, the MBTA has created a specially designated webpage available at mbta.com/BBT2022.

Alternative Travel Options for Orange Line Riders:

• Enhanced Commuter Rail Options: Orange Line riders who must commute downtown are strongly encouraged to use the Commuter Rail as an alternative as the MBTA is making a series of changes in service to accommodate the change in travel patterns:

- 1. All Zone 1A, 1, and 2 fares can be paid simply by showing a CharlieCard or CharlieTickets on ALL Commuter Rail lines. Since many Orange Line riders drive to or transfer between buses and the Orange Line, the MBTA is making it easy to access the Commuter Rail before riders get to the Orange Line by allowing all riders to utilize Commuter Rail stations in Zones 1A, 1, and 2 by showing their CharlieCard or CharlieTicket to a conductor.
- 2. During these 30 days, most passing south-side Needham and Providence Line Commuter Rail trains will stop at Forest Hills, Ruggles, Back Bay, and South Station. On the north-
- side, Haverhill Line Commuter Rail trains will stop at Oak Grove, Malden Center, and North Station. During these 30 days, riders can show their CharlieCard or CharlieTicket to the conductor to access the Commuter Rail. Riders should review the latest Commuter Rail schedule changes as a result of adding these stops, which will be available soon.
- Seek existing MBTA bus and subway alternatives.
- Consider working from home.

A Nostalgic Remembrance



A short while ago, I woke up in the middle of the night and couldn't get back to sleep. I turned on the TV and watched the original Thomas Crown Affair with Steve McQueen and Fay Dunaway on TCM. The film was shot in Boston back in 1968 and came out in '69. I had actually gotten a call to audition for a part in it, but I was on the west coast during the time they were filming. Here it is 54 years later and the tallest buildings in Boston back then were the Custom House and the original John Hancock building. I couldn't believe how the skyline had changed and what Boston was like back then.

I was a young man in my 20s and in my prime, teaching school in Boston, playing music at night appearing in commercials done locally and performing bit parts and walk-ons in any Hollywood production filmed in our fair city. The Boston I knew then doesn't really exist today. The neighborhoods have changed and most are too expensive to live in any more. Back then, the neighborhoods of the city were quite ethnic, Southie was predominantly Irish, Eastie was mostly Italian, the North End was all Italian, the West End had been torn down (unfortunately), the South End was a mix of middle eastern, African American, Gypsies, and a smattering of Chinese. Beacon Hill, the Fenway and the Kenmore area still had a lot of Boston Yankees (Boston Brahmin) with an ever growing student population, considering the amount of colleges that are in or surround the city.

Allston and Brighton had its sections also, Irish, Italian, and Jewish. Roxbury was mostly African American with a spattering of Jewish and West Indians. Jamaica Plain had several Irish neighborhoods, with new comers settling there, mainly from Cuba and Puerto Rico. Near Forrest Hills, there was a sizable German population, and Roslindale, and Hyde Park had many mixes with Italians leading the way. Mattapan was beginning to change from Irish and Jewish to Haitian. Wow, what a city. I loved it, and compared to New York which was ten times the size, Bostonians in general had more class. This is not a fact, it is my personal opinion. Oh, Beacon Hill was and still is Beacon Hill.

Back then, Boston was a walking city even at night. The only time I didn't wear a suit and tie to go somewhere was when I went to Fenway Park to watch a Red Sox game.

As I continued to watch the *Thomas Crown Affair*, I saw scenes of the North End, Faneuil Hall, downtown, especially State Street around the Old State House, the old cemeteries on Beacon Street and the Mt. Auburn Cemetery in Cambridge. I recognized the sand dune areas on Cape Cod as Steve McQueen raced his dune buggy over then.

The one thing I was aware of was the way people dressed back then ... ladies in dresses, business suits including pant suits and men in suits or sports outfits with shirts and ties.

Many men and women still wore hats. Today both sexes wear baseball caps, some forward and some backward. Ladies wore high heels and men wore shined shoes. Like I said, it was 54 years ago. If you want to see people dressed in Boston, head to the financial district or the government center and you might find brokers or lawyers dressed Monday through Thursday ... Friday might be optional???? Oh, another thing, men shaved every day. I guess I sound like an old timer and maybe I am, but we had more class back then.

I had a funny one happen not to long age. Both my sons were at the dinner table and I looked at them both as we were about to eat and said, "My sons, you are neither Orthodox Jews nor Conservative Muslims, take your baseball caps off at my table, we're Italian American". They removed them.

The morning after I saw the film, I decided to drive through Boston and look at the architecture and compare what I was seeing with what I saw in a 54 year old movie. We've come a long way. I next drove to Logan Airport. The way it looked in the film was the way it was redesigned by my mother's late cousin, Arthur Ceruolo, and the engineers he worked with back in the '60s, no comparison to the way Logan International looks today.

The Thomas Crown Affair was about a bank robbery pulled off in a downtown bank. When the police got involved, they showed the old police headquarters on Berkeley Street and the way police cars were painted gray with the front doors in navy blue and Boston Police written on those doors.

The restaurants included were Durgin-Park, a long gone steak house then located near Faneuil Hall. Pier 4 in its heyday, and several others on Newbury Street, then the 5th Avenue of Boston.

On the way home, I began reminiscing about a nightclub which I frequented a couple of nights a week but closed in 1968, the Cave. The Cave was a Latin American night club located in the alley just to the right of the Colonial Theater on Boylston Street. Back in the mid 1960s, I headed there on Tuesday and Thursday nights and tied up with Sal Meli and what was called "The Cave Crowd." They were regulars and included the dance instructors that worked at the Arthur Murray and Fred Astaire studios. They were great dancers and on those two nights the management would sponsor an event called the Cha Cha Jamboree. It was a dance contest that included the dance teachers and the regulars. The winners of the contest would be awarded a magnum of champagne (domestic) but whoever won it would share it with the crowd.

Sal Meli was the best at a short lived dance craze called the pachanga, and received the nickname of Pachanga Sal. There was an older guy who had a following. He was called Charlie Cha Cha. He had been taking dance lessons for many years but the cha cha was his forte. I kind of specialized in the Mambo, and Sal's girl friend was my dance partner when the band played a mambo. I even won a bottle of champagne one night.

Babbononno loved stories about the Cave and I guess reminisced about his days playing for Italian dances in the North End. Dad had worked with one of the bands that played the Cave in the '50s and knew the management and the owners, so he often asked questions about who was still around. Oh yes, we guys wore suits and ties. If you didn't have a tie on, the person at the door might have one you could wear. Without one you couldn't get in. Recently, I drove past a nightclub. The people in line waiting to get in were decked out in jeans (dungarees) with holes in them, shirts that had comical or political comments on the front and all had baseball caps on frontward and backward. I definitely am a dinosaur from the past ... thank God.

At this time of the year, when most are slicing peaches to make peach cobblers, those of us in Italian American homes are preparing our peaches to make an Italian Peach Tart or *Crostata di Pesche*. Sweet *crostatas* are one of Italy's most simple and comforting desserts that families make year after year, throughout the seasons. Whether rustic shaped or lattice-topped, these sweet tarts are made with a sweet buttery pastry referred to as *pasta frolla* and are typically filled with fruit, jam, *ricotta*, or *crema Pasticceria*. Simplicity and seasonality usually dictate what the filling will be. At this time of year, peaches are at the peak of their flavor so this is the perfect time to make an "Italian Peach Tart." This buttery crusted tart, filled with sliced succulent sugared-spiced peaches, is one that is sure to please just about everyone's palette!

From as far back as I can remember, my Nonna and I would make *crostatas* in all shapes, sizes and flavors, and one was always more delicious than the other. When making a sweet *crostata*, we used various recipes for the dough or *pasta frolla*, but never a specific one for the filling. If using fresh fruit, the amount of sugar and spices we added was always dependent on the sweetness or tartness of the fruits being used. Regardless of the flavor or season, I really can't think of anything homier or more comforting than a freshly baked sweet crostata. I guarantee, just the smell of this "Italian Peach Tart" baking will take you back to the warm summer days you spent in your own Nonna's kitchen!

ITALIAN PEACH TART

Crostata di Pesche



Pasta Frolla (Pastry Dough)

2-1/4 cups (300 grams) all-purpose flour 1/2 (100 grams) sugar 1-1/2 sticks (200 grams) unsalted butter at room temperature 2 large egg yolks 1 tsp. vanilla extract Grated zest of 1 organic lemon

Cream the butter and sugar in a large mixing bowl until pale and creamy. Add the egg yolks, one at a time, then vanilla and lemon zest, beat well. Gradually add the flour, a little at a time and mix until dough comes together. Turn the dough onto a lightly floured pastry board and form it into a ball and flatten into a disc. Wrap in plastic wrap and refrigerate while making the filling.

Peach Filling

3 to 3 ½ pounds fresh ripe peaches (if they are too hard, they won't cook well), more or less depending on the size of the tart pan and/or crostata, sliced to a ¼-inch thickness 1/4 cup and 2 tablespoons granulated sugar 1/4 teaspoon cinnamon 1/4 teaspoon nutmeg Pinch of ginger

Mix all ingredients together, cover and set aside for 20 to 30 minutes (allowing to macerate)

Directions

Preheat the oven to 400°.

For the rustic tart, line a baking sheet with parchment paper. Roll out the dough into a disk (it is a rustic tart, so it can be a rough circle) to about 1/8-inch-thickness and place on the prepared baking sheet. Starting at about 2 inches from the edge, begin arranging the prepared peaches in overlapping circles working inward toward the center. Fold over the edges of the dough overlapping the outside edges of the fruit. Brush the edges with milk or cream, and sprinkle with granulated sugar. Bake for approximately 25-45 minutes (depending on size of the crostata, number of peaches, and oven) until the dough is golden brown and the peaches are tender.

If using a tart pan, such as I did (I use a 9-inch or 11-inch fluted tart pan with a removable bottom), grease and flour the tart pan. Take ¾ of the dough and roll it into a circle (about 2 inches larger than the tart pan) and fit it evenly on the bottom and up the sides of the pan. Take the remaining dough and roll out for the lattice top. Cut the dough into lattice strips and arrange the strips on top of pie, brush the lattice with milk or cream, and sprinkle with granulated sugar. Bake for approximately 35-45 minutes (depending on size of the tart and oven) until the dough is golden brown and the peaches are tender.

Let the crostata cool for at least an hour so the filling will slightly thicken. Serve plain or with a scoop of vanilla gelato and refrigerate leftovers!



HOOPS and HOCKEY in the HUB

Although we saw Bill Russell numerous times when he visited the Garden during his retirement years, our fondest memory of the Hall of Famer occurred not in a basketball setting but in a very different environment.

It was back in May of 2019 and the occasion was the memorial service for John Havlicek that was held at Trinity Church in Copley Square. Following the conclusion of the service, held within the inspirational and historic setting, members of the congregation were invited to join the Havilcek family in the church's community room for a collation.

It was there that people saw a somewhat different aspect of the Celtics superstar and it was charming. So much so that several people reached for their cell phones and took keepsake photos of the scene before them.

There was Bill Russell seated in an easy chair with a group of youngsters (who we assumed were the children of members of John Havilcek's extended family) kneeling or seated on the floor in front of him. Bill was smiling as he talked to the children.

The children were quiet and seemed somewhat in awe of the person seated before them. Bill was having a wonderful time as he smiled and told them stories.

This wasn't the Bill Russell of points scored, rebounds captured or shots blocked. It wasn't about the Bill Russell who won two state championships in high school, two NCAA championships while in college, an Olympic gold medal and 11 NBA titles.

No, this wasn't the Bill Russell that the public would identify with. This was the more human, more private side of Bill Russell, the side that undoubtedly only a select few probably ever saw. It was wonderful, it was charming. It was memorable, so much so that it captivated the attention of numerous adults.

Of all the memories that we have of Bill Russell, the one that made the most lasting impression on us was the one that we witnessed that day in the church community room following the service for John Havlicek. One very different from those publicized in the outpouring of media reports and remembrances that followed the passing of Bill on July 31.

It was a very human side of a basketball superstar. A singular memory, for those privileged to have been there and witnessed it, for all time.

PHIL KESSEL STILL AT LIBERTY — As we entered the first week of August one of the more recognizable players still at liberty with his unrestricted free agent status was former Bruin Phil Kessel.

The veteran forward, who put up 52 points for the Arizona Coyotes (eight goals and 44 assists, including 14 power play points), last season, will turn 35 in October. He has won two Stanley Cup championships with Pittsburgh and still appears to be a quality player for the right team. He made \$8 million last season while playing out the final year of his contract with the Coyotes, a team that finished last in the Western Conference this past spring.

Indeed, Kessel is on the verge of becoming the most durable player in NHL history. His regular season consecutive games played streak currently stands at 982, just seven behind that of Keith Yandle who saw his own streak stopped at 989 back in March while playing for Philadelphia. That means if Kessel can sign with another club and play eight more games in a row, he will become the new ironman, owner of the longest consecutive games played streak in NHL history.

Kessel grew up in the Madison, Wisconsin suburb of Verona, played for the U.S. National Development Program and then enrolled at the University of Minnesota.

His final college game proved to be a memorable one for fans of New England college hockey. as Holy Cross traveled west to Minnesota and eliminated the Golden Gophers in the 2006 NCAA playoffs.

But his 18 goals and 33 assists for a total of 51 points drew interest from the Bruins who drafted him fifth overall in the 2006 NHL Draft.

Kessel played well for the Bruins for three years but needed offseason shoulder surgery In the late spring of 2009. In September of that year, the Bruins traded him to Toronto for several draft picks. It also proved to be a financial bonanza for Kessel since the Leafs signed him to a five-year, \$27 million contract.

Back in Boston, memories of Phil came to fore at future drafts, so much so that the trade involving Kessel came to be known in the Hub as "the gift that kept on giving." The initial yield came when Tyler Seguin was selected in the first round of the 2010 NHL Draft. As such he played on the team that won the 2011 Stanley Cup. Another first round pick as a result of the Kessel trade brought Dougie Hamilton to the Bruins during the summer of 2011.

Kessel played six seasons in Toronto before being traded to Pittsburgh. It was there that he experienced the thrill that every NHL player aspires to, winning the Stanley Cup. In his case, he accomplished the feat not once but twice--in 2016 and 2017. The head coach of Pittsburgh during those terrific times was none other than Mike Sullivan, a former bench boss of the Bruins.

Kessel was traded to Arizona during the summer of 2019 and played three seasons for the Coyotes. He was able to keep his consecutive games played streak going during the Covid-19 pandemic. As August began he was still a man without a team with the mid-September opening of training camps looming just over the horizon.

Here's hoping Phil finds a roster spot somewhere and can come to the Hub at least one more time in his career.
