The St. Lucy Society kicked off their 96th Feast in honor of Santa Lucia, St. Lucy, Vergine e' Martire — Protectress of Evesight, on Thursday, August 24, 2017, in Boston's North End. The festivities began at 5:00 pm with the exposition and blessing of the Statue of Santa Lucia and devotees, followed by the solemn procession of the statue of Santa Lucia through the streets of the North End accompanied by Italian street bands, flower girls and color guard. Later in the evening, attendees got to rock out to the music of Vinyl Groove,

an annual feast favorite! The night closed with a candlelight procession bringing the statue of Santa Lucia back to an outdoor chapel for her overnight vigil.

This year, St. Lucy's Feast was moved from the Monday night after to the Thursday night before St. Anthony's Feast. The change appeared to bring out more people to the festivities.

Following St. Lucy's Feast on Friday, August 25th, thru Sunday, August 28th, was the 98th celebration of St. Anthony's Feast. # Stirpe Nostra

### THE PATHETIC GALBA

Following his tour of duty as a governor in Africa, Galba returned to Rome and lived in partial retirement until midway in the reign of Nero. It was said that he was so concerned about being required to leave the country on short notice that he never went away from his villa for any reason without taking about \$50,000 dollars worth of gold with him in a second carriage. This precaution apparently served him well because one day while visiting in Spain, he accepted the governorship of a province in that country and was required to assume his duties immediately.

During his initial years as a governor in Spain, he maintained his energetic and disciplined characteristics, even to the point of being overly severe. He ordered a moneylender's hands cut off and nailed to the counter of his shop because he was dishonest in business. A man who poisoned a ward and benefactor was ordered to be crucified. When the man claimed immunity from punishment on account of his Roman citizenship, Galba ordered a taller cross, had it painted white, and continued with the crucifixion.

It soon became quite obvious to Galba that any government official who became notorious because of some high degree of proficiency or talent was sure to attract the attention of Nero, and any jealousy on the part of the emperor would certainly bring an end to the career and possibly the life of that official.



Because of this fear, his activities gradually took on a lower profile, but the damage had already been done and Galba soon discovered that Nero had secretly ordered his execution. These events happened just about the time that the people were rising up against Nero and before long the emperor was reported to have died.

The assembled multitudes soon saluted Galba as emperor and he accepted, declaring that he was acting as a lieutenant of the Senate and of the people of Rome in order to put an end to the disgraceful tyranny of Nero.

He investigated those who had enriched themselves through association with Nero, but most of them had already squandered their ill-gotten wealth. Restitution by confiscations once again became the order of the day.

He condemned to death many distinguished men on minor

suspicions and without the benefit of a trial. He even revoked any grants that Nero had given and made a bungling attempt to tighten the reigns of the economy. This action caused him to be hated by people of every class, but especially so by the soldiers and the Praetorian Guard. His refusal to give the gifts promised embittered the soldiers throughout the empire.

An uprising soon followed in Rome, but a false report indicated that the trouble was over, the rebels had been killed and the faithful were coming as a group to offer their continued support. This news induced Galba to appear in public, where he was quickly abandoned by his followers, then attacked and butchered by the forces of Salvius Otho.

As a Roman emperor and a Caesar, his reign probably ranked with the most pathetic of his 104 counterparts. In person, he was of average height, bald, with a hooked nose. His hands and feet were crippled by rheumatism or gout, he could not wear shoes or hold a scroll, and his skin hung from his bones like a sack. He was a heavy eater and lavish in his tastes, often heaping up the remains of his dinner and leaving them for his attendants. Like some of the other Caesars, he had his share of extramarital sex and in this activity preferred the macho type. He died at the age of 73 and in the seventh month of his reign

# American Red Cross, Boston Red Sox, Beth Israel Deaconess Medical Center Invite Community to Give Blood at Fenway Park September 11th

The American Red Cross, Boston Red Sox, and Beth Israel Deaconess Medical Center invite eligible blood donors to help save lives at the Day of Remembrance Blood Drive at Fenway Park on Monday, Sept. 11th. This annual event honors the lives lost in the 2001 attacks while giving people the chance to make a difference for hospital patients today. Since this blood drive began in 2002, nearly 11,000 blood donations have been collected. The event is also supported by the Honorable Mayor Martin J. Walsh and the City of Boston, Boston Police, Boston Fire, Boston Emergency Medical Services, Legal Sea Foods, and Six Flags New England.

The Day of Remembrance Blood Drive has also become a meaningful way for local 9/11 families and survivors to mark the date with an act of community service. Maura Heidcamp of Plymouth was on the 55th floor of the North Tower when the building was struck. Her husband, Bob, was sightseeing and rushed back to the World Trade Center to search for his wife. Hours later, they reunited at a Red Cross emergency relief center. Maura says the moment she walked into the Red Cross shelter was the first time that day that she felt safe. "The Red Cross provided phones, food, and medical care to anyone who needed it. That was very comforting," said Heidcamp. "Attending the Day of Remembrance Blood Drive at Fenway Park is now a yearly event for me and my family, and always will be. This is a way we can not only remember and reflect on 9/11, but also give back by donating blood and possibly saving someone's life."

All who attend the blood drive can snap photos with the World Series trophies and enjoy a cup of chowder, courtesy of Legal Sea Foods. # How to Donate Blood

Simply download the American Red Cross Blood Donor App, visit redcrossblood.org or call 1-800-RED CROSS (1-800-733-2767) to make an appointment or for more information. All blood types are needed to ensure a reliable supply for patients. A blood donor card, driver's license or two other forms of identification are required at check-in. Individuals who are 17 years of age or 16 with parental consent (in MA), weigh at least 110 pounds, and are in generally good health may be eligible to donate blood. High school students and other donors 18 years of age and younger also have to meet certain height and weight requirements.

Blood donors can now save time at their next donation by using RapidPass to complete their pre-donation reading and health history questionnaire online, on the day of their donation, prior to arriving at the blood drive. September, a Golden Month

Lately, I have been paying special attention to the trees in my backyard. If I look at the leaves closely enough, I can detect the slightly perceptible hues of fall - crisp reds and golden yellows tickling the borders of still-green fronds. The other day, a small breeze lifted a few orange leaves and blew them gently to the ground as they swirled around like tops. These sights, both the delicate colors and the falling of the leaves, are reminders that autumn is here, the season of cooler weather and harvest and the rhythms of nature. The month of September starts this wonderful season, bringing with it the smell of juicy apples and the purring motors of big yellow school buses. The beginning of September is always a very busy time for me, as it coincides with the commencement of the school year and all of the preparations that entails. Nevertheless, when I stop to pause and really think about September, I feel a rise of excitement bubbling inside me. This is a month chock full of rustic holidays and old-country proverbs that highlight September's prominence as a seasonal turning point.

The first September holiday to occur in America is Labor Day, falling on September 4th this year. A festival honoring the contributions of working people, Labor Day also signifies the unofficial end of summer, as many schools return to their sessions after this long weekend. As such, Labor Day is often celebrated with a picnic or barbecue, and this year I will add to the food tradition by baking a sparkling apple cider pound cake to honor the seasonal flavors of this month.

Over in Italy, September heralds a flurry of feasts and activities that will last until the holiday season in the winter. It begins in a regal fashion with Venice's Regatta Storica occurring on the first Sunday of the month. In this renowned boat race, a parade of elegant gondolas introduces an intense competition where skilled rowers in various different categories vie for first place. This event has a royal pedigree, as it is modeled after the welcome procession given to the queen of Cyprus, Caterina Cornaro, when she returned to Venice in 1489. Later in the month, the people in Naples celebrate the feast day of Saint Gennaro on September 19th, when spectators wait to see the mysterious liquefaction of the saint's blood and then hold an eight-day party as stalls selling trinkets and candy line the streets. This holiday has become so popular that many Italian-American communities hold their own Festa di San Gennaro. As autumn intensifies, the fall equinox arrives on the 22<sup>nd</sup> of the month, after which the balance between daylight and night tips towards the edge of darkness. Finally, the Feast of St. Michael the Archangel, or San Michele l'Arcangelo, closes out the month on September 29th. Also known as Michaelmas, this ancient feast features the autumnal themes of balance — the scales of St. Michael echo the equal hours of day and night during the equinox — and harvest, as ingredients like carrots and ginger are traditional on this day.

For our Italian ancestors of yore, September meant collecting the harvest, enjoying the bounty of the Earth, and

ter. In this deeply agricultural society, proverbs reminded farmers to pay attention to the weather and the crops in order to ensure a successful harvest. Rain in September proved a mixed blessing. One proverb bluntly states that "La pioggia di settembre è veleno per l'uva," meaning that September rain is like poison for grapes. However, another proverb happily declares "A settembre pioggia e luna, è dei funghi la fortuna," advising farmers that rain and moonlight made favorable conditions for collecting mushrooms, such as the delectable Italian truffles. Other dictums reflect the changing weather of the month, as summer turns to autumn. A delightful little ditty proclaims: "Aria settembrina fresco la sera e fresco la mattina." According to this proverb, September air is cool during both the evenings and the mornings. This axiom reminds me of the autumnal mist I often see rising above fields like lace on crisp mornings, or dark evenings huddled under a blanket and drinking a cup of apple cider. Italian truisms even mention the autumn equinox. "Di Settembre la notte col dì contende" roughly translates that night competes with day during September, a reminder of the long winter

evenings to come. From holidays to proverbs, September is a month brimming with great significance as a seasonal milestone. Whether you enjoy the changing foliage or admire the taste of a fresh apple, be sure to pause and be grateful for all that the autumn has to offer. For it is autumn that teaches us humility before the gifts of the Earth and an appreciation for the cycle of the year. So no matter how you desire to honor September, here is to a month full of bountiful blessings and new beginnings!

# Stop Politicizing Hurricane Harvey

What has happened down for \$50 billion, but two-thirds in Texas is devastating. Hurricane Harvey hit land at Corpus Christi, which is about 150 miles from the City of Austin where my nephew and family live. # Saint Jeanne Delanoue

Jeanne Delanoue was born in Saumur, in the valley of the Loire River, on June 18, 1666. She was the youngest in a family of twelve. Her parents owned a business near the sanctuary of Notre-Dame-des-Ardilliers. Her father was a draper, and her mother ran a shop selling religious goods, catering to pilgrims visiting a local shrine to the Blessed Virgin Mary, under the title of Our Lady of Ardillier. Although she was only six years old when her father died. she helped her mother run the store in order to provide for the family. Her qualities were remarkable: she was skillful, energetic, and indefatigable, even to the point of keeping the store open on Sundays and holy days, which was an unusual practice and frowned upon in that period.

On Pentecost Sunday 1693, when Jeanne was 27 and shortly after the death of her mother, an elderly woman by the name of Francoise Fouchet from Rennes, a faithful pilgrim to the

shrine of Norte Dame des Ardilliers, invited Jeanne to consecrate herself to the many poor people of her neighborhood.

Despite the responsibilities she had accrued, in response to this call, which she believed to have come from God, Jeanne turned toward the poor. They assumed more of her time each day than did her clients until finally they became her full-time occupation. Within a

short time, no longer did the poor await her visits to them, but they came to her. In 1700, she welcomed a destitute child into her home, and soon after she took in the sick, the aged, and the impoverished.

Jeanne, along with other women who shared her vision of helping the needy, founded the Sisters of Saint Anne of Providence of Samur. The congregation was formally approved by the Vatican in 1704.

Worn out by her labors, Jeanne Delanoue died on August 17, 1736, at Fencet, France, of natural causes. At the time of her death, there were twelve communities of her sisters, spread throughout France, serving the poor and needy. The congregation Jeanne founded was renamed the Congregation of the Sisters of St. Anne of Providence of Saumur on December 3, 1964. She was canonized in October 1982 by Pope John Paul II. The Feast Day of Saint Jeanne Delanoue is celebrated on August 17th.

In addition to the Steve Pini Memorial Stakes, Saturday's card will include six turf





# Should Wild Animals be Kept as Pets?

Consider the risks to human health and safety, animal welfare, and the environment. The Humane Society of the United States strongly opposes keeping wild animals as pets. This principle applies to both native and non-native species, whether caught in the wild or bred in captivity. The overwhelming majority of people who obtain these animals are unable to provide the care they require.

Caring for wild animals is difficult or impossible. Despite what animal sellers may say, appropriate care for wild animals requires considerable expertise, specialized facilities, and lifelong dedication to the animals. Their nutritional and social needs are demanding to meet and, in many cases, are unknown. They often grow to be larger, stronger, and more dangerous than owners expect or can manage. Even small monkeys and small cats such as ocelots can inflict serious injuries, especially on children. Wild animals also pose a danger to human health and safety through disease and parasites.

Baby animals grow up. Baby animals can be irresistibly adorable until the cuddly baby becomes bigger and stronger than the owner ever imagined. The instinctive behavior of the adult animal replaces the dependent behavior of the juvenile, resulting in biting, scratching, or displaying destructive behaviors without provocation or warning. Such animals typically become too difficult to manage and are



confined in small cages, passed from owner to owner, or disposed of in other ways. There are not enough reputable sanctuaries or facilities to properly care for unwanted wild animals. They can end up back in the exotic pet trade. Some may be released into the wild where, if they survive, they can disrupt the local ecosystem.

Wild animals spread disease. The Centers for Disease Control (CDC) and Prevention advise against direct contact with wild animals for a simple reason: They can carry diseases that are dangerous to people, such as rabies, herpes B virus, and salmonella. The herpes B virus commonly found among macaque monkeys can be fatal to humans. Tens of thousands of people get salmonella infections each year from reptiles or amphibians, causing the CDC to recommend that these animals be kept out of homes with children under five. A 2003 outbreak of monkeypox was set in motion when African rodents carrying the disease were imported for the pet trade and infected native prairie dogs, who were also sold as pets.

Domestication takes centuries. Wild animals are not domesticated simply by being captive born or hand-raised. It's a different story with dogs and cats, who have been domesticated by selective breeding for desired traits over thousands of years. These special animal companions depend on humans for

food, shelter, veterinary care, and affection. Wild animals, by nature, are self-sufficient and fare best without our interference. The instinctive behavior of these animals makes them unsuitable as pets.

Capturing wild animals threatens their survival. The global wildlife trade threatens the very existence of some species in their native habitats. When wild-caught animals are kept as pets, their suffering may begin with capture. Every year countless birds and reptiles suffer and die on the journey to the pet store. Animals meant to live in the wild may languish in a cramped backyard cage or circle endlessly in a cat carrier or aquarium. Often, they become sick or die because their owners are unable to care for them properly. Captive breeding is no solution. It does not take the wild out of wildlife.

Having any animal as a pet means being responsible for providing appropriate and humane care. Where wild animals are concerned, meeting this responsibility is usually impossible.

People, animals, and the environment suffer the consequences.

That's all for now ... Remember to pick up after your pet.

### WAR MACHINE - NICK CAVE & WARREN ELLIS Lakeshore Records

War Machine is a Netflix original film based on the non-fiction book by Michael Hastings, titled *The Operators*, starring Brad Pitt, Anthony Michael Hall, and Ben Kingsley, with an interesting soundtrack composed by Nick Cave and Warren Ellis.

The duo creates music using voices to create the sounds of instruments, and the results are rewarding. The direction of the music is flowing, almost sounding surreal, sometimes appearing to be happy, only to have the tone change dramatically to one creating a pensive mood, almost hypnotizing. No matter what label is given to the music Cave and Ellis constructed, one thing is for sure, the mood is real. Four of the tracks are from German electronic music pioneer Hans-Joachim Roedelius, and include "In Liebe Dein," "Kamee," "Fabelwein," and "Staunen Im Fjord." The chamber rock band Rachel's contributes the haunting "NY Snow Globe." The remaining tracks are Cave and Ellis gems that enhance the film's story brilliantly!

### TULIP FEVER -DANNY ELFMAN Sony Classical

Whenever the name of fourtime Academy Award-nominated Danny Elfman is listed as composer of a given soundtrack (and that is often), you can be sure that it will be amazing. Proof of that can be found on the original motion picture soundtrack of Tulip Fever, a film based on Deborah Moggach's novel. The 17-track collection opens with the piano sound of "Sophia's Theme," trailed by the silken sound of "Lost," "The Unveiling," "A Storm is Coming," "Ultramarine," "Nailed," and the strains of "The Reveal." Elfman's accomplishments are legendary, from his first score for Pee-wee's Big Adventure to his current creations, he has an immeasurable track record. Elfman maintains the mood with "The Streets - Part 2," followed by the lengthy "Devastation," "The Wait," "It's Done," "The Orphanage," and "The Grand Finale." Another Danny Elfman soundtrack gem!

### CAGE THE ELEPHANT UNPEELED RCA Records

Turn up the volume, settle back into a comfortable chair and enjoy Cage the Elephant delivering their first ever, live album - surprisingly acoustic. They've recorded a total of 21 tracks live from shows in Nashville, Washington, D.C, Knoxville and Los Angeles. Of the 21 cuts, the trunkful of tracks include 18 originals and three cover songs. # Commonwealth Shakespeare Company Announces 2017-2018 Season

Commonwealth Shakespeare Company (CSC) Founding Artistic Director Steven Maler has announced the 2017-18 Season, to be presented at the Sorenson Center for the Arts at Babson College in Wellesley, as well as in downtown Boston.

Mr. Maler explained the themes connecting the season offerings: "William Faulkner said 'The past is never dead. It's not even past.' I keep coming back to this quote as I think about the world we find ourselves in today, as we struggle to make sense of our rapidly changing world. Industries are being disrupted, politics are being disrupted, and lives are being disrupted. In this sea of change, where norms are being upturned and the future is murky, I wanted to look at how great writers responded to mercurial times, how they captured the fleeting moments of civic and personal decisions when history was not yet inexorably fixed, when a change of direction was still possible. These plays capture the subtle, and not so subtle, fissures in the daily domestic tapestry as the Nazis came to power in Germany in Bertolt Brecht's Fear and Misery in the Third Reich; the half-lives of destruction in the wake of a tyrannical military dictatorship in Ariel Dorfman's Death and the Maiden; the power of money, both old and

new, in Wendy Wasserstein's Old Money; the chaos and devastation of political instability in Macbeth; and of the destructive rise and fall of one of Shakespeare's most riveting villains in Richard III. It's an intense season for an intense time, a season of plays that we hope provoke deep thought about how we want to be remembered by history."

Fear and Misery in the Third Reich: A Staged Reading. A play by Bertolt Brecht, translated by Eric Bentley, directed by Steven Maler. Featuring Tony Shalhoub and Brooke Adams. Monday, November 13, 2017, at 7:00 pm, Carling-Sorenson Theater, Babson College

Brecht's series of 18 interconnected plays describes what life was like in German households in the 1930s as the Nazis came to power. Written while Brecht was in exile in Denmark and first performed in Paris in 1938, these poignant stories dramatize the suspicion and anxiety experienced by ordinary people, particularly Jewish citizens, as the power of Hitler grew. The reading features renowned film and theater actors Tony Shalhoub and Brooke Adams. "Theatre in the Rough" is a script-in-hand reading series presented without common theatrical elements like sets or costumes. These pared-down

readings uniquely engage the audience by immersing them in the immediacy of the text and the actors' performances, allowing one's own imagination to take creative flight.

# Nanna & Babbononno

A Nostalgic Remembrance



The Labor Day weekend was approaching and this signaled the end of the county fairs in the northeast. After that point in time, farmers would be harvesting what they had grown on their farms since the late spring. So, this was the last hurrah. Dad was playing in a band conducted by his pal, Chet Nelson. They had been on the road playing for Lowell Thomas fifteen years earlier and were now entertaining at some of the same fair grounds.

Dad packed the car with things we would need and then wedged in Nanna, Babbononno, Mom and me. He pointed the '49 Chevy toward New York State, and headed for Schaghticoke (prounced skarty coke), a tiny upstate town. I think their annual fair was bigger than the town itself. I could hardly wait! I worked for the scenery man at most of the fairs Dad played. A cigar-chewing Irishman named Louie, who was from South Boston and supplied the scenery for the shows that were staged at many east coast fairs, had trained me to be his helper a couple of years earlier. I would receive \$35.00 per fair and felt like a ten-year-old millionaire.

When we arrived at the fairgrounds, I discovered that Louie wasn't there. Other than the band, everyone else responsible for the entertainment was from New York City, including the scenery man. I was out of luck, no job. When Dad had to speak to the officials of the fair at the main office, he asked them if any of the concession workers could use a helper. They told Dad that a novelty salesman named Norman often hired local kids to help him at the fairs they worked. Dad told me where the novelty stand was located and I headed to speak to the man named Norman. Using the man's name from the front office as a reference, I was hired immediately.

When I got back to the entertainers' tent, I found Babbononno and Nanna with the Laddie family. Johnny Laddie had a dog and pony act and the family was from Foggia, Babbononno's home town. I told them I had a job on the fairway with the novelty concession. Mr. Laddie told me in Italian to make sure I collected my money after each time I worked. Babbononno asked why and Mr. Laddie said, "Perche il uomo, esso e uno ubriagone." (Because the man, he is a drunk.)

I started that night. It seemed that many of the visitors to the fair spent time trying their luck at the concession stands. If they didn't win anything, a stuffed Teddy Bear or a cupie doll, they might just stop at the novelty stand, buy something and tell the folks back home that they won it. When it was time to wrap things up for the night, Norman gave me \$30 dollars, saying, "I don't know what it is with you Arabs, but you really know how to sell. Be here at 9:00 am tomorrow morning."

I arrived early, but the novelty stand wasn't open yet. I waited and waited, but Norman didn't show up. In the meantime, I watched the happenings at a nearby concession stand. There were two brothers, new to the country from Greece, who had a concession where people would pitch nickels, dimes or quarters into the chinaware or glassware that was on display on a tenfoot by ten-foot table with a three-foot fence surrounding it.

If your pitched coin remained in a glass, cup, saucer, dish or whatever, you won. If your coin bounced or slid off and landed on the table, they won (your money). That three-day fair netted those two brothers \$8,000 — not bad for a long weekend in 1950!

Finally, at about noon, Norman arrived looking like he had had a rough night. He was hung over. I helped him set up and told him that I had been there waiting since 9:00 am. I guess I irritated him because his next comment was, "I don't give a damn; you don't get paid for anything until I get here." At 9:00 pm, it was time to wrap things up (for me a 12-hour day) and Norman said that I didn't sell that much, and gave me \$10.00.

I felt cheated, but didn't say anything to Dad who was still on stage when I returned to the tent set up for the entertainers. Babbononno saw the look on my face and asked me what was wrong. When I told him, Mr. Laddie, his new paesano from Foggia, overheard. He then asked if I was going to work for Norman the next day. I said I had to report to the novelty stand at noon. He then said, "It looks like everything you take in should be split in half. If something costs a dollar, half of it should be yours."

I reported at noon, but Norman didn't show up until around 2:00 or 3:00 o'clock, hung over worse than the last time. He was rude, crude and vulgar, and those were his best qualities. I did most of the selling that day and when Nanna and Mom dropped by to bring me something to eat, I gave them the empty bag the food had been in and told them in Italian not to throw it out.

When it was time to call it quits, Norman gave me a twenty saying that it was all I was worth and he wouldn't need me any longer. Well, it was the last night of the fair and I wouldn't be working for him anyway. Being the polite little kid that I was, I thanked him, shook his hand, said goodbye, and headed to the tent behind the stage where Mom, Nanna and Babbononno were waiting.

Mrs. Laddie had made a couple of dishes that were from Foggiana, especially for Babbononno and there were leftovers for me, and something for Dad, whenever he was able to leave the stage. Mom gave me the bag that my lunch had been in and asked why I wanted her to keep it since it was used and had oil stains on it. I opened it and counted out about \$100, my half of every sale I had made that afternoon.

Dad wanted to know where I got all the money. I, Babbononno and Mr. Laddie told my father the story. After we had eaten, Dad walked me back to the fair office to locate Norman and give him back the money. Reluctantly, I accompanied him and, when we got there, the coordinator of the fair and the head of the King Reed Concessions were finalizing their agreement with each other. Both men asked what was wrong and Dad told them. The head of the concessions told us that he had fired Norman because of several reports of his behavior from prospective customers and due to several warnings regarding his drinking, especially while working, and that the \$100 dollars was mine. He said that I earned it, deserved it, and if Dad's band was ever on the same bill where the King Reed concessions were working, there would be a job waiting for me.

When we got home, I still felt guilty and went to confession at the Sacred Heart in East Boston. I told the priest everything and he listened without interruption. When I finished he said, "Young man, say five Our Fathers, ten Hail Mary's, and on Sunday, when the collection basket comes around, make a good donation, no coins, just paper."

# SWORDFISH STEAKS Broiled or Grilled

4 Swordfish steaks 2 medium onions ½ cup olive, canola or

vegetable oil 2 tablespoons mayonnaise 1/4 cup lemon juice
1 teaspoon cider vinegar

(optional)

2 tablespoon of butter or margarine

**SWORDFISH STEAK:** Spread some oil or mayonnaise on the bottom of a broiling pan. Then spread a little oil or mayonnaise over the top and bottom of each Swordfish steak before placing in the broiling pan. Place in preheated oven about two inches from broiling unit. Turn steaks to broil on both sides slowly. Steaks will turn whitish in color when they are cooked. Depending on size, broiling time will be about fifteen to twenty minutes. Then set broiling pan with steaks aside.

**ONIONS:** Remove outer skin from onions. Cut onions in half, lengthwise, and then into 1/4-inch slices lengthwise. Set aside in a bowl.

Heat oil in a skillet. Add butter or margarine and onion slices to the skillet. Stir and simmer until onions are about to brown *slightly*. Remove from burner and add lemon juice. Add vinegar (optional). Stir and return to burner. Simmer slowly a few seconds. Remove from burner.

Spoon onions and liquids from skillet over each Swordfish steak in the broiling pan. Cover with aluminum foil and return to heated broiler for about a minute. If you desire to brown tops, remove cover and broil for a few seconds longer. Serve each steak topped with onions and liquids from broiling pan. Serves four.







For starters, newly named head coach Tony Granato had a 13-year career in the NHL, a span that saw him score 30 or more goals in four separate seasons. He then spent an additional 13 years as a coach in the NHL with the Colorado Avalanche (2002-2009), Pittsburgh Penguins (2009-2014), and the Detroit Red Wings (2014-2016). He also played for the U.S. in the 1988 Olympics and was an assistant coach with the 2014 Olympic squad.

He then came back to his alma mater (Wisconsin) last season, where he earned Big Ten Coach of the Year honors. His assistants include current Yale men's head coach Keith Allain, who was previously a coach with the Washington Capitals and a goaltending coach with St. Louis; and Chelios, who had a 26-year career in the NHL; and Ron Rolston, a former head coach of the Buffalo Sabres.

Granato is not taking a leave from his position at Wisconsin this year. He has indicated that he will be able to do both jobs this winter, saying that his duties during the Olympics will only result in his missing a small number of games — as few as four or five - with his college team.

He also has indicated that he is very open to recruiting former NHL players for Team U.S.A. The plan, as revealed in a New York Times article in August, is to find several NHL veterans who have recently retired. The core of the team would then be formed around them.

nd stav in shape, they'd be great leaders," Granato stated in the article. Additional players would come from the American Hockey League and the collegiate ranks.

One thing there won't be is an extended pre-Olympic tour that serves as a training ground. Such a trip was a feature of the 1980 "Miracle on Ice" U.S.A. Olympic Team that won the gold medal.

Instead, players will be identified and then invited to a camp that will take place in November in Germany as prospects compete in the Deutschland Cup Tournament.

There is a possibility that international politics may well

cast a shadow over the upcoming Games. The South Korean host city of PyeongChang is only 40 miles from the demilitarized zone border that separates South Korea from North Korea.

In fact, back in June, South Korea actually proposed using a North Korean ski resort as a venue for some of the competitions. Apparently that didn't fly, as all venues are slated to be within South Korea. But it was somewhat in line with the athletic relations (as distinct from government relations) between the two nations. It may surprise some, but actual athletic competitions between athletes from the two nations have gone quite well in the past.

However, as we all know, there are a large number of countries participating in the Winter Olympics, many of which are uneasy about the actions of the government of North Korea.

"U.S. and South Korea Start Military Drills amid Tensions with North Korea," read a headline during the last week of August — only a day before the government of North Korea launched a missile that flew over Japan.

It should also be noted that, as we enter September, North Korea has absolutely nothing invested in the 2018 Winter Olympics. North Korean athletes are not banned from the Olympics (by either North Korea, South Korea, or the International Olympic Committee), but so far none have qualified to participate. The government of South Korea is on record as stating that North Korean athletes will have free and safe passage through the demilitarized zone to compete in the Olympics.

In contrast, South Korea is heavily invested in the upcoming Games to the tune of several billion dollars. The government realizes that the nation will be on center stage throughout the world for the first time since 1988 — when the nation hosted the Summer Olympics. Preparation for the spotlight has included the construction of venues in remote areas, complete with the widening of roads. A new railroad line has also been built.

It causes one to wonder about "If they can play somewhere the "white elephant" factor: how many of these facilities will actually be used on a steady, on-going basis once the Games conclude? If the facilities stand unused, then the money could have been better spent on other

> We have the feeling that if North Korean teams and individual athletes were scheduled to participate in the Games, the actions of the North Korean government might be quite a bit different. But right now, the only thing predictable about the government of North Korea is that its actions are unpredictable — a very sad situation with the Games only five months away. We hope that changes, but only time will tell.
