Stop & Shop Closes Everett Store

The Stop & Shop in Everett on Revere Beach Parkway has closed its doors after 21 years. "It is a sad day," said Store Manager Glen Sanford when the store closed its doors forever on August 14th. What caused the closing? The store manager stated the landlord didn't want to renegotiate the lease and added, "He wants to give the property to a developer to build some apartments." Sanford stated all 75 store employees will be relocated to a nearby Stop & Shop location.

Hospital Windows Can Make One Real Sick Real Fast, Huh?

The chair of Russian oil giant Lukoil and an opponent of Putin's war on Ukraine has died in a 6-story plunge from a hospital window last week. The death of Ravil Maganov was reported as a suicide by Russian state media, but two sources told Reuters it was unlikely he took his own life. Maganov is the latest in a string of energy execs to have died since February.

N.C. Town Defunds Woke Pol

A tiny town in North Carolina gave the boot to newly installed Town Manager Justine Jones and blamed her progressive ideas for creating a hostile work environment "that led to the entire police department resigning from duty." The town council gave her the boot after just three months into her two-year contract.

Santa Rosalia de Palermo Society Members

Santa Rosalia di Palermo Society held their 83rd Annual Mass and Procession on Sunday, September 11, 2022 in Boston's North End closing out the 2022 feast/processon in Boston's North.

The Santa Rosalia Society was formed in Boston in 1939, hailing from Palermo, Italy.

The story of Saint Rosalia: Rosalia was born of a noble family descended from Charlemagne before being led by angels to a solitary life in a cave on Mount Pellegrino where she died alone in 1166. On the cave wall she wrote "I, Rosalia, daughter of Sinibald, Lord of Roses, and Quisquina, have taken the resolution to live in this cave for the love of my Lord, Jesus Christ." In 1624, during a plague in Palermo, Rosalia appeared to a sick woman and then to a

hunter to whom she directed to find her remains. In a procession of her bones through

the city, the plague was lifted. Santa Rosalia is also known as The Little Saint.







CALIGULA (The Nut Cake)



Legend has it that Caligula loved his were warned to give horse Incitatus so much he planned on anointing it to high office. were warned to give no advice to their clients that was con-

Caligula considered himself to be a god and continually demanded that suitable honors be paid to him. He also openly deplored his time in life because it had not been marked by any great public disasters. Every now and then, he wished for the destruction of his armies, an earthquake, a configuration, or even a famine. One of his favorite sports was to close the granaries and condemn the people to hunger for long periods of time.

When the occasion presented itself, he would smash statues of famous men from earlier historical periods. He even forbade the erection of the statue of any living man anywhere in the empire without his personal knowledge and consent. One day he stood beside a statue of Jupiter and asked an actor which of the two seemed to be the greater. When the actor hesitated, Caligula had him whipped.

Prior to theatrical plays, he would scatter gift tickets in public to induce the rabble to take seats, which were reserved for the highest order of guests, the so-called equestrian order. At gladiatorial contests, he would suddenly order that the sun shades be opened when the sun was the hottest, and then give additional orders that no one be allowed to leave. He is also known to have forced common

citizens with conspicuous infirmities to fight each other as gladiators in the arena just for kicks.

At one time, the consuls of Rome forgot to make proclamation of his birthday and he immediately removed them from office. They were lucky to get off with their lives. Later he had his own public prosecutor stripped and flogged because he feared a conspiracy against him. The prosecutor's clothing was placed on the wet ground to provide a good footing for the flogger. Lawyers were warned to give clients that was contrary to his wishes,

otherwise he threatened to abolish the practice of law, and whenever he observed handsome men with fine heads of hair, he ordered that the back half of their heads be shaved clean.

Caligula outdid everyone in reckless extravagance, such as bathing in hot or cold perfumed oils, drinking expensive pearls that had been dissolved in vinegar, or consuming bread and meat that had been colored with gold. He built villas and country houses with no regard whatsoever for the expense involved. His horse named Incitatus (Speedy) was his favorite. Some sources say that he made his horse a priest and also declared it to be a consul (high magistrate). The horse was kept in an ivory stable and fed from a golden manger. When invited to dine with the emperor, the horse was served gold colored oats from a gold dish. This is our earliest record of horse manure being worth its weight in gold. His extravagance was equal to his cruelty. His favorite amusement was to stand on a balcony and throw gold pieces into the street. He squandered twenty eight million dollars in a single year, and if you think that's easy, just try it sometime.

MassGOP Chairman Jim Lyons statement on post-primary gubernatorial poll results

Emerson College poll shows Republican Geoff Diehl with lead in independent

vote over Democrat Maura Healey, with the economy as voters' top concern

An Emerson College poll of registered Massachusetts voters has found that Republican candidate for governor Geoff Diehl holds a seven point lead in favorability among independents over Democrat Maura Healey, with the status of the economy identified as the top concern by an overwhelming margin, especially among independents.

"One-party rule will devastate the commonwealth economically and in other ways as well, just like we're seeing in Washington, D.C., where the current president has been reduced to a pandering puppet of the far left," Massachusetts Republican Party Chairman Jim Lyons said. "Voters are right to be concerned over that possibility."

Massachusetts Republican Party Chairman Jim Lyons added that the poll results support this assessment and indicate an appetite among independent voters, far and away the largest block of voters in Massachusetts, to dump leftist policy makers like Healey, especially as the economy sputters both nationally and at the state level under the leadership of the Democrats.

"These numbers tell me that a big block of voters fear Democrats like Attorney General Maura Healey are mostly interested in pandering to the far-left's agenda, just like what's going on in Washington, and her record shows they have every right to be concerned," Lyons said. "She's gone after the energy industry to score political points while working families suffer the effects of soaring fuel costs, and you can bet that the same economic disaster unfolding as a result of the Democrats' one-party stranglehold in Washington will happen tenfold in Massachusetts if she becomes governor.

"Republicans like Geoff Diehl have shown time and again that they are the only ones who can ultimately lead the way out of the Democrats' self-created economic malaise. The fact that the economy is the voters' number-one concern tells me that citizens are frustrated with the Democrats' socialist-driven agenda, both nationally and here at the state level."

Lyons stressed that voters are the only thing that stands between what's happening in Washington and what may occur in Massachusetts.

Saint John Houghton

Houghton was born around 1487, a native of Essex, (according to one of his fellow Carthusians) he was educated at Cambridge, but cannot be identified among surviving records. Similarly no certain records can be found of his ordination.

He joined the London Charterhouse in 1516, becoming sacristan in 1523, and procurator in 1528. In 1531, he became prior of the Beavale in Nottinghamshire, in November of that year, he was elected prior of the London house, to which he returned. In addition, the following spring he was named Provincial Visitor of the English Carthusians.

In 1535, the community was called upon to make the new oath as prescribed by the 1534 Act of Supremacy, which recognized Henry VIII as the Supreme Head of the Church of England. Houghton, accompanied by the heads of the other two English Carthusian houses (Robert Lawrence, prior of Beauvale, and Augustine Webster,

prior of Axholme), were summarily arrested. They were called before a special commission in April 1535, and sentenced to death, along with Richard Reynolds, a monk from Syon Abbey.

The three priors were taken to Tyburn in their religious habits. From his prison cell in the Tower, Thomas More saw the three Carthusian priors being dragged to Tyburn on hurdles and exclaimed to his daughter: "Look, Meg! These blessed Fathers be now as cheerfully going to their deaths as bridegrooms to their marriage!"


John Houghton was the first to be executed. After he was hanged, he was taken down alive, and the process of quartering him began. Parts of his remains were put on display in assorted spots throughout London. Pope Paul VI canonized him in 1970 as one of the Forty Martyrs of England and Wales. The Feast day of Saint John Houghton is October 25.



Balance and Earth's Bounty on the Equinox

After a stifling hot summer, during which even five-minute walks in the sweltering sun immediately drove me back to the air-conditioned interiors of my home, I was relieved when one morning dawned overcast and cool. Finally, the smell of September — that wonderful month when the leaves begin to blush with shades of red and gold, and chilly nights creep in cat-like with their early darkness — permeated the air. Wherever I turn my head, it seems signs of autumn wink at me playfully, announcing the presence of the season with a crisp and snappy flair. Juicy apples lent their tartness to an old-fashioned crisp I baked for my family not too long ago. Scarecrows smile from store shelves, their broad grins and crackly hair joyfully heralding the feasts to come. Leaves shine in the slick pavement after a rainfall. There will even soon be a carton of iced pumpkin spice coffee sitting in my refrigerator, waiting for me to enjoy its creamy goodness. These hallmarks of fall intensify as we near the autumn equinox, which this year occurs on Thursday, September 22nd. This equinox embodies the rhythm that pulses throughout the fall, its measured dance of harvest and community and interplay between light and dark. Indeed, the autumn equinox is celebrated throughout the world, including Italy, as a seasonal marker and as a significant date in which people honor the generosity of the

people may mourn the end of the astronomical summer and its idyllic, carefree nature, it is important to look at the autumn equinox as an opportunity to begin anew. The return to work and school fills the air with a sense of purpose and organization, a feeling that will guide us as the cadence of autumn eventually dissipates into the jollity of the holidays. Since autumn brims with renewal, it is little wonder that many cultures begin their new year around the equinox. One such example is Rosh Hashanah, the Jewish New Year, which begins on the evening of September 25th this year and is celebrated with meals of apples and honey to ensure the sweetness of the upcoming year. However, the equinox also signifies another important time change: while the day of the equinox consists of equal hours of day and night, after this date the darkness will overwhelm the light. The darkness beckons me indoors; to cozy evenings spent with my family and friends as our stories and laughter form a barrier against the dim night. I may even spend the early nights alone baking with the abundant produce of autumn, filling my kitchen with warm and spicy scents. The equinox affords us opportunities to reconnect with our families and our deepest selves, to devote time to projects and hobbies and take pleasure in the spirit of the season, which is at once both communal and introspective.

In addition to the turning of time, the autumn equinox is also a wonderful time to pay homage to the bounty and as such is used to indicate of the Earth. In Europe, the the passage of time. While some last collection of harvest takes

equinox. Our Italian ancestors, living off the land in a primarily agricultural society, may have waited until the Harvest Moon to finish harvesting their crops. The Harvest Moon, or the full moon closest to the equinox, illuminated the fields sufficiently so that farmers could work well into the night. This year, the Harvest Moon occurred on September 10th, and as usual I celebrated the occasion by baking my appropriately-named Harvest Moon cookies, or almond cookies half-dipped in melted chocolate. As the harvest ended in Europe, many cultures would ritualistically cut the last sheaf of grain, a practice which stems from ancient times, when people believed that the goddess of the grain was embodied in the final remaining bundle. It was then time for cozy feasts known as "Harvest Home," which still exist to this day and can be seen in the harvest fairs that dot event calendars throughout the fall. For Harvest Home, the community gathers together at tables laden with the foods of autumn — apples, pumpkins, pears, carrots, nuts, ginger, spices — and celebrate the generosity of the land and the fruits of their labors. In Italy, these kinds of feasts often take the form of sagre. Derived from the Latin word "sacrum," which also lends itself to the English word "sacred," sagre are festivals devoted to a specific crop or product. Italians love their sagre, and the various regions of Italy each have feasts that honor a local delicacy. Villages in Northern Italy, for example, may host sagre di mele — apple festivals — while Southern Italians often honor grapes in their sagre di uve. No matter what autumnal staple is being celebrated, these European feasts remind us that good food, a strong sense of community, and the love of family are sacred treasures indeed.

Rather than bemoan the darkness, we can welcome it by resolving to use nighttime as an opportunity to do something that makes us happy - whether it involves spending extra time with our families and friends or crafting some alone time in which we may develop our interests and hobbies. We can honor the bounty of the Earth by enjoying the fruits of all and truly relishing them, slowly biting into a tart and juicy apple and inhaling the spicy scent of a cinnamon-flecked cider. Moreover, we can spread the love of the Earth by donating our time or our food to those less fortunate. Let us carry the lessons of the equinox to our heart, and then the pleasures of fall will always have a home — a harvest home, if you will inside our souls.

Make Our Neighborhoods Livable

We Can't Afford a Tale of Two Cities, One for the Rich, the Other for the Poor

The housing crisis Boston faces today didn't start overnight it goes back decades. Back in 1982, when I lived in Charlestown, I was an elected board member of the Charleston Economic Development Corporation and there was a real need for more affordability in housing for neighborhood folk. We proposed affordable townhouses on Main Street for first time homebuyers, especially young families wanting to stay there rather than leave.

That housing was built and it remains today. Whenever I pass by those townhouses, I think at least we on the EDC played a role in building those affordable row houses.


Here we are in 2022, and the need for housing affordability is even greater than 40 years ago, not just in Charlestown, but also in East Boston and across the city. Politicians going back to the beginning of the condo conversion era, which led to the election of Ray Flynn as Boston mayor in 1983, had always talked about Boston being a livable city. That was a popular word going back to the election of Mayor Kevin White.

Is Boston a livable city today? The answer to that question is open for debate, as it seems developers are in the driver seat. I see news stories over and over again where neighborhood groups are standing up and speaking up for their neighborhoods back. Right in East Boston, the Grove Street Citizens Association is attempting to control what many see as overdevelopment. At the site of the former Our Lady of Mt. Carmel Church and its surroundings, there is growing opposition to the addition of 108 units with 84 parking spots. Currently, the project is under review by BPDA.

The threat of gentrification continues. It is like a Japanese movie monster gobbling up seemingly whatever it wants. Boston has grown in many good ways over the past 40 years. We were downhill back then. However, what really has happened is a growing shortage of housing for working families and struggling middle-class homeowners who can no longer afford all this prosperity.

I am starting to think we should be treating the loss of housing like a natural disaster since nothing else seems to be working in the long term. Pretty soon, if we don't tackle this issue, we will all be living in homeless encampments.

We have a problem to fix and a solution to find. Where and to whom shall we look for answers? The clock keeps ticking as affordable housing continues shrinking away from us. Time to stand up and demand our elected officials do something more than just talking about the growing housing issue across our cities. Do something positive for our neighborhoods. Stand with us and not on the sidelines for a change.

POLITICAL ELECTIONS - SEPTEMBER 25, 2022

Please be informed that the electoral packages have been mailed to Italian citizens voting abroad (and registered with the Registry for Italians who reside abroad – AIRE), and to voters temporarily residing abroad (as per Law 459/2001).

Voters are required to comply to the instructions provided in the electoral package on how to complete and return the ballots, which must be mailed promptly using the pre-paid envelope provided, in order to ensure delivery to the Consular Office **NO LATER THAN** 4:00 PM (LOCAL TIME), ON SEPTEMBER 22, 2022.

Voters who have not received their electoral package may request a **duplicate** at the Consulate General of Italy in Boston **beginning September 11, 2022** during the opening hours of the consular office, from Monday to Friday, from 9.30 to 12.30.

The request for a duplicate can be made in person at the consular office or sent by post, by ordinary e-mail (elettorale.boston@esteri.it) or by certified e-mail (con.boston@cert.esteri.it). The request can be made using the form available on the Consulate's website and must be accompanied by a valid identification document.



East Boston Ferry Service

The MBTA announced that beginning September 12th, a new ferry service project will operate between East Boston at Lewis Mall and the downtown Boston area at Long Wharf.

"We're pleased to be able to demonstrate this ferry service between East Boston and downtown Boston this fall and

next spring," said MBTA General Manager Steve Poftak. "We know riders valued the ferry service last spring when Blue Line service was suspended for maintenance. Demonstration projects such as these take coordination and funding, and I'd like to thank our local elected leaders for pursuing and securing the funds necessary to allow the T to operate this seasonal service."

"This ferry service will be a critical link in further activating the inner harbor and connecting the North End and East Boston. I am proud that we were able to receive state funding to make this investment possible and I look forward to building off its success in the near future," said Representative Aaron Michlewitz, Chair of the House Committee on Ways & Means (D-Boston). "I want to thank my colleagues in the Legislature, Representative Madaro, and Senator Edwards, for the work they did to help secure these critical funds."

"The return of the East Boston ferry through the fall season and next spring is a win for residents across our community," said Representative Adrian Madaro. "At a time when increased congestion and transportation challenges have meant more difficult commutes, the ferry will offer people an additional transit option with frequent service at peak hours and at a cost on par with the subway. I was proud to partner with Rep. Michlewitz and Sen. Edwards to secure funding to bring back the ferry, and I'm excited for residents



to be able to use this enjoyable, accessible mode of public transit to cross the harbor."

The East Boston ferry will operate seven days a week during fall 2022 and spring 2023. Each trip will be approximately 10 minutes. The East Boston ferry service project will operate from September 12th to November 30,

2022. Service will pause for the winter and resume for the spring season on March 1, 2023. The full East Boston ferry project schedule will be available on *mbta.com* soon.

On weekday mornings, 11 trips will depart Lewis Wharf every 30 minutes beginning at 7:00 a.m. and 10 return trips will depart from Long Wharf every 30 minutes starting at 7:15 a.m. On weekday afternoons and evenings, ferries will depart Lewis Mall every 30 minutes beginning at 2:30 p.m. with the last trip at 7:30 p.m. Trips from Long Wharf to Lewis Mall will leave every 30 minutes beginning at 2:15 p.m. with the last trip at 7:45 p.m.

On weekend mornings, eight trips will depart Lewis Wharf every 30 minutes beginning at 9:00 a.m., and seven return trips will depart from Long Wharf every 30 minutes beginning at 9:15 a.m. On weekend afternoons and evenings, ferries will depart Lewis Wharf every 30 minutes beginning at 3:30 p.m. with the last trip departing at 8:30 p.m. Twelve return trips will depart Long Wharf every 30 minutes beginning at 3:15 p.m. with the last ferry departing at 8:45 p.m.

A one-way fare for the East Boston ferry is \$2.40 or \$1.10 for reduced fare riders, the same fare as the subway. Fares can be purchased at the Long Wharf ticket booth and on the *mTicket app*. The MBTA also accepts printed LinkPasses, Commuter Rail Zone passes, and M7 passes. More information on ferry fares is available at *mbta. com/fares*.

North End Community Issues Outdoor Dining Finally Coming to an End

Outdoor dining ends September 30th, tables, chairs, and barriers are to be removed by October 3rd. Is Mayor Wu going to end outdoor dining completely? Are legal cases still in court from the restaurant owners? Was it fair to charge restaurant owners \$7,500.00 plus \$450.00 extra each month for parking spaces?

All I heard this summer was the North End is too congested, we need more trash pick-up, power-washing, extra street cleaning; extra detail from police officers, etc. My question is ... was any of this done? Street cleaning is Tuesdays and Thursdays as it has been for years in the North End. Trash is still all over the streets which just adds to the rodent problem.

Has Inspectional Services or any city employee assigned to outdoor dining been reporting what restaurants are not following regulations to Mayor Wu?? So many questions and no answers? Truthfully, many residents feel the same as I do. We live here, we love our restaurant owners that have always been very supportive to our community.

Again, is outdoor dining meant for the North End? Our streets are congested only because of the extra tourists and people from different areas who

Today, the North End is about high rises, hotels, and condominiums.

Let me add what is going on with Haymarket vendors produce area near the hotel they were asked to remove all tents and items into storage and not leave anything outside at night, why? This area has been for years the Haymarket area that sold fruit, vegetables, and fish at low prices that became a way of living for North End residents and people from other areas. These people are trying to make a living during the weekend. To clean up the entire area and start all over again the next morning, where is the compassion and understanding from these hotels??? Why now! If Fred Langone was still alive today would this happen. He fought long and hard for the Haymarket vendors for years. God love him, he loved the North End and fought for the residents.

Again, I say outdoor dining is not designed for the North End. What will Mayor Wu decide for 2023, and will the restaurants owners continue to pay this fee for 2023?

St. Teresa of Calcutta

25th Anniversary Mass at St. Peter's in Dorchester

was born in August 1910 into an Albanian family when the Ottoman Empire was still in existence. It is no wonder that Mother Teresa was awarded the Nobel Peace Prize in 1979, as the Nobel Prize Foundation's website indicates that she was given the prize: "for her work for bringing help to suffering humanity.'

A Nostalgic Remembrance



Welcome**Dante Christoforo**



Arrived on Earth, Tuesday, September 13th at 12:30 a.m., Dante Christoforo, son of Michael and Kathy Christoforo and grandson of our columnist John Christoforo. When he showed up, he was a week late kicking, screaming and very hungry.

Now I know what Nanna and Babbononno went through babysitting me when I was a kid. Son John's kids, Lina and Nathan stayed over ... she's almost six and he's two and a half, and Loretta and I are OLD!!!

John and Beth had tickets for a Friday night concert at the Leader Bank Pavilion on Northern Ave. in the recently renovated waterfront section of Boston. Needless to say, they couldn't take the kids who go to bed between 7:00 and 8:00 p.m. So, seeing Beth's parents live on the north shore of Long Island in New York, we were asked to babysit. Once they were dropped off and John and Beth's car was out sight, Loretta and I were in charge. Within five minutes, I said to myself, "I'm too old for this." The kids played with every toy they keep at our house plus new ones Loretta just happened to buy before the kids arrived.

When it was dinner time, I thought of taking the kids to a restaurant but "chickened out." When we dine out as a family, John takes care of feeding or helping to feed Nathan while simultaneously teaching him the social graces necessary for restaurant dining.

After Loretta and I decided on staying home, the kids asked for spaghetti and meatballs.

Loretta and Lina made meatballs while I played with Nathan. Once the pasta was cooked and the meatballs had been simmering in a pot of gravy for a while, we sat down to eat. The main course that I've mentioned was preceded, by kiddy requests, to pieces of cheese and prosciutto. The spaghetti and meatballs were followed by fruit and Canoli. Lina ate well. Nathan wore the food well.

After dinner, the kids watched cartoons for a bit and when it was time for bed, Loretta brought them upstairs to what had been their father's bedroom when he was a kid. Finally, by 8:30 p.m. they were sound asleep. By 9:00 p.m., so was Loretta. Twas a long day.

They were up at the crack of dawn, with Nathan riding a horse on wheels and Lina helping Loretta to cook breakfast. They fried bacon and eggs, toasted bagels, and cut up fruit. (Thank God, Loretta made me coffee.) After breakfast, which Lina ate and Nathan wore, we headed to the back vard and played with outside toys for the next couple of hours. Finally by 11:30 a.m., John and Beth arrived to reclaim their kids. (Again, thank God.)

After calm and quiet were established, I started thinking back to the days when I was a kid and Nanna and Babbononno babysat me. When I was Lina's age, it was the middle of WWII. We were living with my grandparents and Dad, being the musician he was, often had to play in New York. If he had to travel there for a weekend, he often took Mom with him and I stayed with my grandparents.

Like my grandchildren who psyched us out ahead of time, I had psyched out Nanna and Babbononno to see what I could get away with. Italian grandparents, historically, are more liberal with grandchildren than are parents. My parents could be strict, and if I didn't obey, Mom owned a wooden spoon that could leave splinters on my backside, OUCH!

On one given weekend back in the day, Dad was playing with a band in New York and Mom went with him. Nanna and Babbononno were in charge of caring for me, and when Babbononno was out, Nanna let me get away with almost anything. Babbononno was out visiting his dentist. His uppers were brand new and hurting him. The visit didn't correct anything, and to ease the pain, my grandfather stopped off at a couple of pubs on the way home. So, by the time he was back at 70 Eutaw Street in East Boston, he wasn't feeling any pain at all.

When he came into the house, the first thing he spotted was me wearing one of Uncle Gino's best custom-made suits which was umpteen sizes too big for a six year old. I had gotten into Uncle Gino's closet and pulled a suit of its hanger and put it on. Babbononno seeing this, yelled at Nanna for letting me get into my uncle's closet while he was in the service fighting in the Pacific. When I heard him yell, I yelled back, "Lascia stare mia nonna." (Leave my grandmother alone.) Babbononno hit the roof, ran into the bathroom, grabbed

his razor strop and came after me. I jumped under the dining room table, came up on the other side and proceeded to nose thumb my grandfather, yelling, "Na-na-ya-na-nah." Babbononno started swearing at me in Italian and spit out his false uppers which flew across the table and hit me on the forehead. He continued swearing without his teeth and what came out was only know by him, no one else.

Nanna was in hysterics, laughing out loud. Babbononno started swinging the razor strop under the table trying to hit me but I scampered out from my safety zone and quickly crawled into a bedroom and rolled under the bed with Babbononno right behind me swinging the strop. Nanna ran to the liquor cabinet, poured her husband a shot of cognac and ran into the bedroom where the first generation in America was trying to injure the third. My grandfather swallowed the cognac and was coaxed back to reality and upper teeth by Nanna who yelled at me to take off Uncle Gino's best suit.

When my folks came home on that Sunday, they asked my grandparents how I was over the weekend. Nanna made it sound like I was bound for sainthood. Babbononno poured himself a shot of cognac, drank it and said nothing. I was saved.

I guess kids, even young kids learn fast what they can get away with and when to stop being fresh, just in case. When son John was a young father, he complained to me about all of the things he had to deal with a new young daughter (before Nathan was born). My answer to him was, "Figlio mio, e tempo di recupero." (My son, it is payback time.) I then started to rehash some of the things his mother and I had to go through when he and his younger brother, Michael, were kids. All John remembered were the days that he and his brother played sports, baseball and basketball. They both were walking (holding on) by six months and running around the house by the time they were nine months. If I remember correctly, their pediatrician did a study on them because of their advanced stages. I wonder if my grandkids will show some of the same traits displayed by their parents who knows!

As the temperatures begin to drop and Fall is just days away, it's the perfect time to warm up with a bowl of Zuppa di Scarole e Fagioli or escarole and beans. This well-known "comfort food" is a longtime favorite of many Italian Americans. It was said to have originated in southern Italy years ago when resources were scarce. Peasants originally created this dish using just wild greens from their fields, water and beans. Today, Zuppa di Scarole e Fagioli is customarily made with escarole and cannellini beans, and the addition of garlic, chili pepper, and grated cheese to flavor. Zuppa di Scarole e Fagioli depicts cucina povera at its finest. It also demonstrates the culinary talents of the old-world Italians as they were able to take just a few available ingredients and make an amazingly delicious and *nutritious meal from them!*

As with most dishes, many Italian families developed their own recipe for Zuppa di Scarole e Fagioli. Some added additional greens, others included pasta and/or broth in theirs, and many chose to add meats such as pancetta, pepperoni or sausage. My Nonna always followed the more traditional recipe she was taught from her mother in Sicily. She used escarole, dry cannellini beans, water, garlic, red chili pepper and parmesan cheese. Hers was simple yet incredibly delectable, especially when served alongside fresh Italian bread. Though I continue to follow my Nonna's recipe, I also add homemade chicken broth to the liquid which I feel gives it a much better flavor. Either way, it's easy to make, full of nutrients, and extremely delicious to eat. Zuppa di Scarole e Fagioli is so comforting; it's like getting a great big hug from your Nonna on a cool crisp day. Buon Appetito!

ESCAROLE and BEAN SOUP

Zuppa di Scarole e Fagioli

2 cups dry cannellini beans (2 15-ounce cans with liquid may be substituted, but are not recommended)

- 8-10 cups water
- ½ cup & 3 tablespoons olive oil
- 4 bay leaves
- 8 cloves garlic
- (2 whole, 6 pressed) 2-3 heads escarole, cleaned, soaked, rinsed well and

chopped 1 tablespoon red chili pepper flakes (more or less to taste) 4-6 cups chicken broth

1 parmesan cheese rind (optional) grated parmesan cheese salt to taste

Place dry beans in a glass container; fill with cool water double the height of the beans. Cover and let soak for about 8 hours. Drain, rinse, and add the beans to a Dutch oven or medium stockpot. Fill with 8-10 cups of water, bay leaves, 2 cloves of garlic, 3 tablespoons olive oil, and bring to a boil. Adjust the heat to retain a simmer and cook until the beans are tender and just under an inch of the liquid remains, approximately 1 ½ hours, or more if needed. Remove bay leaves, discard and remove pan from heat. If using canned beans, empty beans and their liquid in a medium saucepan, add the bay leaves, garlic cloves, and olive oil. Let simmer on very low heat for about 15 minutes, do

In a large stockpot, add ½ cup olive oil, 6 pressed garlic cloves and red chili pepper flakes, cook a few minutes, just until fragrant. Add the escarole and slowly cook until wilted, turning frequently. When cooked, add the beans and their liquid (should be no more than an inch) to this escarole mixture. Add the chicken broth (as much or little as preferred), parmesan rind, and salt to taste. Stir together and simmer on low for about 20-25 minutes. Ladle into serving bowls and serve with fresh Italian bread.



Rest in Peace Earnie Shavers

Hard Hitting Heavyweight Answers His Final Bell



In his prime

With the passing of Earnie Shavers on September 1st, the ranks of exciting heavyweights from the 1970s that still are with us gets smaller. Shavers passed away at the home of one of his daughters in Virginia one day after celebrating his 78th birthday. The cause of death has not been disclosed.

After having an outstanding amateur career culminating in his winning the National AAU Heavyweight title in 1969, Shavers turned pro. He won his first two matches by kayo before dropping a decision to Stan Johnson. He ran off a streak of ten straight knockouts before being put down for the count by Ron Stander in the 5th round in 1970 in Omaha, Nebraska. Over the next three years, Earnie would go undefeated winning 33 fights, 32 knockouts. As he worked his way into contention, he scored wins over former Light Heavyweight Champion Vincente Rondón and former WBA Heavyweight Champion Jimmy Ellis. Rondón was the only opponent to last the distance with him over this period.

The win over Jimmy Ellis put him in line for a fight against top contender Jerry Quarry in 1973. If he could get past Quarry, he would be in position to challenge for the world title. In an explosive fight, Jerry kayoed Shavers in the first round. This was a major setback for the hard punching Shavers. The next couple of years were a mixed bag for Earnie. He struggled to get back into contention. to journeyman Bob Stallings, title.

and fought a draw with Jimmy Young (he had stopped Young in 1973). In 1975, he was knocked out in a brawl with Ron Lyle, a fight where both men visited the canvas.

Again working his way back into contention, he put together wins over Henry Clark, whom he decisioned and then kayoed, and knocked out Roy Williams in the tenth after being down himself in the same round. A knock out over Howard King on April 4, 1977 was enough to earn Shavers a shot at Muhammad Ali and the Heavyweight Crown.

Shavers, who wasn't known for his stamina, not only went the entire fifteen rounds, but along the way hit Ali with some brutal punches. Shavers had Ali badly hurt in the second round but could not put him away. While the champion did enough to win the decision, the horrendous shots he took from Earnie took their toll on him. Many argued that Muhammad should have retired after this

Six months later Earnie took on Larry Holmes. In what was billed as a WBC Title Eliminator, Holmes won a one sided twelve round decision. Larry would go on to win the WBC Title, while Shavers would once again look at fighting his way back into contention.

He won his next four matches with his biggest win being a one round demolition of Ken Norton on March 23, 1979. The win earned him a rematch against In 1974, he dropped a decision Larry Holmes, this time for the a man who was at peace with




A contented Earnie Shavers in retirement

This encounter looked very much like a repeat of their first fight, with Holmes dominating through the first six rounds. Then fireworks exploded in the seventh when Shavers hit Holmes with a devastating overhand right that put the champion flat on his back. Larry arose on wobbly legs and survived the round. In the 8th round, Holmes once again took control and by the 11th round exhausted Shavers was in no condition to continue and the referee stopped the fight.


Earnie Shavers would continue fighting for another eight years but with mixed results. He would never again fight for the Heavyweight Championship. In 1995, he made a brief comeback before calling it quits for good.

After retiring, Earnie became an ordained minister preaching the Gospel in Phoenix, Arizona and then moved to England to pastor a church. He was very popular after his retirement. Known for his kindness and gentle demeanor which was quite the contrast to his explosive punching in the ring. I have never heard anything negative about the man from Warren,

Shavers ended his career with a record of 74 wins, 14 losses, and one draw. An astounding 68 of his wins came by knockout, 23 in the first round, fifty within three rounds. As remarkable as his boxing career was, I get the sense that has true calling was as a messenger of God. By all accounts, he was himself and the world.

It was a somewhat mild and murky morning as we headed into the Hub, on our way to the TD Garden for what is considered to be the opening of the winter sports season on Causeway Street.

It was the annual Hockey East Media Day press conference being held in person for the first time since 2019 — an event that signals the renewed commencement of winter sports activity for major colleges throughout New England.

Boston has a strong maritime history and as we neared North Station, the city seemed to be enveloped in gloom, the fog blotting out a good portion of the skyscrapers that make the metropolitan skyline so distinctive.

But inside at Legends Restaurant the bright lights and atmosphere of renewal that accompanied this resumption and reunion enabled the undertakings to be defined by a bright and sunny tone as coaches, athletic directors and media members all engaged in the September ritual so common to those activities that are based at academic institutions.

"How are you? How have you been? Did you have a good summer?" Such were the questions most often heard, the ones that have echoed down through the years as the late days of August signal summer's closure and the early day of September bring renewed possibilities and rejuvenation.

The off-season was one of change for the Hockey East men, most especially in the immediate Boston area, where new head coaches were named at both Boston University and Boston College.

Thus, "the Battle of Commonwealth Avenue" will feature new faces this season as Jay Pandolfo takes over behind the bench at BU and Greg Brown does the same at BC.

Pandolfo, who was an assistant coach with the Bruins for five seasons, came back to BU last year as an assistant to then head mentor Albie O'Connell. He was promoted to the top job following O'Connell's dismissal last spring.

Pandolfo is a BU alumnus and was captain of the 1995-1996 Terriers. He later played with the Devils, Islanders and Bruins, winning a pair of Stanley Cups with New Jersey in 2000 and 2003.

Greg Brown earned All-America honors at BC and later was an assistant coach under legendary mentor Jerry York for 14 seasons, a span in which the Eagles won three national championships (2008, 2012 and 2012) as well as six Hockey East Tournament titles. Having most recently served as an assistant with the New York Rangers, Brown returned to Chestnut Hill following York's retirement. He now attempts to continue BC's lengthy run of success.

One of the highlights of the season will take place on January 7th as the popular "Frozen Fenway" hockey series returns to Fenway

Coming on the heels of the 2023 NHL Winter Classic between the Bruins and the Pittsburgh Penguins on January 2nd, Hockey East will keep the action going with a men's doubleheader on January 7th. Northeastern will take on UConn at 2:30 p.m. and UMass-Amherst will go against Boston College at 6:00 p.m. Northeastern has been picked by media members as the pre-season favorite to win the Hockey East regular season title.

There will also be a women's doubleheader (date to be announced) with Boston University taking on Holy Cross in one game while the opponents in the second game will be announced later in the fall.

Another highlight will be the annual Beanpot Tournament at the Garden with opening night slated for February 6th when BC will meet Harvard and defending champion BU clashes with Northeastern. The winners will meet in the 70th championship game on February 13th.

Unlike the men's tournament, the women's Beanpot rotates among campus sites. In 2023, the 44th annual event will be held at Boston College with BU facing Northeastern in the first game on opening night (February 7th) and BC meeting defending champion Harvard in the nightcap. The two winners will clash in the championship game on February 14th.

Last year the Northeastern women had an outstanding season, advancing to the Frozen Four where they lost 5-4 to Minnesota-Duluth in double overtime in the national semifinals. In 2021, Northeastern was beaten by Wisconsin, 2-1 in overtime in the national championship game.

The annual Joe Concannon Award was presented to former Hockey East Commissioner Joe Bertagna. He thanked everyone, noting that he was prevented from giving a proper farewell address in 2020 because the annual media day was cancelled by COVID-19 protocols.

The award is given annually to an individual who has demonstrated outstanding work in covering and/or promoting the interests of Hockey East.

Bertagna has spent his life in hockey, playing goal for Arlington High School and Harvard University, followed by a time in the minor leagues with the Milwaukee Admirals. He later served as commissioner of ECAC Hockey for 15 years and then went on to lead Hockey East for 23 additional years.

He is entering his second year as Commissioner of the Eastern Hockey League. He is also the Executive Director of the American Hockey Coaches Association, a position he has held since 1991. In addition, he has run summer hockey camps for the past 46 years, served as the goaltending coach of the Bruins for six years (1985-1991) and the U.S. Olympic team in 1994.

When media members filed out of the Garden at the conclusion of media day, they knew they would return in the middle of March for the annual Hockey East Tournament.

Hockey East commences and concludes every season at the same location. There is a media day press conference at the Garden to open the season and another in March to close the season. That one is the postgame press conference featuring the team that wins the Hockey East Tournament.

What team will that be? The next six months will tell the tale.
