Biden Goes to Queens

On September 7th, President Biden spoke on a scheduled trip to Queens to view the destruction in NY and NJ and to meet with those impacted by Hurricane Ida. However, many in those neighborhoods affected by the heavy rains and massive flooding saw and heard Biden talking about climate control and his costly infrastructure bill sitting in Congress at the moment.

Biden actually stated the first thing he thinks of when he says "climate change" is "JOBS," and his new \$3.5 trillion spending bill. His tone deafness is becoming maddening to many. Procession of Santa Rosalia

in Boston's North End

Santa Rosalia di Palermo Society held their Annual Mass and Procession on Sunday, September 12, 2021 in Boston's North End. The Santa Rosalia Society was formed in Boston in 1939 hailing from Palermo, Italy.

The story of Saint Rosalia

Rosalia was born of a noble family descended from Charlemagne before being led by angels to a solitary life in a cave on Mount Pellegrino where she died alone in 1166. On the cave wall, she wrote, "I, Rosalia, daughter of Sinibald, Lord of Roses, and Quisquina, have taken the resolution to live in this cave for the love of my Lord, Jesus Christ." In 1624, during a plague in Palermo, Rosalia appeared to a sick woman and then to a hunter to whom she directed to find her remains. In a procession of her bones through the city, the plague was lifted. Santa Rosalia is also known as The Little Saint.

THE ETRUSCANS THREE

The three succeeding kings following the death of Ancus Marcius were Etruscans. No explanation is given for this choice of Dynasty except that the powerful Romans had no greater leader in their own race at that time; consequently, they supported Tarquinius Priscus, an Etruscan of Greek ancestry. He was young, ambitious, wealthy, and had come to make his home in Rome some years earlier. This Etruscan supremacy in Rome lasted for about one hundred years and probably no other period in its history has ever been so momentous or fruitful. The three rulers in this royal succession were Lucius Tarquinius Priscus, who ruled for thirty-eight years; his sonin-law, Servius Tallius, whose reign lasted forty years; and Lucius Tarquinius Supurbus who, after twenty-five years of autocratic government, was expelled from Rome.

Within this century of Etruscan domination (616 to 509 B.C.), the world was enriched with four great architectural and engineering works. The first was a great temple to Jupiter (chief of all Roman gods) on the Capitoline Hill. A statue of Jupiter was seated on a gold and ivory throne in one chamber, while another of his wife Juno, goddess of marriage, was shown standing in a second chamber, and still a third statue depicting their daughter Minerva, goddess of wisdom, stood in the third chamber. The second of the four great works was a temple to Diana, the goddess of the moon, the hunt, and virginity (reminiscent of my high school dates). It was built on the Aventine Hill among the humble dwellings of the common people, as a center of worship for all Latin leagues.

The third great work was the Servian Wall, named after Servius Tullius. It enclosed the seven hills and protected Rome for five hundred years. Hannibal, who had come all the way from Africa through Spain, France, and Switzerland for the one purpose of entering Rome, took one look at it and turned away. The fourth great work was the underground system that drained the low ground and the marshes, and also ran off floodwaters to the Tiber. Twenty five hundred years later, this system called the Cloacae is still performing its intended function and serving the needs of a city that has expanded far beyond the comprehension of its designers.

In addition to all of this, the complete civil, political, and military organization of the city is attributed to this short dynasty. It included a form of coinage, a system of weights and measures, a basic or common form of writing, a civil administration, a military force, a form of taxation, and the establishment of political rights for the people.

During the rule of Lucious Tarquinius Priscus, he put to death some of the leading senators, tried many criminal cases himself, and often resorted to excessively harsh penalties. He entered or broke off war, peace, treaties, and alliances to suit himself without consulting the people or the Senate. One after another, his own people were being made to suffer death, exile, or confiscation. His expulsion in 510 B.C. brought an end to the Regal Period of ancient

RMV Announces New Statewide Customer Service Options

21 Service Center Locations Will Offer Appointments, Walk-Ins, and Business-to-Business Services Beginning September 20th

Senior Citizen Advocacy Groups Will Staff Informational Tables at Select Locations

The Massachusetts Registry of Motor Vehicles (RMV) is announcing on Monday, September 20th, it will begin offering a new wider variety of statewide services to provide convenient service options and flexibility and to continue ongoing efforts that have been put in place to keep customers and staff safe. Beginning September 20th, the RMV will be reopening the Attleboro Service Center for in-person services by appointment. In addition, 21 statewide Service Center locations will offer appointments for in-person vehicle and driver services, walk-in visits, and Business-to-Business (B2B) needs. The B2B locations process bulk transactions for auto dealers and insurance agents including new registration and titles, registration transfers and renewals, address changes, and cancellations.

The new and expanded customer service options will be as

- · Appointments for driver's license, identification and vehicle transactions, Businessto-Business Center bulk transactions, and walk-in services will be available as of September 20th at the following 21 Service Center locations: Braintree, Brockton, Danvers, Easthampton, Greenfield, Fall River, Haverhill, Haymarket, Lawrence, Leominster, Milford, New Bedford, Pittsfield, Plymouth, Revere, Springfield, South Yarmouth, Taunton, Watertown, Wilmington, and Worcester.
- · Customers are strongly encouraged to go online to schedule available in-person appointments at statewide Service Centers. Customers, if needed, are welcome to conduct walk-in transactions during early morning or late afternoon hours, but are advised they will be served after customers with prescheduled in-person appointments. Customers without appointments may have to either wait until assistance can be offered or return to a center on another date. A scheduled appointment will save time and provide flexibility and convenience.
- will offer only Business-to Business services.

- · Business-to-Business services will not be available at Service Center locations in Attleboro, Lowell, Martha's Vineyard, Nantucket, and Southbridge.
- Starting September 20th, individual registration dropoff services which temporarily replaced Business-to-Business in-person services during the State of Emergency will no longer be available at RMV Service Centers.

RMV customers who are members of AAA are able to perform many RMV transactions by appointment at their local AAA office.

The RMV is also pleased to announce that during the month of September, senior citizen advocacy groups will be on-site at select RMV locations to help provide information and support to seniors who are conducting in-person transactions during the scheduled senior hours that are held on Wednesday mornings. MAY 8, 1936 - SEPTEMBER 10, 2021


Jerry Maffeo, 85, of Melrose, passed away peacefully on September 10, 2021.

Of Harvest and Balance on the Equinox

After a stifling hot summer, during which even five-minute walks in the sweltering sun immediately drove me back to the air-conditioned interiors of my home, I was relieved when one morning dawned overcast and cool. Finally, the smell of September — that wonderful month when the leaves begin to blush with shades of red and gold, and chilly nights creep in cat-like with their early darkness — permeated the air. Wherever I turn my head, it seems, signs of autumn wink at me playfully, announcing the presence of the season with a crisp and snappy flair. Juicy apples lent their tartness to an old-fashioned crisp I baked for my family not too long ago. Scarecrows smile from store shelves, their broad grins and crackly hair joyfully heralding the feasts to come. Leaves shine in the slick pavement after a rainfall. There will even soon be a carton of iced pumpkin spice coffee sitting in my refrigerator, waiting for me to enjoy its creamy goodness. These hallmarks of fall intensify as we near the autumn equinox, which this year occurs on Wednesday, September 22nd. This equinox embodies the rhythm that pulses throughout the fall, its measured dance of harvest and community and interplay between light and dark. Indeed, the autumn equinox is celebrated throughout the world, including Italy, as a seasonal marker and as a significant date in which people honor the generosity of the Earth.

The autumn equinox falls about halfway between the summer and winter solstices, and as such is used to indicate the passage of time. While some

people may mourn the end of the astronomical summer and its idyllic, carefree nature, it is important to look at the autumn equinox as an opportunity to begin anew. The return to work and school fills the air with a sense of purpose and organization, a feeling that will guide us as the cadence of autumn eventually dissipates into the jollity of the holidays. Since autumn brims with renewal, it is little wonder that many cultures begin their new year around the equinox. One such example is Rosh Hashanah, the Jewish New Year, which began on the evening of September 6th this year and is celebrated with meals of apples and honey to ensure the sweetness of the upcoming year. However, the equinox also signifies another important time change: while the day of the equinox consists of equal hours of day and night, after this date the darkness will overwhelm the light. The darkness beckons me indoors, to cozy evenings spent with my family and friends as our stories and laughter form a barrier against the dim night. I may even spend the early nights alone baking with the abundant produce of autumn, filling my kitchen with warm and spicy scents. The equinox affords us opportunities to reconnect with our families and our deepest selves, to devote time to projects and hobbies and take pleasure in the spirit of the season, which is at once both communal and introspective.

In addition to the turning of time, the autumn equinox is also a wonderful time to pay homage to the bounty of the Earth. In Europe, the last collection of harvest takes place around the time of the equinox.

the land in a primarily agricultural society, may have waited until the Harvest Moon to finish harvesting their crops. The Harvest Moon, or the full moon closest to the equinox, illuminated the fields sufficiently so that farmers could work well into the night. This year, the Harvest Moon occurs on September 20th, and as usual I will celebrate the occasion by baking my appropriatelynamed Harvest Moon cookies, or almond cookies half-dipped in melted chocolate. As the harvest ended in Europe, many cultures would ritualistically cut the last sheaf of grain, a practice which stems from ancient times, when people believed that the goddess of the grain was embodied in the final remaining bundle. It was then time for cozy feasts known as "Harvest Home," which still exist to this day and can be seen in the harvest fairs that dot event calendars throughout the fall. For Harvest Home, the community gathers together at tables laden with the foods of autumn — apples, pumpkins, pears, carrots, nuts, ginger, spices - and celebrate the generosity of the land and the fruits of their labors. In Italy, these kinds of feasts often take the form of sagre. Derived from the Latin word "sacrum," which also lends itself to the English word "sacred," sagre are festivals devoted to a specific crop or product. Italians love their sagre, and the various regions of Italy each have feasts that honor a local delicacy. Villages in Northern Italy, for example, may host sagre di mele — apple festivals — while Southern Italians often honor grapes in their sagre di uve. No matter what autumnal staple is being celebrated, these European feasts remind us that good food, a strong sense of community, and the love of family are sacred treasures indeed.

This equinox, let's bring back a sense of balance and purpose to our lives by enjoying the season. Rather than bemoan the darkness, we can welcome it by resolving to use nighttime as an opportunity to do something that makes us happy - whether it involves spending extra time with our families and friends or crafting some alone time in which we may develop our interests and hobbies. We can honor the bounty of the Earth by enjoying the fruits of all and truly relishing them, slowly biting into a tart and juicy apple and inhaling the spicy scent of a cinnamon-flecked cider. Moreover, we can spread the love of the Earth by donating our time or our food to those less fortunate. Let us carry the lessons of the equinox to our heart, and then the pleasures of fall will always have a home — a harvest home, if you will — inside our souls.

STANDING TOGETHER AND NEVER FORGETTING 9/11

I still remember Tuesday, September 11, 2001. I stood outside a polling precinct in North Quincy next to the Sacred Heart School Hall. I recall it was a great looking late summer day with sunny blue skies and then everything that we considered "normal" changed in moments at 8:46 a.m. when five hijackers crashed American Airlines Flight 11 into the North Tower of the World Trade Center.

We were only beginning to see the reality of what this day had in store for us. Another five hijackers at 9:03 a.m. crashed Flight 175 into the South Tower. This flight, like the first, departed from Logan Airport.

It was then that a sense of panic hit us all. The unthinkable had happened on American soil. Many who were holding political signs just wanted to run home and seemingly hid or glued themselves to TV screens. However, most of us stayed on duty outside the polling precinct because if we just ran away, those hijackers would win the day.

I remember running to the nearest Blockbuster in Wollaston Center, as every screen inside the store showed those same ugly images repeatedly. I can't speak for others, but I was in a sensory overload.

Even remembering these events on the 20th anniversary left me shaky and all those images came flowing back inside my head.

On this 20th anniversary, all who witnessed that day will remember those we lost, those who survived, and the families whose courage and bravery remind us: **NEVER FORGET**.







Sheriff's Department Warns Of Ongoing Telephone Scam



The Suffolk County Sheriff's Department is warning citizens of a telephone scam involving people falsely claiming to work for the Department's Civil Process Division.

In this scam, the callers tell victims that they owe money and must pay the Department or risk imprisonment. When the victim calls the number, they are fed into an electronic voice mail tree that appears to represent the Department, listing various offices, divisions and titles that one might find within a law enforcement agency, including a designation for a S.W.A.T. team and a Sheriff, among others.

Victims are then reportedly instructed by the perpetrators to purchase a prepaid credit card from their local drugstore and provide the card number or numbers to the scammer via telephone. In some cases, the scammers told their victims to deliver the cards to the JFK Federal Building at One Courthouse Plaza, and in past scams, victims have also been told to deliver the card or cards

in person to what is the official address of the Civil Process Division at 132 Portland Street in an effort to convince the victim that the caller is an official representative of the Division or Department. There may be numerous other locations that the scammers are telling their victims to meet them to deliver the money.

The Department wants to emphatically reiterate that it does not call to collect money and, if anyone should receive a call resembling the examples given above, they are advised not to give out any personal information and to call their local police department to report the caller. Above all, they should not, under any circumstances, take out money and go to meet these callers at any location.





Junipero Serra, Pioneer, Missionary, Saint by Agnes Repplier

undeveloped Mexican controlled territory but also the beginning of the areas settlement cannot be overstated. Indeed, Cluny Media LL.C has recently published a biography about Fr. Junipero Serra by Agnes Repplier, and edited by Jeremy Beer, that not only gives credence to the Franciscan's tenacity in spreading the Gospel to California's many native

Junipero Serra, Friar

Junipero Serra to be precise,

was instrumental to the establishment of Roman

Catholicism in California

during the Eighteenth

century. Father Serra's

contribution to not only

the proselytization of many

of the native Americans

who inhabited the vast

inhabitants but considers how California's land was settled via the formation of the "Mission system." Truly, an effective, albeit precarious method of creating a series of churches (built from 1769 to 1833) from what is now San Diego to San Francisco. There were 21 Missions and each, although some more successful than others, were quasi self-sufficient installations that provided space for worship, growing and fostering agriculture and dispensing the sacraments. Of course, instruction on the Catholic faith was paramount and justified its blessing from not only the Spanish Church but the Mexican government itself - located far south in Mexico City.

A daunting task indeed, given the distance — the "Mission system" began (and lasted 65 years before the secularization of the Missions) with Serra's journey from Baja (lower) California and traveling north through Alta (Upper) California ultimately reaching San Francisco. In the course of these difficult but, (what one would ascertain based on Repplier's biography,) very rewarding life.

One will find by reading this concise and well written historical biography, (with just under 200 pages) that with an aggravating leg ulceration, increasing frailty and often struggle in a land that was not always hospitable with natural terrain or inhabitants, somehow did not deter Serra from fulfilling his service to the Church. Certainly one thinks as his difficulties do not abate in his quest to bring the native population to Christianity, how could he endure such problems. Repplier's coverage of Junipero

Serra, the man — and more importantly, the priest, will give the discerning reader the answer.

This well researched work consists of 16 chapters. For the student of history, the "Mission system" background, with respect the physical layout of the complex is quite interesting; also, for those who have an interest in the settlement of California by Mexico -(relative to the concern that should the Spanish not settle California, other more covetous powers might!) this book addresses this issue. Also, one must also realize that since the Mexican government had an interest in California's settlement, the "Mission system" was not without protection as there were

Presidios established for the protection of the Missions military installations staffed by soldiers to help insure that hostile elements would be curtailed. Repplier addresses writes cogently and descriptively of this unfortunate historical fact - nonetheless, one must also realize that California was settled and its Spanish heritage has been long lasting.

Junipero Serra, with subtitle Pioneer, Missionary, Saint, is an informative narrative, and historically interesting — not only regarding the life of Serra and in his desire to convert California's native population to the Church, but also how such a man could be so effective in making such an impact in such a large land.

Saint Lawrence Giustiniani

Born to the Giustiniani family, a noble Venetian family, which includes several saints, Lawrence ancestors had fled Constantinople for political reasons. The piety of his mother seems to have served as an inspiration for his own spirituality. Against his widowed mother's wishes, he chose to enter religious life.

In 1404, after he had been ordained a deacon, at the suggestion of an uncle who was a priest, Giustiniani joined a community of canons regular following a monastic form of life on the island of San Giorgio in Alga. He was respected by his brethren for his poverty, mortification, and fervency of prayer and chosen to be the first prior of the community. The community followed the Rule of St. Augustine. He was ordained a priest in 1407.

In 1433, Pope Eugene IV named Gustiniani as the Bishop of Castello. His administration was marked by considerable growth and reform. The new prelate restored churches, established new parishes in Venice, aided the foundation of convents, and reformed the life of the canons. Gustiniani above. all was noted for his Christian charity and his liberality. All the money he could raise he gave to the poor, while he himself led a life of simplicity and poverty. He was greatly respected in both Italy and elsewhere by the dignitaries of both Church and State. He tried to foster the religious life by his sermons as well as by his writings.

A Nostalgic Remembrance



Like most men in the first generation of Italians to come here, Babbononno was concerned about his sons succeeding once they were out of school. To my grandfather, a man with a trade could earn his way through life and be considered successful, a man of respect, and so, he made sure all of his sons learned trades. For the Contini family, the trade was music. Higher education was a couple of generations down the road.

Babbononno learned early on that his sons had no interest in one of his trades, cabinet making. Babbononno made furniture most of his life working with hand tools he learned to use under the watchful eyes of the priests at his school in Foggia. (Hand tools because electricity hadn't yet hit Foggia in the late 1800s) His sons, my uncles Paul, Nick and Gino, readily accepted their father's other passion, music. All learned to play instruments. Uncles Paul and Nick learned clarinet from a teacher, and later, alto and tenor sax from another, then on their own. Uncle Gino learned drums from his father.

Babbononno wanted his sons to play classical or symphonic music, but had to accept the fact that all three opted for the music of the day. Uncle Paul had a passion for Dixieland, the music of New Orleans. Uncle Nick became quite proficient at playing the dance music of the post World War I era, and Uncle Gino played drums for pick-up bands that catered to weddings, Italian parties of all types, Christenings and holiday get-togethers.

After high school, Uncle Paul went into the printing business by day and music became his sideline. Uncle Gino, after high school, went to work at the Chelsea Navy Yard, and like his oldest brother, used music as a

Uncle Nick wanted only music and would stay with performing and union politics for the rest of his career. He became one of the most sought after tenor sax players in Boston during its heyday as an east coast entertainment center. During WWII, he joined the Navy, auditioned for the Andre Kostelanetz Orchestra stationed at the Newport, Rhode Island Naval Base and made it to the sax section of the unit, playing with them until his discharge in 1946. (I was always closer to him than any of my other uncles due to the fact that he was my Godfather.)

Uncle Paul was too old to serve in the war but continued with his printing trade and playing at night until he was in his 80s. Uncle Gino would eventually marry Aunt Ninna, a flamenco dancer from New York, and after they were married, they made a decision that both would give up the entertainment business. He would never play the drums again. However, he was very successful in sales, especially within the liquor business.

Uncle Nick had a double header, one Saturday back in the early thirties. He invited the band's bass player to come home with him for dinner before they headed for the second job. John DeCristoforo, (Johnny Christie) the bass player, met Nick's sister, Angelina, at dinner. Anne, as she preferred to be called and John immediately hit it off and they began dating. Babbononno approved seeing John was a musician. They actually dated for three years and were married on October 25, 1936. Two years later, I showed up and was named John Jr. I later discovered that the reason my folks dated for three years was that, like Uncle Nick, Dad was on the road with swing bands during the big band era. Once he and Mom were married, Dad got off the road and settled down playing with local bands at Boston's nightclubs and Chinese restaurants, all of whom had live music back in the day.

Once WWII began, Dad opted for a day job. He began a daytime career teaching in the Boston Public Schools. He wanted to get his foot in something more secure than music before he was drafted. With two incomes, I grew up in a comfortable situation. Dad was never drafted. He was recruited by the OSS, forerunner to today's CIA, to interrogate Italian war prisoners housed at forts on Boston Harbor Islands and at the long closed East Boston Immigration Station. He worked at this after the school day ended and avoided the draft as a result. Once the war ended, knowing the music scene was changing, Dad became a pioneer in the Department of Audio/Visual Education and stayed with the Boston Schools for the rest of his daytime career. At night, he now played something called "club dates." They were onenighters and he could pick and choose if and when he wanted to work.

Being the grandson, son and Godson of musicians, I didn't stand a chance. Babbononno taught me to read music while I was still in short pants. I tried almost every instrument and rejected most everything until I was in my mid-teens. When I

finally decided on bass violin, Dad taught me his instrument and taught me well. At age 18, I turned professional and since then have played everything from symphony to soul.

Both sons, John and Michael, play guitar (one of Babbononno's instruments) for their own amusement. They won't go beyond the journeymen levels, but they constitute the 4th generation of musicians in my family, something I'm very proud of. It's their world now. I'm part of the past as were my parents a generation before them, with Nanna and Babbononno's generation before them ... ad infinitum. My sons know that I have a rehearsal group I play with in Florida and want to know if we will ever let the public hear us. My answer is always, "We'll be ready to go on stage in the spring of 2083, on a Tuesday." I think they get the general idea.

It's progressive. Babbononno didn't understand the music his sons played. He was born in 1875, and by the time he was ten years old, had learned the music of his day, playing guitar with a pop band and drums and tympani with symphonic and marching orchestras. His sons and son-in-law (Dad) played the music of their day, Dixieland, swing and the pop music of the '20s, '30s, '40s and '50s.

I learned their music, but my day was late '50s to about 2000. Playing with dance bands, I learned many of the rock and roll tunes of the day, but it wasn't the same as if it was played by someone of a younger generation. The beat goes on ... Sorry Babbononno.

Fall is almost here and pumpkins are starting to show up just about everywhere! Americans are beyond obsessed with these orange-colored gourds. Aside from carving them and roasting their seeds, Americans will consume almost anything that is pumpkin flavored. They especially enjoy pumpkin lattes, pies and all sorts of desserts. Italians also enjoy pumpkins, however, when it comes to cuisine, they prefer to eat pumpkin on the savory side. Rarely will you ever find pumpkin used to make a dessert in Italy. Though, you will see it in a variety of savory dishes such as Tortelli di Zucca, Gnocchi di Zucca, and Risotto alla Zucca.

When in season, my Nonna would take fresh pumpkins, roast them, and then use the pureed flesh to make an array of delightful dishes and desserts. I loved her pumpkin gnocchi, and the pumpkin bread she made in a coffee can was absolutely amazing. One of my all-time favorite pumpkin dessert recipes was "Pumpkin Pie Squares". This recipe was given to my Nonna many years ago, from one of her friends. These layered squares consist of a brown sugar and oat crust, creamy pumpkin pie center, and they are topped with a crumbly pecan streusel topping. They are extremely easy to make and absolutely delicious to eat. If you like American Pumpkin Pie, you are going to absolutely love my Nonna's Pumpkin Pie Squares. They are a perfect Fall dessert when served plain, with a dollop of fresh whipped cream, or even alongside of a scoop of vanilla bean gelato!

PUMPKIN PIE SQUARES Piazze di Torta di Zucca



Crust:

1 cup all-purpose flour

½ cup rolled oats

½ cup firmly packed brown sugar

½ cup butter, room temperature

Filling:

3/4 cup sugar

pumpkin

15 ounce can organic pure

13 ounce can evaporated milk

2 eggs

1 teaspoon cinnamon ½ teaspoon salt

½ teaspoon ginger

1/4 teaspoon ground cloves

Topping:

½ cup firmly packed brown sugar

½ cup chopped pecans

2 tablespoons butter Preheat oven to 350°. Mix crust ingredients until crumbly. Press

into bottom of ungreased 13 x 9-inch pan. Bake 15 minutes. Beat filling ingredients at medium speed, until smooth. Pour

over crust and bake for 20 minutes. Mix topping ingredients until crumbly, sprinkle evenly over fill-

ing, then bake 25-30 minutes more or until slightly firm to touch. Cool well (best when refrigerated for several hours) then cut into 2-inch squares. Refrigerate leftovers.



Help for Weather-stressed Lawns

The extreme heat and drought of 2021 across much of the country has turned many lawns brown. Damaged lawns may be thin, contain dead patches or are overrun with weeds.

Fall is a good time to improve the health and appearance of a weather-worn lawn. Start the process by evaluating the damage. Then plan a course of action and be prepared to follow through as needed with proper

Fall fertilization can help improve thin lawns and those with numerous small dead patches the size of a baseball or smaller. Apply fertilizer in early September to help lawns recover from summer stress while encouraging denser growth and deeper, more drought tolerant roots. Those in warmer climates growing grasses like centipede, Bermuda and zoysia should make sure the last fall application is at least one month prior to the average first killing frost. Use a low nitrogen, slowrelease fertilizer that won't harm stressed lawns and young seedlings if repairing or over seeding the lawn.

Continue to mow high as long as the grass continues to grow. Taller grass produces deeper, more drought tolerant roots. Mow often, removing only a third of the total height. This is less stressful on the lawn and results in shorter clippings that can be left on the lawn. The clippings return moisture, nutrients, and organic matter to the soil.

Use a sharp blade for a cleaner cut that closes more quickly, reducing water consumption and risk of insects and disease while leaving the lawn looking its best. You'll also save time as sharp blades cut more efficiently and reduce fuel consumption by as much as 22%.

Improving a lawn's growing conditions will help it recover more quickly and equip it to better manage environmental

stress. Core aerate lawns that have more than one half an inch of thatch, those growing in compacted soils, or before over seeding. By removing plugs of soil, you will break through the thatch and create channels for water and fertilizer to reach the grass roots. For best results. core aerate the lawn when it's actively growing; fall for cool season grasses and spring or early summer for warm season

Hand removal of weeds is the most environmentally friendly option. Organic broadleaf weed killers with the active ingredient Fehedta or Hedta is another option. Spot treat problem areas to minimize the use of chemicals and reduce the stress on already stressed lawns. As always, read and follow label directions carefully whether using traditional, natural or organic chemicals.

Repair dead and bare patches in cool season lawns that are the size of a soccer ball or larger as needed. Those growing warm season grasses will have the best results when seeding in spring through early summer. Rake away dead grass and debris roughening and exposing the soil below. Spread grass seed over the area and lightly rake to ensure seed-to-soil contact. Or mix a handful of grass seed in a bucket of compost or potting mix. The organic matter helps conserve moisture and promotes seed sprouting. Spread the mix over the soil surface. Water these areas often enough to keep the soil surface moist until the grass seed sprouts. As grass begins to grow, water more deeply and less often to encourage a robust drought tolerant root system.

Proper maintenance and a bit of cooperation from nature will help transform your lawn from a disappointment to an asset in your landscape.





HOOPS and HOCKEY in the HUB

Nearly every nation that fields a team in the Olympic tournament will have at least some NHL players, with Team USA and Team Canada most likely having rosters comprised entirely of players from the league.

This means that the original schedule released to the public over the summer will be the one that is followed over the course of the 2021-2022 NHL regular season. Essentially, all teams will play about 60 percent of their games between Opening Night in the middle of October and early February before taking a three-week break for the Festival of the Five Rings.

For the Bruins that means they will play a total of 49 games before entering the Olympic Break — starting with the season opener against Dallas at the Garden on October $16^{\rm th}$ and extending through a February $1^{\rm st}$ matchup with Seattle on Causeway Street.

Following the Olympics, the Bruins will resume league action at Seattle on February $24^{\rm th}$ and continue with contests through April $29^{\rm th}$ when the regular season concludes at Toronto.

There is one caveat and it is the one that all segments of society have been struggling with since March 2020. According to the official NHL website: "The agreement allows for the possibility of a later decision to withdraw in the event evolving COVID conditions are deemed by the NHL/NHLPA to render participation by NHL players to be impractical or unsafe."

This means that the NHL could decide to withdraw from the Winter Olympics at some point between now and early January. It does not mean the games would be cancelled. It simply means that NHL players would not participate.

By the way, the American Hockey League, which includes the Bruins' top minor league affiliate in Providence plus three additional New England based teams (Springfield, Hartford, and Bridgeport), will not observe a break during the Olympics.

Providence will open its regular season by hosting Bridgeport on October 16th and conclude its 72-game schedule (36 home games, 36 road games) with a contest at Springfield on April 24th. Several home games are scheduled during the Olympic Break, giving those who have a "hankering for hockey" the opportunity to see some possible future heroes of the Hub in action.

ALL HANDS ON DECK FOR HALL — He's been with Boston only briefly but in that span has given the Bruins a boost.

Joining the Black and Gold back on April 11th after being acquired from Buffalo, Taylor Hall proceeded to score eight goals and assist on six others in the 16 regular season games he played for the B's.

Now, he's on schedule to reach an NHL milestone by posting his 600th career point, quite possibly during the first few games of the 2021-2022 campaign. That's because he will enter the opening matchup with Dallas with a total of 596 points (goals plus assists) to his credit. While he could possibly reach the threshold that night, it is more likely that will come a bit later.

Still, although numerous players have reached that career output over the decades (Hall is currently 40th on the list of active NHL point leaders), it is still quite an accomplishment.

Causeway Street must have seemed like a paradise for him after leaving the Sabres, who finished the 2020-2021 pandemic-delayed season in last place. It was such a good feeling that he signed a \$24 million contract extension with the Bruins over the summer.

Thus, the management of the B's believe that the former number one pick overall in the 2010 NHL Draft still has some productive years ahead of him. Now entering his $12^{\rm th}$ season in the league, he certainly has had some prolific campaigns.

He had an 87-point effort during the 2012-2013 season split between Edmonton and minor league affiliate Oklahoma City followed by an 80-point output exclusively with the Oilers the following year. His best came in 2017-2018 when he went 39-54-93 in his second season with New Jersey, en route to winning the Hart Trophy (regular season MVP). Time later spent with Arizona and Buffalo led to performances below his norm.

Now that he's with the B's, however, one significant aspect needs to be worked out. Hall's point production with the Bruins late last spring came as a left winger on center David Krejci's line.

Over the summer the 15-year Bruins mainstay, who never played for another NHL team, announced that he was leaving the Hub to return to his native nation, the Czech Republic. Now 35, he signed a one-year deal in early August to play with HC Olomouc of the ELH. He scored his first goal in his debut game with HCO on September 10th.

With Krejci gone, it remains to be seen how productive Hall will be following the change. Remember, the biggest change for Hall in recent years was leaving a weak Buffalo team and being brought aboard a club that has been a playoff contender. In the 10 seasons (before Hall joined the team) the B's won a Stanley Cup, reached the final round on two additional occasions and participated in the playoffs five other times. Thus, what line he will be on (and who will be centering it) are crucial matters as training camp gets under way.

The Oilers never qualified for the playoffs in the six years Hall was with them. He has participated in the playoffs just twice — once with New Jersey and once with Arizona. Both resulted in first round eliminations.

Thus Hall has the opportunity to rejuvenate his career while working towards a rewarding playoff experience here in the Hub.
