# October as Italian Heritage Month Begins with Mass at St. Leonard Church Sunday, September 30<sup>th</sup>

Italians and Italian Americans all Over the Commonwealth
Celebrate October as Italian Heritage Month

This year, the Society of St. Joseph will open October as Italian Heritage Month with Mass celebrated by Cardinal Sean O'Malley on Sunday. September 30th at noon at St. Leonard of Port Maurice Church. Attending the Mass will be Governor Charlie Baker, Lt. Gov. Karyn Polito, Speaker of the House Robert De Leo, and members of the Italian American Legislative Caucus which number more than 48 state representatives and senators of Italian lineage. Several former Speakers of the House and members of the judiciary are also expected to be present along with the officers and members of the Italian American Alliance and other Italian and Italian American organizations. Also expected to attend will be the new Consul General of Italy, the Honorable Federica Sereni, as well as key members of her staff. The Mass will be preceded by an Honor Guard by sailors stationed on the USS Constitution

Dignitaries of the various organizations and public officials will parade up and down Hanover Street following the Mass to greet residents and visitors to the North End.

The lodges of the Sons and Daughter of Italy hold open houses and sponsor everything from masquerade balls to spaghetti dinners in a flurry of activities all over the state. The Federation of Italian Organizations also sponsors programs featuring Italian music and culture which are open to the public. The Columbus Day parade in East Boston and the annual Columbus Day Program in Cambridge have all become a standard part of the holiday which is now observed throughout the entire month.

Columbus Day is a central part of Italian heri-

tage and has become particularly significant over the past few years in the face of hostility towards Columbus. His antagonists blame Columbus for introducing slavery to the New World and for allegedly introducing European diseases which caused the deaths of indigenous natives. However, more recent findings dispute these claims and many Italian and Italian Americans, themselves the object of harsh discrimination, believe that the anti-Columbus movement is actually a more modern method of continuing discrimination against Italians and Italian Americans by attacking Italian heritage in which Christopher Columbus is a central figure.

# Stirpe Nostra

### **SUMMER OPERA**

Just a "saltellare, saltellare, e saltare" (hop, skip and jump) behind the famous Roman Colosseum is the well known "Via delle Termine di Caracalla" which skirts the famous seventeen-hundred-year-old bathtub. During the Months of July and August, natives and tourists alike vie for a seat at the opera, magnificently staged under the stars amidst the ruins of this once majestic structure. It was named for Aurelius Antonius Bassianus Caracalla, the eldest son of Emperor Septimius Severus.

Caracalla was born at Lugdunum (Lyons) France in 188 A.D. and was appointed to be his father's co-ruler at the age of thirteen. It is said that even at this tender age, his treacherous nature was revealed through his attempt to murder his father. Severus died in 211 A.D. and was succeeded by his two sons, Geta and Caracalla. They hated each other from early childhood and an attempt to divide the empire between them met with great opposition so Caracalla resolved to get rid of his brother by assassination. After several unsuccessful attempts, Geta was eventually stabbed while seeking protection in his mother's arms.

Caracalla bribed the Praetorian Guard to proclaim himself emperor and to declare Geta an enemy of the State. Any persons who had been connected or associated with Geta including

their children were executed. One historian estimated the number of executions to be at least 20,000.

Caracalla maintained his popularity with the soldiers by showering expensive gifts upon them and by pay raises which exceeded 280 million sesterces a year (about 14 million dollars). It is also said that his cruelty and contempt for the people was equal to that of Caligula and Nero. His greed for more money caused him to grant citizenship to all freemen of Rome and then to send them a tax bill.

His greatest folly was in his admiration for Alexander the Great. From the time of his early childhood, Caracalla admired Alexander and imitated him wherever and whenever possible. He even organized a Macedonian-style infantry unit of 16,000 men who were all born in that ancient kingdom and commanded by officers who

were given the same names as those who had served under Alexander. He treated the memory of Achilles with the same kind of veneration, even to the point of poisoning his favorite freedman so that he could imitate Achilles in his grief for Patrocles, the great warrior.

His conduct during wars with other nations revealed his cruel and treacherous nature. He called together the young men of one Germanic tribe as if to reward them and then had them surrounded and butchered by his troops. Friendly kings were invited to his camp, then put in chains and their estates confiscated.

Caracalla offended a Prefect of the Praetorian Guard and was assassinated at Edessa, a city in ancient Mesopotamia, in 217 A.D. after a degrading reign of slightly more than six years.

What seems to be most remarkable about this emperor are the great monuments which he left behind and which characterize the nature of his lavish expenditures. The first of these great monuments is now in ruinous condition and, of course, we know it as "The Baths of Caracalla." The second monument is the triumphal arch dedicated to his father Septimius Severus and which still stands majestically at one end of the Forum Romanum.

# Another Scotus Confirmation Put into Question

# CITY OF BOSTON LAUNCHES EARLY VOTING WEBSITE AND SCHEDULE

"Vote Early Boston" Website
Will Help Voters Find Early Voting Locations

Boston election officials recently launched the "Vote Early Boston" website (boston. gov/early-voting) which provides voters with important information about the City of Boston's early voting initiative. "Vote Early Boston" begins Monday, October 22<sup>nd</sup>, and runs through Friday, November 2<sup>nd</sup>. During that time, registered Boston voters will be able to cast their ballots for the November 6<sup>th</sup> Election, at any early voting location.

"Ensuring all Boston voters are able to vote conveniently, and on their own schedule, is paramount to ensuring voter turnout," said Mayor Martin J. Walsh. "We have seen in past years the success of early voting, and I am proud that we'll be able to offer this resource again to our residents, in addition to all the other resources the City provides during election season."

"The City has gone above and beyond again by offering Boston voters many different options for early voting," said Pam Wilmot, Executive Director of Common Cause Massachusetts, a nonpartisan organization that led the campaign to enact early voting in 2014. "The many different days, locations, and hours will making voting more convenient and accessible for Boston residents and will facilitate participation while reducing long lines on election day. It's a great plan."

Unlike Absentee Voting, no reason is needed to vote early. Any Boston voter who wishes to vote early may at any early voting location.


During the early voting period, City Hall will be Boston's main early voting site, with voting daily during normal business hours (9:00 am to 5:00 pm) on Mondays, Wednesdays, and Fridays. On Tuesdays and Thursdays, City Hall will also be open until 8:00 pm for early voting.

Early voting neighborhood "pop up" polling locations will also be available throughout the city on Tuesdays and Thursdays, from 12:00 pm until 8:00 pm, during the early voting period.

"Early Voting Weekend" will occur on Saturday, October 27th and Sunday October 28th; there will be nine early voting locations - one in each City Council District - open on both days from 10:00 am to 6:00 pm. A multi-channel outreach campaign in several languages will be used to inform Boston Voters about Vote Early Boston 2018.

### CHRISTOPHER COLUMBUS PART 5

# The Columbus of History

The revisionists have said that 1992 should not be a time for celebration at all, but rather "repentance" for a great historical crime. These people see Columbus as a monster akin to Hitler, having been responsible for an invasion and colonization with legalized occupation, and a deep level of institutional racism, genocide, economic exploitation, and moral decadence. Others are telling us that what Columbus did is not properly described as a discovery, not even an event that should be honored. Did your ancestors make a mistake when they put up statues across the nation and honored him each October?

Let us begin by properly defining the word "discovery." A discovery is made when an individual or a nation finds something, someone, or some people or places of special importance which were not previously known to them. Indeed, when any previously unknown people are first found by other people, that people may be said to have been discovered. So much for the argument that Columbus cannot rightly be said to have discovered America because there were already people in America when he reached it. In all of history, only the Europeans and the Polynesians of the South Pacific have been true discoverers, sailing for the explicit purpose of finding new lands, trading with their people, and colonizing them. Columbus was the greatest discover because he accomplished the most against the highest odds. Columbus project striking directly across an unknown ocean, to reach an unknown ocean, to reach an unknown shore was unprecedented, unique in Europe in his time. Nothing like it had ever been imagined or tried before. It is for the boldness of his conception and his magnificent courage in laying his life on the line to carry it out Christopher Columbus is most rightly honored.

It is grossly unfair to judge Columbus, and grossly erroneous to study the events of his life from the perspective what we know happens to the Indians later, once contact with Europe had been opened up. First, we have to understand the situation that existed in the Caribbean and mid-America when Columbus arrived. One of the most ferocious people in recorded history, the Caribs. They were conquerors who practiced cannibalism, not as an occasional cultic ritual, but as a regular diet. Captured prisoners were immediately eaten. Conquered peoples were systematically devoured. On every island they seized, the Caribs would have exterminated every peaceful Taino if Columbus had not found them. The Aztec in Mexico sacrificed at least 50,000 a year. One out of every five children in Mexico was sacrificed. Read The Last of the Mohicans and you will learn about the injustices various tribes committed against each other. The facts of history totally dispose of the romantic fantasy of a hemisphere full of peaceful, nature-loving Indians who threatened no one until the cruel white man came. Columbus did not always treat the Indians as he should have. Crimes and follies are in the history of every people.

Although claims that "so-and-so got there first" arouse public interest, they are of little concern of the historical. The historian will ask the bottom-line question: What difference did it make? The voyage of Columbus did make a difference, a profound difference.



Bringing the Harvest Home on the Equinox

The autumn equinox falls about halfway between the summer and winter solstices, and as such is used to indicate the passage of time. While some people may mourn the end of the astronomical summer and its idyllic, carefree nature, it is important to look at the autumn equinox as an opportunity to begin anew. The return to work and school fills the air with a sense of purpose and organization, a feeling that will guide us as the cadence of autumn eventually dissipates into the jollity of the holidays. Since autumn brims with renewal, it is little wonder that many cultures begin their new year around the equinox. One such example is Rosh Hashanah, the Jewish New Year, which occurred on September 9<sup>th</sup> this year and is celebrated with meals of apples and honey to ensure the sweetness of the upcoming year. change: while the day of the equinox consists of equal hours of day and night, after this date the darkness will overwhelm the light. The darkness beckons me indoors, to cozy evenings spent with my family and friends as our stories and laughter form a barrier against the dim night. I may even spend the early nights alone baking with the abundant produce of autumn, filling my kitchen with warm and spicy scents. The equinox affords us opportunities to reconnect with our families and our deepest selves, to devote time to projects and hobbies and take pleasures in the spirit of the season, which is at once both communal and introspective.

In addition to the turning of time, the autumn equinox is also a wonderful time to pay homage to the bounty of the Earth. In Europe, the last collection of harvest takes place around the time of the equinox. Our Italian ancestors, living off the land in a primarily agricultural society, may have waited until the Harvest Moon to finish harvesting their crops. The Harvest Moon, or the full moon closest to the equinox, illuminated the fields sufficiently so that farmers could work well into the night. This year, the Harvest Moon occurs on September 24th, and as usual, I will celebrate the occasion by baking my appropriately named Harvest Moon cookies, or almond cookies half-dipped in melted chocolate. As the harvest ended in Europe, many cultures would ritualistically cut the last sheaf of grain, a practice which stems from ancient times, when people believed that the goddess of the grain was embodied in the final remaining bundle. It was then time for cozy feasts known as "Harvest Home," which still exist to this day and can be signifies another important time seen in the harvest fairs that

dot event calendars throughout the fall. For Harvest Home, the community gathers together at tables laden with the foods of autumn — apples, pumpkins, pears, carrots, nuts, ginger, spices — and celebrate the generosity of the land and the fruits of their labors. In Italy, these kinds of feasts often take the form of sagre. Derived from the Latin word "sacrum," which also lends itself to the English word "sacred," sagre are festivals devoted to a specific crop or product. Italians love their sagre, and the various regions of Italy each have feasts that honor a local delicacy. Villages in Northern Italy, for example, may host sagre di mele — apple festivals — while Southern Italians often honor grapes in their sagre di uve. No matter what autumnal staple is being celebrated, these European feasts remind us that good food, a strong sense of community, and the love of family are sacred treasures indeed.

This equinox, let's bring back a sense of balance and purpose to our lives by enjoying the season. Rather than bemoan the darkness, we can welcome it by resolving to use nighttime as an opportunity to do something that makes us happy whether it involves spending extra time with our families and friends or crafting some alone time in which we may develop our interests and hobbies. We can honor the bounty of the Earth by enjoying the fruits of all and truly relishing them, slowly biting into a tart and juicy apple and inhaling the spicy scent of a cinnamonflecked cider. Moreover, we can spread the love of the Earth by donating our time or our food to those less fortunate. Let us carry the lessons of the equinox to our heart, and then the pleasures of fall will always have a home — a harvest home, if you will — inside our souls.

### Never Forget 9/11

I still remember that Tuesday morning back in 2001. It was a late summer day with a blue sky and warm weather, unlike this past Tuesday on the 17th anniversary of our worst day, when our nation was attacked by a band of radical jihadists using our own passenger air-liners against us as missiles.

When the attacks began, I was at a polling site at the Sacred Heart School on Hancock Street in the City of Quincy. I was there with others pushing our candidates to incoming voters. Then, I remember someone ran up with a small radio and told us a plane had crashed into one of the twin towers in New York City. We all thought it was a horrible accident until a few minutes later when she returned to say a second plane did the same thing. I immediately knew it wasn't an accident. We were under attack, but by whom and why?

Almost 3,000 died that Tuesday. Folks on the planes, in the Twin Towers, first responders ... lots of first responders! It seemed like a living nightmare. I can't tell you how many times I watched those two jets crash into the towers, over and over again until I couldn't watch that sight anymore! Then, we heard about the plane that crashed into the Pentagon, and a fourth plane into a field near Shanksville, Pennsylvania.





Magdalena was born in Verona on March 1,1774. Her father was the Marquis Ottavio di Canossa and her mother Teresa Szluha a Hungarian countess.

Wealth and privilege did nothing to prevent Magdalena from following her calling to serve Christ in the poor. Nor did the protests of her relatives, concerned that such work was beneath her. Magdalena knew her mind and followed it. At age 15, she announced she wished to become a nun. After trying out her vocation with the cloistered Carmelites, she realized her desire was to serve the needy without restriction.

As Magdalena matured and with the passing of her father, she assumed the title of Marchioness and became the head of a large household at the family palace at Canossa. She was a leading lady of her time.

When the Napoleonic Wars broke out, the Canossa family took temporary refuge in Venice where Magdalena had a dream in which Our Lady showed her needy girls, poor children and sick people. Upon their return, Magdalena began to work assisting the sick and the wounded, particularly girls and those left abandoned. On several occasions, the young Magdalena hosted Napoleon Bonaparte. Impressed with her dedication, Napoleon granted her an abandoned convent for her work.

# Parla Come Mangi!

(Speak as You Eat!)

This Tuscan recipe comes from the city of Prato. Biscotti di prato or cantuccini also called cantucci o giottini, are a beloved Tuscan sweet specialty. They are baked twice (biscotti) to be very firm and dry. These crisp cookies are traditionally dipped in Vin Santo for dessert. Vin Santo ("Holy wine"), is a dessert wine made from Trebbiano and Malvasia grapes, and is always paired with cantuccini cookies. Although the origin of the name Vin Santo is debated, we can say with certainty that it dates back to the Middle Ages and some say it was the wine used in religious Mass.

### Biscotti di Prato or Cantuccini (Prato biscotti)

1 egg

2 cups almonds, skinned and roasted 4 1/4 cups flour

 $1 \frac{1}{2}$  cup sugar

4 eggs

Grated zest of 2 lemons ½ tsp anise oil or anise extract Butter (to grease the baking sheet)

**Preparation:** chop the almond coarsely and mix with the flour, sugar, eggs, and a pinch of salt in a mixing bowl. Add the lemon zest and anise to taste. Form the dough into long rolls about 1 inch diameter and place on a greased baking sheet. Whisk the egg with a little sugar and brush the rolls with it. Place into a preheated oven and bake, or rather dry, at 250°F for no more than 30 minutes. Cut the rolls into ½ inch thick diagonal slices, and bake these for about another 15 minutes until completely dry. Serve with a small glass of Vin Santo for dipping. Buon appetito!

# Nanna & Babbononno

A Nostalgic Remembrance



I've been asked by a couple of people who have been following my stories over the years, how I wound up in Hollywood. Well, it's a bit complicated, but it amounts to being in the right place at the right time.

In September of 1956, I started my freshman year at Boston State College (now part of U. Mass Boston). The people I met were quite different than my pals from the street corners of East Boston, and to understand them better, I got involved with a lot of the school-based social activities that were at hand. At that time, I fashioned myself as a comedian and did a little standup at college socials. I hadn't, as of yet, turned professional as a musician and this was my baptism into show business, even though it was on an amateur level. I wasn't bad, but there was another freshman who was much better. Bob Blasser. He was good and I convinced myself that I should stick to music, and I did.

A year or so after graduation, I was called by a band leader whom I had never worked for but knew of through the business. He asked me if I was free on a couple of particular dates. I checked my book, saw that they were in the middle of the week, and told the man I was free. He gave me all of the information and said I would be the bass player in the pit band for the Bob Blasser Show.

Evidently, their bass player quit, and the band leader, Frank Martelli, got my name from his trumpet player, Frank Biondo, whom I had known from my Boston State days. When I arrived at the theater where the show was to take place, I had a big hello from Biondo who introduced me to Martelli. Once I met the rest of the musicians, I realized we had all heard of each other through the business, but I had never worked with any of them. Martelli gave me the music for the acts and a verbal walk through for the things Blasser would be doing, and twenty minutes later, the show began.

When Bob Blasser walked on stage, I saw that it was the same comedian I had known at Boston State. Before he began the show, he introduced someone I knew of rather well, Arch I knew, we had a Sunday eve-Bishop Cardinal Cushing. The Cardinal made a short speech to the crowd and after it I knew the reason for the show. It seems that when a young man from one of his parishes was killed in Vietnam, he would put a scholarship together in that serviceman's name, and

kick off the whole thing with a fund raising show. The Cardinal knew of Blasser, due to the fact that after college, Bob joined a seminary hoping to become a priest, but he left the priesthood, headed for show business, and stayed friendly with the Cardinal. The show went off without a hitch. Bob did several minutes of standup and then imitated several radio and TV greats of the day, Jack Benny, George Burns, Red Skelton, and a few others. When he was done, several acts of entertainment followed, hence the earlier hand out of the music which now sat on a stand in front of

George Mann, an Irish tenor, led off the next part of the show, followed by a tap dancer, a doo wop group, Bob Blasser again, and then a jazz selection from the orchestra. After intermission Blasser came down the main isle of the theater with a basset hound on a 20-foot leash. He was dressed in formal attire, like Reggie Van Gleason, one of Jackie Gleason's characters. As the audience roared, we played Melancholy Serenade, the tune that usually introduced this Gleason character. Once he was on the stage, the dog decided to relieve himself, a biological function which had the audience roaring in laughter. In Jackie Gleason's voice, Blasser made a couple of comments regarding the dog's public indiscretion, and the show continued. When it ended, we serenaded the people as they exited the theater. After all the folks were gone, Bob Blasser came over to me and both of us reminisced about our days at Boston State.

The next thing I knew, I was part of the band permanently. Bob had told the leader that we were old friends and he wanted me to stay on and do all of his shows. Well, for the next couple of years, just about all of his shows were during the week and I could do them. Again, most all were for Cardinal Cushing. After the end of the second year, Frank, the band leader, and Bob, the producer, had a disagreement which I won't go into, but Frank quit. Bob asked me to take over as music director for his shows. I said yes, and the next thing ning variety show on one of the Providence, Rhode Island TV stations. As I got more involved, Bob asked me to be his partner in the production department. From this point on, whenever he met with the Cardinal, I was part of the meeting process as a partner.

When Bob told the Cardinal, that we would like to try our hand at operating in New York, he made several contacts for us. One was with Allan Funt the producer of Candid Camera. We actually wrote skits for him and appeared in a few of them ourselves. One of the other contacts that the Cardinal made was with Otto Preminger, the Hollywood producer/actor who had a New York office. To begin with, Preminger set us up with Alka Seltzer. Bob and I wrote and appeared in a commercial that was rather funny. It showed in other parts of the country, but not the northeast. My mother, who was dying to see it, sat up nights watching for it, but the commercial never

did appear locally. One of the people close to the Cardinal was Jimmy Durante. He was a guest at a few of the Bob Blasser shows. As a result, Bob, I and a few of the musicians in the band did a little traveling with Jimmy. His act in those days consisted of himself, Eddie Jackson, a member of his vaudeville act from years earlier (Clayton, Jackson and Durante), and the retired heavy weight champ of the world, Rocky Marciano.

When we were back in New York, contacts were made for us in Hollywood. Bob and I went out together and called the people who were waiting to hear from us. As a result, we began to go in separate directions. He began to appear on the Jack Benny Show, the Red Skelton Show, the Jonathan Winters Show and the Art Linkletter Show. He got me bit parts on the Skelton and Winter's shows, but I was told that my face was too pretty for comedy or too sinister ... I could take my pick. It seemed that Hollywood wasn't for me, so it was back to Boston and New York, continued work on a Masters degree, played music on weekends and taught school in Boston Monday through Friday.

Some of the contacts I made in New York paid off and I began to get more bookings in music there on weekends than here. Dad was thrilled that I was making it in New York. Babbononno was happy that I made the musician line in the family three generations in a row. But, unbeknown to most, the Hollywood bug had bitten me and I wanted to try my hand, not at comedy, but more serious acting, but that's a story for another time.





### When Eddie Ran into Ingo's Toonder

Machen vs. Johansson Took Place 60 Years Ago What Really Happened?



Ingo decks Machen

In 1958, Eddie Machen was the leading contender for the heavyweight championship held by Floyd Patterson. Machen was undefeated and held victories over such men as Joey Maxim (twice), Nino Valdes, Bob Baker, and Tommy Jackson. Of course, having a strong claim to a title shot during their reign of Floyd Patterson was a sure way of never receiving one. The leading contenders of the day were routinely bypassed in favor of inferior opposition.

While the top contenders included men named Liston, Valdes, Pastrano, and Folley, Patterson's manager Cus D'Amato opted instead for bouts with the likes of unranked Roy Harris, Pete Rademacher (he was making his pro debut in his title shot), Brian London (whose ticket to Patterson was a loss to a young Henry Cooper), and Tommy Jackson (Patterson had already defeated him before becoming champion). It was truly a dark time for the heavyweight championship.

Meanwhile, over in Sweden a young star was making some waves. His name was Ingemar Johansson and he was undefeated. Ingo was scoring knockouts with a lethal right hand that was known as "Ingo's Toonder." His record was impressive but not his opposition. He had won the European Heavyweight Championship when he kayoed Franco Cavicchi in the 13th round.

His other notable wins were a 10 round decision over Brit Joe Bygraves, a one round kayo of Hein Ten Hoff, a 5<sup>th</sup> round knockout of Henry Cooper, and a decision win over American Archie McBride. None of these opponents were near the quality of Machen, Liston, or Folley. Also, Johansson had not been seen by fans in the U.S., so he was truly an unknown quantity. On top of this, ever since Tommy Farr had given Joe Louis a very tough go of it in his title challenge, European Heavyweights had not been taken seriously.

What happens next in the heavyweight division is something that is worth looking into. It is 1958, and we have Eddie Machen as the top contender. He is undefeated in 24 fights with 15 knockouts. In any other era, he would have received a well-deserved title shot. But the title is now controlled by D'Amato and he is having nothing to do with signing Floyd to fight a serious opponent. Machen now signs to fight number two contender Zora Folley, another deserving contender. The two fight to a draw. Meanwhile, Patterson bypasses both men and takes on Harris and London instead. A disgrace!

After the Folley fight, Machen is offered a match against Ingemar Johansson in Sweden. The fight doesn't make any sense for Machen other than it would be a decent payday, but number one contenders do not look for decent paydays, as the ultimate payday is winning the crown. Why would he take on an unknown quantity such as Johansson in Ingo's hometown and risk everything, while having nothing to gain?

For years, it was thought Machen took a dive in the fight. When I was young that was the word among all the knowledgeable fight people. The story was that D'Amato's people, and he had some very shady people around him, had told Machen that if he lost to Johansson they would guarantee him a title shot later on. This was not unprecedented. Jake LaMotta had agreed to such a deal when he fought Billy Fox. He threw the fight and did get a title shot in return.

Why would D'Amato want Ingo to win? In Ingo, he saw the potential for a big draw with little risk

of Patterson losing. He had heard Johansson was another slow moving European heavyweight who would pose no threat to Floyd. His undefeated record would make good copy for publicity, and a win over Machen would give him number one contender status, a status none of Patterson's previous challengers had ever come near to having.

The story gets really interesting here. Machen travels to Gothenburg, and is knocked out in one round. Word in the States is Machen took a dive. Movies of the fight were not distributed here so the rumors were easy to believe. It wasn't until decades later that footage of the bout made its way to the U.S.

Looking at it, you see that not only did Johansson legitimately kayo Machen, he nearly killed him. At the opening bell, both fighters came out tentatively.

Machen was standing straight up in a classic boxer's stance throwing left jabs. Johansson was moving very quickly on his feet and circling Machen while pawing with his left jab. About a minute into the fight Ingo landed a tremendous right hadn't that dropped Machen. Machen struggled to his feet and was dropped again by an Ingo right. He went down hard but managed to get to his feet. The fight should have been stopped here, but the courageous referee let it continue. Machen was driven to a corner and sank half way down while Johansson pummeled him mercilessly. The referee stood idly by. Finally, Machen fell to the canvas unconscious. It was as brutal a knock out as you will see.


It looks as if this proves the fight was not fixed, right? Well, no. The fight could have been fixed and at the same time, Johansson could have legitimately knocked out Machen. You see, Machen would have been planning on losing a ten round decision. He would fulfill his end of the bargain and eventually get a title shot, though I very much doubt that would have happened. At the same time, Ingo proved to be much better than anyone believed and he was too much for Machen. His Toonder was the real thing. It ends up Machen was knocked out before he could throw the fight.

Now, another question arises. If D'Amato was so hell bent on avoiding serious competition for Floyd, why would he now agree to have him defend against Johansson? Not only did Johansson prove he could fight, he also showed he had one of the hardest right hands in heavy-weight history. D'Amato would have taken Patterson and run for the hills to get away from him. If things had followed, their usual M.O. it would have been Machen who would have been more likely to get a title shot after having been destroyed.

I believe D'Amato never saw a film of the Machen vs. Johansson bout. He believed Machen lost as planned, though made his exit sooner than expected, and still figured Johansson was an inferior opponent. Looking at how D'Amato managed Patterson it makes no sense he would have signed to fight Johansson after what he did to Machen. This was one time when D'Amato outsmarted himself, as Ingo took the title from Patterson in his next fight. Not only did he win the title, but he destroyed Patterson in much the way he did Machen, only in this bout it ended in the third round.

There is one final question that begs to be answered. If Machen was going to take a dive anyway, why didn't he just stay down after the first knockdown? That's easy to answer. Machen was a pro with tremendous heart. He was seriously hurt when he went down the first time. It is likely he no longer knew where he was and began fighting on instinct and his instincts were those of a courageous fighter. If you look at the film of the fight, you will see Machen sitting in his corner after being stopped. He is seen mouthing the words "What Happened"? When his seconds respond you can read his lips again and see him saying "Really?"

And what did really happen? We'll never know for sure, but I think the evidence backs up my theory.

That's what the NHL has just revealed as the 2018-2019 regular season approaches the doorstep with the first games that count coming your way on October 3<sup>rd</sup>.

The new internet site — records.nhl.com — marks the first time all NHL records will be available in one place — rather than spread out through a number of publications put out by the league. According to a press release, it "is the new home for official league records and history, including team and individual regular season and Stanley Cup Playoff records, milestones, trophy and NHL Draft histories and more."

The site brings a number of these aspects to life through historic photographs and videos of classic moments in NHL history. Perhaps most importantly, the numerous categories can be "dynamically updated" on a daily basis — meaning the records are current as one views them.

This means, of course, that something went by the wayside. It is the venerable *NHL Guide & Record Book*, an annual publication consulted on a regular basis by writers, broadcasters, bloggers, and faithful fans.

As a media member who thought highly of the *NHL Guide*, we will miss its physical presence. Yes, there really is something to be said about holding a publication in your hands — as we do every day when we purchase at least two (and sometimes more) print edition newspapers.

But as Dan Diamond, the publisher of the *Guide* noted, "once the first games are played, players' statistical panels continue to evolve." These, plus team stats and just about every statistical category can be continuously updated as the regular season and playoffs progress.

Or as the NHL chose to word it: "the site expands on the book's offerings, organizing records into logical and sortable categories and presenting expanded lists of record holders. Unlike the book, it will update with each game's results to present the most current information."

BRAD MARCHAND IN CHINA: SHOPPING FOR CLOTHES AND SLIPPING AWAY — The Bruins forward, who wrote several blog entries for *NHL.com* while the team was in China, mentioned a visit to the Silk Market in Beijing.

After a one-hour visit, he had to go but promised he would return a second time after he saw some hunting gear as he was leaving.

Upon his return "I actually was pulled into the basement and put in this room and locked in this room for an hour," wrote Marchand. "The lady asked if I wanted to see all the new clothing and everything they had in stock so I said "Yeah, sure." Marchand said he was then invited to go to the warehouse and he accepted the invite.

"So I walked with her to this elevator in the back room, went down—it must have been three floors—into the basement. We get out, it's all dark, back alleys. She leads me to this metal beaten-down door. Opens the

door and it's a closet. I thought we were going through there. We weren't. I walk in, she closes the door, locks it, and calls somebody. I was like, oh, man, I'm in one right now. She told me to sit down. I said OK. I sat down. Then she started to ask me what I was looking for. She brought out clothes and suits. I was a little nervous about that one—just me, all by myself. But she was a kind lady. It worked out well. I got out of there alive."

Marchand added that he bought a number of items for himself as well as for friends and family members. "I got some stuff for myself, my wife, and kids. I'm stocked for like the next 15 years with gifts."

**PROMOTING THE BRAND IN ASIA** — There certainly is nothing wrong with the NHL attempting to gain a foothold in the Asian market. It will continue to spread the NHL message in China by playing preseason games there for six of the next eight years.

But there is a cold reality that all the goodwill can't overcome. It's the geography and the vast difference in time zones between the U.S. and China.

For example, the time difference between Boston and Beijing is 12 hours. That means that the vast majority of the Bruins home games, which start shortly after 7:00 pm in the Hub, would actually be shown live around 7:00 am in Beijing where it would actually be the next morning.

And those few afternoon starts in the Hub would actually be post midnight face-offs in China. Not exactly the optimal times that lead to a growth of a fan base. Remember, wasn't one of the major reasons that the NHL would not go to the Winter Olympics last February was the huge time zone difference between the U.S. and South Korea — and the small pool of fans that would stay up to watch games that began at 3:00 am back in the U.S.

What is possible is to try to grow the game at the grassroots level in China, with the hope that some players in the future may be able to make the jump to the NHL. But the time zone difference remains a major challenge in the attempt to grow an NHL fan base.

Europe is a much more likely option for the NHL. While there is a time difference (5-6 hours, depending on location), it is a much more manageable one as is the distance by plane. In addition, many players from Europe and Russia already play in the NHL. As we recently wrote, a typical trip by plane from the East Coast of the USA to Beijing can take about 17 hours nonstop.

We could foresee the day sometime down the road when the NHL might place a franchise or two in Europe. We can't envision such a scenario for China or anywhere in Asia. The geography is just too vast (literally halfway around the globe) and the time zone difference is too great (at least 12 hours).

The NHL might be able to grow the game in China and sell more logoed products in a nation of 1.4 billion people. Those are reasonable goals for the league to set its sights on.
