Join us for the 19th Anniversary of October as Italian Heritage Month

The 19th Anniversary of October as Italian Heritage Month will officially begin on **Monday**, **October 1st**, **at 6:00 pm** in the **House Chamber of the Massachusetts State House** with the Honorable Speaker of the House, Representative Robert DeLeo serving as master of ceremonies.

The event is co-sponsored by the Speaker of the House; the Consul General of Italy, Federica Sereni; and the Italian Heritage Committee.

This year's program will honor Fr. Antonio Nardoiainni, OFM, Pastor of St. Leonard of Port Maurice Church for Distinguished Community Service; Mogol, for Distinguished Service in Music and Language; and Rep. Paul Donato for Distinguished Public Service.

The event will also provide scholarships for worthy students donated by C.A.S.IT, the East Boston Savings Bank, the Italian Consulate, and the St. Joseph's Society.

This year's program will end on a special note with the signing of a "Common Accord" between the officers of the Italian American Alliance, the Asian American Association of Boston, and the Italian American Heritage Committee. The Accord reads as follows:

This Alliance of Common Accord represents agreement between the Asian American Association of Boston and the Italian American Alliance — each representing distinct ethnic and racial identities, and each having confronted discrimination — but which hold common principles that bind us together in united cause.

Given the righteousness of those common principles, we pledge ourselves to work together and to mutually support each other's heritage, social welfare, educational, and economic interests as though they were our own for a more beneficial American society.

The accord will also be witnessed by the officers of the Italian American Heritage Committee.

Throughout the month of October, Italian and Italian American Organizations will be celebrating Italian heritage with a wide variety including of events the traditional Christopher Columbus parade which will take place this year in East Boston.

ROMAN LAW

The early Roman law that we've heard so much about in earlier years is the legal system which was developed about 450 B.C.

When their laws were first arranged into a systematic collection, this collection was known as the "Law of the Twelve Tables" and it set simple rules which were suitable for the community as well as establishing equal treatment for the rich and poor

alike. Enactment of these early laws was through assemblies of the common people, but this kind of assembly soon fell out of use because large numbers of persons sitting together in this manner were difficult to oversee and very expensive to bribe. Later, under the Roman Republic, a Praetor or Magistrate decided which cases were fit to be brought before a judge and which were not. The Praetor also exercised other powers of decision regarding civil law. Still later under the emperors, those rulers or their designates made all of the necessary legal decisions which, of course, were irrevocable.

These ancient statues contained a "Law of Persons" which made distinctions between freemen and slaves. A slave was considered personal property and anything that he acquired, including inheritance, became the property of the master. A



master could not order that a slave be put to death for any reason, however, reasonable chastisement was permitted, and the master was not held liable if a slave died under the lash. Slaves, on the other hand, were not without some protection under the law.

A poorly treated slave could run away from his master and take refuge at a statue of the emperor, thus compelling the master to sell him to someone else. Paternal power was also highly recognized and seemed to give absolute power to a father over his son, including any property that a son might have acquired.

There was also a "Law of Things" which made a distinction between things which could be owned and those things which could not. Temples, tombs, rivers, air, and running water are examples of those things which could not be owned. Abandoned property, gems found on the seashore, and wild beasts are examples of some of the odd things which could be owned. If a wild beast was found and then escaped, the ownership was lost. A person, who improved another's property believing it to be his own, could refuse to return it unless compensated for the work. If a son was guilty for any

wrongdoings, the father could either pay the damages or surrender his son to the injured party.

These are just a few examples of the rules by which people were required to live 2,000 years ago. Living conditions, social attitudes, literacy, and just plain basic survival probably forced the enactment of laws which seem absurd to us today. We should not lose sight of our history of lawmaking since the Declaration of Independence and those "blue laws" which now seem equally ludicrous. Two thousand years from now, people might be writing about their ancestors who were required by law to pay Federal income taxes, State income taxes, Social Security taxes, Real Estate taxes, Sales taxes, Gasoline taxes, etc., etc., etc.



L'Anno Bello: A Year in Italian Folklore Finding Balance During Michaelmas



Around this time a couple of years ago, my husband helped me bake a pumpkin bread for a family dinner. The smell of quintessential autumn spices – cinnamon, nutmeg, cloves mingled together in the air as we stirred pumpkin puree, as bright as any Halloween decoration, into a sweet mix of flour and brown sugar. The recipe yielded a delicious bread, perfectly moist and studded with chocolate chips for extra richness. However, the pungent aroma and seasonal taste are not the only parts of this bread that I remember, as I also cherish the visual memory of making it. My husband and I baked after the sun had disappeared under the horizon and the last dusky light of the evening dissipated. As the kitchen lamp filled our surroundings with a cozy, honeyed glow, the sky outside the window was black and velvety. This combination of fairy-tale darkness outside and the warmth of the kitchen wonderfully captured the essence of fall, a season when the longer night hours beckon us indoors and the slight chill of twilight ushers us into the comfort of home and hearth. As the autumn equinox passes, the balance tips in favor of the night and there are more hours of darkness than light. While some may grumble about this, I find that this darkness helps us quiet down, appreciate the current season, and look forward with hope to the return of the light during the winter solstice. Europeans have long been celebrating a holiday that marks this period of transition - Michaelmas - and it continues to wield inspiration even today.

September 29th, and it is the feast

and served as harvest festivals marked by special dishes. Roast goose forms the backbone of the English Michaelmas, where superstition dictates that whoever eats goose on this feast day will enjoy money all year long. Carrots, an autumnal root vegetable, were instead the food of choice among medieval Scots on Michaelmas, along with oat cakes known as bannocks. Italy also abounds with Michaelmas traditions and lore. There, St. Michael's Day, or la Festa di San Michele l'Arcangelo, functions as the gateway to fall, a harbinger of colder weather, darker nights, and the start of the school year. Numerous proverbs, left over from the agricultural past, speak to the importance of St. Michael's Day as a seasonal milestone in Italy. The adage "San Michele, l'uva é come il miele" means that grapes are as sweet as honey on St. Michael's Day, since the holiday occurs during the time when Italians harvest the ripened grapes from their vineyards. Another dictum states that "a San Michele, il calore va in cielo," which when translated literally says that the heat departs for the sky on Michaelmas - in other words, cooler weather begins now. These customs and proverbs remind me that in Italy saints' days are deeply woven into the tapestry of everyday life, imbuing farming and weather with a deeper resonance. They make me think of the small white church dedicated to St. Michael in my father's hometown of Sulmona, a center of community that embodies much of the homey essence of this holiday.

As a seasonal turning point, Michaelmas occurs on Michaelmas grants us the opportunity to respect and honor the darkness of autumnal nights. Though I sometimes find the early nighttime of the fall to be spooky, I also appreciate it for the unique insights it affords and its place in the cycle of the year. When shadowy skies summon me indoors, I seize on the chance to develop my hobby of baking, making the most of fall's produce as I stand in my golden,

warm kitchen. As my home brims with the flavors of the season, from tart apples to creamy pumpkins to juicy pears, I am thankful to provide such comfort food to my loved ones. I even have a special Michaelmas recipe — soft and spicy gingersnap cookies, as ginger is connected to the medieval celebrations of this holiday and frequently lined the stalls of harvest fairs that dotted the countryside of olden Europe. The autumnal darkness also instills in me a love of mystery, a longing for the lure of the unexplained and the indelible feeling of telling spooky stories and eerie legends around a crackling fire. How different would Halloween celebrations be without the sense of shivering anticipation and wonder of the unknown that accompany long, dark nights! Finally, the dim fall evenings give me a renewed appreciation for the light. I relish every bit of autumn sunshine, particularly at day's close, when the last gilded rays of sun shine through the colorful leaves, crafting them into a kaleidoscope of fiery hues. This desire for light breaking through the darkness forms the symbolic backbone of upcoming winter holidays that feature candles or honor the rebirth of the sun, such as Advent, St. Lucy's Day, Hanukkah, Christmas, Kwanzaa and New Year's Eve. Michaelmas, therefore, taps into a primordial desire in the human consciousness as it expresses the simultaneous need for darkness and hope for a shining future.

Autumn provides us with a whole calendar of celebrations as well as lovely images to mark the season. Bright red and orange leaves swirl down from treetops like celestial feathers, carpeting the ground in a mosaic of multihued patterns. The harvest of crops like apples and pumpkins not only remind us of the Earth's abundant bounty, but also inspire people to joyfully express gratitude in the forms of fairs and applepicking excursions. However, while we are often quick to revel in the pleasures of foliage and pumpkin patches, we often treat dark autumn nights with disdain. A new perspective will let us see the many benefits the short days of fall have to offer. This darkness encourages us to seek the company of family and friends, to spend time developing our interests, and to reflect on the things for which we are the most grateful. It opens our eyes to the mysteries of the world. Moreover, it shows to appreciate the light, which we often take for granted. The holiday of Michaelmas reflects this balance between light and dark and, through its myriad symbolic connotations in Italy and elsewhere, teaches us that both are necessary components of the year's enduring journey. So let us take these lessons of Michaelmas to heart, and find peace in the darkness as we yearn for the light.



Kavanaugh-Ford Supreme Showdown?

I have been following closely the Judge Brett Kavanaugh-Professor Christine Blasey Ford media circus that developed shortly after all the testimony in the Confirmation Hearings on Judge Kavanaugh for a vacancy on the U.S. Supreme Court. It seemed like the usual stuff with all Democrats opposed to him and all Republicans with him. That is what goes these days in hyper-partisan Washington, D.C.

worked in the mental health field for four decades as a mental health counselor and police officer, I do not presume that Ford is lying as many of her critics have charged, or that she brought this story forward to get Kavanaugh.

What does concern me, is the fact that this alleged 1982 event reportedly was not divulged until 2012, when she brought it up in therapy. I do know that incidents of great trauma can be denied in someone's head to protect themselves. I am not surprised at the time lapse either, or the fact her memory of that evening is still blurry, except the alleged attack. However, there still is a presumption of innocence until the facts bear witness to an actuality. That has not been reached.

Outdoor Activities for Dogs to "Dig" into this Fall!

When the leaves change and the weather cools, outdoor activities for dogs jump into season. Rather than sit inside and play with the same old toys, you and your dog can dig into these fun (and inexpensive) activities that take you on new adventures.

Skip off to State a Park: Many State parks offer great hiking trails to enjoy with your dog. First, be sure to pack a small backpack to store water for you and your dog, as well as a leash and a collapsible water bowl for your pup. Secondly, leave some old towels in your car, since some state parks have swimming areas for dogs. Next, be sure to check your state's park and recreation website for restrictions and guidelines as well as hiking maps. Finally, when going hiking, make sure your dog is up to date on all vaccines and always check for ticks after your adventure in the woods.

Hunt for Leaves: Whether you're in the backyard, or at the local park, piling up leaves can be fun for you and your dog. Hide balls or other toys in the pile and encourage your dog to find them. For small dogs, you can gather up leaves and put in an empty baby pool on your porch for them to enjoy. Just be careful to make sure only leaves make it into the pile. Sharp sticks may lead to some painful pokes.

Pumpkin Patches and Hay Rides: There is no doubt that fall is often signaled by the appearance of pumpkins throughout the land, and one of the biggest fall treats is to go and search for your own pumpkin. Because most of these pumpkin patches are outdoors, dogs are often allowed to accompany you, but it might be worth checking with the farm ahead of time to be sure. He'll enjoy the exercise and excitement of the large orange balls while you search for the perfect ones for your family.

Hay Rides: Are also a fun treat for the family as you ride through farm fields and mazes in a trailer pulled by a truck or tractor. Your dog will love all the scents and sights while touring around the farm. The cool air in his face will also be a treat. Just be sure to keep him on a leash so he doesn't get any ideas of chasing after any wildlife or farm animals on the way.

Craft Matching Costumes: Fall is the perfect time to shop for (or even craft your own) matching outfits for you and your furry best friend. Once you have the perfect costumes, go trick-ortreating together or greet trick-ortreaters at your house with your fashionable outfits. Just make sure to keep the candy away from your pooch as it can be harmful to his health.

Dig for Adventure: Fall is a great time to visit a beach or lake since the peak season is over and fewer people are around. Let your dog dig in the sand and splash in the water. The beach or an open grassy area is also a great place to play fetch. Since toys may easily get lost outdoors, why not make your own inexpensive toy to take with you? All you need is a tennis ball, an old t-shirt, a large rubber band, and scissors. Cut the neck and sleeves off the shirt and then cut one of the side seams to give you one long rectangular piece of fabric. Place the tennis ball inside the fabric and secure with a rubber band wrapped around the fabric. Next, cut the remaining fabric into strips but stop cutting about a half inch before you get to the rubber band. Then, take your strips and braid them. Finally, knot off the end of your braids. You now have a tug-and-throw toy that you can play with at the beach or lake that can also be thrown in the washing machine if it gets dirty. MassDOT: Boston – Alford Street Bridge

Traffic Reduced to One Lane in Each Direction October 1st through April 30, 2019 Travel Impact Will Be 24/7 and Will Allow Crews to Replace Bridge Deck

The Massachusetts Department of Transportation (Mass-DOT) has announced that traffic will be reduced to one lane in each direction on Route 99 in the area of the Alford Street Bridge in Boston beginning on October 1st, and continuing 24/7 through April 30, 2019. This lane closure will allow crews to safely and effectively conduct bridge deck replacement operations. The Alford Street Bridge is a City of Boston owned structure that carries traffic on Route 99 over the Mystic River. This work period has been selected with input from key stakeholders including the United States Coast Guard. The Mystic River channel must be closed to marine traffic during bridge deck replacement operations, and marine traffic volumes are lowest during this time frame.

As always, work will be conducted in ways that help minimize the impact on the local community and traveling public. MassDOT encourages the public to be mindful of these traffic impacts. Those traveling through the area should reduce speed and use caution. The schedule for this work is weather dependent and subject to change without notice. 

three nights of outdoor dining and entertainment including The Midtown Men, Sal "The Voice" Valentinetti, the New York Bee Gees, Tenor Giovanni Formisano and local favorites Vanessa Salvucci and Vinyl Groove.

Authentic pizza ovens were brought in as restaurants and food vendors served up classic Italian feast food of pizza, sausages, meatballs, pasta and cannoli. 

Ollie West plays the title character who brings us into his world as he deals with the struggle to understand his relationship, or lack of, with his famous father whom he barely knew. Young West is first seen live with a knapsack projected onto a large screen as he makes his way from the audience onto the stage. That screen and the projections on it will be used to incredible effect throughout there performance.

We learn right off this isn't going to be a historical work, but instead a metaphysical exploration. While bouncing a ball off the screen Hamnet tries to explain, with the use of Google, the theory of quantum

What's in a name? A lot when your father is William Shakespeare. But it is not the name Shakespeare that troubles him. Hamnet is aware that his name today is most often seen as a typo, and he is trying to measure his self worth. Hamnet has many questions and turns to the audience and Google for answers. But as Vladimir and Estragon find in *Godot*, often times there simply are no answers.

"Why would anyone chose not to be?" is one of those questions, and in the remarkable scene where he gets to face his father he asks that, and many other questions. The scene is done with the senior Shakespeare appearing on the screen with his son. Hamnet is seen both on the screen as well as on the stage itself at the same time. Shakespeare

is only with him on the screen throughout most of this time; it gives a touch of Banquo's ghost. I'm not sure how all of this was done, but it is amazing to watch. The fact that there is a bit of the handy dandy to it does not diminish how powerful the dialog between father and son is. Whether you see the work of Shakespeare in this conversation, or Beckett, or even Bart Simpson, you will be touched by it. Can fathers and sons ever understand each other? Here, they do try, but it is emotional and awkward for them.

Using the relationship between Hamnet and Will Shakespeare to explore so many questions does not limit us to just these two people. It speaks to all of us, and it will leave you with more questions than answers, but also with more understanding.

Ollie West, who is simply outstanding as Hamnet, will be replaced by Aran Murphy midway through this run. I highly recommend you take in this amazing production. I would even go as far as saying it would be worth seeing a second time when the cast change is made.

Walter "Pops" Washington (Tyrees Allen) is a former N.Y. City police officer who is living in a rent controlled apartment. He is no longer on the force because he was shot six times by a rookie cop. The shooting took place at an after hours bar when Pops was off duty. Pops is black; the cop who shot him is white.

Between Riverside and Crazy by Stephen Guigis does not fit into a narrative of racist white cop shooting a black man. It gets much more complicated as the story moves along. Pops is sharing his apartment with his son Junior (Stewart Evan Smith), an ex con who is trying to turn his life around, though it appears he may still be a bit stuck in his old ways. Along with Junior is his girlfriend Lulu (Octavia Chavez-Richmond), who is pregnant and might be working as a prostitute, and Oswaldo (Alejandro Simoes), a As I said, this is not a play about police shootings. It is about how people play the game and play a bit fast with the truth to get what they want. While at times it seems underhanded, everything done here is not over the top.

It is also a play about relationships. Pops finds it difficult to show affection to Junior, while he is such more comfortable getting closer to Oswaldo and Lulu, both of whom he shows much empathy to.

Pops former partner Detective O'Connor (Maureen Keiller) and a Lieutenant Caro (Lewis D. Miller) visit Pops for dinner one evening. It doesn't take long to realize there is an ulterior motive for the meeting as Caro attempts to get Pops to agree to a deal with the city. The smarmy Caro, the smarminess is overplayed here, is not so much looking out for Pops as he is advancing his own career by helping the city put this lawsuit behind them. Pops, as well as the audience, quickly see through this game.

The other scene is when the Brazilian Church Lady (Celeste Oliva) comes to visit Pops. She is filling in for another caregiver, and like many of the characters (Photo by Nile Scott Studios) just think about how you may have acted if you were in any of their positions.

Yes, I think this play could have been better, but it is definitely worth seeing. Tyrees Allen's portrayal of Pops is a pleasure to watch. His humor, his anger, his human weaknesses, and his quest to find what he considers justice is well served in the hands of Mr. Tyrees, who does a wonderful job in the role. You'll feel much the way Junior does when watching. He will aggravate you, frustrate you, but you won't be able to resist liking him.

I would also like to say that Alejandro Simoes is touching as Oswaldo. It is heartbreaking to see how bad things engulf good people. You will be rooting for him to make it and overcome the demons in his life. People make bad choices, but that doesn't mean they are bad people. Simoes Oswaldo shows us that.

I would recommend not approaching this play as a commentary on the ills of society, but rather to look at it through more personal lens. I believe in doing so, you will develop a more sympathetic view of people who play life's poker game while keeping a few cards up their sleeves.

Just a note for those considering taking children to this play, it has much adult language and situations.

While the relationship between Junior and Pops is strained, Oswaldo appears to understand the cantankerous Pops and the opening dialog between the two is both funny and revealing. The elder Washington displays a degree of bitterness as he spends most of his days sipping whiskey. He is not only angry about having been shot, but also over the loss of his wife who died after a long illness. He spends time sitting in her wheelchair.

He filed a law suit against the city eight years earlier He is seeking \$5 million dollars in damages, but the city has not settled because of the circumstances of the shooting, which we learn more about as the play progresses. He is also receiving eviction notices. There are a number of other stories playing around all of this including Junior's relationship with Lulu as well as how he seeks to receive words of affection form Pops. Oswaldo's own issues with his father and his set back with staying clean. All are interesting, but I found a depth lacking in the way these stories are portrayed. While good, I thought there was so much to work with here that was left not fully developed.

There are two scenes where things seemed to really catch fire. When tempers flare between Pops and Caro over settling the lawsuit, it appears things are really going to get moving. It is a powerful scene, but the action fades shortly in the play, is looking to get something for herself. It is quite the performance. Both steamy and funny, Ms. Oliva plays it outstandingly. It's a scene you will not forget.

Towards the end of the play Pops finds out Lieutenant Caro likes to play poker, and this is when we see how much of what is going on is like a giant poker game, with each player looking at his cards and seeing just how much he can bluff.

The play ends on an interesting note as the characters are pretty much revealed and while we may be tempted to judge some, if not all of them, harshly,

A Nostalgic Remembrance

It was the end of September, 1956, and I was a 17-yearold freshman at Boston State College. It was the first day and a fellow English High graduate, Bob Pesce, picked me up and we headed to the college which used to be at the intersection of Huntington and Longwood Avenues. The college, which was sold to the state by the City of Boston, went from being called Boston Teacher's College to Boston State College. Bob and I had been selected to be members of the freshman class majoring in Industrial Arts. We wanted to be the future shop teachers in the Boston schools.

Before I left the house, Staff Sergeant Babbononno had to inspect my appearance from my hair down to my suit and tie and the spit shine on my shoes. When he thought I looked presentable, I headed down the three flights of stairs to the street and into Bob's waiting car. We weren't sure what to expect on that first day and discussed our curiosities as he drove west on Storrow Drive toward the Fenway section of Boston. When we entered the lobby of the college, we were directed to an assembly hall and joined up with a couple of other people that we had known from Boston English High.

Not long after we were assembled, one of the deans climbed the steps to the stage and called us to attention. He gave the call letters and numbers each of us would have to respond to depending on what we were majoring in. Seeing this assembly was for freshmen only, the letter we had to remember was "F." The dean called names followed by things like F1, English majors, F2 Math majors, F3 History majors ... when he got to us, he called, "F20, industrial arts majors.'

Following instructions, Bob and I headed to a classroom to be registered with all of the other boys and men slated to study industrial arts. There were 42 of us who sat in the room we were assigned to. A Mr. Thornton introduced himself as a new teacher who had just arrived from the mid west. He then began calling the names of the students on his list. Coming from the midwest, the most difficult names he probably had to pronounce were Smith, Jones, Brown or Johnson. Much to his chagrin, the first four names on our list were Gaetano Abruzzese, John Christoforo, Paul Ciccarelli and Renato Civili. Of course, he butchered them. There were three other Italian surnames on the list that he killed: DePaoli, La Bollita and that of my friend, Pesce. Well, we were told to fill out schedule cards and all types of paperwork that registered us as incoming freshmen. Being industrial arts majors and considering the point in time we attended college, our assembly of students was all male. Pesce and I looked around at our future fellow classmates. Some looked quite older than we were, but there were several

who looked green behind the ears and we knew that they were recent high school graduates just like the two of us. We discovered a bit later when we had a break, that the older looking of the crowd were actually veterans who were taking advantage of the GI Bill before it ran out for Korean War vets. We kids were 17 or 18, but the vet's ages ranged from their late 20s to mid 30s.

We discusses our forth-coming schedules which includes all of the academic subjects the rest of the freshmen were given, plus all of our shop subjects which we were told would take place at our shop school, the Parkman School for Teachers of Mechanic Arts. We also found out that the shop school was located on Broadway in South Boston and we were to commute there one and a half days per week. What we didn't know was that the school was built when Lincoln was president and that it had been condemned a few times, but was still in operation as a training facility for shop teachers.

A day or two later we began attending Boston State, taking our first academic courses on campus and then heading to South Boston to check out the shops as our schedules indicated.

We were greeted by four men, Mr. Staebner, the director, Mr. Hartnett, who would teach us machine shop, printing and graphic arts, Mr. Walker who would teach us sheet metal and electricity, and Mr. Ventura who specialized in woodworking and drafting. They gave us the rundown as to which of us would be taking what course at what points in time and described the shop courses. When I returned home, Babbononno wanted to know what the wood shop looked like and what I learned. I told him we hadn't started yet and he reminded me that he had taught me how to use hand tools and that I shouldn't have any trouble making things. I assured him that what he taught me would be applied to whatever they gave me as projects and he felt relaxed. When Dad came home and Mom had dinner on

applied to several cities and towns around the eastern part of Massachusetts. One of my class mates, Paul Ciccarelli, and I accepted jobs at Tewksbury High School, he in the wood shop and me in a drafting room, and there we stayed for a year.

At the end of that first year, I met with the administration to discuss a better contract for my second year. They promised me everything I asked for and we shook hands. I was still a little wet behind the ears, and when I started the 2nd year at the same school, everything they promised me was forgotten about, and I didn't have anything in writing, my fault for being naïve. I started that second year very upset with the school administrators, but more upset with myself, a former street kid from East Boston. I should have known better. But, as luck would have it, two weeks later, I received a call from the director of the Vocational Ed. and Industrial Arts Department of the Boston schools, telling me that he had a job for me. I gave a two week notice to the Tewksbury School Department, and was gracious enough to supply my own replacement, a fellow classmate who didn't have a job. I then returned to my own city, Boston, and stayed with the school department for the next 43 years.

Unfortunately, I've lost touch with most of my classmates. It is now 58 years later and all but two of us are retired. Attempts to get all 21 of us together for a reunion never happened, and many of those vets and a few of the guys my age are gone. The last time we had a reunion, about 8 classmates showed up. Since then, several more have left us and a couple don't get around much anymore.

I guess I'm one of the lucky ones and don't have any complaints (no one listens anyway), so I will close as usual with, "May GOD BLESS AMERICA."

LINGUINE WITH CLAMS IN BIANCO in White Sauce

2 dozen freshly steamed littleneck clams*
4 or 5 garlic cloves chopped
¹/₄ cup of olive, canola oil, or a mixture of both 1 tablespoon chopped parsley (preferable fresh) Romano or Parmesan grated cheese

1 pound linguine

***OPTIONAL:** In place of freshly steamed clams, use two cans of chopped or minced clams and two bottles of clam juice available in supermarkets.

To steam clams: Wash clam shells thoroughly several times. Add about one quarter of an inch of water to saucepan and place on burner to heat. Then add clams. Cover and allow steaming until the clamshells open. Remove saucepan from burner. Remove clams from shells and set aside. Save the broth.

White sauce preparation: Skin and chop garlic cloves. Heat oil slightly in two-quart saucepan over medium heat before adding chopped garlic. Simmer slowly. Do not brown garlic. Remove pan from burner for a few seconds before adding parsley and clam broth from steamed clams. Return to burner and bring to a boil. Add clams, chopped or whole. When mixture comes to a boil, turn off burner. Cover and let stand.

Follow directions on package for cooking linguine or pasta as desired. After draining cooked pasta in colander, place in serving bowl. Pour clam broth from saucepan over linguine. Top each serving with one or more tablespoons of clams. Serve with preferred grated cheese.

Saint Margaret of Hungary

Saint Margaret was born in the Kingdom of Croatia on January 27, 1242. She was the eighth and last daughter of the royal couple, Bela IV king of Hungary and Maria Laskarina. The royal family resided in Croatia during the Mongol invasion of Hungary (1241-42).

Margaret was the younger sister of St. Kinga of Poland and Blessed Yolanda of Poland, and through her father, the niece of the Saint Elizabeth of Hungary. Margaret was born at a moment when the country was threatened by enemies. The king promised God that if things reversed in his favor, he would dedicate Princess Margaret to the religious life. The prayer was answered, and Béla put Margaret in the care of the Dominican Sisters at Veszprém.

When Margaret was 12, Béla built a convent for her on an island in the Danube near Buda, the Margareten Insel near Budapest today, and where the ruins of the convent are still to be seen. It was there, Margaret passed all her life, which was consecrated to contemplation and penance.

Margaret was venerated as a saint during her lifetime. She took her solemn vows when she was eighteen. She strenuously opposed the plans of her father, who for political reasons wished to marry her to King Ottokar II of Bohemia. She received the Consecration of Virgins along with some other royals to prevent further attempts on the part of her father to have her vows dispensed by the Pope for marriage.

All narratives call special attention to Margaret's sanctity and her spirit of earthly renunciation. Her whole life was one unbroken chain of devotional exercises and penance.

Margaret passed away on January 18, 1270, at the age of 27. She was canonized by Pope Pius XII in 1942. The Feast Day of Saint Margaret of Hungary is January 18.

The Herkimer Hurricane

Former World Lightweight Champion Lou Ambers was known as the Herkimer Hurricane. Ambers was from Herkimer, NY and if you had been in the ring with him you would have felt like you were walking into the forceful winds of a hurricane.

Throughout the history of boxing sportswriters and promoters have enjoyed bestowing nicknames on prizefighters. Some are comical, some are puzzling, and some are downright scary.

Max Baer was known as well as Madcap Maxie as well as the Livermore Larupper. The first would be considered comical while the second is puzzling. It's no secret Baer was a funny and charming personality so it is no wonder he would be called madcap, he was also at times called the Clown Prince of the Ring. The puzzling one is the Livermore Larupper. He lived in Livermore, CA so that accounts for the first part of the name, but what on earth is a Larupper? I can't find a definition anywhere.

In the scary category, two fighters come to mind and both were known as assassins, a pretty clear term about what intentions both men carried into the ring. The Michigan Assassin, Stanley Ketchel, and the Easton Assassin, Larry Holmes. I've never cared for the term assassin as it describes somebody lurking in the shadows in order to gun down an unarmed victim. Both Ketchel and Holmes stood face to face with their opponents and hid nothing more than their chins. Going back to the beginning of modern boxing history and the first celebrity boxing champion, we have John L. Sullivan, known as The Great John L., also known as The Boston Strong Boy Sullivan held a very high opinion of himself and was known for his braggadocio. He certainly thought of himself as great, and there wasn't another heavyweight champ to match his outsized ego until 1964, when Muhammad Ali took the title from Sonny Liston. Ali immediately announced to the world that he was The Greatest. and that humble self definition stayed with him for the rest of his life and after. Poor Sullivan, had he known what the future held might have deemed himself





more than just merely great. It would have been fun to watch these two square off, not in a ring but in a battle of words.

The vast majority of heavyweight champs had nicknames. After the Great Sullivan, there was Gentleman Jim Corbett, so named because he fashioned himself a bit of a dandy. Next was Ruby Robert Fitzsimmons due to his red hair. Jim Jeffries was known as the Boilermaker though I am not certain he ever made any boilers.

Jack Johnson was known as Lil Arthur (his middle name was Arthur) and as the Galveston Giant. And speaking of giants, the man who took the title from Johnson, Jess Willard, was known as the Pottawatomie Giant, and standing at just over 6'6" proved that Pottawatomie grew their giants quite a bit larger than Galveston. Of course, the man who cut Jess Willard down to size would become known as Jack the Giant Killer. The Manassa Mauler, Jack Dempsey, even before beating Willard, was known for beating men much larger than he was. In fact, he seemed to have an easier time when faced with larger opponents. Dempsey would lose to the Fighting Marine, Gene Tunney, who was perhaps the most cerebral of all the champs. He was as fond of Shakespeare as he was of boxing. Max Schmeling was called the Black Uhlan of the Rhine. Uhlans had been German Calvary men. I don't know why Max was given this name as he wasn't in the Calvary, but I am sure some promoter or newspaper writer thought it sounded good.

key, was so called because he had been in the Navy. It's a name that would not exactly strike fear into the heart of an opponent, but it stuck.

Poor Primo Carnera ended up being tagged the Ampling Alp, because of his size, though he was far from ampling. The big man actually moved pretty well on his feet and deserves to be remembered better.

I've already mentioned the Larupper. The man who took the title from Baer became known as The Cinderella Man. James Braddock's story certainly was one of fairy tales as he came back from oblivion to become heavyweight Champion.

Joe Louis was called the Brown Bomber. That title would certainly have political correctness police screaming today, but I have never heard that Louis complained about it. He certainly could bomb. I'll leave the rest alone.

Ezzard Charles was given the name The Cincinnati Cobra, a fitting description of his fighting style.

After Charles the names started to become less colorful. Jersey Joe Walcott was not known by anything other than Jersey Joe. Rocky Marciano was very fittingly called The Brockton Blockbuster, though he was also known as The Rock. There were many Rockys who stepped into the ring but only one Rock.

HOOPS and HOCKEY in the HUB

Could LeBron James and his move from the Cleveland Cavaliers to the Los Angeles Lakers actually result in a shift in how the National Basketball Association constructs its schedule?

That was the rather intriguing topic of a New York Times column by Marc Stein recently as he discussed the possibilities of scheduling changes following the move by King James to the Lakers — the archrivals of the Celtics.

While Stein admits up front that the chances that scheduling will be tweaked range from slim to none ("Don't Count On It" read a portion of the headline), the ideas contained in the piece are worth examining.

As far as the playoffs go, Stein brings up the point that perhaps it is time to consider once again the seeding of teams for the playoffs "purely based on overall record." This has been brought up a few times over the past decade. The thinking goes that since the Western Conference has had many of the better teams in the league, it is only fair that the best 16 teams in the league overall make the playoffs, rather than some weaker teams in the Eastern Conference that may get in under the current top eight in each conference seeding.

While this may seem attractive to some, it also seems as it is of the moment. While the Lakers in their first couple of years with James are not expected to be title contenders, it is possible that they could finish in the lower positions of a 1-16 ranking system and thus at least make the playoffs.

We're sure that TV executives would be thrilled if James could be a playoff participant, even if that occurred with a lower ranked team. To his everlasting credit NBA Commissioner Adam Silver said he is not a fan of the "1-16 regardless of record ranking" and that it is not on the table for discussion. While it is true he never said never, it is also true that he made it clear the present twoconference ranking system will remain in effect for many years to come.

One idea that Stein put forth that we believe is worth considering is to have every NBA team play every other team in the league three times during the regular season. That would increase the number of regular season games by five - from 82 to 87. The argument against it is that the regular season is long enough as it is and lengthening the schedule and imposing additional travel requirements would take away from the optimal performances by the players. But, we have a solution for that. It occurs in college hockey all the time. When a good number of college hockey teams travel substantial distances over a weekend, they play two games against an opponent, not one. That doesn't occur that much in southern New England because the travel distances between schools are much shorter but in the Midwest it is a popular feature on many schedules.

So, if every NBA team played every other team three times that would mean in any given year there would be an imbalance with some teams playing a single home game against an opponent plus two on the road or vice versa.


Rather than play those two road games at different points in the schedule, we would suggest that they take place in one visit with perhaps a day off between games. This would cut down on travel and allow the players some additional rest by having at least a three-day stay in a host city. The day between games could be used for a short practice or as a day without any activity.

Perhaps an off day practice by the visitors could be open to the public so that those fans (particularly youngsters) who could not afford a ticket could at least see some of the league's stars in person — a good will gesture that would further enhance the community relations efforts of the various franchises.

Such a scheduling feature would mean that half of the teams in the NBA would be in half of the cities in the league every year for at least three days. Plus it would also mean an extended home stay for the host franchise. The visiting players could see the sights, sign some autographs, hold an open practice on the off day and create a lot of positive impressions. Perhaps the home team could also conduct some public practices on occasion. Doesn't sound like a bad idea at all.

It would also diminish the phenomena of what we personally call phantom teams — ones that arrive late the night before their one annual appearance at the Garden, play a game the next night and then fly right out after the contest ends - never to be seen again until next year.

Notice also that the threeday stay curtails the notorious back-to-back scheduling that so many players and coaches dislike. Under the present system the Celtics might play in the Garden on a Friday night, then immediately board a plane and fly to say, Chicago for another game the next night - or sometimes even as early as the next afternoon. In addition, think of the visiting team that the Celtics just played. Those players flew into the Hub, played the C's and then had to fly right out to play another game the very next night. Even if they did have to resort to back-to-back contests because of the scheduling of events at the Garden, there would not be any additional travel involved because both teams would stay in Boston overnight and play the second game in the same location. It's a tweak of the schedule that doesn't rely on the presence of a superstar - just an adjustment that makes some common sense.
