#### "Gamer Rage" Latest Cause of Gun Violence?

The massive shooting at a video game tournament in Florida now has people concerned about "gamer rage" as a root cause of violence. It always seems easier to quickly come to a conclusion about gun violence. It's always the gun and not the shooter, and now it's something called "gamer rage." What most don't want to consider is mental health and the lack thereof. This latest shooter had a long and extensive history of mental illness, hospitalization, and prescribed antipsychotic and anti-depressant medications. Whether he has been taking or not taking his meds will be determined.

Too many folks are out in society refusing to take their meds when needed and often think the side effects are worse than the benefits. In the end, we always see that not taking your meds often leads to violent episodes of murderous mayhem as in this latest case in Florida.

Society needs to come to grips with this issue of untreated mental illnesses. The carnage keeps growing and we still feel as a society that we are helpless. We need to get more people into treatment and rid society of the stigma of mental illness. We need to start treating illnesses of the mind the same as we treat illnesses of the body.

How many people living among us are being haunted with voices commanding them to hurt others? How many fight these voices their whole lives, living in constant pain? How many in society come close to losing it? How do we as a society stand up to this illness and commit ourselves to doing something about it?

We need to fund more treatment, provide more education, and create more places for folks seeking help. Mental illness can be addressed if we stop pretending it's not a real issue needing attention.

The greatest problem today is DENIAL and that only OTHER people need help. Too often, the OTHERS become US. We have come far since 1972, when I began my mental health career, but we still have far to go before we can declare victory.

My longtime friend Domenic Amara from East Boston sent me the following and I wanted to pass it on to my News Briefs fans.

"Nearly twenty years later, former Secretary of State Dean Rusk was being interviewed by Peter Arnett on a CBC documentary called The Ten Thousand Day War.

Mr. Arnett asked, "It has been rumored that the United States provided the North Vietnamese government the names of the targets that would be bombed the following day. Is there any truth to that allegation?"

To everyone's astonishment and absolute disgust, the former Secretary responded, "Yes. We didn't want to harm the North Vietnamese people, so we passed the targets to the Swiss Embassy in Washington with instructions to pass them to the North Vietnamese government through their embassy in Hanoi."

Massachusetts Primary Day turned out a few surprises. The victory of Boston City Councilor Ayanna Pressley over 10-term incumbent Congressman Michael Capuano in the 7th district, which includes much of Boston and a number of surrounding communities north and south of the City. The final voting margin was 59 to 41. percent. In the end, it was about turning out your base. #### APHRODISIACS, ETC.

#### Boston Residents Increased Risk of West Nile Virus

Residents are Strongly Urged to Take Steps to Avoid Mosquito Bites After Increase in Reported Cases and Positive Mosquito Pools

The Boston Public Health Commission (BPHC) recently announced the second reported case of West Nile Virus (WNV) in a Boston resident, a male in his 50s. The announcement comes after the Massachusetts Department of Public Health raised the risk level for WNV from moderate to high in Greater Boston communities earlier this week.

This is Boston's second confirmed human case of WNV this year, bringing the total number of reported cases in Massachusetts to five this year. In the past two years, there was one reported human case in Boston.

Within the last week, the total number of mosquito pools that tested positive for WNV in Suffolk County have nearly doubled to 15. A second type of mosquito has also been reported. This mosquito type is primarily active during daytime hours unlike the previously reported mosquito type, which was active during dusk and dawn.

WNV is most commonly transmitted to humans through the bite of an infected mosquito, and poses greater health risks to people over 60 and those with certain medical conditions, such as cancer, diabetes, hypertension, kidney disease, and people who have received organ transplants.

Residents are strongly urged to take steps to protect themselves, their loved ones and pets, from mosquito bites:

• Use (and re-apply as needed) EPA-approved insect repellents when outdoors

• Wear clothing to reduce skin exposure

• Install or repair window and door screens to keep mosqui-

toes outside

Residents are also advised to take measures to reduce the number of mosquitos in their yard by dumping all standing water weekly to prevent them from breeding, as well as treating larger pools of water with larvicide. Residents may contact the Suffolk County Mosquito Control at 781-899-5730 to request larvicidal treatment of swimming pools and other large containers of water that cannot be emptied.

## Achievements Were Simply Stupendous

Christopher Columbus was born in Italy in the city of Genoa in 1451. As an Italian American I am very proud of the fact that it was an Italian who discovered America. Did you know Christopher Columbus wrote a book? Entitled The Book of Prophecies, it is not a series of predictions, but actually a compilation of passages selected from the Bible which he believed were pertinent to his mission of discovery. ## Mass Honoring Saint Padre Pio at St Leonard Church

Followed by Procession with Vile of the Saint's Dried Blood Scheduled for Sunday, September 23rd

In the span of just fifty years since his death in 1968, Padre Pio, OFM, Cap. has become one of the most beloved saints in the Catholic Church.

So it is with great anticipation that on Sunday, September 23rd, the Padre Pio Society of St. Leonard Church will sponsor a procession through the streets of the North End with a Franciscan Capuchin Friar from Italy carrying a firstclass relic consisting of a vile containing the saint's dried

Festivities honoring Saint Padre Pio will begin at noon with Mass at St. Leonard Church (Prince and Honover Streets, North End, Boston) celebrated by Bishop Peter J. Uglietto. The procession itself will begin from St. Leonard Church at 2:00 pm and end at 4:30 pm at St. Leonard Church

Padre Pio was born in Pietrelcina, in Campania where his parents labored as peasant farmers. In 1990, the Congregation for the Causes of Saints investigated how Padre Pio had lived his life, and in 1997, Pope John



Paul II declared him venerable. Cases were studied such as a reported cure of an Italian woman, Consiglia de Martino, which was directly associated with Padre Pio's intercession. In 1999, on the advice of the Congregation, John Paul II declared Padre Pio blessed. Then, after further consideration of Padre Pio's virtues and ability to do good even after his death, including another healing attributed to his interces-

sion, the Pope declared Padre Pio a saint on June 16, 2002. An estimated 300,000 people attended the ceremony.

One of the countless stories about Padre Pio tells of a woman whose husband was very sick so she decided to ask Padre Pio to intercede to God for his recovery. But there were so many people that she had to wait for three days just to go to confession. In her consternation, and noting the long lines, she walked from one side of the Church to the other, praying all the while, until finally she reached a corridor where Padre Pio had to pass. As soon as he saw her, he said, "Woman with little faith, when will you finally stop asking for my help? Do you think I am deaf? You have already told me about your husband five times. When you were in front of me, at my back, on my right, and on my left. I understood! I understood! ... Go home! Everything is OK." She went home and found that her husband was healed.

# Memorial to a Genius in the Field of Medicine

Dr. David J. Sugarbaker past away suddenly, and the country lost one of the greatest surgeons that ever lived. He became a beacon of hope to those who had no hope left. He was on the cutting edge of technology and used his skills to save many, many patients with life threatening lung cancer by operating, when other doctors gave no hope. Patients came from all over the world to be treated by Dr. Sugarbaker. He had extensive waiting lists, but managed to take the most critical first.

Dr. Sugarbaker served as a chief of Thoractic Surgery at Brigham and Women's Hospital for 27 years before stepping down in the spring of 2014 to create the Lung Institute at Baylor College of Medicine in Houston, Texas. During his dedicated service to the Brigham, Dr. Sugarbaker shaped the Division of Thoracic Surgery into one of the top in the nation. He pioneered the technique of extra pleural pseumonectomy and its application to patients with mesothelioma, developed innovative multimodality

therapies and directed translational research programs in this disease that are known worldwide.

Dr. Sugarbaker attended Wheaton College in Wheaton, IL and Cornell University Medical College in New York City. He completed his residency at Brigham and Women's Hospital and his cardiothoractic training at the Toronto General Hospital and Mount Sinai Hospital in Toronto. Following his training, he returned to Brigham and Women's Hospital as Chief of the then newly formed Division of Thoractic Surgery. He also served as the Richard E. ## L'Anno Bello: A Year in Italian Folklore

La Vendemmia and the Harvest Within

September in Italy is a glorious time of the year. The sun still bakes the landscape into glorious hues of amber and ochre. Local festivals called sagre celebrate the ongoing harvest, with town squares becoming veritable banquets of local specialties ranging from apples to truffles to figs. Of course, the country begins gearing up for the autumn as well, as the dusky nights become cooler and people adjust to rigorous rhythms of the new season. However, one September event particularly captures the whole essence of Italy in the fall. It is called la vendemmia, or the grape harvest, and it sweeps the country through the autumnal months. La vendemmia is a sacred ritual in Italy, where the grape comprises a prized crop and its final product, wine, forms the crux of the national character. Throughout this harvest, Italian towns buzz with the energy of people collecting their grapes in giant wicker baskets or on the back of tractors, ready to be eaten as a fresh seasonal treat or distilled into the country's famous wines. Communal pleasures blend with hard work in order to create a beautiful dance of quaint customs, careful food preparation, and long-term planning for the cold months ahead. Observing Italian vendemmia customs reveals much about the power of harvest as a way of respecting the Earth and the lure of traditions, even in modern Italy.

Indeed, the sight of vineyards perched on rolling hills, with dappled sunlight shining through the gemlike green leaves and violet grapes, has become an indelible symbol of Italy, often being the first image that enters people's minds when they think of the Italian countryside. Italian immigrants to the United States brought over

their love for the all-important grape when they crossed the ocean, making it a staple of Italian-American culture. Grapes were my father's favorite fruit, and a bowl of translucent and sweet pale green grapes, or velvety purple fruit, frequently sat on our kitchen table. Several relatives of mine grow grapes at home, the gnarled vines and wild leaves creeping over backyard trellises like a labyrinth. Back in Italy, the same vineyards that adorn postcards and posters are humming with activity for the September vendemmia. Skilled farmers know the precise temperature and weather that make for the best picking conditions and will produce the optimal grapes and wine. Nowadays, many people adapt technological methods to la vendemmia, using the latest gadgets to test the acidity of the grapes. However, tradition still reigns supreme in many parts of Italy, where the whole village assembles to pick grapes, from the grandmothers in kerchiefs to the hip young people on break from college. One can sense the Bacchanalian revels of old in these communal gatherings.

La vendemmia is so vital in Italy precisely because much of these harvested grapes will be used in one of Italy's most iconic products, wine. Wine, or vino, holds a significant spot in Italian culture and society, finding a place on every dinner table and forming the basic tenet of Italian hospitality. Wine is also imbued with a religious connotation, serving a prominent place in the Eucharistic ritual of bread and wine. It is not unusual for the basements in some of my family member's homes to be stocked with bottles of wine, glowing an eerie shade of white and purple in the dim light, aged to perfection and

ready to be brought out to greet the arrival of a guest. Indeed, wine is such a touchstone of Italian society that numerous superstitions protect its reputation and warn of dire consequences to anyone who mistreats wine. A superstition that hearkens back to Roman times states that a person who spills wine must dab a little behind each ear to ward off any bad luck that comes from the waste of the precious drink. However, Italians do consider it good luck to spill wine on new clothes or a tablecloth. Perhaps this is a way for the wine to transfer its inherent positivity to the new garments. Miscellaneous wine superstitions further include never toasting with water, but rather always with wine; avoiding serving wine "backhanded," or with the back of the hand facing guests; and women refraining from drinking the last drops of wine in a bottle at the risk of remaining unmarried (this superstition, of course, is from olden days when society dictated that women must get married). I do not drink wine myself, but I appreciate the wisdom and customs of my ancestors behind its making.

I believe that one of the most important lessons to be gleamed from la vendemmia is patience. Farmers must wait a long time for the grapes to be just right for picking; gathering the crop any sooner or later impacts that taste of the fruit and the eventual wine. Later, winemakers similarly ready themselves for the grapes to be distilled and the must to turn to wine. The traditional day in Italy for tasting new wine is actually St. Martin's Day, or la Festa di San Martino, which falls on November 11th two months after the bulk of the grape harvest has taken place. Afterwards, though, the wine becomes a crucial part of the Italian holiday season and beyond. As we enter the fall, with its new rhythms and its return to school and work, we can all learn lessons from la vendemmia. We can set many goals for professional and personal improvement, but we should realize that they will take patience, dedication, and hard work in order to manifest. Once they do, however, they will be as beautiful and well-earned as the finest Italian wine, which once started from the lowliest, barest vine. Just as Italians gather grapes this September, let us gather our own hopes, dreams and challenges and work to make them come into fruition this autumn and all year long.

There is a horrible drug crisis going on all across America as more and more deaths are reported by the hour and day. One day last week, I was caught in traffic in Edward Everett Square in Dorchester watching a young woman in maybe her late 20s or early 30s, who looked to be about 50 years old crossing the street sideways. She almost fell several times, but made it safely to the other side. Let me go on. Driving on Melnea Cass Boulevard passing by the so-called "Methadone Mile" area, I have seen folks shooting up in public right there on the sidewalk near a Chinese funeral parlor. An undertaker on one side and the BMC Emergency entrance on the other.

There is always a crowd of these drifters. We drive past them as fast as we can. I look at them and see pathetic souls lost forever destroyed by drugs of all sorts.

I can remember as a police officer over my 28 years on the job arresting folks for drugrelated issues. I once arrested a drug dealing scumbag hanging near a methadone clinic and pushing his wares. He had so much cash on him it was unbelievable. I am sure this happens every day somewhere.

I once found someone so snowed on oxy that every time he bent over, he fell asleep and started snoring. He told me he started taking it for pain, and before he knew it, he was hooked.

Things are only getting worse than when I retired five years ago. I recently heard that in neighboring Connecticut a suspected bad batch of synthetic marijuana led to 75+ overdoses at New Haven Green next door to Yale University in just 24 hours. Several of the overdoses were actually repeat victims within the same 24-hour period. They overdose once, almost die, and then run back for more drugs, chancing death

We aren't just talking young people either. It is all ages. A friend of mine whom I have known for about seven years recently died from a drug overdose. He wanted to stop, but just couldn't. He was found dead by his girlfriend. He was 48 years old. There is also a question of whether it was an accidental overdose or suicide. Perhaps, he couldn't live with his demons and decided to leave this life in hopes of a better one elsewhere.

Politicians need to stop barking at each other over senseless stuff and start moving forward in dealing with this drug menace killing our society one victim at a time. We need to do something other than talking about the issue or doing a drive by past it.

# **Harvest Cucumbers for Slicing and Pickling**

Harvest cucumbers when they're small or large, depending on how you plan to use them.

It's all about timing when harvesting cucumbers for eating fresh or preserving as dill or sweet pickles. Picking these low-calorie vegetables ensures the best flavor, greatest nutritional value, and suitability for pickling.

Harvest cucumbers based on how you plan to use them. Pick the fruit when it is  $1\frac{1}{2}$  to 2½ inches long if you plan on making sweet pickles. Allow the cucumbers to grow a bit bigger, three to four inches, if dill pickles are on the menu.

Allow them to grow longer, if you plan on using them fresh in salads, beverages, or for snacking. Harvest slicing cucumbers when the skin is firm, bright green, and the fruit is six to nine inches long. You can leave burpless cucumber varieties on the vine a bit longer. They have been bred to maintain their mild flavor when harvested at ten to twelve inches in length.

Impress your family with the crisp, mild flavor of the long Japanese cucumber. Pick these when they are 12" to 18" long.

The flavor remains mild and skin easy to digest despite the longer size.

Misshapen and bitter flavored cucumbers are usually the result of drought, improper fertilization, and large fluctuations in temperatures. These are safe to eat but may not have the best flavor. Remove about an inch of the stem end and peel to remove some of the bitter flavor.

Compost poor quality fruit that is not suitable for eating. Then adjust your care to ensure better quality cucumbers for the remainder of the season.

These low-calorie vegetables are a good source of fiber, potassium, and vitamin K. Plus, they have a high-water content, making them a mild diuretic to help in weight loss and reduce blood pressure. Enjoy cucumbers in chopped salads, chilled soups, or sandwiches. Or add a few slices to a glass of water for a refreshing drink.

Cucumbers can also sooth and minimize eye puffiness. Just place a few chilled slices of cucumber on closed eyes and relax.

No matter your desired use for this multi-purpose vegetable, harvest it at just the right time to enjoy its many benefits.

# Feast of the Three Saints — Saints Alfio, Filadelfo & Cirino LAWRENCE, MA

Over the Labor Day Weekend the City of Lawrence and the St. Alfio Society celebrated their annual 95<sup>th</sup> Feasts of the Three Saints, in honor of St. Alfio, Filadelfo, and Cirino. The Feast began on Friday evening at Lawrence City Hall with a procession throughout the community.

New to the Feast this year, in partnership with the Sons of Italy, "learn to play bocce" was held on Friday and Saturday, a children's bocce on Saturday, and a bocce tournament on Saturday night.

This year's Feast included the infamous torchlight procession, live musical entertainment including the original Drifters and yes of course, delicious Italian food.

Alfio, Filadelfo, and Cirino were three brothers born in the third century in the town of Vaste, in the province of Lecce located in southeastern Italy to a noble and Christian family. Alfio was the oldest, followed by Filadelfo and finally Cirino, the youngest of the three.

They were arrested by Roman soldiers and taken to Rome where the Imperial Court tried to make them denounce their faith. Unsuccessful, the Romans sent them to Tertullo, the governor of Sicily in the city of Lentini.

The Brothers and soldiers traveled from Rome to Messina, Sicily and then marched south through Sicily. Along the way, the Three Brothers and soldiers stopped and rested in the town of Trecastagni in early September 252.

Once in Lentini, they were beaten and cruelly tortured by Tertullo's soldiers trying to make them deny their Faith, but they remained steadfast

After months of torture, Tertullo became furious and ordered his soldiers to produce the final instruments of death if they refused to worship the pagan gods.

On May 10<sup>th</sup> in the year 253, the Brothers were martyred in Lentini and received the palm and crown of martyrdom. The Romans tied 22-year-old Alfio to a post and tore out his tongue, as he was the most outspoken of the three. Filadelfo, 21 years old, was burned on a gridiron and Cirino, only 19, was thrown into a cauldron of boiling oil.

But the story does not end there. It's just the beginning. During their lifetime and after their death, numerous miracles have occurred which are attributed to the intercession of the Saints.

Since the 1500s, the people of Trecastagni have held a grand Festa each May  $10^{\rm th}$  and in early September in honor of the Three Saints who stopped and rested there.

Early 20th century immigrants from Trecastagni who settled in Lawrence brought their faith and tradition of the Saints with them and established the Feast in 1921.

Today, The Saints Alfio, Filadelfo & Cirino Society maintains this faith and tradition in its charitable works and the annual Feast of the Three Saints.



#### KISS OF THE SPIDER WOMAN

Spins an Interesting Web

The Lyric Stage Company in Boston has kicked off its 44th season with the rarely produced Kander and Ebb musical Kiss of the Spider Woman. The play, with book by Terence McNally, is based on Manuel Puig's 1976 novel and the movie that followed. The Tony Award winning musical first appeared in 1993. This production is directed by Rachel Bertone who helmed last years wonderful Gypsy at the Lyric.

The story, which takes place in an Argentine prison, revolves around Molina (Eddy Cavazos), a gay window dresser who has been imprisoned for "corrupting a minor", and Valentin (Taavon Gamble), a Marxist revolutionary, who has been sent to jail for his political activities. Valentin is initially tortured and then tossed into a cell with Molina who nurses him back to health. Upon regaining consciousness, Valentin draws a line down the center of their shared cell marking of each's territory (I Draw the Line). He clearly is not comfortable with the gay Molina.

Molina has learned to cope with the horrific conditions of being in prison by escaping in his mind and to the movies he used to see when he would accompany his mother (Johanna Carlisle-Zepeda) to the cinema she worked in. One actress occupies his mind, Aurora (Lisa Yuen), whose movies he replays over and over in his head. We meet Aurora in the opening number "Aurora." The one role she played that terrifies him is when she played a spider woman who kills with her kiss. As we see Molina and Aurora, though his imagination, reenacting scenes from her movies the character of the spider woman reappears over again as the haunting kiss of death that the prisoners live with everyday.

While Molina is apolitical, Valentin sees in his life a mission to change society. The two learn from one another, with Molina it is begrudgingly, and eventually form a bond with

turns into love. The set is provocative as it reaches out to the audience giving a feeling of bringing everyone into the prison. Lighting and shadows on the floor alternate between a spider web and the outline of prison bars. It is subtle yet effective. The off stage screams of prisoners being tortured is unsettling, as it should be, and adds to the feeling of hopelessness Molina and Valentin feel.

This was my first time seeing a production of *Kiss of the* Spider Woman, and my take away is it is a work that is very

dependent on having the right people in the roles in order for it to work. Eddy Cavazos is superb as Molina. His body language speaks as much to the audience as do his lines. He moves about the stage with a patience that proves very effective for conveying the depth of the character of Molina. Watching Molina as he copes with the misery and suffering around him, and that is inflicted on him, we also see how he learns to understand his value as a human being. This is a role that could easily be overplayed, but Mr. Cavazos resists that temptation.

Of course, this is not a one person show, and Taavon Gamble has his work cut out for him as Valentin, the angry young man who feels he will never get the chance to save the world. Valentin, who wants equal rights for all, is confronted with having to face his own problems, now having to share a cell with a gay man. Can he retain his masculinity while at the same time having feelings and caring for a gay man? It is where he learns we are defined not by what we are but rather by who we are. Mr. Gamble has done a marvelous job in bringing so many conflicting emotions to the stage in a way that we can understand them and share in his growing to embrace Molina.

Lisa Yuen is Aurora and she sparkles in numbers such as "Aurora" and "Let's Make Love." She is also haunting as the spider woman who is the ever present shadow of death. Ms Yen is joined by Katrina Zofia, who plays Valentin's girlfriend Marta; on the song "I Do Miracles."

Molina's mother is played by Johanna Carlisle-Zepeda. Her rendition of "You Could Never Shame Me" is a touching and

moving love song showing a mother's unconditional love for

While Kiss Of The Spider Woman is a story with much darkness and horrific situations, the tension is broken in the same way Molina has learned to escape from his misery; through the imagining of Aurora's performances and show tunes, which are excellent. These breaks are much needed and make the story bearable. It is also much in the tradition of Kander and Ebb to take such dark stories and make them palatable. We can witness the suffering and misery while not being overwhelmed by it. That enables us to try to understand it and find ways to prevent it, or at least get through the suffering in life.

Today, almost everything is viewed through a political lens, particularly in theatre, and this play is political. While many will look to find comparisons with what happens in the play with what is happening in our society, it might be a good idea to look a but further away and a but closer to where the play is set. In Argentina, three decades of Kirchener rule may be coming to an end, while in Venezuela the Marxist government has left the once prosperous country in a state where people are now starving to death. Cuba is still very much a prison island lacking basic human rights. Perhaps Valentin will reconsider his Marxist views in light of all this. I hope so, as he has the drive to do much good.

# Nanna & Babbononno

A Nostalgic Remembrance



It was the mid-1960s. September had just rolled around, and I was back to school teaching at Hyde Park High. For most of that summer, I had been playing with a band at a hotel in San Juan, Puerto Rico. As a result of not being in Boston for a couple of months, I didn't have anything booked in musically for the fall. Uncle Nick, my Godfather, was the vice president of the Boston Musicians' Union back then, and I let him know of my dilemma. He told me that a call had just come in from the manager of the Piety Corner Gardens, a restaurant, nightclub, function facility in Waltham. It seems that they needed a band to play for dancing and back the shows they had booked in their nightclub on weekends. He told me that he would have the manager call me if I agreed, and I did.

The manager didn't want anything larger than a trio, and I told him that I could handle the job with piano, bass and drums. I called the members of a trio I had performed with the year before and offered them the job, provided we passed the audition, and a price could be determined. Both the pianist and drummer were available, and the audition was to cut both Saturday night shows cold, and play for dancing in between shows. The wall separating the restaurant and the nightclub was rolled back and for an hour before the first show, we played dance music for their diners, mostly senior citizens. The standards seemed in order, and we had the dance floor filled from 8:00 'til 9:00. The show consisted of a tap dancer followed by a comedian, followed by a singer. We handled the three acts as if we had rehearsed them, and at midnight, when we finished, the manager offered me the

We were there for about a month on weekend nights, and the manager, an authoritarian type, made life miserable for us and most everyone else that worked at the complex. By the end of the month, we had developed a good reputation, and many of the night clubbers were in attendance just for the music. One Saturday in October, the pianist arrived sick as a dog. He played the first set and couldn't continue. The drummer got on the phone and found a pianist who was home that evening and accepted the fill-in position. We started the

second show a bit late as we had to await his arrival. Once he was on stage, everything went smoothly. At the end of the evening, I had an argument with the manager over the situation and he fired the band. I reminded him of the type of contract he signed, a twoweek notice contract. This was a standard union document which stated that if we wanted to quit a job or the management of the place we were playing wanted to let us go, a two-week notice had to be extended. The manager had a few choice words for me, and as we left, I told my musicians that I was going to report the situation to the union on Monday morning.

During my free period on that Monday, I called Uncle Nick to let him know the circumstance and he told me that the owner of the Piety Corner Gardens had called the union looking for my number. I thanked my uncle and gave him the scenario that unfolded that past Saturday night. He told me that he would handle the problem and I went back to my teaching chores. That afternoon, I explained my dilemma to Babbononno and Dad as we ate dinner. Just then, the phone rang. The man identified himself as Steve Santamaria, the owner of Piety Corner Gardens. He apologized for the happenings of that past Saturday night and asked if my trio could return on the coming weekend. I thanked him but let him know that I didn't want to work for the man managing the establishment, and explained why. Steve then explained that he had fired the manager, his nephew. He told me that, if I decided to return, I would answer to him, and no one else, and he offered me a salary that was above union scale for the job. I called the pianist and drummer, who were happy about the new arrangements and we went back to work that weekend.

There was a sliding wall, that when opened, made the dining room and the nightclub one big room. When the dining room closed, the wall would be rolled in place and separated the two rooms, making our location a free standing nightclub. For the next year, the Johnny Christy Trio performed on weekends, playing for dancing and cutting the shows Piety Corner Gardens had booked in. During our intermissions, Carmel Bruno, an elderly organist played music for the old folks to sing and dance to.

During that year, Dad, Mom and Babbononno joined us several times, had dinner and sat through at least the first show. Babbononno loved the tap dancers and singers, but couldn't identify with the comedians, having no idea as to what they were saving.

After about a year and a half, Steve the owner decided to change his entertainment format. He booked in a group called the Kopy Kats for weekend entertainment and had us playing strictly for dancing Monday, Tuesday and Wednesday nights. For us, this was great. It freed us up to book in weekend work above and beyond our new commitment. I became quite friendly with the owner, Steve Santamaria. When I was called to head to Hollywood, Dad took my place leading the band, and he and Steve developed a friendship and became golf partners.

One night, Steve's son, knowing that his father wasn't feeling well, told him to go home early and he would lock up. En route home, Steve's son fell asleep at the wheel, went off the road, hit a tree and was instantly killed. His father was never the same after young Steve's death. Toward the end of a set, a waitress often approached the stage telling me that Steve wanted to see me in the office when I was on a break. When in his office, he would pour me a drink, sit back and lament about his departed son, and then break down and cry. This scenario continued for quite a long period of time and I noticed that things were changing. The restaurant closed. Fewer functions were booked into their facilities. The men's bar in the back of the complex shut down and the only thing left was the nightclub.

Toward the end of the year, Steve called me into the office and told me that he was giving me a month's notice as he was closing the club. Our last job was on New Year's Eve. I hired sax and trumpet players to join us and augmented the new sound with a female singer. The day after the New Year began; there was a padlock on the front door of Piety Corner Gardens. It was a sad ending to a very enjoyable time in my young life. Today you can rent a storage facility where the Gardens once stood, a sad testament to a bygone day.

## Recipes from the Homeland

#### BAKED SCALLOPS

1 pound scallops 25 Ritz or Hi-Ho-type crackers crushed 1 tablespoon chopped parsley

COPYRIGHT, ALL RIGHTS RESERVED

2 tablespoons butter or margarine 2 tablespoons white wine Paprika Salt

Spread some butter or margarine on bottom of baking dish (10" x 12" x 2"). Wash scallops and drain excess water. Place scallops in baking dish. Blend melted butter into cracker crumbs. \*Spread crumbs over scallops. Pour two tablespoons of white wine in a glass with two tablespoons of clam juice or water. Sprinkle gently over cracker crumbs and scallops. Sprinkle paprika over the cracker crumbs. Cover and bake at 400°F for fifteen or twenty minutes or until scallops are the right consistency to serve.

Note: \*When preparing the above recipe for my husband and me, I sprinkle garlic powder over the scallops before adding the cracker crumbs and remaining ingredient. We enjoy the garlic

I often bake this meal in my heated toaster oven set on broil. I cover scallops with aluminum foil before placing in toaster oven. Broil for about eight to ten minutes. Then set the toaster oven to bake for the remaining time needed.

I serve mashed potatoes or rice pilaf along with French-cut beans and/or carrot strips topped with butter or margarine.

# Saint Bonifacia Rodríguez y Castro

Bonifacia was born in Salamanca, Spain, on June 6, 1837, to Juan Rodríguez and María Natalia Castro who were devout and pious people. Her father was a tailor and the family was very poor, frequently having to move because he was unable to pay the rent. From a very young age, Bonifacia helped her father in his small shop, as well as caring for her younger siblings.

After completing a basic schooling, Bonifacia began to work as a rope maker. Later, in 1865 after the marriage of her sister, she was able to set up a small workshop in the family home for making rope, lace and various other items. In this way, Bonifacia lived a quiet life with her now-widowed mother.

After five years as an independent artisan, in 1870, Bonifacia met a newly arrived priest from Catalonia, Fr. Francesco Xavier Butinyà, S.J. who had a vision of responding to the needs of the growing working class which had arisen from the Industrial Revolution. He preached that work was a way for all to become



more free and equal in society, and also a means of witness to the teachings of the Gospel. Bonifacia decided that this priest was the one to guide her in her spiritual search.

Bonifacia opened her workshop as a meeting place for working women like herself, both for socializing and for time of reflection on the themes and issues of the day. They invited Father Butinyà to these gatherings, and under his guidance they established themselves as the Association of the Immaculate Conception and St. Joseph.

It grew into a new religious congregation, the Servants of Saint Joseph, devoted to the spiritual formation and protection of women factory workers. Only eight years after co-founding the congregation, Sister Bonifacia was unjustly removed from the office of mother superior. She received Episcopal permission to begin a new convent in Zamora, but the Salamanca community refused to be reconciled with her. On August 8, 1905, Sister Bonifacia died. Less than two years later, the Salamanca and Zamora communities were united into the single congregation that she had hoped and prayed for.

Sister Bonifacia was canonized on October 23, 2011, by Pope Benedict XVI.





#### Chuck Wepner "The Bayonne Bleeder"

Plodding Heavyweight Would

Look Like Gene Tunney Against Today's Opposition

**Chuck Wepner** 

There is no doubt that today's heavyweights are the worst in the history of boxing. When it comes to boxing skills they have none. I have maintained that any of the previous eras champions going back from the 1990s or so would have an easy time taking the current crop of pretenders apart.

Even the top contenders, the guys that never won the crown, would clean out today's division. Men such as Jerry Quarry and Jimmy Young were miles ahead of the opposition they would be facing today.

As I have thought about how plain awful the heavyweight division has become, I started thinking about how the fringe heavyweight contenders of the past would have done today. Recently, I watched a film of Chuck Wepner vs. Sonny Liston. The

bout took place in 1970. This was Liston's last fight and he did a paint job on Wepner. Wepner was stopped on cuts in the 9<sup>th</sup> round and required 72 stitches. He also ended up with a broken nose and a cracked cheekbone. Liston would be found dead six months later.

At this point in his career Liston was showing the effects of age and hard living, but because of his skills, and his lethal left jab, he could still beat guys. The Liston of this fight, even as far over the hill as he was, would destroy the top heavyweights of today. But, Liston had been world champion, and if not for Ali, would have gone down as an all-time great.

What is more interesting is the way Wepner performed in the fight, and how it set him apart from what you see today. Wepner was never even remotely thought of as a skilled boxer. He was known for his guts and roughhouse tactics along with his determination and willingness to take on all comers. Plodder would be an adjective used to describe him.

Now, in the context of 1970s era boxing, Wepner would be considered a plodder. He would also be described as lacking in skills. Turn the clock ahead to 2018, and you would describe him quite differently. Wepner had been schooled in basic boxing techniques, techniques you just don't see today. He was up on his toes. He used a decent left jab. In fact, it is interesting to watch him trying to out jab Liston. He also used his right hand in an attempt to parry blows. Wepner was in good shape but not muscle bound. He was a big man standing 6'5"and weighing 228

pounds, but he was much more agile than guys like Deontay Wilder. Agile is a word you never would have heard to describe Wepner back then but when putting him in the context of the current crop of heavyweights he comes out looking like Gene Tunney.

I thought I would dig a bit deeper along this thought process so I decided to watch Wepner in his fight against another fighter who never made it to the top of the list of contenders. That man was Duane Bobick.

Bobick was another big man at 6'3" and weighing 217 pounds. An outstanding amateur boxer, Bobick was also more of a plodder but with more skill than

Wepner. Again, in the context of the time in which they fought each other, 1976, they would hardly have been called great "boxers." It was an entertaining fight though, with Bobick winning on cuts in

the 6<sup>th</sup> round.

Once again, move the clock ahead to the present era and watch this fight through that lens and you will notice things. Even before the bell sounded for the first round you can see a major difference from what goes on today. Watch Bobick in his corner during the introductions. He is shaking out his arms and bouncing around on his feet. He is trying to get as loose as possible before the action starts. Today, you see fighters striking body builder poses and flexing their

muscles. Bobick and Wepner as well, are doing what fighters used to do. They are warming up in a way that will give them flexibility and speed. Yes, even two guys who were considered slow moving fighters in their day were working at being as loose and agile as possible before the start of the match. These were not a couple of muscle bound guys, but rather men who trained for athletic competition.

The fight itself was much more interesting than anything you will see today. Both men, while a bit awkward in their motions, came out in defensive postures and on their toes. They feinted each other, used their jabs, and searched for openings. Wepner employed his roughhouse tactics which included rabbit punching. Bobick kept his cool while being fouled and adapted to the situation. He began staying low and going to Wepner's body. This strategy paid off as he wore Wepner down and came away with the victory.

Watching Chuck Wepner in action in two fights he lost really shows just how far boxing has devolved. Wepner was a very tough guy who was never in a dull fight. He went into the 15<sup>th</sup> round against Muhammad Ali, a feat that was the inspiration for the movie *Rocky*. He was not known as a man with boxing skills, but look at him, and compare him with what you see today and you will see a master boxer in comparison with what is happening currently in the ring.

Would Chuck Wepner have been a contender today? Most certainly! He also would have been a champion.

## HOOPS and HOCKEY in the HUB

In a video on the *NHL.com* web site Bruins goalie Tuukka Rask revealed that he does not have pets because of possible allergic reactions.

"I've never had pets," explained the B's veteran netminder. "I'm allergic to cats, and dogs and horses and cows and whatnot so I've never had pets. But if I had to pick one it would be a dog."

In another segment that asks which NHL player has the worst tape job on his stick, Rask smiled and said he would vote for the one used by teammate David Pastrnak. "It looks like a two-year-old taped it," said Rask with a slight laugh.

He also revealed the aspect of life in the NHL that he dislikes the most is waiting around — especially on road trips. "Waiting in hotels, waiting for the bus (to take the team to the arena), waiting in airports — I don't like waiting. I'm a pretty fast mover."

Well, of course, he would have to be, given the position he plays. You've got to be able to move quickly to stop all those shots that come flying your way each and every game.

Rask enters the 2018-2019 campaign fresh off another successful season between the pipes. He compiled a 34-14-5 mark last year, extending his span of consistent performances. Last season marked the fifth straight one that he amassed 30 plus wins for the B's, logging a 2.36 goals against average to go with a .917 save percentage.

Many expect he may be pushed a bit this time around with the acquisition of Jaroslav Halak from the Islanders in July, replacing Anton Khudobin who moved on to the Dallas Stars. Now 33 years old (Rask is 31), Halak appeared in 54 games last year with the Islanders and started 49 of those contests. He posted a 20-26-6 mark with a 3.19 goals against average and a .908 save percentage, his only NHL season in which he posted a losing record.

Having already played a combination of 12 full or partial campaigns in the league, he's had stints with the Montreal Canadiens, St. Louis Blues, the Washington Capitals as well as the Islanders.

The B's are betting that this NHL veteran has some gas left in the tank now that he is with a better club. The Islanders finished dead last in team defense in the 31-team NHL for the 2017-2018 campaign, yielding 3.57 goals per game.

We doubt that he could dislodge Rask from his number one goalie position and we don't see him getting close to those 49 starts here in Boston. It is a two-year deal, providing a rather easy escape for Bruins management if things don't work out.

At a charity event held at the Garden in late August, Rask seemed unconcerned, saying that having competition is good, especially from a fellow European (Halak is a native of Slovakia, Rask hails from Finland).

But to really push Rask, rather than just serve as a

steady backup, Halak would have to return to his former form that he displayed in St. Louis where he recorded a 1.97 goals against average in 2011-2012 and a 2.23 GAA in 2013-2014.

While anything is possible — and nothing should be written off as training camp begins — we think that Rask will remain number one in the nets throughout the season with routine backup duty by Halak. Khudobin played 27 games last year while spelling Rask (one third of the schedule) and that seems about right for a backup.

And remember, should Halak not work out Zane McIntyre (and others) wait in the wings in Providence with the option of in-season trades providing other possibilities.

**WINGING THEIR WAY TO THE ORIENT** — That's what the B's will be doing when they leave on September 11<sup>th</sup> for their 10-day trip to China where they will play the Calgary Flames in a pair of preseason games.

The contests, slated for September 15<sup>th</sup> in Shenzhen and September 19<sup>th</sup> in Beijing, are the most prominent highlights to date of a five-year partnership between the Bruins and O.R. G. Packaging, a firm that is based in China.

During the summers of 2016, 2017, and 2018 the B's sent delegations of current players and former players to China to conduct clinics. For the games against Calgary, about half of the training camp roster is going in order to further extend this goodwill effort.

It's also been a two-way partnership as well with youth hockey players from China coming to the Hub — most recently last February — to play local youth hockey teams, engage in tours of Boston as well as having the opportunity to attend the Beanpot Tournament plus a Bruins game and a Celtics game. One highlight came when the B's held a Chinese Cultural night at the Garden on February 10. Another was on February 14th when the youngsters were on the ice with the Bruins at the B's practice facility (Warrior Arena) in Brighton.
